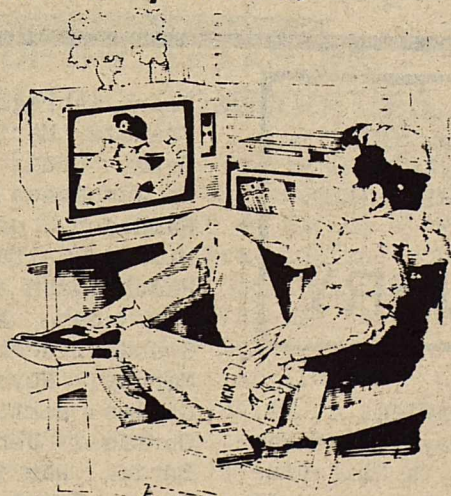

Kinney County will use rules and procedures found in the County Indigent Health Care Program Handbook published by the Texas Department of Human Services. In summary, these are the rules:

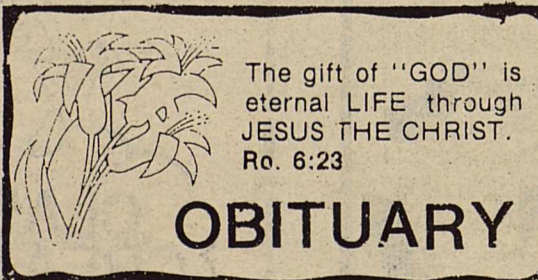
1. Application forms must be filled out completely.
2. Verification of income, termination of income, residence, household composition, and resources is required, if questionable.
3. Net income cannot exceed limits set below

4. Liquid resources assets cannot exceed \$1000. The equity value of a car greater than \$1500 is counted against the \$1000 limit. Personal property and homestead are exempt assets.
5. Eligible persons must be residents of Kinney County.
6. Applicants must provide all requested information and documentation requested or applications will be denied.
7. Applicants have the right to appeal adverse decisions.

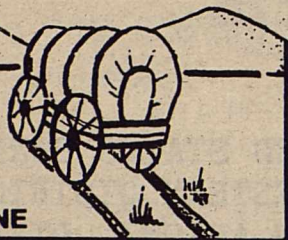

TRACKS ALONG THE TRAIL

In the 1920's the fabulous "101" Ranch was at it's peak. 101,000 acres of rolling prairie in present Kay and Noble Counties taking in three towns; Bliss (now Marland), Red Rock and White eagle. Twenty-five thousand cattle, shipping pens on the Sante Fe, three-hundred miles of fence, one-hundred horses to work the range, two-hundred and fifty employees, every foreman's house connected to headquarters by telephone, mail delivery by a rider everyday. The "One-Hundred and one" had its own churches and schools and miles of roads both private and public.

It's hard to believe that such a place really existed. There was a three-hundred thousand dollar wild west show, a zoo, movie making company and three-hundred Indians.

The Miller Brothers, Zack T. Miller, George L. Miller and Joe C. Miller made their fathers dream come true. Their father Colonel George Washington Miller, was a Confederate Veteran who came West from Kentucky in 1871 to build a huge cattle ranch in the Virgin Indian Territory. This he did, and started his first ranch on the Quapaw Reservation in 1879. His second ranch was in the Cherokee Strip near the present town of Lamont in Indian Country. Then the government issued a proclamation opening the Cherokee Strip for settlement and ordered out the cattlemen.

Along the Salt Fork lay the vast Reservation of the Ponca Indians, Colonel Millers long-time friends. When the strip opened in 1893, the Poncas loaned the Millers acres of their Reservation and all the Millers had to do was move their holdings down the river. The Millers had been made members of the Tribe when first coming to Indian Territory.

Their first headquarters was a dug out on the Salt Fork. The second ranch house was built across the river, but burned. The next home was built in its place and served until it crumbled from age. This one was built two years after the Colonels death. The brothers decided to build a vast farm so they put more that fifteen thousand acres into feed crops, and

orchards. There was seventy-five thousand acres in pasture, buffalo, stallions from Arabia, the largest herd of purebred Duroc-Jersey hogs in the country; thousands of cattle.

They started publishing their own newspaper. At a newspaper convention in St. Louis, Joe invited them to hold their next convention at the Millers Ranch.

One-hundred cowboys and indians put on a wild west show for the guests and the 101 wild west show was born. A special train of one-hundred and fifty freight cars carried the show who played Madison Square Garden, Convention Hall in Kansas City, the Jamestown Exposition in Virginia and the Chicago Coliseum. In 1908 and 1910 it toured Mexico and Canada. It performed for the Queen Mary, the Czarina of Russia, and the Queens of Spain, Greece and Rumania.

About that time England entered the first World War and the stock show as commanded by the British Army. About all the Millers saved was their most highly trained horses.

The brothers made their ranch the biggest producing farm in the coming years. Then in 1924 the National Editorial Association held their Convention at the "101" again and a new wild west show was born. This was the one I saw many performances at the home ranch. It toured the nation and Europe, during one engagement near London, 700,000 persons attended 33 performances.

From 1924 to 1926, movies like "On With the Show", "Trail Dust", "North of 36", and many more were made. In these years, Tom Mix, Buck Jones, Hoot Gibson and William Desmond became stars of the screen.

Just as the ranch reached its peak, Joe and George Miller died. The stock market crashed in 1929, then the Depression. Zack Miller began to sell out. From 1945 to 1949 he took the show on the road again. He died January 3, 1932 and the fabulous "101" Ranch came to an end, and the Millers and Bill Pickett, (the negro who invented bull-dogging) and many others were buried on a lonesome windy hill on the ranch.

Gone the three story "White House" (the ranch headquarters) whose doors swung open to guests from all over the world.

SHERIFF'S CORNER

The Kinney County Commissioners Court held it's regularly scheduled meeting for the month of November on Monday, November 9th with a large agenda of assorted county business including the canvassing of the votes of the November 3rd Special Election and the opening of the one and only bid we received for* the contract of the jail repairs.

The jail issue seems to be plagued with one problem after another and after all these months of sometimes bitter debate and finally having the issue settled by majority vote of the people of Kinney County (528 to 201) we now find more obstacles in our path.

As most of you recall, the jail bond election called for \$90,000.00 for repairs and renovations to the jail. The single bid received was in the amount of \$97,000.00. It now comes to light that legal fees for the preparation of the bonds will be approximately \$6,000.00 which is to be taken from the \$90,000.00 figure leaving a balance of \$84,000.00 for repairs to the jail. This leaves us some \$13,000.00 short of the bid figure. A phone call made to the bidding company by Commissioner, Pct. 4 Bill Bizzell explaining our problem led to the company reducing their bid to \$90,000 which still leaves us some \$6,000.00 short.

After much discussion and various suggestions made as to how to come up with the shortfall amount no solid decision was reached. Several options were discussed, including my suggestion that the amount needed be taken from prisoner care revenue as we are currently running far ahead of court estimates of income from this source. Some members of the court suggested that the standards of specifications be lowered and that we re-advertise for bids thus anticipating a lower figure for the jail repairs. I have no particular problem with this so long as jail safety and security is not compromised as this is and always will be my main concern. At any rate all members of Commissioners Court now appear to be solidly behind the efforts to bring the jail within safe and secure standards and I have every

confidence that the final decision they will make will be in the best interest of safety and security of the county jail and the citizens of Kinney County. My only regret is that the original bond figure was not set at \$100,000.00 as was suggested by the firm that will prepare the bonds. Had that been done we would not be mired down as we are now and the contract could have been let and work started. But hindsight is always 20/20 and I remain confident that the issue will soon be resolved to the satisfaction of everyone.

In the meantime we are still operating under special authority of the Texas Commission of Jail Standards and currently are at full capacity at the county jail with 26 federal prisoners and 4 county prisoners. The 26 federal prisoners are bringing in \$728.00 a day or \$21,840.00 a month. If we can maintain a high number of federal prisoners for the remainder of this fiscal year (as I anticipate we can) we will bring in close to \$200,000.00 in federal prisoner care fees. This revenue will go a long way in easing the financial problems now being experienced by Kinney County.

We handled several criminal cases over the past week ranging from juveniles involved in illegal possession and consumption of alcohol to a violator stopped for speeding and being charged with DWI, No Drivers License, and Unauthorized Use of a Motor Vehicle. Ironically we received notification from the county where the vehicle was stolen advising us that they were NOT going to prosecute the case. The suspect however is also wanted in Travis County for Violation of Probation-DWI and will be released to Travis County authorities after he has met his legal obligations to Kinney County.

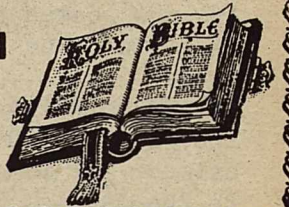

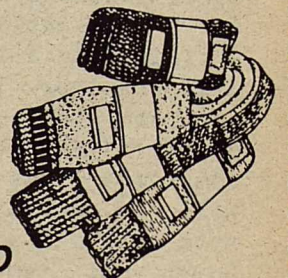

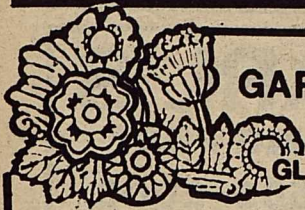

GARDENING TIPS

BY THE MORNING GLORY GARDEN CLUB DEL RIO, TEXAS

"Insect Problems"

While planning your garden, check for insects that will damage your flowers or vegetables. Aphids are red or green insects, usually wingless and small. They like to feast on new growth, and prefer cool weather, so spray with Malathion. The foliage will be curled, and the flowers will not be perfectly formed.

If you have Thrips, your flowers will be discolored with white spots, and sometimes the buds will not open. This insect is light brown, and moves very quickly, but hide within the petals, so examine backs of the petals. Spray from the time blossoms are in tight bud, through full bloom. Spray with Orthene. Another insect is the Red Spider, and is found on the under side of the plant leaf. You will see red specks, they spread very quickly and like very hot weather. Use a good spray of your choice.

If the plants leaves have a lot of holes, you have Japanese Beetles being fed, they also eat unopened flower buds. They are metallic brown with green heads, and they like roses. Grubs of this beetle feed on lawns, so check your entire garden for this insect. There are many more types of insects that harm your garden, so do check your plants, and spray.

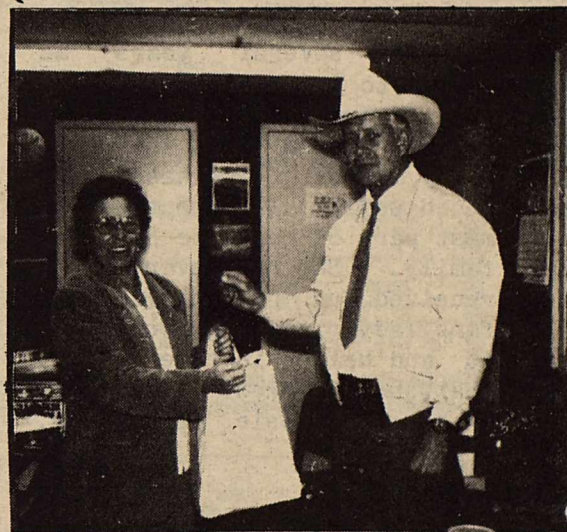

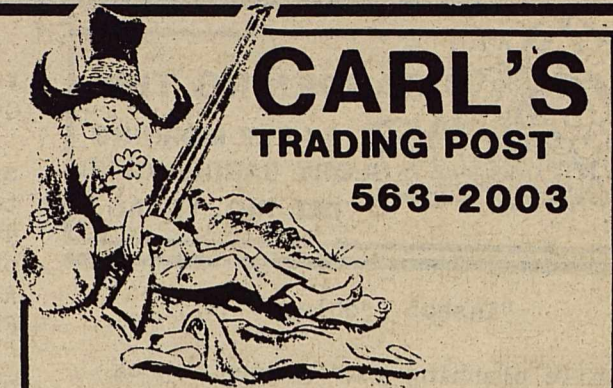


