KINNEY COUNTY LIVESTOCK SHOW & FAIR

With the Kinney County Livestock Show and Fair fast approaching, entries are being sought for the Project Show.

Everyone is eligible to enter the show. Age divisions are as follows:

5 & Under - Little Bits 6 & 7 - Pee Wee 8, 9, & 10 - Pre-Junior 11, 12, & 13 - Junior 14 thru 19 - Senior Adults

Exhibitors in the Youth Division (5 - 19) must be under the direct supervision of the vocational agricultural teacher, vocational home economics teacher, County Extension Agent, or a classroom teacher. The application form must be signed by the respective supervisor.

Entries in writing may be submitted to the supervisors as listed above or brought to the Civic Center on January 22 between the hours of 8:00 and 10:00 a.m.

Exhibitors are limited to one entry in each class. A limit of 4 entries per person is placed on those 13 years of age and younger. For seniors and adult exhibitors, there is a limit of 5 entries per person. Projects from the previous year will not be eligible as an entry of this year's show.

Youth exhibitors will receive either a blue, red, or white ribbon based on the opinion of the judges. Adult exhibitors will receive 1st, 2nd, or 3rd place ribbons in each class.

The show will be at the Kinney County Civic Center on January 22 and 23. Entries are due between 8:00 and 10:00 a.m. on Friday the 22 with the exception of Food entries which will be due Saturday, January 23 between 7:30 and 8:30. Judging will begin at 8:00 a.m. Saturday.

Exhibits will remain on display under the supervision on the 22 and 23. Exhibits must be removed from the building between the hours of 5:00 - 6:00 p.m. on the 23.





SHERIFF NORMAN H. HOOTEN

Norman H. Hooten, 46, current Sheriff, Tax Assessor/Collector of Kinney County has announced that he is a Democratic Candidate for re-election to that office subject to the Democratic Primary Election to be held on March 8, 1988.

Sheriff Hooten is a trained, experienced, professional law enforcement officer with 18 years experience as a peace officer in the state of Texas, the past 12 consecutive years as a peace officer in Kinney County. He has 1200 clock hours and 20 college hours training and education in the field of law enforcement and is permanently licensed as a peace officer by the Texas Commission on Law Enforcement Officer Standards and Education. He holds the Basic, Intermediate, Advanced, and Instructor's Certificates of Proficiency in law enforcement issued by that agency to peace officers in the state of Texas who have met the strict standards set by T.C.L.O.S.E. for education, training, and years of experience.

During his law enforcement career Sheriff Hooten has received several awards and citations for outstanding service to the people he serves. He was recognized for his work with young people when he received the Friend of 4-H Award in 1965 while a state game warden in Ozona, Texas. In 1981 he was selected and recognized as Kinney County Man of the Year for outstanding service to his community in the field of law enforcement. In 1982 he received a Mayor's Commendation and Outstanding Service Award from the City of Brackettville for his contributions to that community while he was Chief of Police.

Sheriff Hooten has been a voting member of the Board of Directors of the Middle Rio Grande Law Enforcement Academy located at Southwest Texas Junior College in Uvalde, Texas since 1980. The Board of Directors of the academy are responsible for monitoring and improving the quality of education and training received by area law enforcement officers attending the facility. Sheriff Hooten most recently served as Vice President of the Southwest Texas Law Enforcement Officers Association for the year 1987.

When asked about his platform for re-election as Sheriff of Kinney County, he replied, "Anyone who is a candidate for the office of sheriff should first seriously consider what he has to offer the people of his community, not what they have to offer him."

"I stand on my proven record of strong leadership, firm but fair law enforcement, and effective jail administration."



Crime reports associated with and directly connected to illegal aliens from Mexico and other countries south of the border continue to be a major problem plaguing south Texas counties, in particular those counties adjacent to Mexico along the Rio Grande. Kinney County is no exception.

Our record log of break-ins to hunting camps, ranch homes, and in some cases homes in Ft. Clark and Brackettville that are without question the work of illegal aliens continues to grow with each passing month. Two such break-ins occured this past week with no success on the part of local law enforcement officers in apprehending In one incident the culprits. burglar took only small change such as quarters, dines, etc.. It is believed that the intruder was in the house at the time of the arrival of the owner and was forced to flee before other items could be taken. In the other burglary the thief made forcible entry through a rear door of the headquarters after breaking out a window and reaching through to unlock the door. He then prowled throughout the two story dwelling going through drawers, closets, etc. The only items dwelling that could be positively listed as missing were various foodstuffs and two pillow cases, evidently used to carry the food in.


Each and every hunting season sparks a rash of reported breakins, not because they don't occur year around because they do, but because the hunters bring valuables and food to the camps and leave them unattended while they hunt. when they return to camp they find that it has been broken into and quite often valuable property in addition to food has been taken. In one incident this past hunting season, a \$5,000.00 rifle was taken from a jeep while the owner was drinking inside the camphouse coffee. The valuable rifle was later found approx. 1/2 mile from the camphouse along a brushy trail. Evidently an illegal alien passing through picked up the gun and carried it with him for aways then grew tired and discarded it.






Chief James Bigheart was an Osage full chief, and was probably the first to realize the value of grazing and fattening of cattle on the bluestem grass that grew on the prairie of Indian Territory in which he lived and became the wealthiest man on the Osage Reservation before the discovery of oil there.

In 1882 the government began rationing cattle to the Osage Tribe in payment for some of their ceded land in Kansas.

In lots of three to five the cattle were given to the heads of the Osage families. The cattle were driven up from Texas to Guthrie and Pawhieska. Some of the Osages were not interested in the cattle business so Chief Bigheart offered cash for the cattle some of his people didn't want.

The land on the reservations belonged to the whole tribe and any Osage could fence off what land he wanted to use. He built a log cabin two miles along Bird Creek and the present town of Barnsdall, Oklahoma. Bigheart was the first

name of this little town. I moved there with my family and was living there when the name was changed to the name of Barnsdall.

Many disagreements were present between the government and the tribe over cattle operations.

James Bigheart became principal chief of the tribe in 1875, appointed by the Pawhusk a Band held a Federal investigation of the Osage Rolls in 1896. Bigheart is credited with holding up passage of the Osage Allotment Act for ten years. Enrollment of that date was estimated \$25,000 to \$30,000 per member at that time, 926 full bloods were left.

"Pah Hue Skah" (White Hair) was supposed to have been named by one of the Chauteau Brothers who were traders. The first "Pah Hue Skah", who died in 1808 got his name "White Hair" during a battle with European soldiers. During the battle a boy raced in and wounded an English officer, who was wearing a white wig. When the officer fell, the young man took hold of the wig and drawing his knife was going to take his scalp. The officer jumped up and ran, leaving the Osage boy holding the white wig. He was so astonished he let the officer escape. But the wig was still a mystery to him. So he fastened it to his own hair and believed no harm could come to him in battle as long as he wore the wig. He was ever after known as "Pah Hue Skah" (White Hair). The second Pawhuska died in 1833 and the third came with his people to their lost reservation in Oklahoma Territory.

Barnsdall began as Bigheart named for Chief Bigheart. It was a government planned community, Chief Bigheart. At one o'clock in the morning on March 1, 1925, high-pressure stills at the Barnsdall Refinery exploded killing two and injuring several, and bounced several citizens out of bed, including me. My family lived about a mile away.

Besides being rich in oilproduction, Barnsdall oil well in the middle of main street made Robert Ripley's Column in the 1920's. It's depth is 1,771 feet.

Osage Chief James Bigheart is buried beside Bird Creek near Barnsdall.



SCHOOL BOARD MEETING

The Trustees of Brackett Independent School District met for their regular monthly meeting on Monday, January 11, 1988. Proposed cheerleader guidelines were discussed, modified, and approved. There will be a maximum of eight cheerleaders and no alternate or mascot. Cheerleader tryouts will be held with both impartial judges and the student body having an equal vote in the cheerleader selection. Head cheerleader will be selected by a vote of the cheerleaders. Camp for cheerleaders is recommended, but is no longer a requirement. The principal and cheerleader sponsor will be the final authority on uniforms and cheerleaders expenses. The Board expressed a desire to see costs held to a reasonable level.

In further action, the Board approved personnel position changes and pay scale adjustments recommended by the superintendent. They also approved using tax appraiser collector computer printouts for audit purposes and eliminating the hand ledger currently being kept.

The Board heard a report from Mr. Schermerhorn on the Exit Level TEAMS test given to eleventh graders in October. Results were not as good as last year. Student scores have improved, but increased state standards for mastery of the test have left 14 students who will have to take at least one of the portions (math or reading) again. All students who failed to meet state standards will be offered special remedial classes designed to eliminate their deficiences.

Superintendent Bob McCall submitted the 1986-87 Annual Performance Report to the Board. This report will be released to all local news agencies on February 1, 1988, and copies will be available at all campuses and the central office for interested parties to view. Individuals may purchase a copy for \$1.00 per page.

After emerging from executive session, the Board approved a three year contract for the superintendent. Mr. McCall had had a two year contract with the District.





SCHOOL BOARD CONSIDERS CHEERLEADER GUIDELINES

& SEEKS COMMUNITY COMMENTS

The Brackett Independent School District Board of Trustees considered committee recommendations on guidelines for junior and senior high cheerleaders Monday, December 14, 1987. A consensus of the committee was that interested community members be given an opportunity to provide input.

The goals of the committee were:

- 1. Provide some limits to the cost of being a cheerleader.
- 2. Provide a fair election process that considered both popularity and skill.
- 3. Establish a fixed member of cheerleaders that could be elected.

The purposed guidelines are reproduced below. Citizens may direct written comments and suggestions to the superintendent's attention. Oral presentations may also be made at the next Board Meeting on January 11, 1988 at 6:30 p.m. in the Board Room. Both adults and students are invited to offer comments for the Trustees consideration.

CHEERLEADER GUIDELINES

Cheerleader Qualifications

1. Must be a student in Brackett school the previous semester.

2. Must be eligible under UIL rules at the time of the cheerleader tryouts.

Cheerleader Selection

- 1. Cheerleader candidates will be selected by a combination of three impartial judges, and student vote, each making up 50% of the candidates overall score.
- 2. Cheerleaders will be required to do the following:
 - a. Cheer
 - B. Chant
 - c. Routine (dance)
- 3. Judges will vote on each performance awarding from 1 to 100 points. Total scores for each candidate will be added and divided by three. The total of all judges scores will be multiplied and factored by .5.
- 4. The student body will vote for a maximum of _____ cheerleaders. Student vote totals will be factored by .5.
- 5. The factored judges score and the factored students score will be added. The top ____ scores will be cheerleaders for the coming year.
- 6. The head cheerleader will be selected by popular vote among the cheerleaders.

Sponsor

- 1. The sponsor must be a full-time employee of the District, and will be selected by the principal.
- The sponsor is responsible for:
 a. Setting practice times,
 and supervising practices
 - b. Accompanying cheerleaders at all official school functions.

c. Coordinating with the principal concerning grades and conduct.

Conduct

Cheerleaders represent Brackett Independent School District. They are expected to conduct themselves in a way that brings honor to the school. Selection as a cheerleader is an honor. The privilege of representing the school can be removed either temporarily or permanently, at the discretion of the principal with consultation by the sponsor, for:

- 1. Failing to meet UIL qualifications
- 2. Being involved in an incident that would warrant his/her suspension from school
- 3. Conduct unbecoming a lady or gentleman
- 4. Excessive detention due to tardiness, misbehavior, etc.
- 5. Failure to participate in group activities
- 6. Being assigned to on campus suspension

Cheerleader Camp


Cheerleader Camp is recommended, but not required.

Cheerleader Expenses

Cheerleader expenses will be limited. The sponsor will be the final authority on cheerleader uniforms, shoes, etc., but will consult with the cheerleaders and the principal.

Cheerleaders are expected to raise money to cover expenses for crashers, paints, etc.

The Board expects to limit spending to \$200 per year per student/cheerleader for uniforms.







We presently have two illegal aliens from Mexico in jail on charges of burglary stemming from the break-ins of a ranch home and a hunting camp. I will not go into detail of the cases so as to prevent pre-judging their guilt or innocence, but they were arrested two days after a two day search in heavy brush north of the crime scenes after the report were received. Several items of stolen property taken from the house and the hunting camp were recovered at the time of their arrest.






"Nandina For The Garden"

Nandina is a common plant for any garden, but it adds color and colored berries, which the garden birds like. It also is one of the few plants that produces flowers and berries. The plant is sometimes called "Heavenly Bamboo", and comes from China. It sometimes grows to 10 feet in heighth, and it spreads by underground rhizomes to form large clumps. Each of clustered leaves holding many rich green berries in summer and turn red in the fall. The berries stay on all fall and winter, providing food for the birds.

It is many times used for foundation planting, and it also mixes well with other foliage plants. If the plants becomes leggy, just prune it and make other plants from the cuttings. Nandina grows best in moist fertile soil, but tolerates just about any well-drained location. Heat, drought, insects nor diseases bother the shrubs.




