

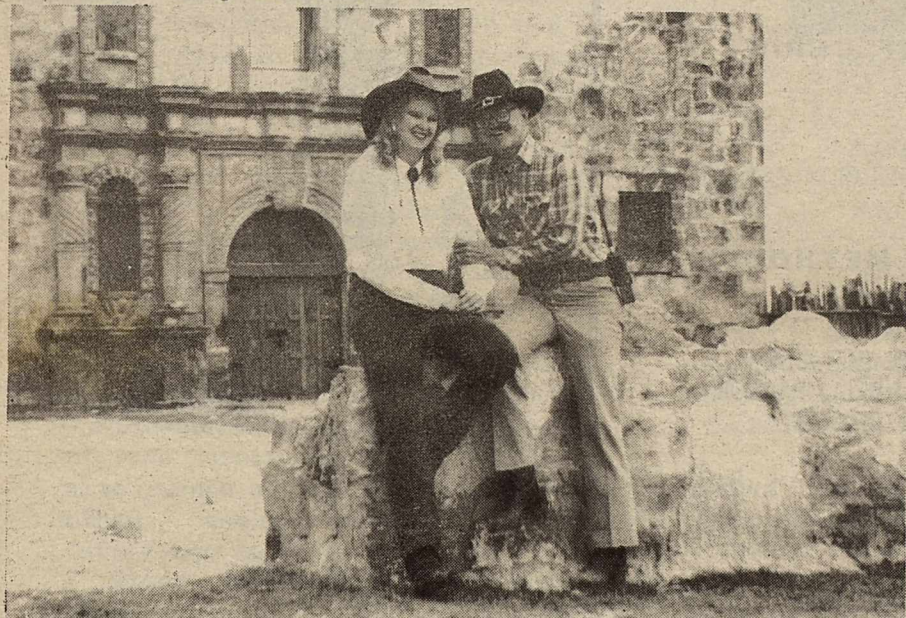

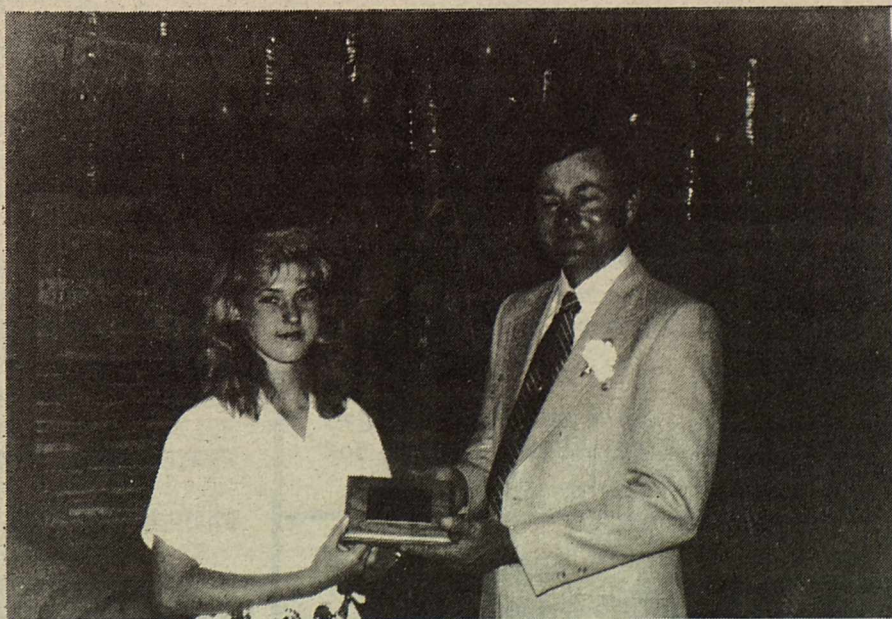

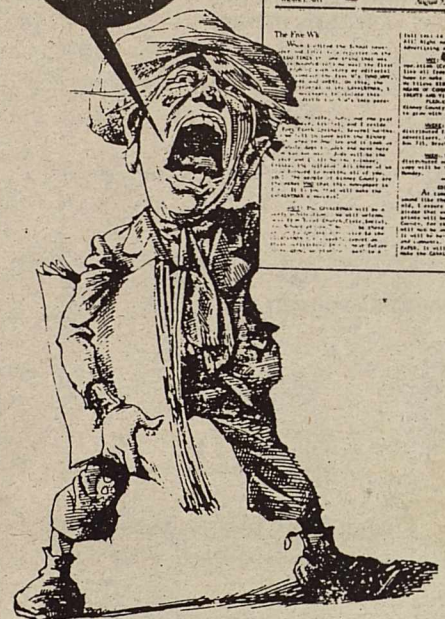

Madge K. Horn, 86 years old native of Del Rio, died Saturday morning at the Val Verde Memorial Hospital. Mrs. Horn was born in Del Rio, April 17, 1901. She was the daughter of Maggie Cochran Kirchgraber and Pete Kirchgraber. She grew up in Del Rio and graduated from Del Rio High School and attended the University of Texas. Since the death of her husband, Henry Horn, December 21, 1969, she operated her own ranch in Kinney County. Mrs. Horn was a world traveler she had visited many countries and went on tours frequently. Mrs. Horn was very involved in the community. She was a member of the Hospital Board of Governors, State chaplain of the Texas Federation of Garden Clubs, member of the Texas Sheep and Goat Raisers Association, member of the New Century Club, The Fine Arts Club, and the Del Rio Music Club. Mrs. Horn organized the Gardenia Junior Garden Club and was a member of the Morning Garden Club. She also wrote a Garden column every other week for the Kinney Cavalryman in Brackettville.

SCHOOL BOARD SETS WORKSHOP FOR BUDGET

The Brackett Independent School District School Trustees scheduled a Budget Workshop for May 2, 1988 at 6:30 p.m. in the Board Room. The workshop will allow the Board to review projected revenue for the 1988-89 school year, and to prioritize projects involving capital outlay expenditures.

Between 72% and 80% of the District's budget is dedicated to professional and non-professional salaries. The remaining 20% to 28% must be divided up among teaching supplies, utilities, maintenance, and extracurricular activities. The workshop will allow the Trustees the opportunity to plan for expenditures several years in advance.

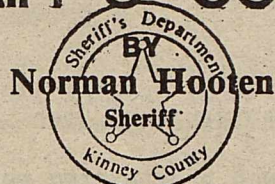

SHERIFF'S CORNER



In last week's column I reported on an aggravated robbery and auto theft that occurred on Easter Sunday at Fritter Park 6 miles east of Brackettville on Highway 90.

After we received the report of the crime an intensive search developed involving law enforcement officers and agencies throughout the state of Texas and eventually the southern United States. Our efforts paid off with the arrest of two suspects in Tennessee on Wednesday, April 6th and the arrest of the primary actor in the crimes near Big Springs, Texas on Saturday, April 9th.

As previously reported a 23 year old Laughlin AFB woman was approached by a man with a gun while she was in the restroom at the park. She was terrorized, her life threatened, and robbed of her money, credit cards and other personal property. The man took her car keys and fled the scene in her 1987 Jeep pickup. The victim stated that she believed the man had at least one accomplice in the criminal act because she heard a horn honk outside and the man left immediately telling her that if she came outside he would kill her.

We later determined that the man did indeed have not one, but two accomplices in another vehicle. The three were sighted and descriptions obtained after stopping at a store in Loma Alta north of Del Rio and again at a Gulf Station in Sonora. An all points bulletin for the three suspects and the two vehicles was first put out statewide and later nationwide. The primary actor was identified as William Bruce Chandler, 21, of South Carolina after an alert gas station attendant in Sonora demanded identification form the three for the use of a Gulf credit card (later determined to be stolen from the victim).

The other two suspects were not identified, though one did give a phony name. A good description of the three and the two vehicles was obtained which aided in our search for the three.

We received reports of sightings of the three suspects and the two vehicles from various locations North and West of Kinney County that ended with the last report prior to the arrests being from

Archer County in North Texas near Wichita Falls.

On Wednesday night, April 6, we received a call from the Winchester, Tennessee authorities advising us that the stolen vehicle had been recovered in that city, though the driver and female passenger had been released. We immediately requested that they be arrested and identified, which was done. We then issued warrants charging them with complicity in the April 3 aggravated robbery in Kinney County. They remain in jail in Winchester, Tennessee in lieu of bonds totaling \$100,000.00. If they waive extradition we will travel to Tennessee to take custody of them and transport them back to Kinney County to stand trial. Should they fight extradition it will be necessary to issue a Governor's warrant for the two and hope that the Governor of Tennessee will yield to our warrants. That process could take up to 30 days.

The intensive search for the primary action in the crime continued until late Saturday afternoon when we first received a report from DPS troopers that the suspects vehicle, a white GMC "Jimmy" had been located on a service road near IH 20, 11 miles west of Big Springs, Texas. About an hour later we were notified that the suspect had been arrested without incident approximately 4 miles east of where his vehicle had been found. He was armed at the time of his arrest with a .25 caliber automatic pistol and a "Butterfly" knife.

Chandler, the primary actor in the Kinney County crime, is wanted on two felony warrants issued in South Carolina. The warrants charge him with Burglary by forceable entry of a habitation in Sumpter County and Felony Forgery in Lake City, South Carolina. Texas Ranger John Allen of Del Rio and myself traveled to Big Springs Saturday night to take custody of Chandler and transport him back to Kinney County for trial. Ironically the cell door lock system at the Kinney County Jail had a complete failure so it was necessary to place Chandler in the Val Verde County Jail.

The cases against the three suspects will be presented to the

Grand Jury at its next session and hopefully they will be indicted and will eventually stand trial for their serious crime against the victim and society. The search and arrests of the three and the recovery of the stolen vehicle took less than a week and is a demonstration of the effectiveness of modern Law Enforcement technology and cooperation between Law Enforcement officers and agencies statewide and nationwide. We are very pleased with the quick results obtained in this case and are satisfied that justice will be served in the end.

An alert local DPS Trooper made a major drug bust after stopping a vehicle for a minor traffic violation on Wednesday, April 6. Trooper Buddy Burgess called for assistance from the U.S. Border Patrol in apprehending the 19 year old driver of the vehicle after he fled on foot into the brushy ranch country approximately 6 miles east of Brackettville. Trooper Burgess reported that after stopping the vehicle he smelled a strong odor of marijuana and after a search of the interior of the vehicle failed to turn up any of the illegal drug, he asked the driver to open the hood, at this time the driver fled on foot. Eighty-one (81) pounds of Marijuana was seized in two duffle bags from under the hood of the vehicle. Seems that the substance overheated from engine heat, thus the smell that caused the bust.

Another drug bust on Hwy. 90 came

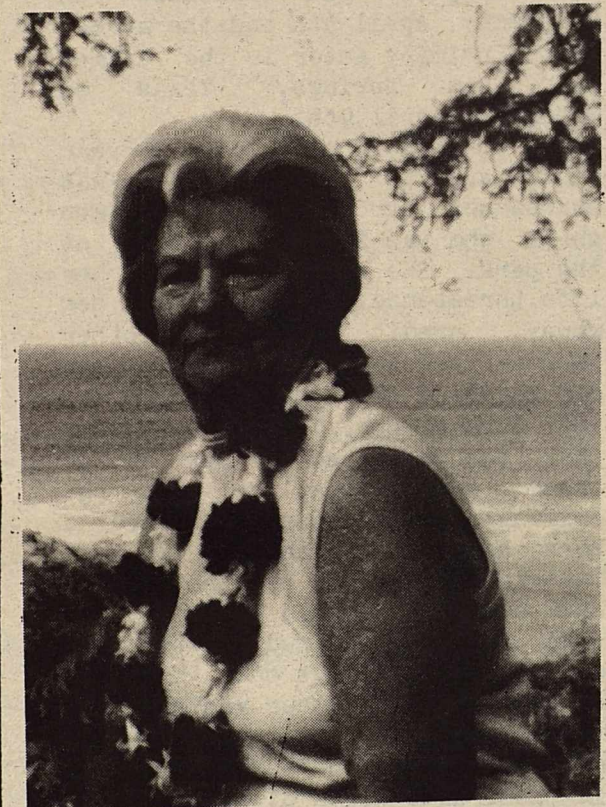

later the night of April 6th after a DPS Narcotics Task Force Agent arrested two San Antonio men for possession of Cocaine and Marijuana. The two were charged with Felony possession of a controlled substance for having in their possession 7.3 grams of Cocaine. The marijuana possession is a class B misdemeanor to be tried in county court because the amount was less than two (2) ounces. One of the suspects was released on bonds totaling \$11,500.00 on Friday, April 8. the other remains in jail at the time of this writing in lieu of the same amount of bond.

Forfeiture proceedings have been started on both vehicles used in the drug crimes. When the proceedings are complete the vehicles will be turned over to the Sheriff's Department to be used in undercover operations or sold with the proceeds from the sale going into a special Drug Enforcement Fund. The recent crack down on Drug Enforcement by the combined efforts of several Law Enforcement Agencies is causing drug smugglers and dealers to squirm and wiggle like a worm on a hot plate. Does my heart good to see the look in their eyes when they are arrested, their expensive drugs and vehicles confiscated and stiff bonds set. The only way to really hurt drug dealers and smugglers is through their pocketbook, after all that's the main reason they are in the business, money. Now if we could only get the courts to set stiff jail terms on convicted dealers, users, and smugglers we might start making headway in our fight against drugs. Slaps on the wrist by small fines and probation is no deterrent to drug trafficking!

**Beat the Heat With
Homemade Ice Cream**

It's difficult to think of a fun-filled summer day that isn't capped off with a bowl of fresh homemade ice cream. It's as American as apple pie and baseball.

Although the results will vary depending on the type of ice cream freezer used and ingredients in the recipe, there are a few basic points to keep in mind while creating a treat that will put a smile on every face.

- Cool the ice cream mixture before churning.
- It is okay to prepare an ice cream mixture for churning a day or two ahead of time—but wait to add fruit until ready to freeze.
- Ice cream expands during freezing—fill freezer only 2/3 full to prevent spillover.

The texture of the ice cream is determined by the temperature of the salted ice used to freeze the mixture.

- Ice Cream Too Soft? Add a little more rock salt to the crushed ice in the freezer.
- Ice Cream Too Hard? Too much rock salt was added. Be sure and measure for best results (about 20 pounds of ice to 3 or 4 cups of rock salt is best for a 1-gallon freezer).
- Homemade ice cream will keep 1 to 2 months in the freezer.
- Don't refreeze partially thawed ice cream. A coarse, icy texture will be the result.

- If the ice cream is stored in the freezer, allow about 10 minutes for softening before serving.

- Store the ice cream in plastic containers—not the freezing canister.

For an easy, delicious accompaniment to cool homemade ice cream, try Easy Pound Cake. The use of a pound cake mix is a convenience bonus, but sour cream adds that richness that seems to say you spent hours in the kitchen.

Easy Pound Cake

2 eggs
1 cup (8 ounces) dairy sour cream
1/4 cup milk
2 packages (8 1/2 ounces each) Martha White Pound Cake Mix
Preheat oven to 325 °F. Grease a 9x5x3-inch loaf pan. In medium bowl combine eggs, sour cream and milk. Add cake mix. Beat two minutes on low speed until blended, scraping bowl constantly. Beat additional 2 minutes on medium speed. Pour into prepared pan. Bake 1 hour 20 minutes or until toothpick inserted in center comes out clean. Cool in pan 10 minutes; turn out onto wire rack and cool completely.

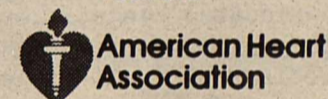

TRAIL**

In old Ft. Union in New Mexico, only scouting, patrols, and campaigns were the only thing to break the boredom.

Any of the old frontier forts in the old West was the same. Life was hard but the hardships became part of the memories of old friends and old times.

Probably the private soldier had the hardest life. Many were immigrants, mostly German and Irish, only recently off the boat, some were the dregs of eastern society, some were fleeing from Justice, some from failure and some were soldiers of fortune who liked adventure.

For the most part the duties of the day seemed unheroic. The men drilled, took care of their mounts, practiced target firing, cared for their weapons and a variety of other duties.

From reveille to taps the men were regulated under the officers orders.

The troops were fed beef, bacon, salt pork, beans, hardtack, desiccated vegetables and coffee. They were clothed in rough heavy woollens in all seasons. Their barracks had grass filled mattresses, springless wooden bunks and blankets. When a new officer reported for duty he had a choice of all quarters of the officers his junior in rank.

Las Vegas was 26 miles from Ft. Union, Santa Fe was almost one hundred, so the soldiers had to entertain themselves, which they did, drinking and gambling were the favorite pastime for the enlisted man. Also popular was hunting and fishing. Officers spent much time at these sports too. Reading was another pastime, the post library had books. Newspapers were usually a month old, and were passed around until almost worn out.

Formal dinners were planned, amateur theatricals, and weddings were gala affairs. The women organized social events at the drop of a hat.

Desperately and continuously the army people fought to overcome the tedium of garrison life, but never entirely succeeded. For forty years from 1851 to 1891 Fort Union played a key role in shaping the southwest.

On the 4th of July, 1879, the first locomotive of the Atchison,

Topeka, and Santa Fe steamed into Watrous, New Mexico, a community close to Fort Union. The railroad ended an era and opened another, but for Fort Union the handwriting was on the wall, the Indians had been put down, the Santa Fe trail had been replaced by the rails and Fort Union had outlived its usefulness.

In 1890 the War Department decided to abandon all the old frontier posts that no longer was useful, including Ft. Union. So on the 21st of February, 1891, the troopers marched to Watrous and boarded the train. The soldiers began their trip, singing "There's a Land that is Fairer than This."

At the present time, parts of the arsenal, the quartermaster depot, and many ruins can still be seen. The ruins of the old Star Fort can still be seen. Extensive evidences of the the old Santa Fe trail are still plain. There is a visitors center that furnishes much information.

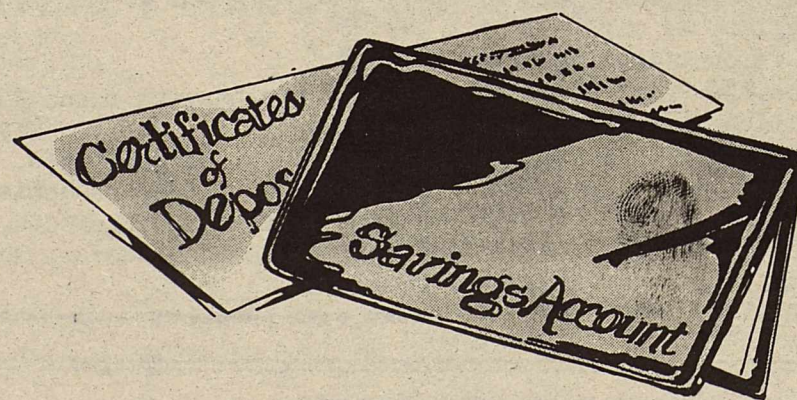

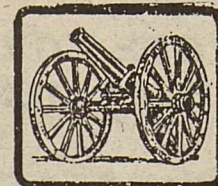

They are "Near Dark" and "Three O'Clock High".

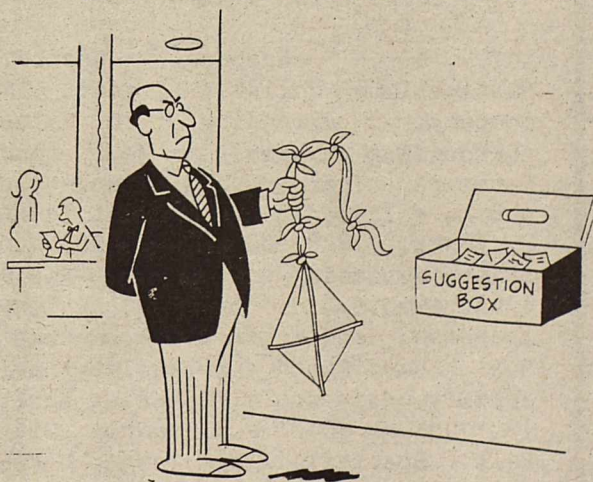

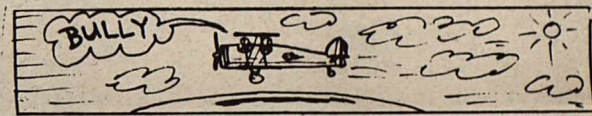
