"GLORY ROAD"

"Something old - something new" describes the 1988 version of the live stage production "The Glory Road", recounting the romance and history of Brackettville's 136-year old Fort Clark frontier cavalry post, with performances scheduled for June 24th, 25th, and July 1st, at 8:30 p.m. in the outdoor setting of the Old Quarry Amphitheatre.

Returning to recreate their memorable roles of the last "Glory Road" presentations in 1986, will be veterans Jody Haynes as Lieutenant (through Colonel) Tim Riley, Harold Floyd as Oscar Brackett, Father David Zumaya as the Comanche Indian Chief, Ray Kurtz as General Philip Sheridan, and Warren Outlaw as the colorful General George S. Patton. Many other cast members return in old and new roles of Kermit Hunter's script, with a number of newcomers making their stage "debut" in this year's edition.

Former Miss Kinney County, Kitten Daly, becomes the female romantic lead Oralee Brackett, and Pastor Preston Taylor lends a clerical authenticity to the role of the frontier parson! All the members of the large "Glory Road" cast are drawn from the local Brackettville-Fort Clark community, representing a link of continuity in the area's dramatic and entertaining story going back to the origins of 1852 around Las Moras Spring.

The exciting tale of the historic Fort will come alive in dialogue, music and dancing, costumes and special effects, under the direction of Fred Brockwell of the Del Rio Upstagers, assisted by Betty Inman.

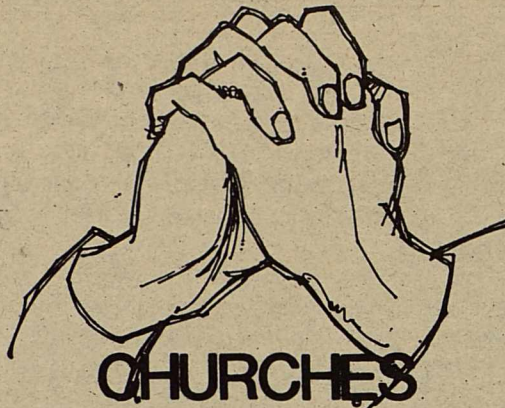

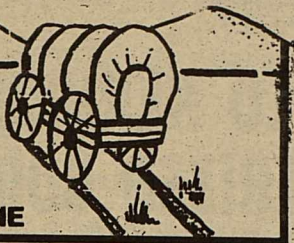

TRACKS ALONG THE TRAIL BY DORTHY PAYNE



During the early 1700's cannon were used to protect the army and for the advance of the troops. Later artillery became more important in battle.

The English scientist, Benjamin Roberts, and one result of his research was the introduction in 1779 of cannonades which were short, light pieces so useful on a ship's gun deck. Cannonades usually ranged in caliber from 6 to 60 pounders.

In North America cannon were generally too cumbersome for Indian fighting. Over the vast distances of early America transport of heavy guns had to be by water. Without ships guns were walled in by the heavy forests.

The United States adopted the Gribeauval system of artillery in 1809. Early in the century cast iron replaced bronze as a gun metal caused by the growing iron industry in the United States. But in 1836 bronze was re-adopted in this country for mobile cannon.

In the war of 1812 the United States did most of its fighting with iron 6-pounders. Fort McHenry has a few pieces of this period.

In the Mexican War the artillery carried 6 and 12-pounder guns, the 12 pound mountain howitzer, a 12-pounder field howitzer, 24 and 32-pounder howitzer and 8 and 10 inch mortars. There were 16 types of siege guns.

In 1857 the United States adopted the 12-pounder Napoleon gun howitzer which remained standard in the army until the 1880's.

Rifling of cannon was begun in the United States and a few rifled pieces were made by the South Boston Iron Foundry and also by the West Point Foundry at Cold Spring, N.Y. At the outbreak of the Civil War in 1861, the Federal Artillery was equipped with 300 wrought iron 3 inch guns. This 12-pounder was made by wrapping sheets of boiler iron around a mandrel. This cylinder was then cooled, bared, turned and rifled. It was in use until about 1900.

In this period Robert P. Parrott made guns that are still seen in our parks today.

The Rodman smoothbore, founded in 8, 10, 15 and 20 inch calibers was the best cast iron gun of its time. The 20 inch gun produced in 1864, fired a 1,080 pound shot. The 15 incher remained in service for the remainder of the century and can still be seen at Fort McHenry or on the ramparts of Fort Jefferson in the dry Tortugas Islands. In later years some of the Rodman 10 inchers were converted into 8 inch rifles by enlarging the bore and inserting a grooved steel tube.

After the Civil War a new era began. In spite of the new infantry weapons, artillery became so deadly that its fire caused over 75 percent of the battlefield casualties in World War I.

During the early 1800's the United States began work on a modern seacoast armament, which helped the war with Spain to a quick close. Some of these pieces were used in the Phillipines. These guns were finally pushed out of the picture by new steel guns.

The Japanese used the French system of indirect laying (aiming at a target not visible to the gunner). Meanwhile the French 75 mm gun of 1897, firing 6,000 yards made all other field artillery obsolete. In other words, artillery had become modern. The next changes would be along the lines of motor transportation, signal communications, chemical warfare, tanks, aviation and mass production.

Summer Camps Must Meet State Standards



Many youngsters will be away from home for the first time this summer at camp, and the Texas Department of Health (TDH) is helping to ensure that the experience is a safe and healthy one. TDH will regulate more than 500 summer camps this season through its licensing and inspection program. Each camp can be compared to a little city, which must meet all the sanitation and safety needs of the campers.

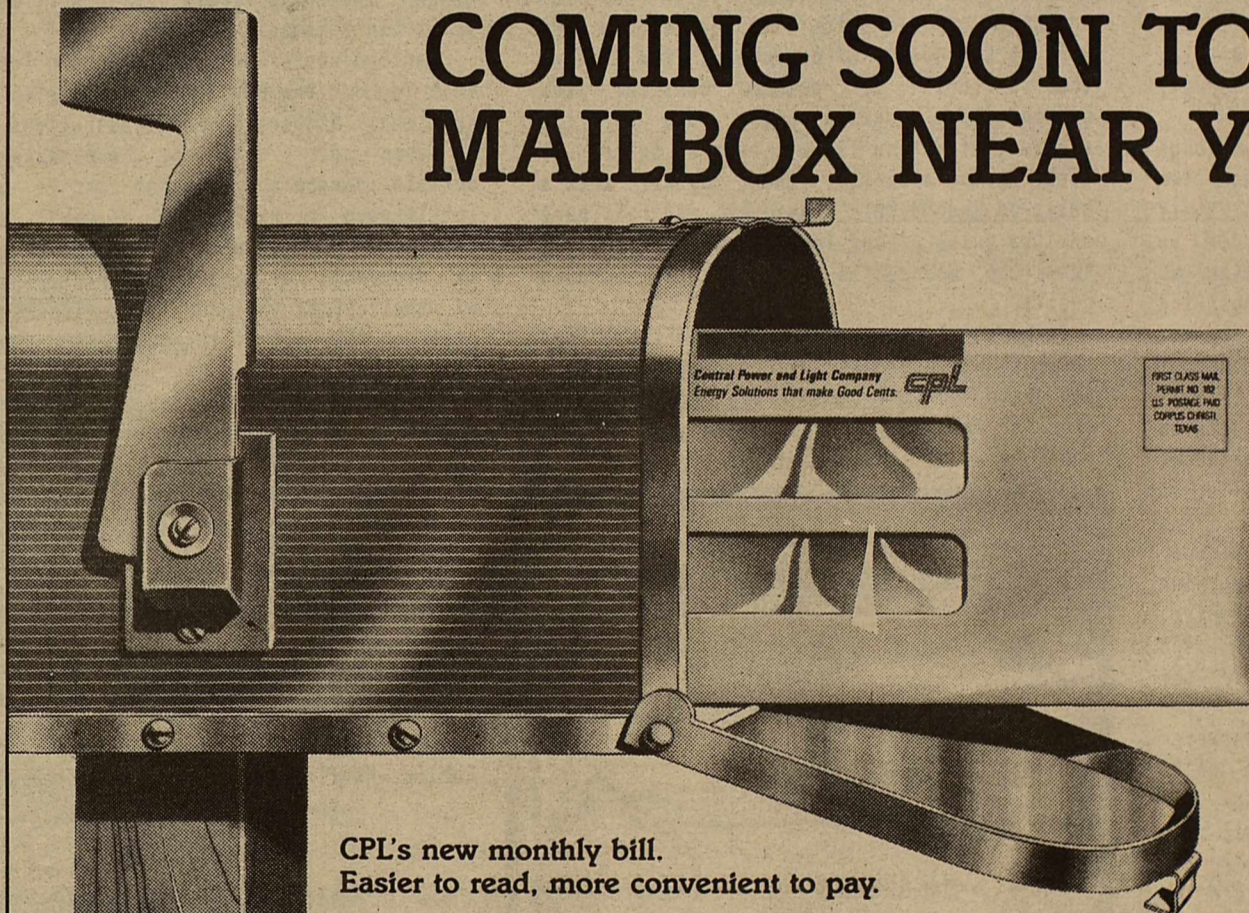
As might be expected, TDH inspectors will check for safe drinking water supplies, adequate garbage and sewage disposal facilities, and sanitary food service operations. But the inspectors also ensure that the camps meet the specific standards of the Texas Youth Camp Safety Health Act regarding qualified counselors and adequate medical care.

The Act specifies that camp activities such as swimming, archery, horseback riding, and riflery must be conducted by experienced counselors whose qualifications are on record at the camp. There must be at least one adult supervisor for every 10 children in the camp. Also each camp must have an infirmary or first-aid facility to handle health and emergency cases.

The infirmary must keep a health record on every child, and a physician must be on call at all times. Any serious accident, illness, or death must be reported to the TDH Youth Camp Program within 10 days. Food- or water-borne diseases, such as dysentery, salmonellosis, shigellosis, or infectious hepatitis, must be reported immediately.

"The Texas youth camp regulations came about mainly because of national publicity given to accidents and deaths at camps in other areas of the nation," said Travis Mansell, a chief sanitarian with the camp inspection program.

Arrangements are now being made to transport two convicted drug dealers we have in custody at the county jail to the Texas Department of Corrections (TDC) in Huntsville. Javier Ruiz Garcia, 19, of Del Rio, Texas received a 5 year sentence and a \$500.00 fine for his recent conviction on Aggravated Possession of marijuana. Garcia was caught in Kinney County transporting 81 pounds of marijuana by a DPS Trooper after what started out as a routine traffic stop led to Garcia fleeing on foot from his vehicle and later being captured by Border Patrol Agents assisting in the chase.

Josue Jimenez Salazar, a 30 year old resident alien from Mexico, received a 3 year sentence to TDC upon his conviction of a 2nd degree felony charge of possession of marijuana. Salazar was apprehended by U.S. Border Patrol Agents at a checkpoint with over 100 pounds of marijuana. His aggravated possession charge (a 1st degree felony) was reduced to a 2nd degree felony via a plea bargain agreement between he, his attorney, and the District Attorney's office.

At the present time we are going through the legal process of confiscating the vehicles used by the two men in their separate cases. This process should be completed soon. As of this writing no decision has been made as to the disposition of the two vehicles. State law mandates that vehicles confiscated by a law enforcement agency in a drug case can either be utilized by that agency or sold at public auction with the proceeds to be used for drug enforcement by the agency involved and for no other reason.

The investigation into the alleged kidnapping and robbery of a 50 year old, San Antonio based IRS Agent is continuing. Treasury Agents and the F.B.I. are now the primary investigators with our part in the investigation being completed. At the time of this writing there are several unanswered questions involved and there are no solid leads in the case and no known suspects.

Our legal system of justice with all its faults is still the best and most fair and impartial in the world. Over the years we

have developed counter checks and balances to guarantee a fair trial for those accused and charged with crimes, sometimes almost to the point of over protection. But those accused and charged with crimes in our country are still considered innocent until proven guilty.

You ever notice how that right seems to disappear in our daily lives? Sometimes seems like the reverse is true. Rumor mongers can start a false, vicious rumor about someone and before you know it the victim of that rumor or rumors is tried, convicted, and condemned by the spread of gossip by eager rumor mongers. Naturally, the story grows with each telling until before you know it there are even eyewitness accounts from people who actually only heard from someone else what that person heard from someone else and so on. Personal lives and careers have sometimes been damaged and even wrecked by vicious, false, and unproveable rumors spread about by rumor mongers who would scream the loudest about fair play and being innocent until proven guilty if they were the victims of the same treatment.

Rumor mongers use that age old tactic of "Say, have you heard?" and, regrettably most of us are guilty to some extent of the weakness of listening with open mouths and ears to the gossip of our peers, the juicier the better. We seldom consider the heartbreaking damage being done to the victims of these vicious rumors unless we also become a victim, then, by all that's holy, we demand fair treatment and fall back on the rules of our legal system dictating that the accused is innocent until proven guilty.

I guess I have been a peace officer and criminal investigator for so many years now and have so many times received different stories from different eyewitnesses to the same incident that I basically pay little

attention to rumors and have come to strongly believe in that old saying "Don't believe anything you hear and only half of what you see."

It's more than a little sad how we fail to freely give to our fellow man what we so vigorously demand for ourselves - fair play and judgements based on fact instead of whispered fiction and coffee shop character assassination. The victims of rumor mongers have no defense against their attackers. They are basically at the mercy of their peers. Those who want to believe a rumor will, regardless of the foundation of that rumor, and will most likely pass the rumor on to others after adding a little of their own "personal knowledge" to the story. Those with fair minds and clear eyes will most likely listen politely and then dismiss the topic from their minds or discount the story unless based on known, documented facts.

Each of us should stop and think before we put our mouths in gear. Do we really know what we're talking about? Is what we are hearing and then passing on to others as fact really based on known, documented facts and eyewitness reports, or are we falling into the trap of a bitter, frustrated rumor monger who doesn't care who is hurt as long as it isn't himself.

Election years and political campaigns seem to bring out the worst in some people. They vent their bitterness and frustrations caused by some prior defeat or the dislike of a certain person and lash out like a blinded rattlesnake at the victim of their vicious gossip. Sometimes this is done in an attempt to discredit an opposing candidate because of the lack of valid qualifications on their part or the part of the candidate they are supporting.

We should all use extreme caution in the spreading of what we hear from someone else based on what they "heard" from someone else. Who knows, you might be the next victim of a false, unfounded rumor. THINK ABOUT IT!

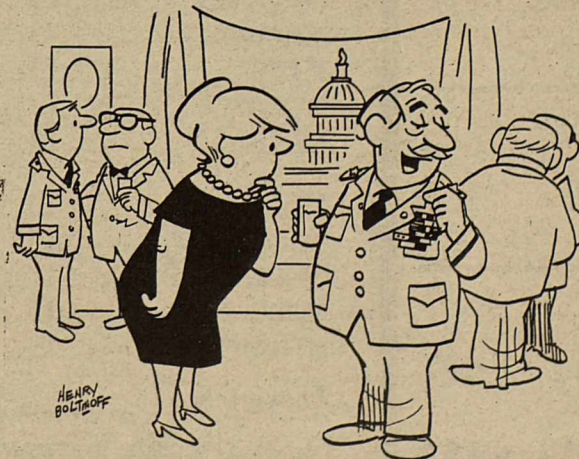

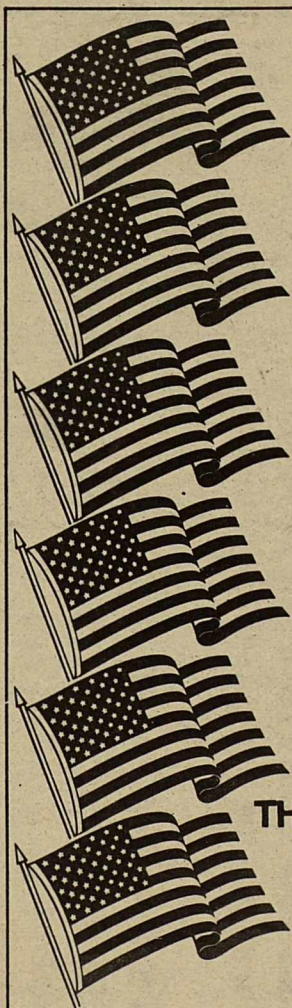

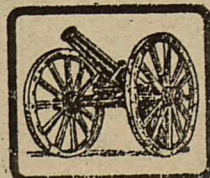
