Many people exercise by jogging a few miles every day, but how many people know someone that runs 11,000 miles in one year?

Sarah Fulcher, who visited Brackettville and Fort Clark briefly last Wednesday, is nearing the end of her 11,000 mile trek. Sarah began her run on July 21, 1987 at Laguna Hills, California and will end at the same place on approximately August 7, 1988.

Sarah's project "Run Around America" is being held to raise money for the United States Fitness Academy whose chairman and CEO is George Allen, a former NFL coach. The purpose of the run is, according to Sarah, to "raise awareness and encourage participation in physical fitness and to generate funds for the Academy."

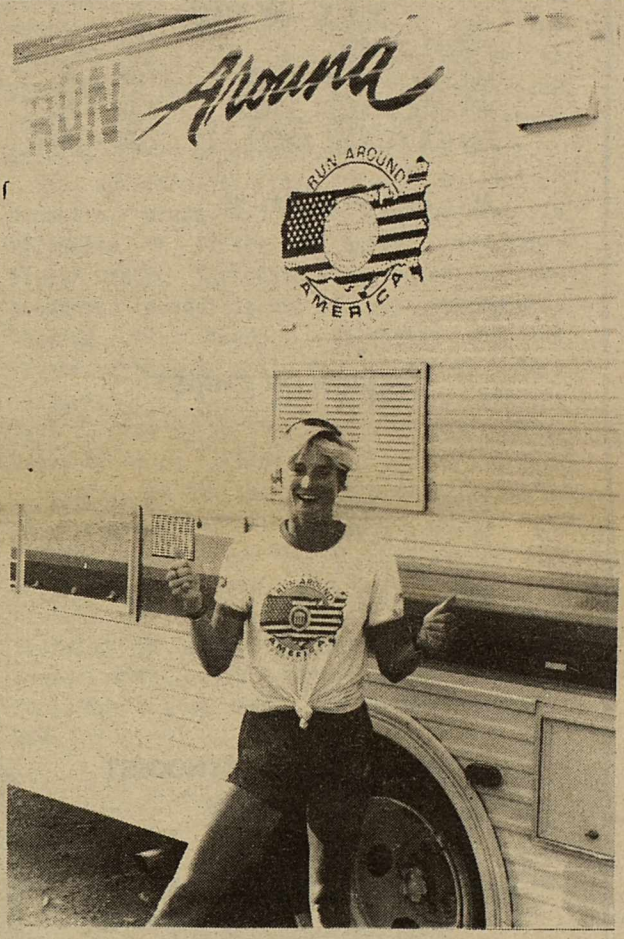
In addition to her endeavor to circle America, Sarah ran across Australia in 96 days for a total of 2,727 miles to raise money for world hunger. Tentative plans are now being made for a run in Africa next year.

Sarah has been recognized by several mayors of the cities she has crossed. She was a guest of Sea World in San Antonio and introduced at the Water Ski Show. Fort Clark also showed hospitality toward her as she was a guest for the night while passing through town.

Nearing the end of her run, Sarah is increasing her mileage per day from 30 to 37. Because of the heat, she plans on beginning early in the morning and is looking forward to the time change in New Mexico.

SWTJC RECEIVES GIFT

Southwest Texas Junior College was named the major beneficiary of the will of Mrs. Hope Victor Witt of Montell, Texas. Mrs. Witt's will was entered into probate Monday, June 6 before Uvalde County Judge William R. Mitchell.

Under the terms of Mrs. Witt's will, the college will receive all the estate which remains after specific bequests are made to several individuals named in the will. The estate residue includes an undetermined amount of cash, personal property, and real property consisting of a 2,500 acre ranch located in Uvalde County near Montell. First State Bank of Uvalde was named as executors of the estate. The will directs that the assets of the estate be liquidated and the proceeds used at the discretion of the College Board of Trustees to construct permanent improvements at the college in memory of Mrs. Witt, her husband, the late Thomas Lee Witt and her son, the late Thomas Lee Witt, Jr.

Southwest Texas Junior College President, Dr. Jimmy Goodson, stated "We are very appreciative of Mrs. Witt's generous bequest to the college. It comes at a very significant time since we are just beginning to develop a new master plan for the college which will in all probability identify some facility needs that must be met in order for the college to continue its progress. Mrs. Will's bequest will help to meet those needs."

"In making this bequest", Goodson said, "Mrs. Witt joins with other generous benefactors of Southwest Texas Junior College, former Vice President John N. Garner, Mr. and Mrs. Joe Richarz, Mrs. Anna Baker, Mr. Will C. Miller and others who have made it possible for the college to grow and prosper as it has without placing a heavy tax burden on the citizens' of the college district. Mrs. Witt's bequest to the college is very much a gift to all the people of the Southwest Texas."

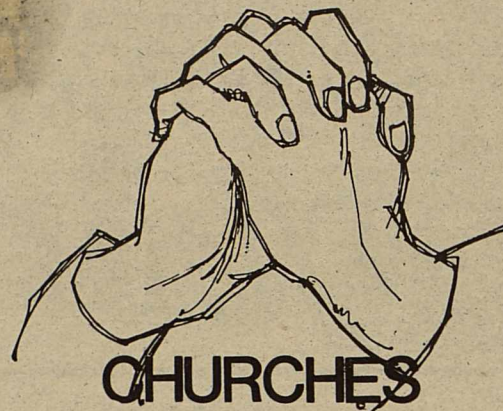

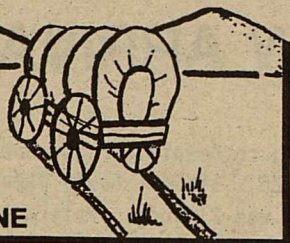

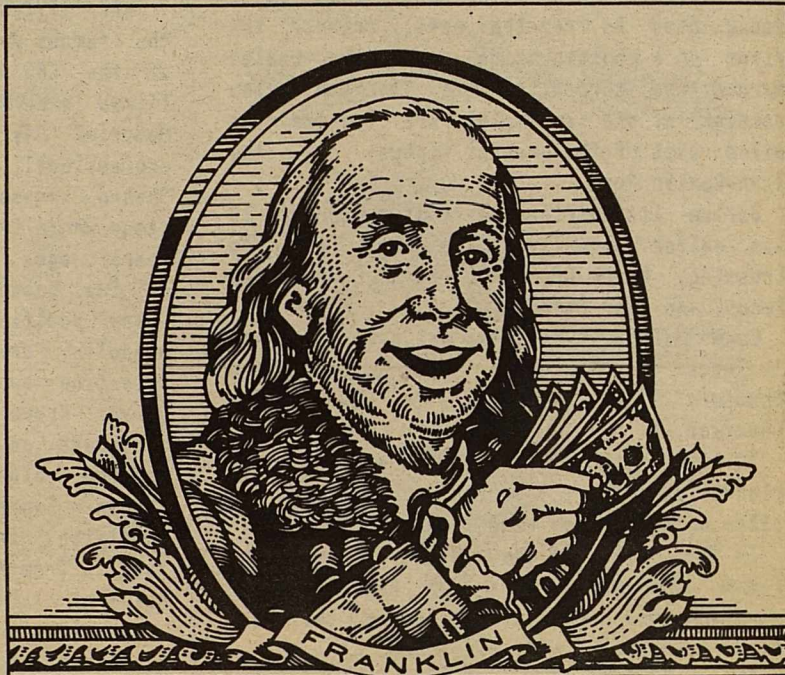

ORDINANCE #207

ORDINANCE NO. 252

AN ORDINANCE ESTABLISHING AMOUNT AND POSTING OF REWARD OFFERED BY THE CITY OF BRACKETTVILLE FOR THE CRIME OF ARSON

BE IT ORDAINED by the City Council of the City of Brackettville

WHEREAS the City of Brackettville has made certain public improvements with the view of reducing the hazards of fire and of effecting more favorable rates of insurance; and

WHEREAS it is believed that improvement in existing conditions may be had by compliance with certain regulations of the State Board of Insurance Commission, one of which is that of the posting of a reward for the crime of arson;

THEREFORE be it on this day that the City of Brackettville does post and offer a reward in the minimum amount of \$250.00 for the arrest and conviction of any person or persons found guilty of ARSON, within the incorporated limits of said city.

WHEREAS it is deemed advisable and advantageous to the City that this Ordinance be effective immediatly and that the rules requiring the reading of ordinances on three separate dates is hereby suspended and that this ORDINANCE is placed upon its first reading and final passage and shall be in full force and effective after its passage and approval and publication as provided by law.

This Ordinance supercedes and replaces any and all previous ordinances pertaining to arson, arson reward and posting of such.

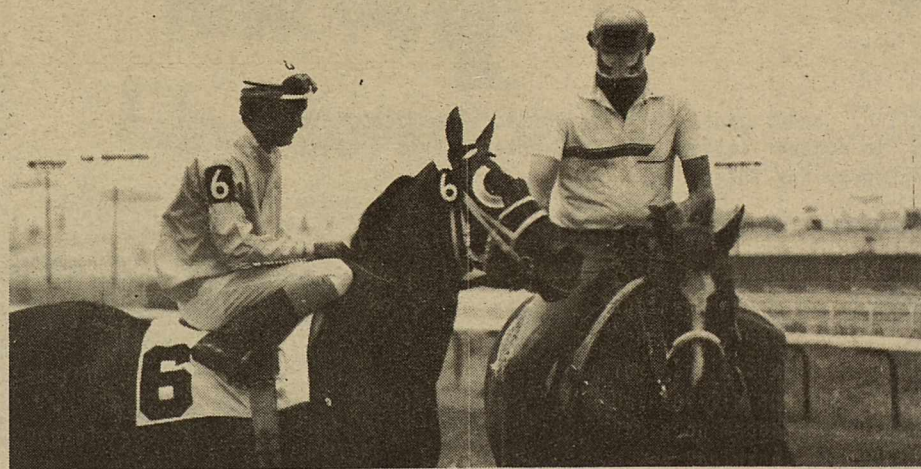

PAVING THE WAY FOR THE "GLORY ROAD"

Popcorn, programs, props and pianos! -- Pre-production preparation proceeds at an accelerating pace for the 1988 version of the colorful Fort Clark/Brackettville live stage play, "The Glory Road", with performances set for June 24th, 25th, and July 1st at 8:30 p.m. in the Old Quarry Amphitheater on the historic former military post.

"There's more going on 'behind-the-scenes' right now, than our audiences may ever realize," said Assistant Director Betty Inman, an officer of the Old Quarry Society for the Performing Arts which is producing "The Glory Road" presentations. Nearly three full months have been spent in detailed advance work preparing for this year's three evening performances which are anticipated to be viewed by a total of 2,000 persons.

A new feature for "Glory Road '88" will be the use of sensitive and highly-directional remote microphones, aimed from off-stage, which will pick up and amplify every sound on-stage so that the audiences may hear clearly all the lines of the cast of characters' dialogue.

In addition to nightly 2-hour rehearsals under Director Fred Brockwell's supervision, the nearly 100 members of the versatile "Glory Road" cast and crew also perform the necessary "roadwork" required for the successful staging of this major local production effort. Their other involvements include: advance ticket sales, stage set design and construction, costume sewing and alteration, program advertising development, concession refreshment logistics, technical work with sound and lighting systems, media coordination and public information efforts.

First presented in the summer of 1986, "The Glory Road" production originally planned for 1987 had to be cancelled due to flooding damage in the outdoor amphitheater. After necessary facility refurbishment, minor script revisions, and the securing of new equipment, the Old Quarry Society developed

the plans for this year's revised and enhanced production.

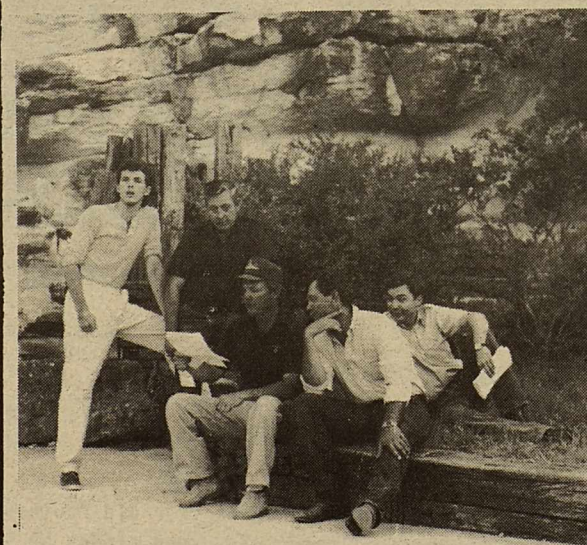

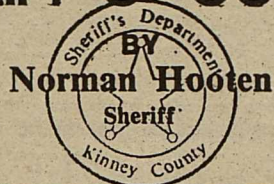

SHERIFF'S CORNER



We were kept busy this past week investigating several minor crime reports and one Burglary of a Building. We also "busted" another minor in Possession of Alcohol case.

The minors apprehended in this case were all from Del Rio and were arrested after a tip was received from a concerned Ft. Clark security guard. The minors were transported to the Sheriff's Office and their parents were contacted individually to come get them. Judging from the reactions of the parents involved, I bet it was a long trip home for the minors. This latest "bust" brings the total number of alcohol related "busts" of minors in possession of alcohol to six (6) in the past three months. In all cases the minors' parents have been contacted and the alcohol confiscated. Thus far, we have apprehended no "repeat offenders". The minors are either not getting involved in subsequent offenses or have taken extra precautions to prevent arrest.

A Brackettville woman reported the suspected theft of her purse and all contents, including \$300.00 cash late last week and during the course of the investigation of the suspected offense the purse was found. It had been misplaced.

Our investigation is continuing into a case of Criminal Mischief and Criminal Trespass reported by a local rancher last Friday, June 10th. Seems that during the absence of the rancher several young people took advantage of the remote location and their knowledge of the ranch and had a party that got out of hand. Some minor damage was done and a lock broken off a room containing a telephone, and some unauthorized long distance phone calls were made. Two male suspects have been contacted and arrangements are being made between them and the owners of the ranch for payment of damages and phone calls. The owners of the ranch have declined prosecution as long as all damages are paid by the suspects.

The Burglary of a Building under investigation occurred at the old rock quarry on Ft. Clark. Burglars entered the concession stand there and took a popcorn machine recently purchased by the Old Rock Quarry Society for the Performing Arts at a cost of over \$400.00. The concession stand has been damaged by vandals on at least one occasion prior to the burglary. The investigation into the crime continues at the time of this writing.

Chief Deputy David Luna was on routine patrol south of Brackettville one night last week when he saw a bolt of lightning strike the ground and start a fire. A sudden downpour from a thunderstorm put out the fire before firefighters could get to the scene. Mother Nature has her ways I guess.

We have two Jailer/Dispatchers attending a Basic Jail Operations Certification Course this week at the Middle Rio Grande Law Enforcement Academy in Uvalde. Vic Bonner and Monica Yoho will complete the mandatory 40 hour course of instruction on Friday, June 17th. Their completion of the course which is required by state law through the Texas Commission on Law Enforcement Officer Standards & Education will complete the basic training of all jailers at the county jail.

We also will have another jail employee who will receive 8 hours training next week in procedures and operations of the new TLETS II teletype system being put into operation by the Texas Department of Public Safety. This new system of communications and TCIC/NCIC inquiries will greatly enhance law enforcement operations statewide. It requires a totally new set of related equipment, thus re-training of operators. Matt Sandoval, Records Officer & Jailer/Dispatcher at the county jail, will train our other Jailer/Dispatchers in the use of the new equipment that will be installed at the county jail sometime later this month.

In order to maintain the quality of professional service and protection that the people of Kinney County deserve and should expect from their sheriff's department, we must constantly update our operational procedures with professional training and education for our personnel in order to take advantage of technical advances in all phases of law enforcement.

STATEMENT OF INTENT TO CHANGE RATES.

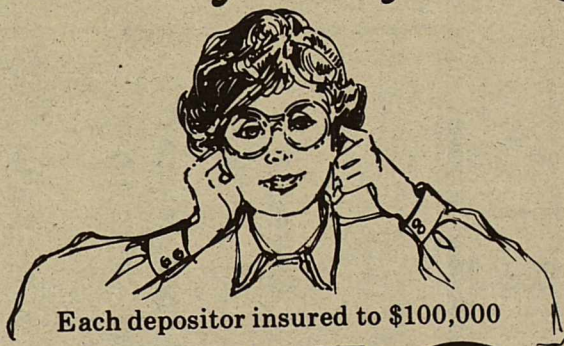

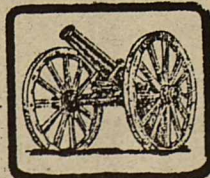
