### BRACKETT STUDENTS HOSTED BY REP. HARRISON

Persuasive and informative speakers on Brackett High School's 1988-89 team were hosted by District 68 State Representative Dudley Harrison on Friday, July 22 at the State Capitol in Austin. Harrison whose district includes Kinney County and six other counties in West and Southwest Texas arranged short informational meetings to help orient the students on issues facing the upcoming legislative session. Students must have knowledge of state and national subject matter when competing in Texas Forensic League and University Interscholastic League competition.

Harrison left a meeting of the Agriculture and Livestock Committee of which he is chairman along with legislative aide Jennifer Yezak to have lunch with students at the capitol cafeteria. Later, he fielded questions along with Yezak from each student. Following a walk through the legislative chamber he introduced a member of House Speaker Gib Lewis's staff who oriented students to the role of the speaker and elaborated on the upcoming legislative session. Late in the afternoon three members of State Comptroller Bob Bullock's office staff gave students a run-down of the comptroller's duties and addressed the issue of school finance.

Sponsor-coach Ron Kelley was very pleased with the trip, and stated that Harrison's secretary Jean Kindle had been especially helpful in making arrangements. Persuasive speakers attending were Virginia Burgess, Tammy Frerich, and Shelley McDaniel. Informative speakers were Pilar Lozano and Clay Hunt.

# GOVERNOR APPOINTS REVIEW PANEL

AUSTIN -- Governor Bill Clements has announced his selections to the Middle Rio Grande Regional Review Committee, one of 24 appointed across Texas to review applications for federal block grants.

"These review committees are vital because they bring a sense of local control to the federal budget process," Clements said.

The block grants typically are used to finance public facilities and provide housing assistance.

The Middle Rio Grande region serves eight counties -- Dimmit, Edwards, Kinney, La Salle, Maverick, Real, Uvalde and Zavala.

Named by the governor to the Middle Rio Grande panel were Alfredo Gutierrez, Del Rio Mayor; Daniel Burr, Del Rio City Councilman; William L. Cotulla, Cotulla Mayor; J.R. Black, La Salle County Commissioner; J.M. Sanderlin, Real County Judge; and John Willems, Carrizo Springs City Councilman.

Members will serve through Jan. 1, 1990. The regional review committees examine requests for federal Community Development

Block Grand funds appropriated to smaller Communities.

The regional recommendations ultimately will be forwarded to the State Community Development Review Committee for review. That panel, in turn, submits the funding recommendations to the Texas Department of Commerce. The governor has final approval over all federal grants awarded under the program.

### FOR VETERANS

Recent Law May Affect You

If you're a veteran, or know someone who is, a recent law may interest you. Thanks to the Veterans of Foreign Wars, Congress has now provided for veterans with a nonservice connected disability seeking care at a VA hospital. The income limits for veterans who can get this new benefit are as follows:

A Category A veteran is one whose income is \$15,833 or less if single, and \$18,999 or less if married. These veterans are entitled to be placed in Category A and are eligible for no-cost hospital care.

Category B veterans, those whose income is above \$15,833 but less than \$21,111 if single and above \$18,999 but less than \$26,389 if married, are eligible for no cost VA hospital care on a space-available basis.

Non-service connected veterans are in Category C if their income is above \$21,110 if single, and above \$26,389 if married. A Category C veteran receives VA hospital care on a space available basis and is charged the cost of the care or \$540, whichever is less, for the first 90 days of care.










Sunlight has weight. That is, it exerts a pressure on anything that obstructs it.

The Whooping Crane has been struggling for survival in this century.

The sad thing is not only do they have to combat weather conditions and disease they also have to fight lead poisoning.

There are a few over one hundred Whooping Crane still in existence. Whoopers are the tallest North American birds, mostly long neck and legs accounting for their average height of four feet. They usually weigh about twenty pounds, with snow-white feathers and a crimson crown. When in full flight the Whooper measures six feet from wing tip to wing tip. During migration the Whooping Crane flies like a glider, up and down for sometimes as long as ten hours.

These birds have been around for a million years, changing little their habits. But when man changed their habits for them there was perhaps as few as 21 birds remained by 1941, but has increased six times that much in 1987.

In the last ten years government and private concerns finally won out and in the last thirty years there ae no cases on record of a hunter killing a Whooper.

The explanation given for one Whooper dying from lead poisoning has been blames on eating scattered lead pellets left by hunters.

Lead poisoning of waterfowl and some of their predators that feed on them has become a serious problem and could be stopped by using steel shot instead of lead.

Range management of our wild birds and animals has come a long way in the last few

In some parts of the southwest there has been organized a group called Wildlife Rescue Inc. to teach people. They teach you what to do if you find an orphaned bird or animal.

In cities birds are mainly in need of rescuing. Contrary to belief if the bird has fallen out of its nest you can pick it up and put it back and the mother won't reject it.

Of course if the bird or animal acts unnaturally leave it alone, because it may be rabid.

These rescue clubs are just getting started, but soon hope to be more numerous around the country.

Perhaps the Whooping Crane could have been helped by a group bent on rescue, instead of destruction. If management are not on their toes, the Whooping Crane and others will follow in the Carrier Pigeons footsteps so to speak.

### TICKS CAN CARRY LYME DISEASE

Summer is the season for ticks in Texas. And anyone working or playing outdoors, should be alert that some ticks, and the corkscrew-shaped organism they carry, can inflict serious arthritic misery.

People can contract Lyme disease after being bitten by an infected tick carrying bacteria called spirochetes. Lyme disease is named for the Connecticut town where it was first recognized in the U.S. in 1975.

The first symptom is often a red circular rash that enlarges. Victims seem to have a flu-like illness with fever, headache, chills, a stiff neck, and extreme fatigue.

Later, other health problems may include arthritis, and disorders of the heart and nervous system lasting months or years. The disease can be passed from a pregnant woman to her unborn child.

Lyme disease was detected in Texas by microbiologist Julie Rawlings at the Texas Department of Health's (TDH) Bureau of Laboratories in Austin. Suspecting the presence of the disorder, she began looking for it while examining lab specimens submitted for Rocky Mountain spotted fever. Today, health professionals at TDH's laboratories use a blood test to detect the disease.

"If a doctor begins treatment soon after infection, consequences such as long term joint problems can often be prevented," Rawlings explained. "If you have Lyme disease symptoms and a known tick bite, you should go see your doctor."

She added that Lyme disease is not a lifethreatening health hazard, but can cause long-lasting discomforts.


In 1987, a total of 33 cases of Lyme disease were confirmed in Texas, compared to nine cases the previous year. Most of the cases occured in the Dallas-Fort Worth area, but other cases also occurred in the Panhandle, and in Central, East, and South

"We have found the spirochete in six kinds of ticks in Texas," Rawlings said. These are the Lone Star Tick, the American dog tick, the brown dog tick, two types of rabbit ticks and the Ixodes tick."

"The disease is reported most during the summer months, and a good preventive measure is to check yourself and your pets for ticks after being outside," Rawlings said.

To remove a tick, she said, gently grasp it with tweezers close to the skin, and slowly pull it loose. Avoid crushing the tick with your fingers.

Rawlings said that Texans needing more information about the disease can contact the Southwest Division of the National Lyme Disease Foundation. The leader of the support group is Judith Williams, at 214/796-2806.



The chopped up and stripped vehicle mentioned in last week's column which was located on a sub-division in north Kinney County has been identified by DPS Auto Theft Agents as a stolen vehicle out of San Antonio. All major parts of the vehicle had been removed along with the usual methods of identification such as license plates and Vehicle Identification Number(VIN). A "hit" on the vehicle was obtained after the vehicle was run through the ICIC/NCIC ILEIS II system now being used by law enforcement agencies statewide. At the time of this writing there are no suspects in the case.

On Friday afternoon, July 29th, a high speed chase between a vehicle suspected of smuggling illegal aliens and a Uvalde based DPS Trooper developed after the Trooper attempted to stop the suspect vehicle on Hwy. 90 near the Border Patrol station. The vehicle then turned south on Hwy. 131 and shortly thereafter ran off the road into the bar ditch and slid up against the fence bordering Ft. Clark on the east side. The driver and another male suspect jumped out of the vehicle and fled into the brush inside Ft. Clark. Five(5) illegal aliens were apprehended at the scene by the DPS Trooper and Chief of Police Johnny Fritter who had joined in to assist the Trooper. A large scale manhunt for the two suspected smugglers soon developed with officers from the Border . Patrol, the DPS Trooper, Chief Fritter and myself involved. A Border Patrol plane also assisted. Ft. Clark residents, particularly those living in the Town House section were advised to make sure their vehicles were secured and to stay inside in case the two suspects attempted to steal a car to make good their escape. The two were finally apprehended on Ft. Clark late Friday night and taken into custody by Border Patrol Agents. It was learned from interrogation of the suspects and the other illegal aliens that the pair had charged \$650.00 each for transporting the five illegals into the interior of Texas.

A major accident occurred on Hwy. 90 Saturday afternoon near the Border Patrol station. Both vehicles involved were local with one of them, a pickup, being struck in the rear by a passenger car. Witnesses at the scene stated that the pickup had stopped on the shoulder of the road with the occupants talking to the occupants of another car also stopped off the road. The driver of the car was alone in his vehicle and stated that he had looked away briefly and when he looked back it was too late to avoid the collision. Extensive damage was done to the car which was later towed away by a wrecker, the pickup had major damage also but had been protected by a large steel bumper on the

rear. It was driveable however and luckily there were no injuries in the accident.

An article which appeared recently in a nationwide publication cited a decision of a judge that allowed \$5,050.00 in compensation to a convicted murderer in a suit he brought against a California county jail because of allegations he made about not being able to get a good night's sleep because of a noise made by other inmates, loud talk by jail guards, being held in a holding cell with other prisoners during the course of trial for murder, and not being allowed to have girlie magazines in his cell. The judge awarded the convicted murderer the following:

- \* \$3,000.00 for not getting at least 8 hours uninterrupted sleep the night before court appearnces during his trial.
- \* \$500.00 for being forced to sit in a holding with no seats.
- \* \$500.00 for not having enough time (according to the convicted murder) to eat meals.
- \* \$500.00 for not getting adequate exercise time.
- \* \$450.00 for being forced to sleep on the floor for three months during a period of jail overcrowding.
- \* \$100.00 for having his Playboy magazines taken from him.

The murderer was convicted for killing his step-father in 1981. The evidence in the case proved that the step-father was working on the engine of a tractor-trailer truck and the murderer slipped up to the truck and pulled a lever that allowed the 2,000 pound cab of the truck to fall on the step-father crushing him to death. The murderer later bragged to fellow inmates about his actions. He is now \$5,050.00 richer due to the judge's ruling on his cry-baby lawsuit against law enforcement officers. Justice? Makes a man wonder!

A local man who has been to prison twice for burlary and auto-theft and only recently released is again in jail on charges from Val Verde County. The Val Verde County charges are misdemeanors but are an indication that the man has not learned from his experiences. As the misdemeanors are a violation of the conditions of his parole he may very well find himself on the way back to TDC to serve out the remainder of his last sentence.

We are still holding two sentenced prisoners awaiting reservations for transport to TDC and sentenced prisoner William Bruce Chandler, the "Highway Bandit", is still in custody in Val Verde County Jail awaiting transfer. If we have not received authorization from TDC to transfer the three prisoners by the end of this week Chandler will most likely be brought back to the Kinney County Jail as we are nearing completion of renovations in the jail. Chandler is an extremely high risk prisoner who has caused numerous problems for Val Verde County Jail officials since they have been holding him for us. He was arrested back in April on Aggravated Robbery charges and recently received a 10 year sentence for his crime. Sheriff J.R. Koog of Del Rio has demonstrated much patience and inter-agency co-operation by continuing to hold such a

troublesome prisoner while we were making out jail secure enough tohold him.

Say, Folks, don't forget the Open Car Show to be held at Fort Clark on Saturday, August 6th. These old cars will bring back memories and will give us a chance to view cars from an era when "cars was cars", not plastic and fiberglass. Judging of the cars will begin at 1:00p.m. and there will be a B-B-Q and dance later that evening. So saddle up and enjoy a day of sun, fun, old classic cars, and nostalgic memories of the good old days.

With a joint effort of both organizations, the culprits were apprehended two days later and my personal belongings returned to me.


I wish to take this opportunity to give a special thank you to your organization. Your alertness, thoroughness, dedication to duty, and joint agency co-ordination is most appreciated.


