### CITIZENSHIP IN ACTION

Kelley Hall and Tammy Frerich were among about 500 Texas 4-H members attending Texas 4-H Congress. The 4-H's experienced the Texas legislative process as they filled House and Senate chambers in the Capital to actually produce legislation.

4-H members assumed the roles of legislators and lobbyists for the congress program. Tammy Frerich served as the lobbyist from District 13.

In their role-playing, the 4-H's introduced a bill on the floor of the House and Senate. The bills were assigned to committees then proceeded through committee action. They then were debated on the floor of each chamber and brought to a final vote before being presented to the 4-H governor.

Bills introduced related to businesses and environment; education; government, finance and appropriations; highways and transportation; judiciary; and public health and welfare.

In addition to their legislative activities, the 4-H members toured the Capital and LBJ Library.

The four day event "Citizenship in Action" was designed to be a leadership and citizenship development experience for 4-H members between the ages of 15 to 19.

Emphasis was on helping youth become more knowledgeable of the legislative process and their citizenship rights and responsibilities.

### SOUTH TEXAS

#### PROJECT UNIT 1

The South Texas Project's Unit 1 reached 100% power at 2:40 a.m. Wednesday, July 27. A series of tests are being conducted. At 10:35 a.m. July 28 one test, a "scram," dropped the unit from full power to zero output instantaneously.

Preliminary results show the power reduction test was very successful. The "scram" is only one of several tests conducted at the 100% power level. For example, three separate tests review how the plant responds to load changes. After power is restored, Unit 1 will begin 100 hours of uninterrupted operation at 100% power. 


Reserve Seat Football Tickets

## NORM MATERIALS DISPOSAL PLANT

BRACKETTVILLE, Tx. -- Texcor Industries, Inc., has begun site identification and investigation activities in the Southern portion of Kinney County in an effort to license and construct a NORM Materials disposal facility.

According to Texcor President Charles W. Salsman, the project will involve:

- . An expense of approximately \$600,000 involving all of the environmental, geological, historical, meteorological and socio-economic evaluation of a site;

- . Filing an application for an operating permit;

- . Construction expenses of about \$6 million;

- . Approximately 75 construction jobs;

- . Some 15 full-time operations jobs in the beginning, and building up to 25 full-time positions within a year;

- . An annual payroll of more than \$550,000 and

- . Annual purchases of approximately \$150,000 from local merchants.

"NORM materials are a classification of waste materials currently being reviewed and regulated by a number of state and federal environmental or regulatory agencies," Salsman explained. "NORM stands for Naturally Occurring Radioactive Materials. They are generated, for the most part, as a by-product of businesses that produce or process natural resources from the earth including oil and natural gas, rare earths and uranium processing, municipal water treatment and fertilizer production. I expect 90 percent of NORM materials that come to this facility will come from the oil and natural gas industry".

According to Salsman, oil and natural gas deposits, much like groundwater, contain minerals. When oil and gas is gathered and transported through a pipeline, these minerals collect and create deposits inside the pipe. In highly mineralized oil fields, this mineral scale eventually begins to clog the pipe and restrict the flow of oil.

"In the past, oil companies would pull the pipe apart, scour out the scale, and use the pipe again," Salsman explained. "The scale was swept out the shop's back door and has been stockpiled all these years. But because this scale contains small amounts of radioactive minerals which occur naturally in the oil, the scale sometimes has radioactivity concentrations high enough to be classified as NORM materials. This facility will be built to store these and related NORM materials."

### DIFFERENT WASTE TYPES

There are three types of radioactive waste classifications. High level waste is generated in nuclear power plants. It's activity level is measured in curies. Low level waste is generated in hospitals and laboratories, and is measured in millicuries, or .001 of a curie. NORM materials are generated in mineral production and processing (described above) and are measured in picocuries, or .000000000001 of a curie.

"One way of comparison would be to assign the value of one curie to the Astrodome,"

Salsman explained. "If that were so, then a hot air balloon would be equivalent to a millicurie, and a marble would be equivalent to a picocurie. Currently, materials that have more than five picocuries per gram would have to be disposed of in a licensed NORM facility, of which none exist in Texas. In talking with oil industry environmental personnel, these NORM materials will run from five to about 4,000 picocuries."

"In fact, the activity level of these materials is so low that our employees will not be required to wear any special protective gear to unload and handle these materials other than basic equipment such as hard hats, steel-toed boots and safety glasses."

Salsman added that there would be less on the job radiation exposure to employees at the site than they normally receive from "background" sources, such as the sun, water, food and housing.

And, because of our proposed method of construction and operation, there will be no off-site release of radiation," he added.

He also noted that this site would be permitted for NORM material disposal only. Both state and federal laws would prohibit any low-level hospital waste or high-level waste from nuclear power plants from being accepted at this facility.

### CONSTRUCTION AND OPERATION

The trench to be constructed will be approximately 20 feet deep, 200 feet wide and 2,200 feet long. All walls are designed at a 4:1 slope. A french drain leak recovery system consisting of network of gravel-packed slotted pipe and sump pump will be installed under the trench and run the length of the facility. This will be covered by a layer of geotextile fabric, which serves as a leak detection system and will line the entire pit. A layer of high density poly ethylene (HDPE) will be laid down next to serve as a leak barrier, followed by another layer of geotextile fabric.

Twelve inches of compacted clay, with the same approximate permeability as asphalt, will cover these layers. Following that, another layer of geotextile fabric, another layer of HDPE, another layer of geotextile fabric, and another 12 inches of compacted clay will be installed in that order. This will provide five independent barriers against leaks, four independent leak detection systems, and one leak recovery system. In addition, the pit will be ringed with a series of monitor wells.

"We'll have all these safeguards installed for a facility that WILL NOT BURY LIQUID WASTE," Salsman added. "We want residents of the local community to feel very safe about this. And, please remember that we don't want to build on top of an aquifer. Our site evaluation work will tell us more, but from what we know of the areas south and west of Spofford, water wells have been drilled through 1,700 feet of clay without finding water. That's good geology for this type of operation."

Once constructed, NORM materials will be stored in the bottom 10 feet of the pit. Each load that comes in will be covered with 10 feet of compacted clay, sealing any possibility of radiation releases into the

atmosphere.

"We expect the life of this project to be 20 years," Salsman said. "At that time, or whenever the trench is filled, we will reclaim the site to standards as set by state and federal regulatory agencies. Also a perpetual maintenance fund in an amount decided by these regulatory agency personnel will be established."

### AGENCY REGULATIONS

At least eight state or federal regulatory agencies will directly or indirectly oversee operations at the site. The project will require an operating permit, good for only five years.

"Before the permit can be granted, an official notice will be published to inform local residents of our intent to file a permit application," Salsman said. "Our application will be a matter of public record, with copies of the application available for review in our offices, a public location in the county and in Austin. We want everyone who has an interest in the project to have an opportunity to have all their questions answered".

A slide show detailing the proposed operation is available. Salsman added that any group wanting to hear the presentation is invited to come by the Texcor office, located across from the Rio Grande Electric Cooperative, or call 563-2481.

"We're only in the very early stages of looking for a site," Salsman concluded. "However, before we began this effort, we wanted members of the community to understand this project and have their questions answered before we proceeded with the expense of site evaluation, which will take from 90-120 days.







In addition, the pit will be ringed with a series of monitor wells. Yet, **NO LIQUIDS WILL BE BURIED** in the facility.



**COMPARING DIFFERENT WASTES** – There are three types of radioactive waste classifications. High level waste is generated in nuclear power plants. Its activity level is measured in curies (represented by the astrodome). Low level waste is generated in hospitals and research laboratories, and is measured in millicuries, or .001 of a curie (represented by the hot air balloon). NORM materials are generated in mineral production and processing, and are measured in picocuries, or .00000000001 of a curie (represented by the marble).

The Mockingbird is the official state bird of Texas, Florida, Mississippi, Tennessee, and Arkansas. Although he is seen in other locations, the Mocker is best known in the Southwest.

Like most of the citizens of the southwest this bird is cordial and friendly, cheerful and unafraid. When he has nothing else to do he is never bored, he just sings.

The Mockingbird is no coward as many cats can testify. Where he lives is his territory. One Mocker lives in my yard and my yard is his personal property. He mocks other birds, it's true, but when danger appears he has a special bugle note that says "call to arms". When an intruder appears this bird and his friends, dart in, peck, flutter and shriek until the culprit is ready to sneak away. They will risk death to defend their nest.

As soon as the danger is past, the Mocker will resume from some nearby perch a cheerful song.

My Mockingbird friend sleeps about as much as I do. His song on moonlight nights is a welcome and cheerful respite.

A Mocker can jump up from his perch, turn a half dozen flips in the air without missing a note. He's a great show-off and seems to sing for your attention. Although he has a perfectly good song of his own he mocks and mimics everything he hears, even a squeaky wheel barrow.

No one knows why Mother Nature gave the Mocker to mimic songs and sounds. There is an old legend how the Mockingbird stole his music. Long ago the old owl who was supposed to be very wise, ruled the forest, before any bird could sing. One day the old owl sent out word that he would teach every bird a song, if they would come to his studio in a hollow tree. All the birds were very excited.

First came the Robin, the Sparrow and the other birds. The Owl stuck his head out of his studio and said, "Where is that gray bird, why doesn't he come to learn his song?"

Above the old Owl the gray Mocker started to sing. He had listened to all the other birds learning their song and knew them all.

The Mocker is a musical policeman that will protect your yard and eats thousands of insects, grass hoppers, cutworms, rosebugs, plant lice and weed seed.

So, if some May you see a pert gray pair of birds building a shabby nest in your yard, consider yourself lucky, because they do eat so many destructive insects, worms and weed seeds. It is estimated the Mockingbird is each worth five to ten dollars per year to farmers and gardeners.

## TEXAS ECONOMY IMPROVING

AUSTIN, Tex. -- State Comptroller Bob Bullock said Friday that payments to cities and counties that collect local sales tax increased again this month.

"The Texas economy is steadily improving," Bullock said. "Cities and counties across the state are still seeing the benefits."

Checks totaling \$10.4 million were sent to 81 Texas counties that collect the one-half percent optional county sales tax, Bullock said.

Kinney County received \$5,292.17 this period as compared to \$4,306.49 last year at this time. That's a 22.89% increase. Payments to date for 1988 are \$24,806.14 as to \$24,190.82 in 1987 at this time. That's a change of 2.86%.

August's checks represent taxes collected by monthly and quarterly filers in June and reported to the Comptroller's Office by July 20.

## STRAY VOLTAGE PROBLEMS

Farm and ranch facilities such as dairy barns or livestock enclosures are particularly good environments for "stray" or "tingle" voltages. The presence of moisture and organic material in these areas may damage or cause deterioration of electrical wiring or equipment. Any small difference in potential between the earth and the different parts of an electric distribution system can lead to stray voltage.

Humans may never notice the "tingle" of a small ground-to-earth discharge. Stock animals such as cattle, sheep and hogs are better grounded, and so are sensitive to much smaller electrical charges. Livestock may become difficult to handle, or may exhibit nervousness or reluctance to enter milking stalls or corrals when stray voltage is present.

Stray voltage in the consumer's system may be caused by incorrect wiring, faulty electrical equipment, or even by the small voltages required to move the required operating current through a grounded neutral system. If it is caused by an electrical fault, the stray voltage may become a hazard or a health risk to humans as well as to animals.

Professional testing will identify stray voltage problem, contact a competent electrician.

## REFLECTIONS

Did you ever take a trip in an airplane? If so, you may have noticed that the plane wings are flexible. They bend a great deal while the plane is in flight. Such a sight may frighten the passenger who sees it for the first time, but such elasticity is necessary to keep the aircraft from breaking apart.

and before the unit can be considered for commercial operation.


Since it began power ascension testing, Unit 1 has generated more than one-half million kilowatt-hours of electricity for South Texas. CPL has received approximately one-fourth of that electricity, or 125,000 kilowatt-hours, enough energy to serve two cities the size of Kingsville. The reactor reached 75% power on July 6, where 17 specific tests and calibrations were conducted. At the 90% testing plateau, reached July 23, nine tests were conducted, including numerous calibrations. Unit 1 commercial operation declaration is expected in August.

On July 8, STP's Unit 2 began hot functional testing approximately one week ahead of schedule. Hot functional testing involves the running of the major systems of the unit at normal operating temperatures and pressures. Heat for the operation is produced primarily from the unit's four reactor coolant pumps. Hot functional testing will require approximately two months. If the unit continues on schedule, fuel will be loaded into the reactor in October. Unit 2 is currently about 98% complete.

A graded drill held at the plant July 13 was considered to have gone very well by Houson Lighting & Power, STP's managing partner. Each year the Nuclear Regulatory Commission observes and grades emergency preparedness at STP.

Prior to the drill, Central Power & Light Co. gave an update on emergency preparedness to area media and discussed the roles of plant and public officials, the states of emergency, procedures for persons residing in the emergency planning zone, and STP's emergency media information center.
