HOUSING AUTHORITY RECEIVES GRANT

Washington--- U. S. Senator Phil Gramm has announced the award of a series of Comprehensive Improvements Assistance Program contracts totalling \$48 million to 72 Texas Cities.

Some of the grants to be distributed are as follows:

- Brackettville, \$269,778
- Carrizo Springs, \$86,650
- Del Rio, \$823,570
- Eagle Pass, \$633,063

CIAP is a program of the U.S. Department of Housing and Urban Development.

The contract obligates the federal government, through annual contributions, to pay the principal and interest on project notes sold by the local housing authorities

FROM THE OFFICE OF JUDITH ZAFFIRINI ECONOMIC DEVELOPMENT II

"The people who get on in this world are the people who get up and look for the circumstances they want, and, if they can't find them, make them." These words by George Bernard Shaw exemplify the efforts of the Texas Strategic Economic Policy Commission (TSEPC).

Created by the 70th Legislature, the 18-member commission recognizes that Texans expect a bright future in spite of the significant economic downturn experienced by the state in recent years. Accordingly, the TSEPC is searching for a course that not only will boost the recovery, but also will help prevent a relapse in future years.

My last column reviewed the factors identified by TSEPC as contributors to our state's economy. It also described the emerging economic trends which the Commission believes must be dealt with in planning future economic prosperity.

Given these circumstances, the Commission developed a preliminary Strategic Plan based on four objectives and the related strategies and an action plan for implementing these objectives. Copies of this plan, entitled "A Blueprint for Tomorrow's Texas," are available via my Capitol Office.

The plan's first objective is to develop a set of legal, regulatory and fiscal policies that are competitive and balanced. This would nurture a favorable business climate

which is essential to attracting new businesses and to supporting and sustaining businesses which comprise the backbone of our state's economy.

To reach this objective the Commission has recommended two strategies. First, it states that the Texas tax system must be examined to ensure that it provides equity and stability while promoting economic growth. This means determining how best to balance the financial needs of the state with the financial limits of businesses as taxpayers.

Second, it identifies the need to reduce regulatory and legal impediments to business and economic growth in Texas.

The second major objective in the plan is to develop a workforce that is internationally competitive, flexible and skilled.

Three strategies focusing on education were identified by the Commission as essential means for achieving this goal. Generally, these focus on upgrading our public education system, with an emphasis on ensuring basic skills and on curbing our rising problems of adult illiteracy and school dropouts; developing a responsive, integrated system of technical and vocational training and retraining; and improving the quality and responsiveness of our state's

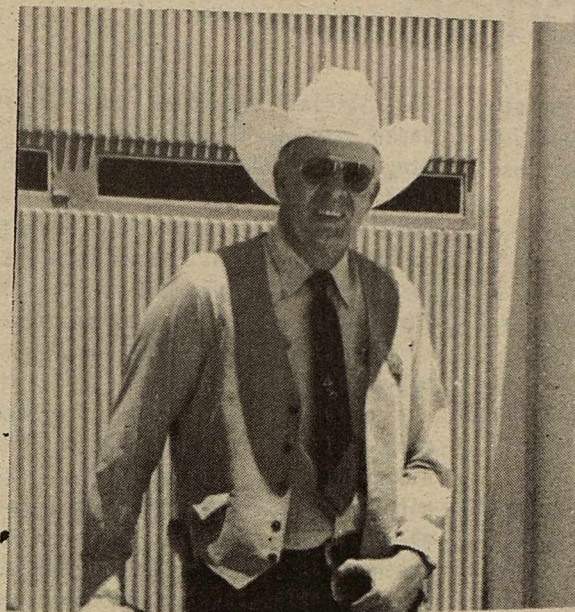

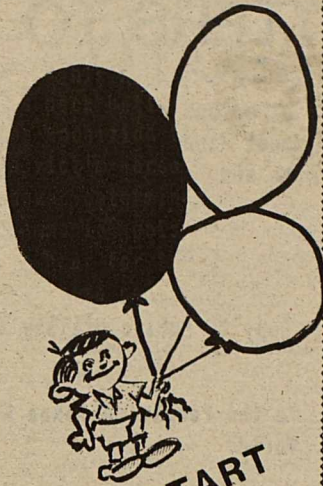

Letter to the Editor;
Del Rio News Herald & Kinney Cavalryman;

The Rio Grande Electric Cooperative has become an enormous problem that must be addressed by the residents of Fort Clark Springs, the General Manager and Board of Directors. Part of Fort Clark Springs residents are being served electricity by Central Power and Light Electric Company and the remainder of the residents are served by the Rio Grande Electric Cooperative, which buys its electricity from Central Power and Light Company, then the RGEC adds a surcharge and a much higher price per kilowatt hour of electricity.

The RGEC is a company set up to serve rural areas. Fort Clark Springs is not a rural area, but a thriving urban community for retired and anyone else wishing to live here in a quiet, serene atmosphere. The question is why are some residents have to pay the RGEC high electric prices and those residents served by Central Power & Light do not?

Well, everyone knows the answer, but what are they doing about it???? The RGEC is charging rural prices to some of the Fort Clark residents that do not live in a rural area. The majority of residents of Fort Clark Springs are retired people living on fixed incomes and many other residents are working people on low incomes, all these people cannot afford the RGEC high electric prices. Some Fort Clark Springs residents want to sell their houses or trailers so that they can move to the area CP&L company serves and many people do not want to buy a home or trailer served by RGEC, due to their high electric prices. This is bad business for Fort Clark Springs and Brackettville. I have heard some residents say, "My electric bill with RGEC is the same or higher than my mortgage payment." Many residents have cut-off their central air conditioners and suffered the heat to save electricity, but the RGEC electric bill is still high. I have complained to the company several times, they never come out to check, but they have said that my ground wire is using the electricity when I cut-off the switches. I have never heard such a story.

The RGEC has many serious problems with high indebtedness, and mismanagement and the clients are not at fault for the RGEC shortcomings.

There are three solutions to these serious problems:

Solution A: Since Fort Clark Springs residents are not living in a rural area, they should not have to pay the rural surcharge or the high prices for electricity.

Solution B: That the residents of Fort Clark Springs that are being served by the RGEC be disconnected and hooked up to Central Power and Light Company.

Solution C: That the RGEC go into receivership, be franchised and the CPL Company take it over.

That the General Manager, Board of

Directors and residents of Fort Clark Springs meet and demand that one of these solutions be adopted to correct these gross injustices.

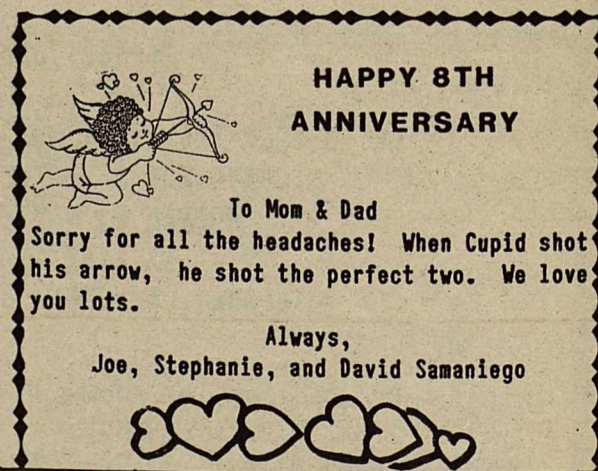

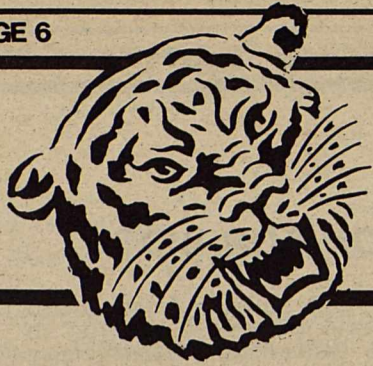

JR. HIGH WINS!

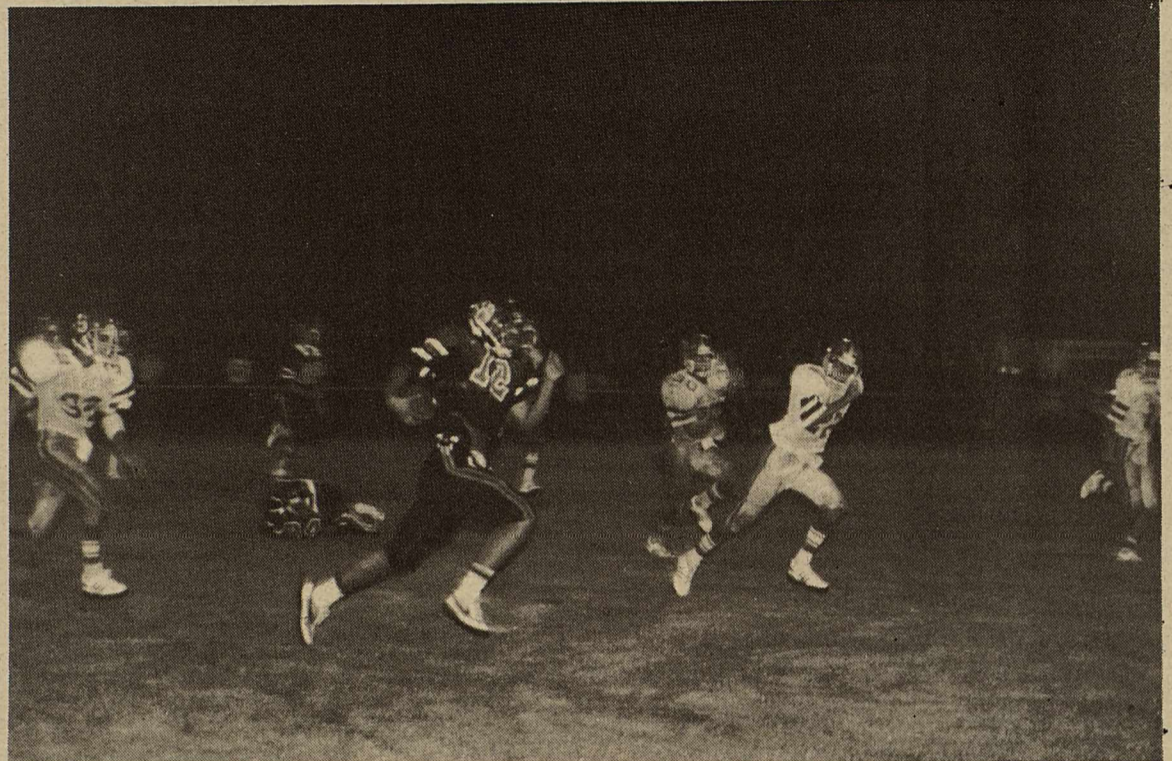

'CARE' SUPPORTERS JOURNEY TO AUSTIN

Twenty-three members of CARE (Citizens Against Radioactive Environment) left Brackettville at 4:30 a.m. Sept. 29, to travel by bus to Austin. They went to observe and to testify at a public hearing by the Texas State Senate Subcommittee on Health Services, called by Senator Carlos F. Truan, Corpus Christi. Stated purpose of the hearing was to hear testimony on "serious deficiencies in the state's regulation of radioactive wastes."

In his announcement of the hearing, Sen. Truan pointed out that "The regulation process is stacked against the citizens of this state," and that "Individuals and even whole communities can be deprived of their property their health, their livelihoods, and their birthright by the capricious actions of state agencies and profiteers."

Among those present at the hearing were a number of lobbyists and attorneys representing uranium and waste disposal industries, a group of citizens from Panna Maria (a small community in Karnes County which is the site of a Chevron Corporation uranium mill), and the CARE representatives from Kinney County. The Panna Maria witnesses testified to several years of vain attempts to obtain from Chevron and from the State Department of Health factual information and data about leakages of radioactive materials from uranium mill tailings dumped by the corporation. Despite an increase in cancer deaths in the area (as observed and reported by health professionals) state officials have refused access to records of monitoring programs designed to detect spread of contamination. Experience at Panna Maria, as reported by the attorney for the citizens group, is that "you can't tell the regulators from the regulated." and that the state agency operates as a defender of the industries against public interest.

Testimony disclosed that at least three uranium mill dumps in South Texas have been operated since 1980 under expired licenses. The State Department of Health received renewal applications from these companies in 1980, but has taken no action to perform the investigations necessary to renew the operating permits.

At a press conference called by the Panna Maria group, representatives of major press and TV media were told of citizen inability to gain access to company or government records which directly affect public health and lives. Evidence was presented that at the dump named Conoco/Conquista, still in operation although the plant closed several years ago, material at least 1000 times more radioactive than allowable under the expired license has been dumped. The head of the Radioactive Materials Department of the Department of Health said that the public was not informed because "They wouldn't understand anyway."

CARE witnesses from Kinney County pointed out that the proposed NORM site near Spofford will have serious adverse effect on the county, including drastic reduction in

property values, loss of retired residents and discouragement of new residents, and loss of hunting revenue. In addition, the very real dangers of eventual health hazards will always be present.

Testimony also indicated that the term NORM (Naturally Occurring Radioactive Material) is deceptive. The term seems to indicate that this material is not different from radiation levels existing in nature. As a matter of fact, both pipe scale and mill tailings are concentrated materials resulting from industrial activity, and are not "natural" nor in the area where they "occur".

In remarks during the course of the hearing Senator Truan expressed serious dissatisfaction with the operations of the State Department of Health. He ordered representatives of the Department to furnish the Subcommittee with concrete and specific proposals to correct obvious problems, among which are:

1. Departmental bias in favor of regulated industries.
2. Obstruction of citizen action to protect individuals and communities against hazardous situations.
3. Failure of the Department to carry out responsibilities assigned by the legislature.
4. Deception and concealment in communication with other departments and with the public.
5. Reluctance to cooperate and coordinate with other state agencies.

Consensus among the CARE contingent was that the trip was productive, but that citizen success in protecting our county from corporate invasion will require prolonged and serious effort, at local, state, and even federal levels. Discussions with the group from Panna Maria disclosed problems and difficulties we had not anticipated. Chief among these is the absence of any protection of Texas citizens from abuse by business interests which have powerful influence in the State Department of Health.

SHERIFF'S CORNER



The Kinney County Courthouse was a beehive of activity Monday, October 3rd as District Court was held and the new Grand Jury was selected and sworn in, this Grand Jury will serve until April. Two criminal cases were presented to the new Grand Jury with one True Bill of indictment and one No Bill being returned.

The True Bill was returned on Alejandro Torres-Cordero, a 20 year old Mexican national charged with the May 1988 burglary of a Spofford residence. Cordero was apprehended and arrested the night of May 20, 1988 near the residence and all property stolen was recovered including an antique .20 gauge double barrel shotgun. He has remained in the county jail since that time in lieu of bond, his trial date has been set for November 14th.

The No Bill was returned on William Howard Smith, a 33 year old transit (hobo) who was apprehended on a freight train passing through Spofford and charged with burglary of a vehicle by Southern Pacific Railroad Police. Due to a lack of viable solid evidence and the fact that Smith was mentally retarded, it was decided to dismiss the charges against him and the District Attorney's office recommended a No Bill be returned.

At long last the aggravated robbery case involving a female Laughlin AFB victim and three Bonnie and Clyde type characters from

North and South Carolina is closed. The last of the three suspects, Ricky Eugene Cagle, 18, was tried and convicted in Monday's session of the 63rd Judicial District Court, Judge George Thurmond presiding. Cagle pled guilty to a lesser included charge of robbery, a 2nd degree felony, and received from the court and an appointment can be obtained for his transfer to TDC.

Law Enforcement officers and insurance investigators have become aware of a new and terrible cruel crime developing over the past 4 to 5 years. This crime is so cruel and agonizing to it's victims that it is beyond the comprehension of most law enforcement officers and citizens. The crime is committed for the same age old reason that the majority of crimes are committed, money, large amounts of money sometimes in the millions. The heinous crime I speak of is that of killing horses in order to collect large insurance settlements. Most of the horses that are victimized are race horses though in some recorded cases they have been pure bred Arabians or performance quarter horses. Quite often these horses are "syndicated" by a handful of owners who fabricate false values of the horses involved by recordial sales of shares in the horses that are false in nature because the sales of the "shares" in the horses are on paper only. Once the paper value of the horse has reached the figure desired by the criminals and con men involved in the fraud (often at the million dollar or higher figure) the horse is killed in a cruel manner in an attempt to appear that the horse died of natural causes. Some of the methods used by these cruel and heartless con men are; electrocution, poisoning by overdose of

ammonia, smothering the horse by placing ping pong balls up his nostrils or by placing a plastic bag over his head and taping it closed around his neck until he is dead. Can you imagine the agonizing terror and pain suffered by the victim horse until he dies. Investigators have determined that in some cases such as ammonia poisoning it takes 40 minutes to an hour for the horse to die. The horse is in extreme pain until dead.

A domestic horse is like a 3 year old child, he is dependant upon his owner or caretaker for his food, water, shelter, and well-being. Try to imagine the cruel and heartless nature of the person who could (and does) authorize (or commit) the killing of a horse or any other animal in this manner.

Insurance companies were defrauded out of millions of dollars in the manner for several years until they began to fight back with well trained, highly professional criminal investigators who use the same techniques of criminal investigation used in homicide cases. Since that time, many arrests of horse killers for money have occurred and millions of dollars in insurance claims have been disallowed. Anyone that would deliberately plan and carry out this type of extremely cruel and terrible crime is of the lowest caliber of human animal on earth and deserves to be apprehended, tried, convicted, and sent to prison for his crime. Thanks to highly professional criminal investigators specializing in this type crime, more and more of the cruel criminals and con men are getting their just dues; convictions and prison terms. Think about it!

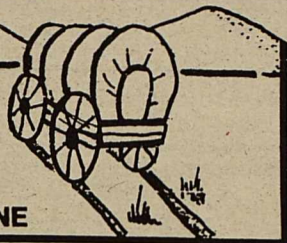
