STAMP OUT VOTE IN TEXAS

The Texas Chainsaw Massacre is not the only horror story in the state. It's frightening to know that on election day, names of the deceased are found on voter registration rolls. Truck loads of ineligible voters are hauled from precinct to precinct. Ballot boxes are stuffed. Votes disappear.

Make no mistake, vote fraud has been, and remains, a serious problem in Texas. While a few wink and turn away, vote fraud is a crime. Even in a state as large as Texas, one or two fraudulent ballots per precinct

can change the outcome of an election.

In this year's presidential campaigns, both candidates have made crime a major issue. Certainly, no crime strikes at the heart of our democratic system more insidiously than vote fraud.

As Chief Election Officer of Texas, I have launched a crusade to end vote fraud. I asked my Assistant Secretary of State, Randall H. Erben, to personally take charge of this effort. The Secretary of State is authorized to deploy election inspectors across the state at his discretion and must send an inspector to an area where 15 of its registered voters request one. The demand for inspectors is great this year, reflecting the public's growing intolerance of vote fraud.

Inspectors stationed in a polling place are usually inconspicuous. They merely arbitrate disputes and point out irregularities to election officials. If an election judge or clerk refuses to follow the law, then the inspector will call in specially trained law enforcement officers who will be on standby that day.

To ensure that partisanship and egos do not interfere with elections, we targeted two groups from which to recruit election inspectors. First, I asked attorneys. Lawyers, as officers of the court, are easily trained on applicable election law and can receive continuing legal education credit from the State Bar of Texas by taking our course and working on election day. The second group we targeted are public employees. These dedicated public servants administer the laws of Texas day in and day out in an even-handed, non-partisan fashion. Both groups make excellent inspectors.

The training session an inspector must attend provides a clear, concise presentation of Texas election laws. Our professional legal staff covers the most frequent problems faced on election day and outlines procedures for correcting illegalities at the polling place

Election inspectors are not poll watchers or other monitors who work for a particular party, candidate or cause. Election inspectors are officers of the State. The inspectors' activities will be coordinated

DUKE TALENT SEARCH

THREE STUDENTS FROM BRACKETT JR. HIGH QUALIFY FOR DUKE TALENT SEARCH

Three students from Brackett Jr. High have qualified and applied for participation in this year's Duke Talent Search for mathematically and verbally brilliant students sponsored by Duke University's Talent Identification Program. The program identifies bright seventh graders from 16-state regions in the south, southwest, and midwest.

To be eligible, students must have scored at the 97th percentile or better on an in-School achievement or ability measure. They will take the Scholastic Aptitude Test (SAT) or ACT Assessment (ACT), normally taken only by college-bound juniors and seniors, in December, January, or February. Many of these students score as well or better than the average college-bound senior on these measures. All participants recieve Certificates of Merit and some become eligible for state-wide recognition ceremonies or a variety of educational programs.

TIP, established in 1980, has provided thousands of students with information about their abilities and educational options. The purposes of the program are to help academically able students develop their

special abilities, to assist schools in working with the brightest students, and to understand the nature of exceptional mathematical and verbal ability.



Tuesday, November 8, 1988 is Election Day and I urge all of you who have not already voted absentee to get out and exercise your right to vote. Cast your vote for the issues and candidates of your choice. By voting you are voicing your interest in local, state, and national government and stating by your vote your opinion in how your government should be run.

I sometimes hear folks say "I'm not going to waste my time voting, my vote won't make a difference anyway." WRONG-WRONG-WRONG! What if everyone felt that way? Our democratic way of life and freedom of choice would soon disappear and we would end up with dictatorships running our governments. Sure your vote counts, and most importantly, it counts to you because you have voiced your opinion regardless of how it turns out. If you don't vote, you really give up your right to gripe and groan later about how things are or the decisions of the officials in office. All elected officials are selected by majority vote, and YOUR vote counts. If you don't vote, don't gripe later.

We have several criminal investigations going on at one time right now and we are spread pretty thin in our efforts. But we are used to that and will keep on keeping on to the best of our ability. The three major criminal investigations we are involved with at the present time are as follows:

(1) An alleged armed robbery that was reported to have occurred at the roadside area 6 miles east of Brackettville on Hwy. 90 the morning of Friday, October 28th.

(2) Our continued investigation into the arson case that occurred at a south Kinney County Ranch in September 1988.

(3) Allegations of insurance and mail fraud connected with the death of a highly insured race horse that died a painful, cruel death under suspicious circumstances. We are being assisted in this investigation by Private Investigator William "Bill" Graham, better known as "The Fat Man". Mr. Graham of Seneca, South Carolina specializes in cases involving equine mortality for profit. He has successfully solved over 100 cases of killing horses for profit (insurance fraud) and has appeared on several national television shows with case histories of the more prominent cases he has worked on being discussed to demonstrate the cruel, painful, and deadly methods used by low class criminals against horses for personal gain (money). Mr. Graham is highly capable and competent and indicates that investigation into this current case will soon be completed. All available evidence of criminal activity on the part of the suspect(s) in the case will be turned over to the F.B.I. and the District Attorney's Office for consideration and probable presentation to both federal and local Grand Juries.

Dear Editor:

Today I read a political ad in the October: 20 issue of the Kinney Cavalryman. The ad was paid for by C. C. Veltmann, Candidate for sheriff in the upcoming November election.

One statement that was made, "Can we afford this Jail income?". Don't be mislead by this remark; for we can't afford to be without it.

By law....The county is mandated to maintain a jail and the jail must pass jail standards set by the State. No matter who is sheriff, this has to be this way. With or without a prisoner program, it cost money to operate our jail. The average cost of running a jail of our size, on the bare minimum, is around \$140,000 to \$150,000 per year. What this means is that without a prisoner program we know we are going to spend whatever that amount will be with no money coming in to offset the expense. Instead of spending the "\$52,702"; we would have spent the \$140,000 to \$150,000....now which one would you, the taxpayer rather have?....

As far as the cost of food per meal is concerned, the \$4.92 cost per day, for each prisoner; take another look and really understand all the facts....

First the County receives \$28.00 per day for each prisoner that we have on the prisoner program; we receive nothing on our local prisoners.

I believe the figure of \$598.60 a month for a family of four is correct; but if you were receiving \$3,360.00 a month income, the family of four really shouldn't mind spending the \$598.60 for food...this leaves \$2,761.40 for other necessities. The figures as given in this ad are very misleading and I do not want the taxpayers to be mislead.





EFFECTS ON HUMAN HEALTH

Uranium and radium are known bone-seekers, and cause bone cancer as well as other cancers. It is well known that radiation can lead to severe health effects, but radioactive contamination of soil, water, air, and food is easier to document than are radiation-induced human health problems. That is because cancer, birth defects, etc., can have multiple causes; because the chain of cause-effect is difficult to build; and because cancer may take many years to appear. Yet the state is shirking its responsibility if it fails to follow the water-soil-air-food- chain to its final link--human beings.

Evidence from other states and from Texas convinces us that it is time for a full-scale health surveillance survey in the South Texas area, and that it shoud be initiated by the state. Quite frankly, the horror stories we have heard from farmers and ranches in Karnes and surrounding counties are disturbing: of cancer cases in farm after farm, household after household; birth defects kept quiet in the close-knit communities; the first out-of-court action lawsuits against uranium companies for widespread damaging health effects. It is time for the public health issue to come out from the rumor stage and be fully investigated; it is time for the state

to undertake an intensive survey of uraniumarea residents, rather than relying on reported incidences.

A related issue is the effects of NORM (Naturally Occurring Radioactive Material) on human health—in both rural and urban areas. NORM typically contains radium and emits radon gas. Examples of NORM would include: the piles of phospho-gypsum waste from fertilizer processing plants in Texas; lignite ash at electric power plants; and the scale of oilfield pipes and equipment.

Phospho-gypsum piles alone are five to six time the volume of uranium mill tailings in the United States. The Texas Department of Health and the Texas Low-Level Radioactive Waste Disposal Authority are currently examining health standards and possible regulations for NORM.

Letter to the Editor:
To whom it may concern:

I would like to state the simple fact that I have put in considerable financial and physical effort here in the City of Brackettville. My know-how from past experience in land development includes clearing and burning. I personally have cleared from the top of Crockett Street and also from Rock Street huge piles of debris, at no expense to the City. I have cleaned and cleared the lots of various property owners, to improve the looks of our City.

1. The reason I was not at the burn site, or had not appointed someone to be there in my place was: in my opinion it posed no particular hazard.

2. On Friday, October 21, 1988 we received three urgent phone calls from the Regional Office of the Land Division of the Justice Department, in regards to their purchase of our land for a local Border Patrol Station. They realized that their time-limit option with us had expired and they had no valid contract to purchase the land. They asked for our cooperation, which of course we willingly gave, to sign an extension of time, so they could send a valid proposal back to Washington, D. C. Mrs. Conboy was asked to stand by the phone; she arranged with a neighbor to drive her up to fetch me to the Border Patrol, when a delegate from Del Rio had arrived at the local Border Patrol Station with the necessary papers for us to sign.

The phone call came again from Dallas: meet the Del Rio representative at 11:30 a.m. We did so. We waited until 11:45, then went directly home to await whatever developed. At 11:50 we were asked to return to the Border Patrol and sign the papers, which we did; these facts are verifiable by Mr. Marshall and a Terry McIntosh from Del Rio. After lunch I returned to the burn site, staying and clearing until dark.

I feel that we had an extremely valid reason for leaving the area of dispute. The Mayor obviously felt there wasn't really a danger, since no one checked to see if I were injured, sick or just didn't care.

This hardly seems to me a courteous way to treat hard-working taxpaying citizens and boosters of Brackettville. We have contributed willingly to various causes: the 4-H Club, Salvation Army, Brackett Boosters, Firemen's Fund. We pay over \$3,000 a year in taxes. We have invested ALL our money in this area.

I willingly fought in World War II and again in the Korean War, against our country's enemies. But I will not subject myself nor my wife to unnecessary sabotage locally. We are senior citizens. We could leave here and live on my Teamster's Pension and other income. We can leave all property here to our heirs. The City of Brackettville, and the local Border Patrol personnel are more directly affected than we would be if the Border Patrol Station were in Eagle Pass, Uvalde, or Del Rio than here. We will continue to cooperate...but we will not be further harrassed.

LOVE INSPIRES GRAY-Y COACH

Paul Lopez, a five-year veteran of Gray-Y football coaching, did not get into the act of his own free will. His son dragged him into the sport.

Raised in Brackettville, Lopez said there was nothing for the kids to do. When he moved his family to San Angelo, the call of sports lured his son into the YMCA-sponsored Gray-Y football program.

"I love working with kids," Lopez said.

At first, Lopez's wife, Mary Ann, found the 5:30 - 7 p.m. Monday through Thursday coaching activity more disruptive to supper than interesting. But, the bug got to her also, and she is now the "team mom," he said.

Lopez has been involved with the YMCA coaching project for five years and still enjoys it.

He started with 8-year-olds and will work with them until they reach age 12.

Most of the 19 children now on the football team have been with him from the start.

The youths attend various elementary schools in San Angelo. They will go into junior high school next year where some will be pitted against their former teammates.

"It will be interesting," he said. "I'll be watching to see if we have helped them. They have been a good bunch of kids."

Lopez said he has had no problems with the children, contrary to warnings he received when he started.

"These kids come from all walks of life. You can't help from liking them," he said.

"After five years with the same bunch of children, it will soon be decision time," he said. He has the opportunity to start with another group of 8-year-olds next year and work with them for five years. He is also looking at a chance to take on some heavy weights, or older youths, in Grape Creek.

"The decisions are not going to be easy," Lopez said. He seemed to be leaning to the 8-year-old situation again.

Lopez is a lineman for GTE Southwest. His assistant lineman, Juan Garcia, has also been his assistant coach for the past three years. "Garcia moved to San Angelo from Del Rio and also has a natural love for children," Lopez expained.

Frank Alejandro is the third coach on the team. The three men coach football and basketball, which calls for about six months of commitment each year.

But, as Lopez said, "It's an enjoyable time working with these kids." (reprinted from the San Angelo Standard-Times written by staff writer Joe McClure).





A few weeks ago I had occasion to pass through Shafter, an old silver mining town, almost a ghost town.

Silver mining lasted only a short time in Texas. Silver was discovered in the Chinati Mountains near the old Milton Faver Ranch. Faver was one of the first rancher's in the Chinati's.

John W. Spencer mined there on a small scale in the 1860's, taking the ore to Mexico in burro carts to be smelted. Professor Wilhem H. Steeruwitz, a well-known geologist who visited the area in 1878, and reported the prescence of gold and silver, but it wasn't until 1882 that Spencer found enough color to pay off. The vein seemed to have a high ore content, at least the assayers at Ft. Davis seemed to think so. Capital was managed from some California investers.

Spencer began the Presidio Mining Company with W. S. Nayes as president, Lt. John Bullis & General William R. Shafter of Ft. Davis as principal interests.

Because of the terrain that the holdings were in everything had to be brought in by wagon. The machinery was transported to Paisano Pass on the Southern Pacific Railroad and hauled to the mine site by wagon.

Humpries and Company of Marfa supplied

four thousand cords of wood every year because timber was scarce in the Chinati's. The Company even brought wood from Mexico, in spite of the problems.

Marfa was pushing for the market for the miners. The local editor predicted. He figured Marfa would boom especially when investors from the East started to flock in.

But what profits there were came through Shafter, which was built by the Company for the miners, and the venture was a success. The Shafter mine changed hands in 1910. The new owners introduced a new cyanide process using oil as fuel, taking place of wood which was getting harder to come by.

In 1913, the 50 ton mill was replaced by a 300 ton mill, which made it possible to treat 600 tons of ore in one day.

Veins were as rich as \$500 per ton but there were some that only brought \$8 per ton.

They tunneled through the mountains a hundred miles with shafts in all directions but taking out \$20,000,000 in silver.

At times the mines employed as many as three hundred men who came from over thirty different countries. It was probably the first completely company built town in the entire country. Shafter had a clubhouse a hospital, a boarding house, family houses & everything needed for the miners.

When I came through old Shafter a few weeks ago, there were a few people living there. The smelter and parts of the buildings are still standing. When the silver ran out, mining came to a stand still.

Bored with chicken? Try this bold and spicy variation of that

- Whole Chicken Breasts, Skinless and Boneless

- Whole Chicken Breasts, Skinless and Bonelet Tablespoons Oil Cup Onion, Sliced Thin Cups Mushrooms, Sliced Thin Tablespoons Garlic, Minced Cup Celery, Chopped Tablespoon Dregano Tablespoon Basil Cups Green Pepper, Sliced Cups Tomatoes, Peeled and Diced Cup Dry White Wine Tablespoons Lermon Juice Teaspoon Crushed Hot, Red Peppers Tablespoon Margarine Freshly Ground Black Pepper Tablespoons Fresh Parsley, Finely Chopped

Split chicken breast in half lengthwise; cut into 1/2-inch cubes and

set aside.

Heat oil in a large skillet, sauté onion until translucent. Add mushrooms and cook over medium heat until liquid evaporates; then add garlic, celery and spices and cook for 1 minute. Add peppers and cook for 2 minutes. Stir in tomatoes and cook for about 5 minutes. Add wine, lemon juice, hot pepper and mix. Set aside.

In another skillet, heat half the margarine. Add half the chicken and sprinkle with black pepper. Cook over high heat, stirring frequently, until pieces are evenly and lightly browned. Do not overcook. Transfer chicken to separate dish. Repeat procedure for remaining chicken and then return the first batch to the skillet.

Pour creole sauce over all and stir gently to blend. Simmer together for about 1 minute. Sprinkle with parsley and serve.
