

Sheriff Hooten was appointed in 1982 to serve the unexpired term of Morgan Bailey. He was successfully elected as Sheriff in 1984, and again in 1988 with an overwhelming majority. Sheriff Hooten served as the Brackettville Chief of Police for two years prior to his appointment as Sheriff in 1982. He served as the Kinney County Constable for four years, 1976-1980, before he became the Chief of

Sheriff Hooten was presented with the Kinney County "Man of the Year" award by the local Chamber of Commerce in 1981. In 1982, he earned an "Outstanding Service Award" and a letter of acclamation from the Brackettville Mayor for his dedicated professionalism as the Chief of Police. In 1987, Sheriff Hooten was selected by his fellow law enforcement officers as Vice-President of the Southwest Texas Law Enforcement Officer's Association. He is also an active member of the Texas Sheriff's Association.


There was one thing our report reflected low on, that has to do with the number of reference transactions.

I believe there are several things that contribute to this: one, is the limited time the staff is able to spend in each reference transaction. With the steady increases the annual reports reflect, staff's time will become more limited still. Two, a limited book budget. The cost of reference material is rather costly, therefore, the reference collection has suffered. Three, are most of you not aware that the library offers this service?

In next week's column I'll discuss what a reference transaction is and possible solutions to our problem. Suggestions from the public are most welcomed. Let's improve the number of transactions handled at KCPL in 1989.

IT'S TAX TIME AGAIN. IRS Forms are available at the Library. If you can't find the IRS Tax Form you want, ask to use Publication 1132 which contains over 90 different forms. You may use our copy machine AT YOUR EXPENSE to copy forms.

Remember, the Internal Revenue Service (IRS) has asked us NOT to provide tax advice since we haven't been trained in the area. However, to help us be of service to you, the I.R.S. put together a publication which may help answer your tax questions, how to get any tax forms or publications that we do not have available in our library, plus other types of information that will help you in preparing your 1987 Federal Tax Return.



The Osage Indians were moved from Missouri to Kansas according to the Treaty of 1847. Later they were moved to Indian Territory.

I lived on the Osage Reservation in Okalahoma because the Oil Co. my father worked for had purchased drilling rights from the Osage Tribe in the early 1920's. We lived sixteen miles from the Agency. But in the 1800's the Indians were treated by the Indian Agent exactly as he saw fit, which was not good. In my time the Indian Agent's name was highly respected by the Tribe.

John Joseph Mathews was a rancher, historian, naturalist, novelist, pilot, author, scholar, and thinker. When he died in June 1979, John Wayne and John Joseph shared more than the same date of death, more than being a friend of Oklahoma native Ben Johnson. They lived their lives convinced that being themselves was the most important thing in life, and neither John Wayne or John Joseph Mathews will ever be fogotten. They were living symbols of all American courage.

Joe was an Oxford man who had seen the world but chose to build his home in the Oklahoma "Blackjacks". The old Osages will

remember how he could speak their language and was a man who would listen. His long and lusty life ended Monday, June 11, 1979. His writings of the Osage Tribe will live on. "The Osages; Children of the Middle Waters" will live on in those of us who read them. His book "Wah'-Kon-Tak" I have read several times.

The Osage had great dignity, they were tall, some of the men were over six foot. They were aggressive and great fighters with enemy tribes. In later years the tribe wanted to be classed as the sixth civilized Tribe, but this never happened, however they formed their own council, police force, and other departments of self government.

John Joseph Mathews story of the Osage, called "Wah'-Kon-Tah", which means the Great Spirit of the Osages, using the journal of the former Agent Major Miles and his own memories wrote a powerful and unique book about the Osage Tribe. In short it is a book about the "good earth of America."

When I lived among the Osages they had already became rich from their oil royalties. Some could handle sudden riches and some couldn't just like that of other cultures in similar situations.

It is said that when a great Indian leaves this world, the prairie chickens will stop dancing long enough to pay their respects. I'm sure at John Joseph's funeral the respect was fully paid by everyone who knew him or read his writings and they will always remember the Indian boy who combined his memories of the reservations with that of the beloved white Indian Agent to write about the Osage.

#### LETTERS TO THE EDITOR

#### Dear Editor,

I would like to express some of my opinions and concerns regarding the NORM site being proposed for Kinney County.

First, there is the question of why Kinney County was selected? We were told it was due to the geological conditions of the proposed site. But when you consider all the facts, it's obvious how inappropriate the chosen location really is.

The Texcor/BFI site is:

Located 1/2 mile from a community,

Located in an area with abundant

wildlife and extensive livestock raising, Located in an area where groundwater is

found at 17ft to 35ft, Located in the Rio Grande watershed,

Located in an area where rainfall can be as high as 49 inches (1987 was approx. 40 inches)

Located in an area where prevailing winds can carry radioactive wastes across two towns and a retirement/resort area, and

Located in an area where earthquakes have occured.

Below is a chart prepared for the California Waste Management Board showing which groups are most resistant (most likely to oppose a dump in their area), and which groups are least resistant (least likely to oppose a dump in their area).

There are many disturbing things about the material to be placed in the pit that Texcor left out of their promotional package. Some being:

\* Norm typically contains radium and emits radon gas

\* Background radiation levels in
Spofford would be raised

\* Gamma radiation, along with alpha and beta rays would be emitted

\* Health effects associated with exposure to NORM material can include cancer (lungs, liver, bone, lymphatic, leukemia), brain damage, birth defects, and chromosome damage, to name a few.

In regards to the presentation made to

the Middle Rio Grande Development Council by Texcor (Dec. 8th Cavalryman), Mr. Salsman failed to mention a couple of imporant actions taken by the council. First, the original resolution passed by the council was amended to include the wording "radioactive waste". Secondly, the amended resolution was unanimously passed by the council. The council director went on to express his full support of C.A.R.E. It was also stated that the area didn't need any additional potential problems, and the locating of a dump in the region would subject the whole area to other waste companies wanting to locate dumps.

Also there are those in the community who have accused C.A.R.E. of not being for progress. I really don't think anyone in C.A.R.E. has any objection to healthy economic development. Such as the continued growth of Fort Clark, the expansion of the border patrol, the opening of the State Park, etc.. There is a difference in being for sound economic development and being desperate enough to grab whatever is offered, without regard to the consequences.

All the money in the world can't buy the clean air, clean water, and clean earth we've been blessed with here. Especially money from an industry that shares responsibility for many of the environmental disasters happening all over the nation and around the world. Not to mention that BFI has had a history of quesionable business practices, including numerous violations for mishandling of waste, anti-trust suits, and price fixing.

I'm in agreement with Clay Carter of Alabama who said "Rather than assume that we have inherited our land, air, and water from our ancestors, we should regard these precious resources as borrowed from our children."

I fail to see how the locating of a dump that will remain radioactive and dangerous for thousands of years, could be an act of "good will" to the people of Spofford.

#### FINAL NOTICE

The U.S. Department of Agriculture, FmHA, has received an application for financial assistance from the City of Spofford. The specific elements of this action are to construct a new water transmission main from Brackettville to Spofford, along with the construction of a new distribution system within the City.

FmHA has assessed the potential environmental impacts of the proposed action and determined that the location of the transmission line will be within the one hundred year floodplain at the following location as designated on the U. S. Department of Housing and Urban Development Flood Insurance Rate map:

where Imperialist Creek crosses State Highway 131,

approximately 7 miles south of Brackettville -

approximately 2000 feet.


FmHA has determined there is no practical alternative to the laying of the water transmission main through the floodplain for service to areas beyond and outside of the floodplain that are worthy of service.

Adverse impacts to the floodplain will be mitigated by prohibiting the extension of service in the floodplains in the form of new water service to structures not existing in the floodplains as of September 1, 1988.

With the incorporation of the mitigation measure, FmHA has determined that the locational impact is minor to the extent that the floodplain or wetland natural value or functions are not affected.

No other federal agencies are participating in the proposed action.

Any written comments concerning this determination should be provided to Mr. Charles B. Hart, Community Program Loan Specialist, Farmers Home Administration, 101 South Main, Suite 102, Temple, Texas 76501. FmHA will make no further decisions regarding this proposed action during this fifteen days. Requests to review the FmHA environmental assessment upon which this determination is based or to receive a copy of it should be directed to Mr. Don T. Mathis, District Director, Farmers Home Administration, 1001 Main Street, Junction, Texas 76849.



Services were held Thursday December 29th at 2p.m. at Frontier Baptist Church with Rev. Joe Townsend officiating.


A trust fund has been set up for the family at the First State Bank of Brackettville by the Brackett Volunteer Fire Dept. for all those who wish to donate.

Larry was killed in a traffic accident Christmas Day and Albert passed away at his home New Year's Eve night.

Larry was a familar figure around Brackettville and Kinney County and was always eager to lend a helping hand in any situation. Though small in stature he was a giant in heart and spirit. You could always count on Larry to be there in any emergency situation, eager to assist in anyway he could to ease the burden on emergency personnel and/or victims at the scene. He was a member of the Kinney County Volunteer Fire Department for many, many years and was almost always among the first responders to the fire station when a fire alarm was sounded.

Larry was put to rest Thursday afternoon, December 29, 1988 and the respect, admiration, and affection with which he was held was demonstrated by one of the largest group of mourners I have ever seen in Kinney County, with representatives from various law enforcement agencies and fire departments in attendance along with many friends and family members. It was fitting that the long funeral procession that took him to his final resting place was led by the bright red fire truck of the Kinney County Volunteer Fire Department followed by the bright red car driven by the Del Rio Fire Chief.

Larry will be sorely missed by friends, family, and Kinney County, but the memory of his energy, his big heart and spirit, and most of all his compassion for his fellow man will live on forever with those of us who knew him. Rest in Peace my friend.

Albert Postell died quietly at his home Saturday night, December 31, 1988 after returning from his ranch in west Kinney County. Albert was President of the First State Bank of Brackettville for many years and was Justice of the Peace of Kinney County for 21 years in addition to being County Judge for eight years. Albert was a true friend to many Kinney County citizens and will be sorely missed by friends and family. He had been in ill health since being involved in a near fatal vehicle accident several years ago in which he was severely injured. I was his next door neighbor for several years and even long after I had moved to another part of town he still greeted me every time he saw me with a friendly, "H1 Neighbor." Rest in peace, Neighbor.



We have several cases pending that will be presented to the Kinney County Grand Jury at their next session which is scheduled for Friday, January 13th. At that time the Grand Jury will consider evidence we have in drug cases, assault cases, and others.

We recently aquired another vehicle that was forfeited by default on a drug cases filed against a San Antonio man by DPS Narcotics Agents. The man was passing through Kinney County after spending time in Mexico with a friend. He was tried and found quilty in District Court on a plea bargain agreement. The vehicle was only recently awarded to the Sheriff's Department and no decision has yet been made as to the disposition of the vehicle. We also have two other vehicles in custody after the drivers were charged with Aggravated Possession of Marihuana. These also were transporters passing through Kinney County via Hwy. 90 enroute to points East. Narcotics agents believe that there is a well organized drug ring based in Mexico with associates in Del Rio that is responsible for the recent heavy traffic of illegal drug smuggling in this area. It is also believed that due to the pressure being put on the smugglers by law enforcement officers along Hwy.90 the drug smugglers will soon change their route for awhile in an attempt to avoid detection and apprehension.
