NEW LOOK FOR BULLIS HALL

VOTER REGISTRATION BEING UPDATED LIST

The Kinney County Tax Assessor Collector's Office is in the process of updating the current voter registration list. This is being done on a precinct by precinct basis. We are verifying all permanent residential addresses as well as mailing addresses. We have started with Precinct #3 of which 47 notices of examination have been sent along with 23 voter registration change forms. As time permits each of the 4 precincts will be processed in a similiar fashion. This is an apperture time to update our list due to the following reasons:

- 1) This is not an election year.
- This will help the County Court in their efforts to redistrict the voter population after the 1990 census.
- 3) All jury lists are selected from the voter registration list, therefore updating the voters list will facilitate this procedure.

Any voter whose residential or mailing address has changed, please notify the tax Office so that we can make those necessary changes on our lists. In addition we encourage any qualified voters who are not presently registered to do so.

PORK CHOP SCALLOP

4 pork loin or rib chops 1/2 to 3/4 inch thick

1 pkg. scalloped potatoes (dry) 2 tbsp. chopped pimiento (opt)

pepper

Grease 10inch skillet with shortening. Brown chops on both sides, season to taste. Remove chops from skillet. Empty potatoes and packet of seasoned sauce mix into skillet. Stir in pimento and amounts of water and milk called for on package. Heat to boiling, stirring occasionally. Reduce heat; place chops on top. Cover: Simmer 30-35 minutes until chops are tender. 4 servings.

HINT!!! Buy the pork chops when on sale, freeze them in 4 servings. You can have this when you want pork but not the expense.





ECONOMIC INJURY DISASTER LOANS AVAILABLE

SAN ANTONIO, Jan. 17, --- Mr. Julio Perez, District Director, San Antonio Small Business Administration (SBA) Office, announced that the following counties are eligible to submit applications under the Economic Injury Disaster Loan (EIDL) Program from eligible small business concerns:

> Bexar, Dimmit, Gonzales, Kinney, LaSalle, Uvalde, Webb

EIDLS were the result of drought conditions which occurred January 1, through August 31, 1988 and continuing.

In addition to the primary declared counties, the following counties are contiguous and also eligible for EIDL assistance:

> Atascosa, Bandera, Bastrop, Caldwell, Comal, Crockett, DeWitt, Edwards, Fayette, Frio, Guadalupe, Karnes, Kendall, Lavaca, Live Oak, McMullen, Maverick, Medina, Real, Val Verde, Wilson, Zavala.

The interest rates for loans processed under this designation are 4% for small concerns and small agricultural cooperatives without credit avalable elsewhere.


The traditional Shrove Tuesday pancake supper will be held again this year at St. Andrew's Episcopal Church in Brackettville, according to the REv. Bill Koons, vicar. Serving of pancakes and sausage in quantities commensurate with diners' appetites will be from 5 p.m. till 7:30 p.m. Tuesday, Feb. 7. in the parish hall of the church at Fort and Henderson Streets. Fare will be \$3.50 for adults and \$2.00 for children under 12. Tickets may be purchased from local Episcopalians, at Kinney County Land Company, or at the door on Shrove Tuesday.

Pancake suppers on the night before Ash Wednesday are traditional meals in the Anglican Communion, having roots in early England. The day gets its name from the old requirement one confess his or her sins on this date in order to be "shriven" before Lent. Pancakes became popular on this day as cooks used up fats in the house before the rigorous fast days of Lent.

St. Andrew's Church for a number of years has used its annual pancake supper as a means of sharing this tradition with others, as an opportunity for community fellowship. and as a fund-raising effort for its building and improvements fund.

Ash Wednesday services at St. Andrew's Episcopal Church this year will be at 6 p.m. Wednesday, Feb. 8, and will be a Rite I Holy Eucharist and Imposition of Ashes, according to the Rev. Bill Koons.

The first day of the Church's 40-day penitential Lenten Season, Ash Wednesday traditionally has been a time when Christians are reminded as abses are placed on the foreheads by the priest of their mortality as he repeats, "Remember that you are dust, and to dust you shall return."





ARBOR DAY CELEBRATED

The Fort Clark VFW Post 8360 celebrated Arbor Day this year by planting a live oak tree behind the NCO building at Fort Clark Springs. Arbor Day is celebrated in southern states at various times between the months of December and March. It symbolizes respect for nature and naturalists who have helped preserve our nations' wooded resources. Many schools and youth groups plant trees on their chosen Arbor Days as a pact to protect trees and natural resources for the future.

Arbor Day began in Nebraska. Newspaper publisher, Julius Sterling Morton, realized that planting trees would help conserve soil, and enrich everyone's living environment. Through his efforts, April 10, 1872, was set aside as Nebraska's first Arbor Day. The Nebraska state government offered prizes to the groups and






AT ISSUE

'Interest Section' in Vietnam?

Congressman Tom Ridge (R-Pa.) is a member of the House Veterans' Affairs Committee and is a decorated Vietnam combat veteran.



Why do you support establishing an "interest section" in Vietnam?

An interest section provides countries a working presence in the capital of another through a third party embassy. The U.S. has maintained an interest section in Cuba since 1978 through the Swiss Embassy. We must improve our efforts to resolve many important and lingering humanitarian issues with Vietnam—POW/MIAs, Amerasian children, emigration, release of political and re-education camp prisoners, and withdrawal from Cambodia. We have not enjoyed sufficient progress in these matters for 13 years. We must redirect our efforts. We can do so and not undermine any previous arrangements or successes through the establishment of interest sections.

Is such a change in policy tantamount to recognizing or rewarding the Vietnamese government?

On those rare occasions when the U.S. has adopted this arrangement with a foreign government, it has never been interpreted by anyone to be anything more than a special working arrangement to facilitate communication. It cannot even be construed as a first step toward formal diplomatic or economic ties. Admittedly, the Vietnamese have been a continuing source of frustration, disappointment and even anger. However, we must not lose sight of the fact that it is in our best interests to resolve these matters. To oppose interest sections is to conclude that progress to date and the status quo are satisfactory.

Should preconditions be met before we establish interest sections with Vietnam?

While there should be no formal list of preconditions, the Vietnamese must understand that there can be no linkage between the humanitarian issues for which the interest sections are established and diplomatic recognition or economic aid. When we are substantially convinced that Hanoi has abandoned its inconsistent and erratic approach toward the resolution of these issues and is committed toward sustained, good faith negotiations, we should take the initiative and propose such an arrangement.

Why do you oppose establishing an "interest section" in Vietnam?

The U.S. has publicly linked steps toward normalized U.S.-Vietnam relations to a full withdrawal of Vietnamese occupational troops from Cambodia. Premature normalized relations would reduce Hanoi's incentive to withdraw and would be seen by our ASEAN (Association of Southeast Asian Nations) allies as a softening of our Indochina position.

A step toward normalization would induce a flurry of economic activity into the Vietnamese market by other Western nations, causing the collapse of the aid embargo against Vietnam.

Despite arguments for cooperation on accounting for U.S. soldiers missing in action, Vietnam isn't about to loosen its tight hold over its society and allow U.S. personnel to search the countryside for MIAs and POWs.


Lastly, Vietnam has insisted that the U.S. reciprocate with an interest section in Washington. Such an enhanced presence could steer U.S. policy toward a softer line on Cambodia before a military withdrawal is achieved.

Would such a change be tantamount to recognizing or rewarding the Vietnamese government?

Yes. Regional powers and Vietnam itself would view it as a "reward." Hanoi will be certain to rationalize its harsh social policies and aggressive foreign policies by pointing to U.S. "recognition." Moreover, establishment of interest sections would be seen by the American public as compliance with Vietnam's terms.

Should preconditions be met before we establish interest sections with Vietnam?

Vietnam sees normalized relations as the key toward receiving large-scale economic aid from the West. Preconditions should include a complete withdrawal of military forces and civilian advisers from Cambodia, followed by internationally supervised elections; a complete military withdrawal from Laos; an accurate accounting of all U.S. MIA discrepancy cases; and concrete moves toward significant reduction of Vietnam's armed forces.



The speed king of the southwest is the long-eared jackrabbit. Through the years people who live in jackrabbit country have argued about how fast he really is. So one time a motorcycle club decided to find out. Resulting in the report that a jackrabbit can go about fifty miles an hour for a quarter of a mile before tiring. He is not really a rabbit at all, but a hare. The white-tailed jackrabbit is the biggest hare of all, being about 25 inches long. The jackrabbit is so numerous and does so much damage to gardens and other crops he is slain by hunters by shooting, trapping, poisoning and other means.

Rabbit roundups are still held sometimes in many places just like a cattle roundup.

Several years ago the town of Odessa, Tx. introduced to the world a new cowboy carnival. They built a small arena and turned jackrabbits into the arena and a cowboy on foot was timed and prizes were given to the fastest ropers. One time the local sheriff won first prize.

Some of the citizens tried to have it stopped because they said it was cruelty to rabbits. But because the cowboys were used to riding and not walking they had sprained ankles and sore feet. So the roundup was finally judged cruelty to cowboys.

There was a famous basesball player of yesteryear named Pepper Martin. He was from Oklahoma and noted for his speed as a runner and stole many bases. One of his friends said the reason he was such a fast runner was because Pepper was raised in a jackrabbit country and as a boy, he caught jackrabbits for a living. He said Pepper would run along side of a jackrabbit and feel of him to see if he was fat and if he was fat enough Pepper would pick him up and drop him in a sock. If that legend were true, Pepper Martin would be very fast indeed.

BOB BULLOCK

AUSTIN--State Comptroller Bob Bullock on Monday sent checks totaling more than \$10.5 million tyo 221 counties and 437 cities that tax mixed drink sales.

The checks represent the counties' and cities' share of the state's 12 percent mixed drink tax collected during the fourth quarter of 1988.


Bullock said that the state collected \$43.6 million in mixed drink taxes for the fourth quarter, compared to \$43 million collected during the same period in 1987.

Texas cities and counties each receive a 12.5 percent share of the tax collected on mixed drinks sold within their boundaries under the lawthat legalized the sale of mixed drinks in the state.

Of the total \$43.6 million in state collections, counties received \$5.4 million, up from the \$5.3 million received in the fourth quarter of 1987. Cities received \$5.09 million, slightly more than the \$5. million rebated to cities last year for fourth quarter collections. The state's general revenue fund received the balance.

Bullock said the \$33.1 million balance was deposited in the state's general revenue fund from fourth quarter collections, an increase compared to \$32.6 million collected in the fourth quarter of 1987.

The mixed drink tax is collected by the Alcoholic Beverage Commission and city and county rebates are sent by Bullock's office.

CEDAR FEVER A WINTER ANNOYANCE

Every year, some people suffer through the colder months with what feels like a head cold, combined with itchy eyes, headaches, general tiredness and other symptoms, just because they breathe the brisk outdoor air.

Allergy sufferers are plentiful in Texas, especially in the central region and hill country. And December and January are some of their worst months, according to the Texas Department of Health (TDH), since the onset of colder weather invariably brings"cedar fever."

Cedar fever is an allergic reaction to the pollen of male mountain cedar (actually two species of juniper), which grow wild throughout Texas. The male trees have timy green cones which turn brown, spring open, and release a yellow pollen onto the winter winds.

The minute, sticky, pollen grains irritate the eyes and sinuses, and enter the sufferer's respiratory system, triggering an allergic reaction.

Allergy specialists say that cedar fever is second only to ragweed allergy in the number of Texans it affects. And its severity may be greater. Even persons who are able to resist other allergens may fall victim to cedar fever. And for reasons not fully understood, some may react more severly in one year than in another.

In most cases of cedar fever, the reaction is uncomfortable, but temporary. Milder cases may be successfully controlled with over-the-

NOTICE OF INTENTION TO INTRODUCE A BILL PROVIDING FOR LOCAL OR SPECIAL LAW IN THE EDWARDS AQUIFER REGION


Notice is hereby given of the intention to introduce a bill in the 71st Texas Legislature affecting all or parts of Kinney, Uvalde, Medina, Bexar, Comal and Hays Counties. The general purpose of the intended law is to authorize and direct the Texas Water Commission to develop rules for the adjudication and administration of groundwater rights in the region of the Edwards Aquifer. Such rules shall be developed by January 1, 1990, shall take into account municipal, agricultural, industrial, environmental and recreational water needs, and shall provide for the recognition of grandfathered rights. The intended law shall further provide that the Texas Water Commission may delegate enforcement of such rules to other political subdivisions and governmental agencies

NOTICE OF INTENT

To give notice of the intent to introduce in the 71st Legislature, Regular Session, a bill to be entitled an Act relating to the development of a groundwater management plan within the boundaries of the Edwards Underground Aquifer, and implementation and enforcement of that plan.

counter antihistamines. However, TDH advises that anyone with severe or persistent symptoms should consult a physician. Prolonged irritation of the sinuses or throat can lead to infections, or may be signs of other illness.

Also, anyone with histories of serious respiratory diseases may be advised to seek treatment by an allergy specialist.


