


CONGRATULATIONS DR. HARBER!!

Health & Nutrition by Judith Sheldon

THE FACTS ABOUT MOISTURIZERS: I recently received a sample of a new moisturizer that will be on the market in a few weeks. It promises to do what other moisturizers cannot do: go beneath the skin and nourish it from within. The result, the release says, is a smoother, younger, age-resisting skin.

The facts are that while moisturizers can be helpful, they do not affect the aging process, nor, fortunately, can they be absorbed through the skin. And that includes the relatively new collagen creams. (Think about it; would you really want all that undoubtedly germ-laden glop in there?)

To understand what moisturizers can do, it's important to understand what your body already does for your skin: natural moisture - water, oil and salt - is continually produced in the deeper layers and pushed upward. This moisture is lost through evaporation, winds, dry indoor heat, etc. There are two types of moisturizers which can

Type One: Emollients - Like the skin's natural oils, they create an oily barrier that minimizes evaporation of the skin's moisture. Examples of emollients are petroleum jelly, lanolin, mineral oil.

Type Two: Humectants — These work by attracting moisture and holding it on the skin surface. Examples of humectants are glycerin, lactic acid, urea, and sorbitol.

'Consumer Reports' magazine tested 48 moisturizers. They found the most effective were the least expensive, and also had the fewest ingredients such as perfumes, emulsifiers, thickeners and the like. These were also best for people with sensitive skin, or who are prone to allergic

MOTHER RUNS BEST: Motherhood can enhance athletic performance. Runners such as Mary Decker Slaney and Valerie Brisco, golfer Nancy Lopez, diver Pat McCormick, tennis champs Evonne Goolagong Cawley and Margaret Court Smith not only equalled past feats after giving birth, but also topped them. This was true, too, for ballet star Natalia Makarova.

NURSING CARIES: Caries, or cavities, can develop in babies' teeth when they fall asleep with the bottle in their mouths or at their mothers' breasts. Bacteria turns the unswallowed milk, juice or formula into acid, which can then cause cavities.

To avoid nursing caries, remove the bottle when the baby falls asleep. When the first teeth appear, wipe them with a clean damp wash cloth or gauze to remove plaque; do this daily, preferably at night. If you see white or brown spots on the teeth, seek dental help immediately. If these cavities are caught early enough, treatment can be relatively simple and painless. Ask your pediatric dentist or pediatrician about fluoriodes. Start regular dental visits by age two.

EBERT RE-ELECTED, HAGA RETURNS TO FORT CLARK BOARD

Mrs. Dorthy Haga will serve again on the Fort Clark Springs Board of Directors. Mrs. Haga and Director Vern Ebert were selected a field of six candidates to serve 3year terms on the governing board of the 2,700 acre community that was once a U.S. Army base. Election results were announced at the General Membership Meeting at Town Hall on March 25.

Mrs. Haga served on the Board of Directors from March of 1981 to March of 1987. She is the first woman to complete a term on the board, and the first person to be elected by Fort Clark Springs members for a second consecutive term. She and her husband, Jim, moved to Fort Clark Springs in 1980.

Director Vern Ebert was re-elected after completing a one-year term due to the resignation of Mary Hobart Key. He and his wife, Betty, moved to Fort Clark Springs from Wisconsin in 1983.

Shortly after the election results were announced on March 25, the new directors joined fellow directors Emet Huntsman, Dr. Lonnie Green, Guy Hibler, Molley Ardrey and Ralph Beard in the Association Board Room to elect officers. 

On St. Josephs Day, the swallows come back to Capistrano, on the California Coast. Everyone gathers at the old mission and watches them come flying in as they have done for more than two hundred years.

The barn swallow has perfect grace, he skims low over the land, darts up again; he is after the flying insects in the air. He builds his nest under a rafter or any other place his mud dauber nest will cling. With the insect caught he flies back to his nest without missing a beat of his wings and never makes an awkward movement.

They are daring in flight but for all that they are friendly to each other. They often build their nests close to a door as if to enjoy the company of people.

Every spring they come back to the same nesting site. There are usually two broods a season and four or five white eggs in both. Sometimes the first brood helps the parents feed the second brood. Only is this done by the swallow, no other bird performs this remarkable service.

These unique birds range far and wide from Florida and California to Brazil, Argentina and Chile and as far as Alaska, Quebec and Newfoundland. Their speed in the air surpasses the hawk and other enemy birds so they can travel freely in daylight. They eat insects which they capture while in flight. Of course, you can't chase an insect in a straight line which explains their erratic flight.

This is the little bird you see skimming along the top of a pond after water bugs or maybe a little sip of water. He does this entirely with his bill as he swoops down and doesn't wet a feather. If he wants a bath he dips down into the water, then flies to a nearby branch to preen in the sun.

The swallows around our part of the country are barn swallows. They are the only United States swallow that is truly "swallow tailed," and the only one with white tail spots. When flying the swallows song is a soft "vit,vit," or "kuit, kuit." Near their nest their song is a long musical twitter with guttural sounds in between.

Some people don't like the mess they make when they nest under eaves or door sills. But there is a place in the Bible that says many blessings will come to the house where the swallow build their nest.




OVER \$1,200,000 OFFERED TO TEXAS HIGH SCHOOL SENIORS


LIBRARY NEWS BY CINDY GUILFORD FALCON

Texas Elder Abuse Prevention Project Wins National Award

AUSTIN—About 35,000 low-income Texans may be eligible for payment of Medicare fees for federal catastrophic health care, according to Charles Stevenson, acting commissioner of the Texas Department of Human Services.

"The department will pay Medicare premiums, deductibles and co-insurance fees on Medicare-covered services for persons who qualify for the special penefits," Stevenson said.

He said these criteria apply:

- Persons must be enrolled in Medicare Part A.
- Gross monthly income cannot exceed \$429 for a single person or \$568 for a couple.
- · Countable resources may not ex-

ceed \$4,000 for an individual or \$6,000 for a couple.

 Persons must be at least age 65 or declared disabled by the Social Security Administration.

"Texas residents who meet these criteria should contact their local Department of Human Services office to explore eligibility as a Qualified Medicare Beneficiary," Stevenson said.

The federal catastrophic health care law requires the state to establish Medicaid coverage for individuals who are eligible for Medicare Part A, have incomes up to 85 percent of the federal poverty level and have resources no more than twice the limits for the Supplemental Security Income (SSI) program.







To the Editor:

I noted in the Mar. 23 Del Rio News Herald a news item announcing oppostition by State Senator Judith Zaffirini to the proposed radioactive waste dump site at Spofford. The same announcement was carried last week in this paper. At the end of the News-Herald article, TexCor spokesman Charles Salsman was quoted as saying "...none of the groups opposed to the facility has made an effort to listen to his company's side."

As a matter of fact, most of us in CARE (Community Against Radioactive Environment) have seen TexCor's slide show, and have handled samples of the plastic liner which, we were assured, will forever seal the 20 acre dump against any leakage. A number of us have toured the site. We have read and heard the glowing promises of jobs and funds which will flow from this "facility" even as the radioactive trash is planted forever in our midst. We even remember a repeated promise that the proposal would be abandoned if any opposition developed, among local residents.

TexCor representatives have not been deprived of opportunity to present their case. hundreds of residents have seen the slide show, and heard the arguments presented. Senator Zaffirini, in fact, has seen the slides and heard the sales pitch before she decided, as she did, to oppose the dump not only at Spofford but throughout the area she represents.

No, we have not refused to hear TexCor. We have, however, also read widely and attended meetings in many places and seen documentary TV and film presentations. We have sought out scientific data pertaining to radioactivity, and to geology, and to climatology, as these factors pertain to our area. The result of our efforts is overwhelming oppostition to the dump proposal for Kinney County. We do not oppose because we are uninformed, nor because we are unable to understand. We oppose because we have informed ourselves, and we do understand.

Further, we are certainly gratified that Senator Zaffirini, after similar and unbiased research, has joined us in our opposition.

Finally, Mr. Salsman is quoted in the News Herald as saying "It's really an emotional issue." We in CARE certainly agree with that. After learning all we can about the subject, we are emotionally (as well as intellectually) against the radioactive waste dump at Spofford. Our intellectual position is based on research and analysis. Our emotional opposition is founded on concern for the health and safety of this and future generations. We are emotionally opposed to having our environment and our way of life placed in jeopardy by corporations. Emotionally, we resent a state licensing system which has often disregarded citizen concerns when these oppose business proposals. Yes, this is an emotional issue, but it is also a social issue, and a health issue, and an economic issue, and a scientific issue, and an issue of justice. And after considering all these and other issues, an overwhelming majority of regional citizens are united in opposition to this proposal for a radioactive waste dump at Spofford.

DOLPH BRISCOE TO SPEAK AT FORT CLARK SPRINGS

Former Governer Dolph Briscoe, a current prospect for the 1990 Governor's race, will be the featured speaker at a historical building dedication ceremony at Fort Clark Springs in Brackettville on April 22, 1989. The former governor will speak at 2 p.m. in front of Fort Clark's Commanding Officer's Quarters, the Wainwright House, as part of a ceremony marking the home as an official Texas Historical Building. The ceremony is one of the activities planned for former Cavalry Troopers returning for their annual reunion at Fort Clark Springs the weekend of April 21-23.

Born in Uvalde in 1923, former Governor Briscoe served in the Texas Legislature from 1949 to 1957, during which time he was cosponsor of the important Cholson-Briscoe Farm-to-Market Road Program. He began his first term as Governor in January of 1973, and served his second consecutive term as Governor until January of 1979. Briscoe was the first Governor to serve a 4-term as approved in a constitutional amendment passed by voters in 1972.

The former governor will be introduced during the April 22 dedication ceremony by fellow rancher and longtime friend, James T. "Happy" Shahan. Widely reguarded as "the man who brought movie-making to Texas," Shahan traveled with Briscoe in 1968 during his first bid for governor, and again in his successful 1972 election.

. Governor Brisoce served Texas during the turbulent years from 1973 onward when Texas, like the rest of the nation, was caught in a severe energy crisis caused by an Arab oil

producer's boycott. Oil production in Texas surged, as did state revenues, which were also boosted from increased sales tax revenues from inflation-priced goods.

Then Governor Briscoe oversaw Texas state spending during the years when it grew from \$2.95 billion in 1970, to \$8.6 billion in 1979, according to the "Texas Almanac." Spending for education advanced in the Briscoe years form 42 percent of the total state budget in years 1970-71, to 51.5 percent in the 1980-81 budget, according to the "Texas Almanac."

In recent years, former Governor Briscoe has concentrated on his vast ranching and banking enterprises. He is chairman of the Board of the First State Bank of Uvalde, and the Security State Bank in Pearsall. He is a director of Lomas & Nettleton Financial in Dallas, and MCorp, also in Dallas. He was appointed to the University of Texas at San Antonio Development Board in January of 1987. The library at the Health Science Center at the University of Texas San Antonio campus is named in his honor. In March of 1987, former Governor Briscoe was awarded the International Citizen's Award by the World Affairs Council of San Antonio.

Former Governor Briscoe is past chairman of the Mohair Council of America, based in San Angelo, Texas, the Southwest Animal Health research Foundation, and the National Livestock and Meat Board, based in Chicago Illinois.

He is married to the former Betty Jane Slaughter, and they have three children: Mrs. Janey Briscoe Vaughan, Dolph Briscoe, III, and Mrs. Cele Briscoe Carpenter. The Briscoes have six grandchildren.

MAVERICK ARMS, INC. IN EAGLE PASS OPEN PLANT

More than three hundred persons turned out this week for the official grand opening of Maverick Arms, Inc. in Eagle Pass. The new plant, which assembles shotguns, is a subsidiary of 0. F. Mossberg Company of Connecticut. They will employ more than forty people in their first phase of operation.

In his opening remarks Mr. Alan Mossberg, President, explained how the company decided on Eagle Pass. "I drew a line from our parts manufacturer in Torreon, Mexico to North Haven Connecticut and contacted all the regions in between to see what they had to offer," Mossberg explained. "Eagle Pass and Maverick County won out," he added.

The Maverick County Development Corporation, Eagle Pass Chamber of Commerce, City of Eagle Pass, Maverick County, NBC Bank, Frontier State Bank, Central Power and Light, Middle Rio Grande Development Council, Southwest Texas Junior College and the State of Texas all played an important role in the company's decision.

According to Maverick County Judge Rudy Bowles, President of the Middle Rio Grande Development Council Board, it was profits and people, not give away incentives that brought the company to EAgle Pass. "All of the groups really pulled together to offer strong service, research, and support," Bowles stated.

Bowles singled out MRGDC Planning Director Greg Davenport and Planner Carlos Pereda for their work on all phases of the project.

"They were able to help the company analyze all the alternative methods of financing and structuring the deal and come up with a plan that worked for both the company and the community. Maverick Arms wants to be a part of this community for a very long time to come," Bowles explained.

The plant already has orders for more than 35,000 shotguns. According to Maverick Arms President Steve Glick, the Company is very pleased with the area and is already contemplating an expansion. "The quality of the labor force and the training program has been outstanding," Glick told the audience.

The Southwest Texas Junior College under the guidance of Dr. Robert Aguero, worked with the company to develop a special curriculum and training program. Funds were secured by the Middle Rio Grande Development Council from the State Industrial Start Up Fund. The trainees learned blueprint reading, firearm parts terminology, quality control, gun safety, and related subjects.

"All of the employees are from the JTPA jobs training program sponsored by the Middle Rio Grande Development Council", Glick explained. "I can certainly recommend JTPA based on the positive results we have had," he added.

According to Arthur Pine, Executive Director of the Maverick County Development Corporation and the Eagle Pass Chamber of Commerce, the building for Maverick Arms was built by the Maverick County Development Corporation with financing provide by NBC Bank. The loan is secured by a long term lease and other special provisions.

Pine, who served as project manager noted that the building was completed on time and within budget. "We were able to use local contractors and labor for almost all of the building," Pine noted. The dedication was the culmination of a year's efforts by the private sector working in partership with all segments of the community. This project certainly demonstrates why we say Eagle Pass is business friendly," Pine added.

MRGDC Chairman Mike Holley and Chamber President Michael Miller agree that the project marks a new era for Eagle Pass. "We are being discovered, partly because of the maquiladora program," Holly noted.

"The next few years will see a lot of new growth in this area," Miller predicted.

Ernesto Ancira, Commissioner for the Texas Department of Commerce was on hand for the dedication and a tour of the area. "There are many exciting projects going on in this region," Ancira noted. 
DOWNED POWER LINES - THE LOADED GUN

When an overhead power line is downed by accident or weather, it's not necessarily dead -- but you might be unless you stay away from it! An electrical power line is due the same respect as a firearm. Just as there is no such thing as an unloaded gun, there are no dead power lines.

A downed line that seems dead may be reenergized by a lightning strike on the line, contact with other power lines or interaction with another source electricity somewhere back down the line. This may happen without warning or opportunity to break contact.

High voltages may be transmitted through materials other than metals. A wooden pole, a fiber rope or other normally non-conducting materials may carry electrical current if they become wet or soiled. The loose ends of the conductor may also energize the wiring, plumbing or steel supports of structures, metal fences, telephone or cable television systems, and vehicles. Green tree limbs will conduct electricity.

Given the wrong set of circumstances, a current will go to ground in you. Don't give it the chance! Handle it saflely by not handling it at all. Keep others away and give your electrical utility a call.


MAY LOWER YOUR LAND'S **PROPERTY TAXES**

Texas law allows farmers and ranchers to lower their property taxes through agricultural appraisal of land.


If you qualify, your agricultural land will be taxed on its capacity to produce crops, livestock, or timber, instead of its value on the real estate market. This can lower your property taxes.

If your land has never received agricultural appraisal, you must apply to the appraisal district by May 1 to get tax benefits for 1989.
