

VANDALISM STRIKES KC AGAIN

Another hunting camp/ranch has been vandalized and trashed. Leon Gentry who has a hunting camp on the Ranch Estates on Pinto Creek Road, Brackettville returned last Saturday morning, April 22, 1989, to find his mobile home, travel trailer and hunting trucks totally destroyed.

Mr. Gentry reported that he has been vandalized before in the six years that he has been living and hunting there, but never like this. He had installed steel bar doors on the mobile home and bolted them through the wall and these were ripped out. All the glass and mirrors were broken in the buildings and the trucks, furniture was tipped over, slashed and cut open. All the dishes and pots and pans were broken and strewn about. Walls were painted with black spray paint, personal belongings were thrown about the yard and all tires of the vehicles were slashed. Entry to the ranch was made easy after the gate and post it was attached to disappeared.

Mr. Gentry stated he has been hunting in this area now for 22 years, the last six were on the Ranch Estates. He and his six fellow hunters were slowly moving everything in and fixing it up. A reward has been posted for information leading to the arrest of person or persons responsible for the vandalism.

The pickup is a state of mind in Southwest Culture. Just check any parking lot and what do you see. You see an awful lot of pickups. On any back road you see In a pickup you can carry parked pickups. fence posts, firewood, dogs, tools, horse feed, kids, beer, anything that has to be moved from one place to another.

There are pickups with high, wide tires. A tall dog would trot under these pickups without getting one greasy hair. Of course, these pickups are driven with the radio shaking the pickup with hard rock. To support this kind of duded pickup calls for as much money as supporting a habit. These kind of hombres seldom use their pickups off the highway to keep his pickup as shiny as possible. These pickups are so tall you have a tough time just climbing aboard.

In the early days, cowboys invested in a Stetson hat, handmade boots and saddles. After all, wasn't their high stepping horse worth it.

The Texan who actually uses a pickup for his daily work is one who hauls feed for his cattle, hauls firewood, barbed wire, staples, post hole diggers, etc.

About the time the second World War was ending pickups came into their own. Until then the cowboy rode a horse and hauled his gear behind him on a pack animal, maybe the foreman had a pickup and a trailer.

Once ranchers started using pickups and good trailers there was a lot less hard riding and butt pounding. In fact, pickups meant using fewer cowboys, fewer horses and less time.

Pickups and heavier trucks helped control fires in the mountains because they could travel over difficult roads. Poaching could be better controlled by the game wardens, but that worked both ways because the poachers had pickups too.

In the 60's the pickup camper drove onto the scene, enticing city folks to get out in the country and wet a hook in some lake or mountain stream. The rougher the roads and more rural the population, the more pickups.

If a man and family had a small outfit and was trying to make his living, he had to have a pickup to do the hauling jobs and get from one place to another and keep bread on the table. He could use fewer hands and also get to the neighbors to trade help with them. After the work came to a stopping place, it was pile the kids in the back and go to town for supplies and a little R & R and don't forget the pickup is really more than all that. Maybe, the cowboys had the same feeling the Knights of Chivalry felt when he rode among the foot bound peasants.

Nowadays, you can pass any bar on any crossroads, with it's beer sign swinging in the breeze and it doesn't look much different

than eighty years ago. The pickups are lined up in front in a half circle, instead of hipshot horses switching flies at the hitching rail waiting for the cowboys to come out and

CP&L REFUNDS

Central Power and Light Co. customers will see a refund on electric bills they receive in May. April 19, 1989, the Public Utility Commission authorized a fuel refund of \$30.7 million.

The refund amount is based on CPL's savings from nuclear fuel, fuel overrecoveries, and \$2.3 million in interest for the period of January 1988 through February 1989.

Overrecoveries occur when CPL is able to purchase fuel at prices below its set fuel PARTICULAR AND PARTICULAR PROPERTY CONTRACTOR OF CONTRACT PROPERTY.

factor. Falling gas and coal prices, renegotiated fuel contracts and competitive fuel purchasing all contribute overrecoveries. CPL, like each of the nine investor-owned utilities in Texas, uses PUCapproved fuel factors. The fuel factor is listed separately on customer's bills, while another portion of the bill reflects base rate -- CPL's cost of providing service to its customers. (CPL filed a request to raise its base rates in February)

CPL had filed for permission to refund \$21.5 million in fuel savings in late November 1988. In addition to overrecoveries and interest, the company had proposed to include 27.5 percent of the nuclear fuel savings from operation of the South Texas Project, with the remainder of the nuclear fuel savings being used to offset STP's deferral costs. (Approximately 27.5 percent of the investment in the South Texas Project is reflected in CPL's current rates.)

Fuel refunds are normally considered administratively by the PUC, but nuclear fuel savings had never before been refunded by CPL. In early February the PUC staff decided to consider the request in a full PUC hearing.

"While we believe our original proposal would have saved customers more money in the long run by offsetting deferral costs, this refund method will allow our customers to see the full benefit of nuclear fuel savings from the South Texas Project," said Mark Roberson, CPL's director of rates and regulatory affairs.

It costs CPL about 50 cents to produce a million BTU's of heat using nuclear fuel. That compares to an average of more than \$2 to produce the same amount of energy using coal or gas. Over the life of the plant, STP is expected to save customers more than \$5 billion in fuel costs.

"We are pleased to be able to refund these savings to our customers. Since 1984 CPL has refunded more than \$200 million in fuel savings and interest," Roberson noted. "Our children are our most precious resource," Clements said. "We must ensure that taxpayer money is spent on quality academic programs, not wasteful practices."


Clements said effective management programs are a vital part of that effort, and must begin at the building design


The Energy Management Center anticipates that school districts that have requested waivers from the Texas Education Agency, or passed bonds in the past 12 months, will take advantage of this service.



FORMER GOVERNOR HAILS UNIQUE PRESERVATION EFFORTS

Calling Fort Clark Springs in Brackettville a shining example of unique historic preservation efforts, former Governor Dolph Briscoe dedicated the original cavalry post's Commanding Officer's Quarters with a Texas Historical Building Marker on Sat. April 22.

"What is happening here sets an example of what can be done with other National Historic Sites. It is a means through private initiative, towards preservation and practical utilization," said Briscoe, the Governor of Texas from 1973-79 whose name has been widely associated with the 1990 Governor's race. "Fort Clark today represents not just a museum of history of the past, but a living and vibrant way of life for the future," he added.

With the impressive 1873, two-story stone home as a backdrop, the former governor urged the crowd to express their appreciation to Dr. and Mrs. Moore of Baytown for working to preserve the home where Col. Ranald S. Mackenzie, Gen. Jonathan M. Wainwright and movie legend John Wayne once lived. With the aid of the Brackettville Lions Club, the Moores opened the house for public inspection and a cookies and punch reception following the ceremony.

The Moores are part of an interesting and diverse group of people who own and live in the original officer's homes and enlisted men's barracks in the nationally-listed historic district of Ft. Clark. Established in 1852 near the giant Las Moras Spring, Ft. Clark protected the important San Antonio-San Diego trade route as Western expansion pulsed towards California. The Fort served as an active cavalry and military base until 1946 when it was sold to Brown and Root Company of Houston for salvage and use as a guest ranch. Nat Mendelsohn bought the 2,700-acre property in 1971, and developed it into a unique membership community dedicated to historic preservation and future use and development.

"From this date forward, I hope, and I believe, there will be a greater recognition on the part of all Texans of the important role played by this fort, and the many brave men and women who lived here and tamed a savage and often unforgiving land," former Gov. Briscue said. "And of equal importance, will be a greater appreciation on the part of all Texans of the work that has been done in recent years to preserve and utilize this National Historic Site, while at the same time keeping the spirit of those who were stationed here alive and well."

Briscoe's comments brought a round of applause from former 5th and 112th Cavalry troopers attending the dedication ceremony as part of the Ft. Clark Cavalry Trooper's Reunion activities last weekend.

"Because of the efforts of the soldiers stationed here, this great, vast land of West Texas was turned from an empty wasteland into a productive part of the overall agricultural economy of Texas." Briscoe said.

The former Governor and his wife, Janey of Uvalde, toured the Ft. Clark Old Guardhouse Museum earlier in the day to see the temporary display of two ornate swords presented to famed Indian fighter Lt. John L. Bullis by the grateful citizens of Kinney County, and Western Texas in 1882. Bullis and the fearless Seminole-Negro Indian Scouts are widely reguarded as the men who finally brought peace to land raked by Indian violence. They roamed for months at a time the land that is now Bandera, Kerr, Uvalde, Medina, Real, Edwards, Kinney and Val Verde Counties searching for marauding Indians. Bullis and his scouts always attacked at once, earning him the nickname of "The Whirlwind" among hostile Kickapoo, Comanche, Lipan and Apache Indians.

Bullis served at Ft. Clark for nine years. His ornate presentation swords were placed on display for one day at Fort Clark Springs because of a controversy surrounding the San Antonio Museum Association who at first refused the display, even though the swords were in storage in the basement of the Witte Museum. Hundreds of area residents visited the Old Guardhouse Museum to see the swords on April 22 at Fort Clark Springs.

OLD CAVALRY TROOPERS AND FAMILIES IN ATTENDANCE AT REUNION "89"

On the former parade grounds with the Old Batchelor Officers Quarters in the background are some of the dashing U.S. Army Cavaliers of times past. The majority of these troopers were on active duty, with their issued mounts, when the U.S. Government decided to put an end to the mounted cavalry era, February 1943. They dismounted the troopers, sold the horsed and equipment and decided on disposal of most of the cavlary posts. Incidently, some U.S. Army Commanders involved in the North African Campaign were requesting mounted cavalry before they had the knowledge that it was twilight for that branch of the army.

Fort Clark has a very proud historical background of mounted U.S. Cavalry and is very proud that these old warriors choose to return here for their reunions. So far, the 5th U.S. Cavalry Regiment and the 112th Texas Army National Guard units make up the majority of the troopers whom attend. The 1st Cavalry Brigade Headquarters was also represented.

POOL REPAIR





CONGRESSMAN MARTIN FROST REPORTS

Changing the Hatch Act

The Hatch Act of 1939 bars most federal executive branch employees and U.S. Postal Service employees from taking an active part in partisan political activities. The Act prohibits covered employees from Soliciting campaign funds from fellow workers, using their office for political purposes, taking an active part in partisan campaign management, and running for office on a partisan ticket.

Currently, however, covered employees can express political opinions, make political contributions, and engage in non-partisan activities.

The Hatch Act, which is enforced by the Office of Special Counsel, is often the source of confusion about what is and what is not permitted under the Hatch Act. H.R. 20, the Federal Employees' Political Activities Act, was passed by the House on April 17th and is the first basic revision on the Hatch Act since it passage. A virtually identical bill (H. R. 3200) was passed by the House in the 100th Congress; however, the Senate failed to act on the measure.

H.R. 20, which I co-sponsored, passed the House by a vote 297-90. As amended, the House bill would provide the following:


Specifically, the bill allows such employees to run for partisan political office on their own time, without taking a leave of absence, unless campaigning for the office interferes with the performace of their duties. It permits employees to request leave without pay or annual leave to run for political office and provides that such requests must be granted unless the agency management determines that the demands of public business require that leave be denied.

The measure also permits federal employees to manage political campaigns and raise campaign money during off-duty hours.

The bill prohibits federal employees from using official authority or influence to interfere with the result of an election or to intimidate an individual to vote or not to vote, to give or withhold a contribution, or to engage or not to engage in any political activity. The measure prohibits federal employees from promising or threatening certain actions, including providing or withholding compensation, grants, contracts, licenses, and rulings.

The measure prohibits federal employees from giving a political contribution to a superior, and prohibits superiors from soliciting contributions from their subordinates. It prohibits federal employees from giving, receiving, or soliciting a political contribution in a government

The measure makes clear that federal employees may not solicit, accept, or receive a contribution from, or give a contribution to, any person who has or is seeking a contract with the employee's agency, is regulated by the agency, or has an interest which may be affected by the performance of the employee's duties. The bill's



The bill also prohibits federal employees from using official information for political purposed, unless such information is publicly available.

Things have materially changed since the days of 1939 when the Hatch Act was passed, and with proper safequards insured, it makes sense to provide these Americans with the rights many more of the rights that all other American possess.





After Ms. Eva could no longer stay by herself, her son finally made the decision to place her in a nursing home. For her it was the right decision as she found old friends there and can visit to her hearts content. But what to do with the house was another thing. The Costons first tried to sell the house, then rent it. But in the back of Olga's mind a Bed & Breakfast had always interested her. Her daughter knowing this, added fuel to the fire by giving her the book "Open your own Bed and Breakfast" and from there the gears were put in motion. Things went slowly at first with fixing and painting, adding the charm. But last fall, really not totally ready, they opened their home for hunting season.

They have two rooms downstairs that are for visitors. One is down the hall with some privacy from the main part of the house. The other has it's doorway off the dining room. The upstairs at present is liken to a small studio apartment with a double bed on one side, single beds on the other side and living room furniture in the center. Perfect for a group or a family. Windows surround the room with light and has a cross breeze when opened. The Costons hope to make this into two rooms someday.


