New Mexico has the most outstanding distant runners per capita. Indians have an ancient tradition of running. Before horses, telegraph wires, and telephones, intertribal communications was carried on by messages carried by runners. When the Pueblo uprising occured in 1680 the communications were done by running warriors. In the Jemez Pueblo there are two ceremonial foot races a year, one from the south and one form the north. Jewelry is awarded to the winners. These Indians also trained for running on the mountains.

In Mexico Indian runners have been famous for years and years. They too train in the mountains. In the 1930's a group of these runners came to Texas and put on exhibitions of their running. In Pecos, Texas they challenged the town to stage a race between one of their runners and a horse.

A course was laid off in a large circular track east of the town. The towns people put up their horse and bets were laid down.

Immediately the horse raced ahead of the Indian. Round and round they went. The Indian jogged along and kept a steady pace, the horse began to slow a little. Of course the horse was still laps ahead, but little by little the horse slowed. The Indians pace never changed as time wore on the Indian began to gain ground. Finally the horse stopped with his head down completely worn down, and the Indian jogged back to his companions at the starting mark.

Wild horses in the old days have been captured by the same method. Three or four men horseback and running in relays could capture a wild horse by wearing him down. As each man and his horse tired another would take his place until the wild horse became exhausted which made his capture a snap.

UNUSUAL PAINTING

UNUSUAL PAINTINGS BELIEVED TO BE IN BRACKETTVILLE AREA PANCHO VILLA RESCUED SON OF ARTIST FROM DUNGEON

The strange and exciting story of an artist who sold her works all over the Southwest at the turn of the century to help free her doctor son from a Mexican prison, may very well have a Brackettville connection, because some of the paintings are believed to be privately owned here.

Her beautiful pastoral oil-on-tapestry paintings have brightened homes and churches and brought joy to their owners throughout the Southwest since the turn of the century.

Very few know of the despair that accompanied every painstaking stroke of her brush. Certainly every painting had its message, but the strange, remarkable, untold story of the artist and the calamity in her life that motivated her for years is a much greater picture. She painted with a purpose.

And before her story was finally played out over international borders, she would have become involved in the sphere of diplomatic relations, political lobbying and even into the areas of helping finance a foreign revolution.

Texas and American national officials up to and even including the President got to know her well, and foreign revolutionaries felt her influence. She was a mother praying, fighting and laboring for one of her children who she believed had been wronged.

Mexican legend Pancho Villa would prove to be the pivotal key in re-uniting the fragile artist and her physician son who had been a long-time prisoner in a Mexican dungeon.

Putting all the pieces of the strange puzzle together began with a modern woman's determination to identify the artist of a large painting she had bought during the disposal of furnishings from a large nearby

The trail took many turns, including the National Archives, crumbling newspaper files, fading memories, interview, letter writing and days of library and cemetery research. None of the informants knew the whole story. A piece was added here; a new name turned up there; many other paintings came to light and, little by little, the story of Anna Laurie Harle unfolded.

Truly, it was a classic example of international intrigue that was so much a

part of the Southwestern History in the early 1900's. The thoroughly documented account reads today like pure fiction, but its principals actually lived it.

There are believed to be hundreds of the paintings by Mrs. Harle throughout the Southwestern States. Many hung in major churches, and were proud, prized possessions of those who had decorated stately homes. Since then, they have been passed from generation to generation. Now with the publication of this material, their value will be enhanced by knowledge of the story behind the paintings.

She was a Southwestern pioneer artist; her son, a pioneer doctor who first practiced in Mexico, where their troubles began; their combined story is the kind of pioneer experience that helped forge this great area. In the later stages of this epic, Dr. Harle rode with Villa as his personal physician.

Historioans, art-lovers, those who find strength and enjoyment from knowing real people solving real problems, will find the pages of this book intriguing.

The curious initial search for the artist of the old, unsigned tapestry painting turned quickly into a panorama of Texas-Mexico history as the mystery surrounding the artist unfolded.

Readers who know of other paintings which they believe might be Harles are encouraged to correspond with the authors through the publisher.

The complete story with reproductions of the paintings and photographs of the principals has just been released in a book names "Painting For Freedom" by H.V. and Gayness O'Brien through Times Publishing Co., Box 29, Eastland, Tx. 76448.

OLD ARMY DAYS STORY BY WALLACE L. MORGAN 1930'S

The cavalry unit pictured above is part of the Headquartes Troop, 1st Cavalry Brigade, in the field at Camp Stanley, Texas. This location is one of the areas in which cavalry units were stationed at Fort Clark used to go to for training in the field. Camp Stanley is located to the west of and next to, Camp Bullis, and they are west of Loop 1604, and north of Interstate 10, just west of San Antonio, Texas. Camp Stanley and Camp Bullis are still in use by the U.S. Army Camp Stanley is presently in use as a storage facility, and Camp Bullis is primarily a National Guard Training site.

A small number of former members of Headquarters Troop, 1St Cavalry Brigade, were represented at the recent Fort Clark Old Cavalry Troopers Reunion. I was told by on of them that the existing horse stables at Fort Clark, was assigned for the Headquarters Brigade's use, while this unit was assigned to Fort Clark. In addition, their barracks was the building which is now occupied by the Fort Clark Springs Associations Administration staff. The two wings attached to the rear of this building were originally the mess hall (east) and the supply section (west).





NEW DEAF SCHOOL

Legislation was passed today which would permit the sale of the Texas School for the Deaf's East Campus site with the proceeds going to finance renovation and construction of a new campus on the present South Campus location on the South Congress site. The bill was overwhelmingly supported by both the Senate and the House and practically no opposition.

Thanks to a well done Master Plan Study funded by State Purchasing and Supply Commission conducted by Barnes & Russell Architects as well as a report by the General Land Office which recommended the construction of a new school on South Campus for deaf children throughout Texas, the Legislature realized this bill will be cost effective in the long run and would meet the needs of children and staff in the deaf community. The new campus will save approximately two million dollars a year in operating expenses as it will eliminate duplication of services and costly maintenance repairs required on the old campus.

The bill will now be sent to Governor Clements for his signature and he has the honor of giving deaf children from all over the State of Texas a new school, new pride, a new home and a better opportunity to achieve higher goals in education.

MEMORIAL PLAZA TO BE DEDICATED

Laughlin Air Force Base -- A memorial plaza will be dedicated Friday, May 26, in honor of a former Laughlin student pilot who was killed in action in the April 1986 raid on Libya.

The current Plaza Drive near the U.S. Highway 277 entrance to the base will be renamed in a special dedication ceremony scheduled to begin at 3:30 p.m., May 26.

The new name will be Ribas-Dominicci Plaza in memory of Major Fernando Ribas-Dominicci, the F-111 pilot killed in the Libyan Raid. His widow, the former Blanca Linda Berain, of Ciudad Acuna, Mexico, and the couple's son, Fernando, will unveil a bronze bust of her husband.

Fittingly, the ceremony will begin with a formation of F-111's from the 27th Tactical Fighter Wing, Cannon AFB, New Mexico, where Major Ribas-Dominicci served as an instructor pilot and flight examiner. The fighters will fly a "Missing Man" formation in his honor.

The U.S. Air Force Band of the West from Lackland Air Force Base will provide music during the ceremony.

Col. Joseph S. Bleymaier Jr., commander of the 47th Flying Training Wing at Laughlin,

is the event's host. The keynote speaker is Major General Robert S. Gelligatti, a former' F-111 pilot who is now Vice Commander of Air Training Command, Randolph Air Force Base, Texas.

The bronze bust is the end result of a united community effort spearheaded by the Laughlin Heritage Foundation, which agreed to raise the funds needed for the bust and dedicatory plaque.

"Laughlin personnel contributed individually and as units to the fund raising efforts," said Lt. Col. Chet Geurin, deptuy base commander and project officer. He noted other sizeable donations came from the Del Rio area and from throughout the Air Force Community, active duty and retired.

Heritage Foundation Chairman James Long, added that the communities of Del Rio and Ciudad Acuna were united behind the project. "The response was heartwarming. Major Ribas-Dominicci was from Puerto Rico, but he certainly left his mark and is well remembered here," said Long.

He noted that numerous business on both sides of the border contributed to the effort along with civic organizations including the Del Rio and San Felipe Lions Clubs, Del Rio Rotary Club, Air Force Association Chapters of Texas and Del Rio, the International Good Neighbor Council of Del Rio, and the Maquiladora Association of Ciudad Acuna, Coahuila, Mexico.

The bust is shaded by a T-38 "Talon" static display aircraft that was erected by Laughlin maintenance personnel last year.

A reception, sponsored by the Del Rio Chapter of the Air Force Association, will be held at the Officer's Club immediately following the dedication.


