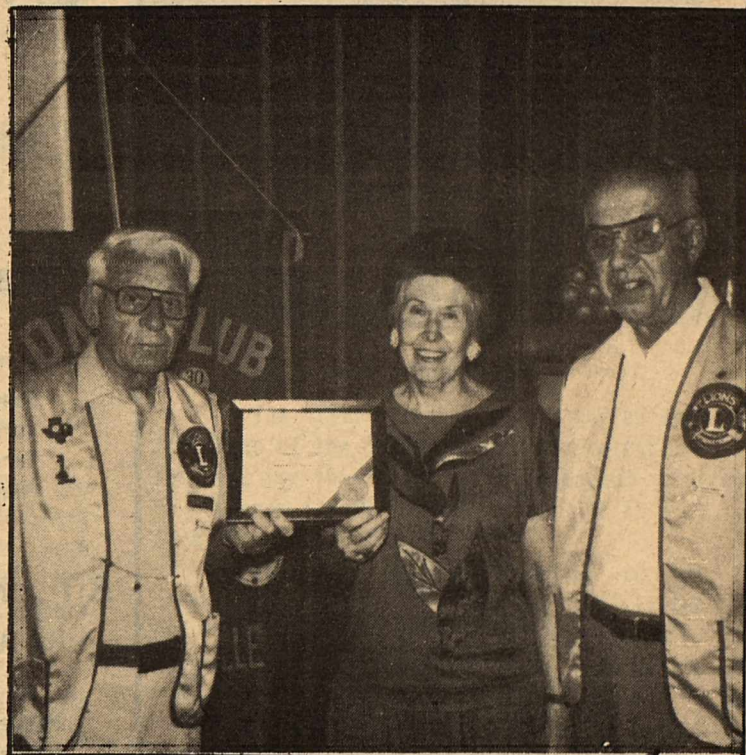


RORY'S VIDEO REVIEW EXPANDING

CITY HALL NEWS

The City of Brackettville had a special meeting at 6:30 p.m., Monday, July 24th.

Mayor Vito La Gioia appointed Anabel Talamantez to the Housing Authority Board.

The City Council appointed Dr. Agustin Luz as City Health Inspector. Dr. Luz is already serving as the County's Health Officer.

The Mayor announced that Mr. Sterling Evans had withdrawn his request for rezoning of his property on 3rd Street in the North part of Brackettville.

The Council set the next regular Council meeting for August 14, 1989, at 4:30 p.m.

Mr. Ted Connors gave an update on Enterprise Zone.

The appointment of Zoning Board Member and the purchasing of radios/beepers for the City was tabled until the regular August meeting.

Following the Special Council Meeting,

was a Public Hearing was held. The purpose of the Hearing was to present information to the Citizens and then to receive their comments and ideas concerning the City making two applications to the Texas Department of Commerce for grants: (1) a grant to finance the cost of the preparation of a Plan and Capacity Building Project for community development and housing needs, including improvements, facilities, economic development, housing, land use & zoning, various regulations, parks & recreations, future growth and development and other similar facilities and programs necessary to improve and upgrade the quality of our City, the environment and the local economy; and (2) a grant for approximately \$93,000.00 in Community Development Grant Funds. These funds may be used for a variety of projects that will benefit low and moderate income persons.

Several projects were suggested and discussed by the citizens and Council Members.

COMMISSIONERS' COURT EMERGENCY MEETING

The commissioners Court had an emergency meeting on July 21, 1989 at 1:30 p.m.

Judge Tommy Seargeant called the meeting.

It was established and verified by Director of Nutrition Center, Hortencia Pena that the employees of the Nutrition were qualified to handle the Center in her absence. If the employees needed assistance they are to call Commissioner Rose Mary Slubar or Judge Tommy Seargeant.

Since there is a list of applicants requesting home delivered meals and there is no more money this year to add new applicants, a request was made by Commissioner Slubar for an additional amount to cover the new applicants for the remainder of this year. The court decided not to add more money and to hold the new applicants until the new budget year which begins Oct. 1st.

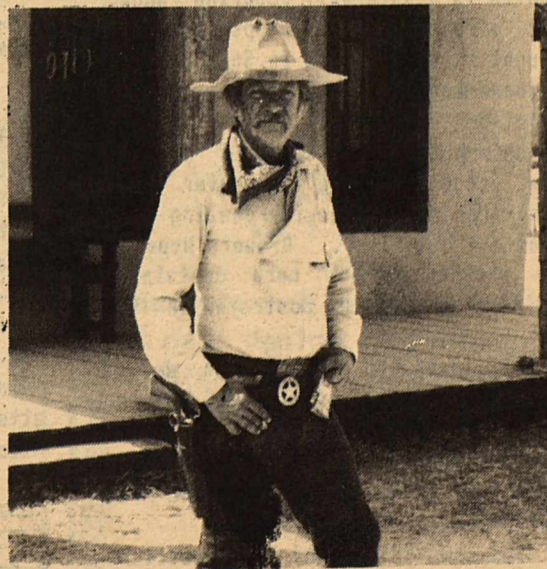

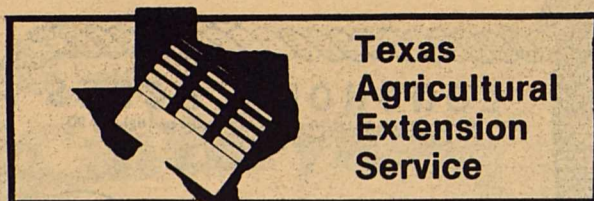

Texas Agricultural Extension Service

This week has been a busy one. We had a very good extension Ag and Natural Resources Committee meeting last Tuesday. Local ranchers planned several excellent educational programs, the first being held this fall. My thanks to those of you attending and participating in the committee.

I had an opportunity to attend the Texas Sheep and Goat Raisers annual meeting briefly and also to listen to a symposium entitled "Improving Lamb Crops Raised". It had some interesting topics and I have a copy of the material and the proceedings if anyone is interested.

An open sign-up period for the Conservation Reserve Program (CRP) has been announced by the U.S. Department of Agriculture starting this week and ending August 4.

During this sign-up, some cropped lands and cropland subject to scour erosion as well as highly erodible lands, are eligible to be bid into the CRP.

Lands are eligible for the program if they were cropped in two of the five crops years from 1981 to 1985 and meet the other criteria.

More than 4 million acres of cropped wetlands were in production in the U.S. in 1982. Bringing these lands into the program is expected to produce additional environmental benefits.

Persons who wish to have more information or think they may have some land eligible for the CRP may obtain additional information from local Agricultural Stabilization and Conservation Service (ASCS) county office in Del Rio.

Aflatoxin in corn is a hot topic lately. The Texas Agricultural Extension Service has a publication entitled "Mycotoxins in Feeds and Food-Producing Crops" that addresses this topic. Here is some general information about aflatoxin.

Aflatoxin is a naturally occurring fungal toxin that affects certain crops produced under drought stress. Corn in South Texas has experienced severe drought stress during 1989 production season and there is some aflatoxin contamination present.

Federal crop insurance may cover some producers but the guidelines for dealing with this problem are not clear. Growers hope to know soon whether or not corn containing excessive aflatoxin can be destroyed in the field.

Chemical tests are available to detect the presence of the toxin at critical levels. Producers are urged to utilize the chemical tests to determine aflatoxin levels and then market grain in accordance with Food and Drug Administrations action levels.

Here are some guidelines or suggestions for livestock producers:

--Know aflatoxin level of corn before you purchase.

--Feed according to Food and Drug Administration action levels.

--Investigate the potential for using feed additives and understand the legal options.

--Blending is not approved for the 1989 crop but individuals who might benefit by this option should keep current on regularity policy.

--Always observe animals regularly who are being fed suspect quantities of corn for early signs of aflatoxin poisoning.

Also, something else to think about is corn left standing produced under extreme drought conditions, should be destroyed by plowing to make it unavailable for wildlife. Birds such as bobwhite quail and wild turkey appear to be more susceptible than other wildlife animals.

There will be a county livestock board meeting Monday, July 31, 1989 at 7:00 p.m. in the county extension office. This is an important meeting -- please make an effort to attend. We need to discuss several items that will deal with the upcoming livestock show.

RECERTIFICATION TRAINING SET

Two recertification training meetings for commercial and non-commercial pesticide applicators in Southwest Texas have been scheduled for August.

Applicators are now required by the Texas Department of Agriculture to acquire five hours of continuing education units (CEU's) in 1989. Twenty CEUs are needed by the end of 1992.

The Texas Agricultural Extension Service and the Texas Department of Agriculture are co-sponsoring two trainings which will provide five credits.

The first is from 8:30 a.m. until 5 p.m. Aug. 16, at Aggie Park, 6205 West Avenue, in San Antonio.

The second, also from 8:30 a.m. to 5 p.m., is Aug. 17, at the Civic Center Reading Room, 300 E. Main, in Uvalde.

There will be a small fee charged at the San Antonio meeting to cover the cost of the meeting room. There will be no fee charged in Uvalde.

The same material will be presented at both meetings. Applicators need only to attend one of the meetings, not both.

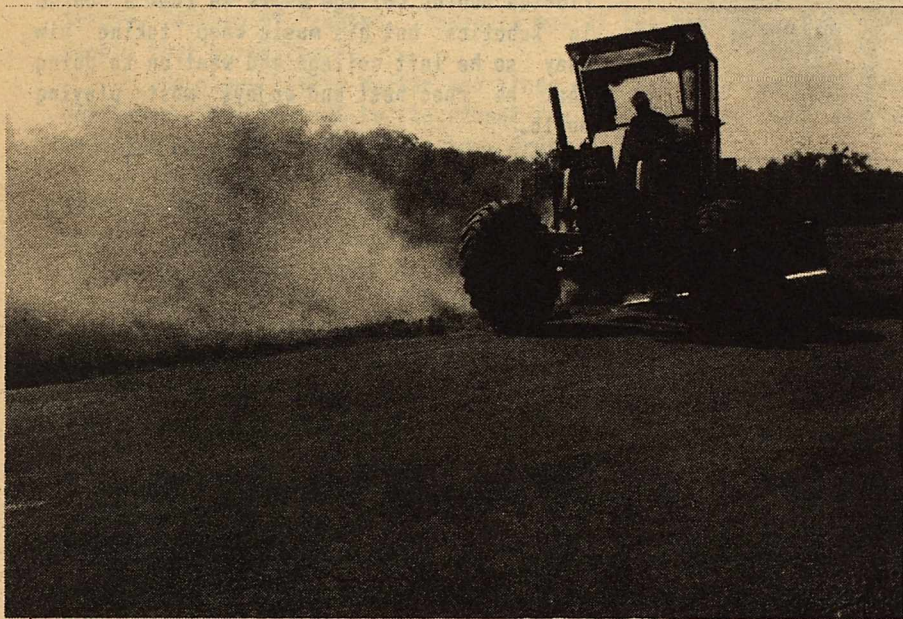
A MAN DROWNED IN LIVE OAK CREEK

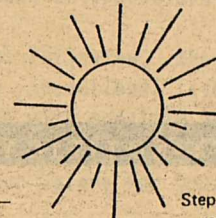

HEAT STROKE - HEAT EXHAUSTION

The severe heat of summer can cause serious problems for the worker in the field. Reactions to heat usually occur when the body loses large amounts of water, salt or both, from sweating. Strenuous work in an extremely hot atmosphere can cause heat exhaustion or heat stroke.

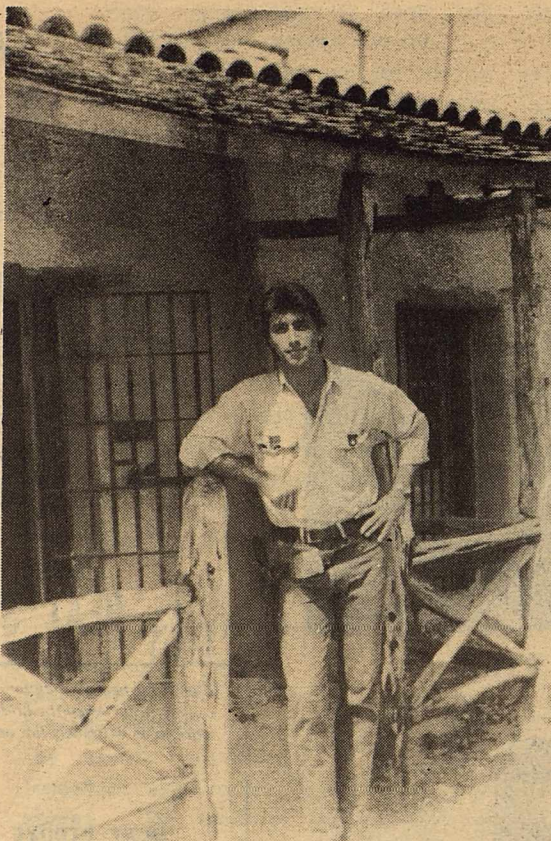

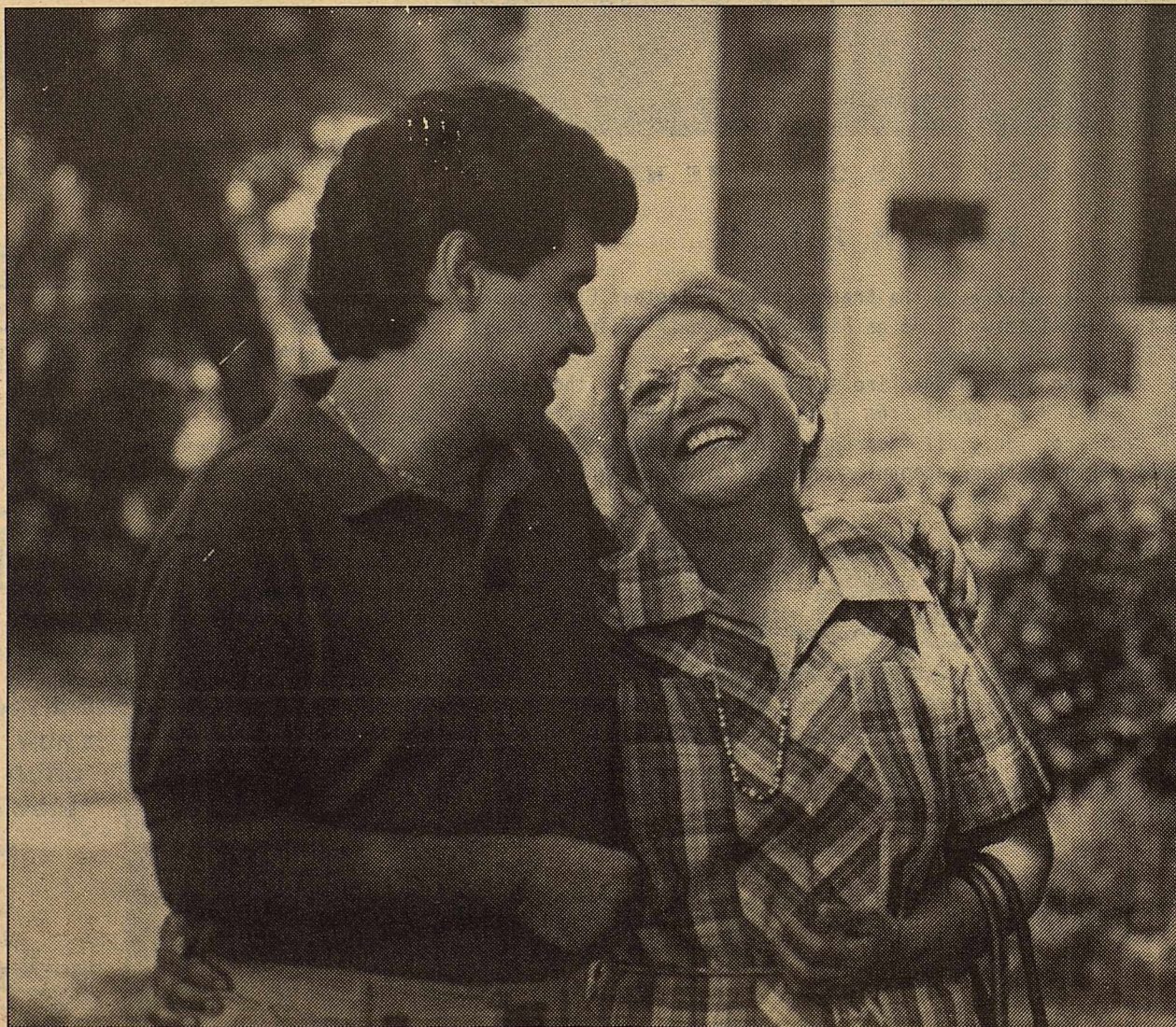

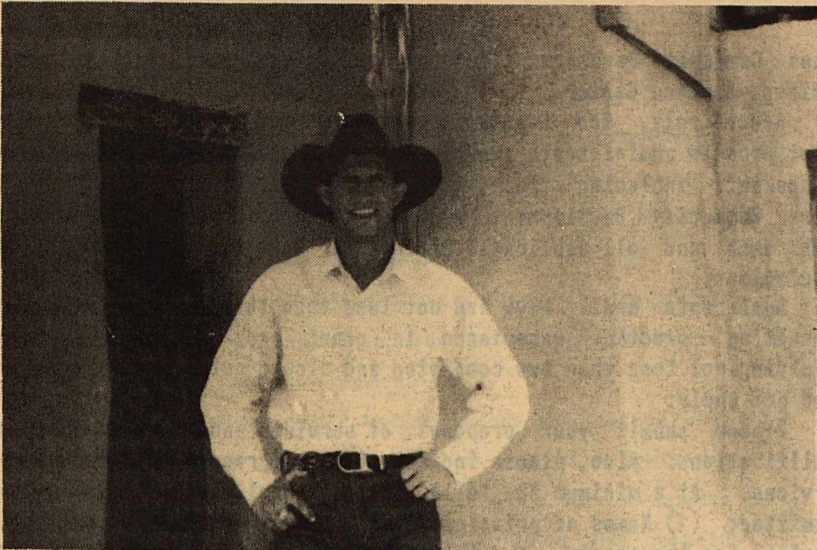

TEXAS NEEDS YOU BACK ON THE JOB

Losing a job can be a devastating experience. Especially when you didn't do anything wrong. In fact, you did everything right. Learned good skills. Put in years of service. Postitive Ways To Start Again.

Title III offers practical, structured help through On-The-Job training, vocational classes, customized training, or remedial education and basic training skills programs. It all depends on each individual's needs and requirements.

The thing to remember is that the Title III program offers lots of choices. Depending on your area of the state, other services may be available, such as child care, phone banks to make calls to get job interviews or secretarial services to type your resume.

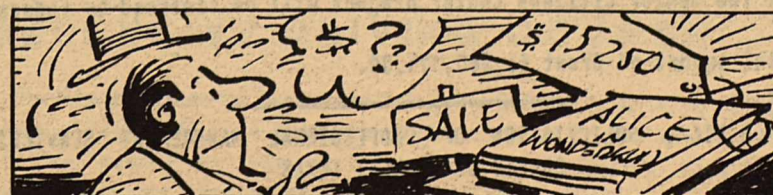

AN ORDINANCE

REGULATING THE DISPOSAL OF GARBAGE IN THE CITY OF SPOFFORD, TEXAS; PROHIBITING THE DISPOSAL OF HAZARDOUS WASTE IN CERTAIN AREAS; AND PRESCRIBING PENALTIES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SPOFFORD, TEXAS:

Section 1: Definitions.

As used in this ordinance --

(i) "city" means the City of Spofford, Texas.

(ii) "garbage" means solid waste consisting of putrescible animal and vegetable materials resulting from the handling, preparation, cooking, and consumption of food, but does not include hazardous waste.

(iii) "hazardous waste" means any solid waste identified or listed as a hazardous waste by the administrator of the United States Environmental Protection Agency, pursuant to the federal Solid Waste Disposal Act.

(iv) "refuse" means nonputrescible solid waste, but does not include hazardous waste.

(v) "person" means an individual, corporation, or association.

Section 2. Disposal of Waste.

(a) A person commits an offense if the person disposes of or dumps garbage or refuse at a place within the city limits or within the extraterritorial jurisdiction of the city, unless the place has been designated for disposal or dumping of garbage by the city council.

(b) A person commits an offense if the person disposes of or dumps hazardous waste at a place within the city limits or within the extraterritorial jurisdiction of the city.

Section 3. Penalties.

A person who commits an offense under this ordinance shall, upon conviction, be punished by a fine. The amount of the fine shall not exceed \$1,000.00.

Section 4. Effective Date.

This ordinance takes effect 10 days after its publication in the official newspaper of the city.



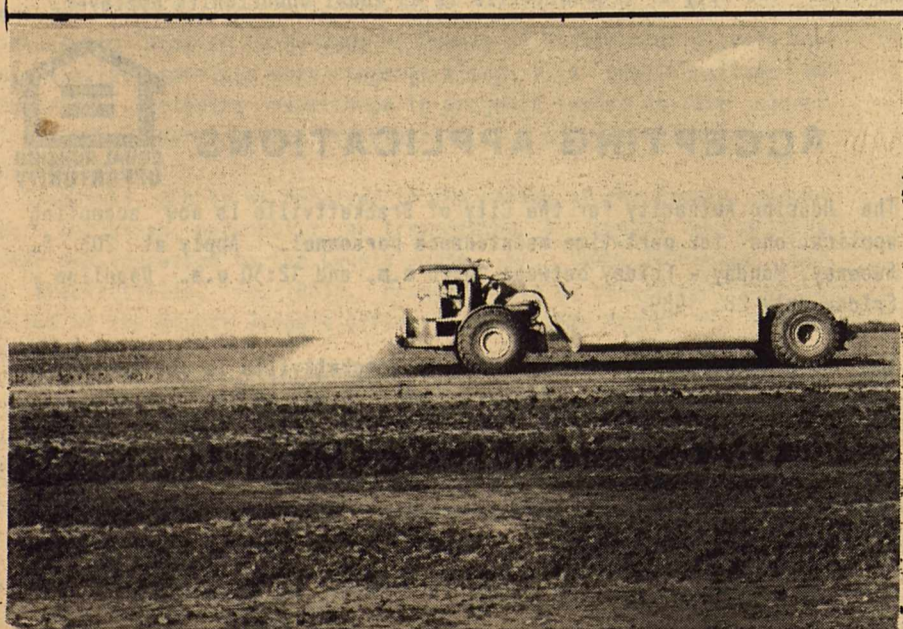

that is being used at this time only produces about 100 gallons per hour. Which is not enough for their demand.

At this time they are in the process of bringing water tankers up from Corpus Christi, which will be filled at Fort Clark Springs, and shuttle water to the site. The water that will be hauled in is being used to wet and pack the dirt that is being moved. The crews are moving eight to ten thousand cubic yards of dirt a day.

The heat has also been taking its toll on the workers and equipment, since most of the workers are from the coastal area it takes them a while to adjust to this dry heat.

Besides leveling the strip, they are now in the process of laying 2,130 feet of concrete drainage pipe, which will run under the landing strip, and down to the highway for water drainage.

Mr. Yancey stated that if everything goes right, the contractors should start concrete work on the fire station and other things in about thirty days.

BOB BULLOCK - COMPTROLLER

AUSTIN--State Comptroller Bob Bullock said Monday that maquiladoras can begin applying now for special tax permits that will allow them to buy some goods tax-free beginning Sept. 1.

Bullock's agency mailed 1238 notices to maquiladoras along the Texas-Mexico border explaining how the exemption works and outlining the permit application process.

"This new law is a good one, and I hope the maquiladoras will take advantage of it. It'll cut their paperwork substantially, making it easier for them to buy their goods in Texas," Bullock said.

Bullock said that under the old law, maquiladoras buying items for export paid sales tax on the goods, then filed with the state for a sales tax refund.

The process will be much easier when SB693, passed during the regular session of the 71st Legislature, goes into effect on Sept. 1, Bullock said.

The new law exempts maquiladoras from paying state and local sales tax on raw goods that will be exported to Mexico.

Bullock said the new law won't affect state and local revenues since the sales tax had previously been refunded to maquiladoras anyway, but it will cut down on paperwork, both for the businesses and for the state.

"I'm glad we're offering incentives to these businesses to spend their money in Texas, on Texas goods. This is a wise move on our part," Bullock said.

This infantry unit insured that buildings and grounds were kept up (to the best degree that existings funds allowed), and that vandals were kept from entering the post. When Fort Clark was sold to civilian owners this group of infantry soldiers were transfered to another duty station.

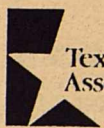

HEED THE HAZARDS OF HOT WEATHER

Summer traditionally is a time for fun in the sun. The Texas Medical Association warns that hot, humid weather may pose severe health problems, ranging from the less serious heat fatigue or heat exhaustion to the potentially fatal heat stroke.

To avoid heat-related illness, drink plenty of water and juices, bathe or shower frequently with cool water, and use fans and air conditioners liberally. When outside, wear light-weight, light-colored, loose-fitting clothing; cotton is best. Avoid vigorous activity during the hottest part of the day, noon to 4 p.m., and wear a hat or use an umbrella when in the sun.

In hot weather or during strenuous exercise, the body cools itself through perspiration. Cooling occurs when perspiration evaporates from the skin. However, when challenged by long periods of intense heat, the body may lose its ability to cool. Hyperthermia is the result. Poor ventilation, improper clothing, and the lack of fluids can contribute to this.

Heat fatigue, the least serious of heat-related illnesses, causes weakness. Symptoms include cool, moist skin and a weakened pulse. The person may feel faint or dizzy. Mild hyperthermia can cause heat cramps -- muscle spasms in the abdomen, arms, or legs after strenuous activity. With both heat stress and heat cramps, body temperature usually remains normal.

Heat exhaustion, caused by the body's loss of water and salt, is a more serious warning that the body is overheating. Symptoms include thirst, giddiness, weakness, profuse sweating, loss of coordination and appetite, and nausea. Body temperature often is elevated, but usually no higher than 101 degrees.

Heat fatigue, cramps, and heat exhaustion may be treated in several ways. Victims should lie down in a cool place, preferably air-conditioned, and drink water or fruit and vegetable juices. Alcohol and caffeine should be avoided. Victims also should shower, bathe, or sponge off with cool water. If left untreated, heat exhaustion can progress to heat stroke.

Heat stroke can be life-threatening, and immediate medical attention is required. Heat stroke usually is preceded by headache,

dizziness, nausea, confusion and even convulsions. The victim may be flushed, but may not be perspiring. The pulse generally is strong and rapid, and the body temperature may reach 104 degrees Fahrenheit and keep rising. The person may lose consciousness. In this situation, keep the victim cool, but do not attempt to render aid. Expert emergency attention is required for suspected heat stroke.

Prevent serious heat-related illnesses by making sure the proper precautions are taken. With sound judgment and an ounce of prevention, the summer can remain a time of fun and leisure for everyone.

Texcor Industries, Inc. Applies For Permit

BRACKETTVILLE, TX.--After more than a year of site investigation work, Texcor Industries, Inc., has submitted a permit application to the Texas Department of Health's Bureau of Radiation Control (BRC). The company is seeking to permit a storage facility for Naturally Occurring Radioactive Materials (NORM) at a site located south of Spofford, in southern Kinney County.

NORM is a classification of materials containing minute amounts of radiation which occur naturally in groundwater, oil and natural gas deposits, fertilizers and the processing of uranium and rare earth minerals.

The BRC will now begin their review of the application. After a review for completeness and accuracy, a notice will be published for the opportunity to call a public hearing on the application.

"A copy of the permit application is available to the public in Brackettville at the Public Library," explained Charles W. Salsman, President of Texcor Industries, Inc. "In addition, a second copy of the application is available in our Brackettville office. We want anyone with an interest in this project to have full and complete access to the application and all the information it contains. Anyone wanting to review the application, and who can't get by during regular library hours should contact our office at 563-2481 and make arrangements."

According to Salsman, the issue of NORM came up several times during the regular session of the 71st Texas Legislature.

"Two bills were introduced," he explained. "The first didn't pass. However the second, which was sponsored by the oil and gas lobby, was passed in the final hours of the session. It would have transferred regulatory authority over oil- and gas-generated NORM to the Railroad Commission of Texas."

"But the Governor vetoed the legislation, citing existing authority to regulate NORM currently existed with the BRC, and that the legislation would have created a duplication of effort between state agencies."

A resolution to study the issues involved in NORM was introduced and passed Sen. Judith Zaffirini (D-Laredo). The resolution establishes an Interim Study Committee, under the direction of the Senate Natural Resources Committee, to evaluate the subject of NORM, and to submit a summary report to the 72nd Session of the Legislature should any further legislation be needed.


