



"HEAT RELIEF"


Low-Income households with a medical need for cooling, may be eligible for a onetime cash benefit under the federal Heat Stress Relief Program according to Kinney County Contractors.



Summer always brings lots of problems around the home. Problems with insects, turf grass, and ornamental or fruit trees are especially prevalent this time of year. We are still receiving quite a few calls about yellowing in grass and trees.

Symptoms of the iron chlorosis are generally a yellowing of the green foliage due to failure of chlorophyll to develop normally. The Chlorosis occurs in plants where and when iron is not available to them. This lack of iron maybe due to a deficiency or to the iron being unavailable because of alkaline soils. In either of these cases, iron supplied by ferrous sulfate or iron chelates will be beneficial.

Ferrous sulfate can be applied as a foliar spray at the rate of two teaspoons per gallon of water plus a spreader sticker. The spray should be applied in the late afternoon to avoid leaf burn and should be repeated in about 10 days if the yellowing does not subside. The iron sulfate can be used as a soil fertilizer. Apply to trees and shrubs in a circle just inside the furtherest spread of the branches. A five foot shrub requires about a fourth of a pound, and trees should have a three-fourths of a pound for each inch trunk diameter. In highly alkaline soils, such as ours, the foliar spray may be a little more effective. ROSES

Changing the subject a little, the care you give your roses in August will go a long way in producing flowers in October. Most importantly, be sure your roses are getting plenty of water. A good thorough soaking at least twice a week, if there is no rain, should provide the moisture they need. Try to water in the morning and keep the water off the leaves.

Next, give the roses a feeding of a 10-15-5 fertilizer. Spread around the bases of the plants and work lightly into the soil. In order to produce more blooming wood, cut the plants back about one-third. Prune as you would in the spring but just not as severely. This will leave you with out any bloom during September but the October blooms should more than make up for it.

TOMATOES

Have you got tomato problems? Few or no fruit development with healthy plants can occur for a number of reasons.

- Extreme temperatures -- the blossoms drop off without setting fruit when night temperatures fall below 55 F or day temperatures rise much above 90 F.
- Dry soil -- blossoms are produced the plants do not receive enough water.
- Shading -- few blossoms are produced when tomato plants receive less than six hours of sunlight each day.

 Excessive nitrogen -- high livels of nitrogen in the soil promote leaf growth at the expense of blossom and fruit formation.

REFLECTIONS BY PRESTON TAYLOR FIRST BAPTIST CHURCH

In WAR AND PEACE Russian novelist Leo Tolstoy describes the city of Moscow as Napoleon arrived to attack it.

Much to the dismay of Napoleon, he found Moscow practically empty on that snowy, sub-zero day in the early part of the last century. Maybe twenty percent of the Russians hovered inside their ruined, burned out city. The fleeing inhabitants had destroyed the city, rather than surrender it to the French.

Moscow, cold and gray and ghastlylooking, had become as deserted as a dying queen-less hive.

From a distance the bee-hive without a queen may smell like honey and some bees may still fly in and out. However, odor of emptiness and decay, the absence of little sentinels sounding an alarm, and disconnected buzzing from the hive clearly says the end has come.

Russia looked and smelled like that in the early 1800s. Without hope and help, the French General marched in front of Moscow's snow-covered Kammer-Kollezski rampart. The "(captured" city...burned! Napoleon's thousands of soldiers...without food...no shelter... shivering in 3 feet of snow...Napoleon felt helpless, forlorn, empty. Their own beloved France Lay hundreds and hundreds of miles across the wintry and impassable forests of Europe. Death stared them in the face.

What about people with houses, automobiles, medical care, enough food, and a sense of well being? These, too, may be like a dying queenless beehive, or an army that soon stands before a Moscow-like burned and deserted city. Hope will vanish. The odor of death will settle upon them. All joyful hilarious sounds will fade away in the cold night air of death.

Only a vital, living relationship with Jesus Christ can change the collision course which man is on. The world, the flesh, and the devil pay off in counterfeit coins. God never deceives. And the eternal God offers us life that will never end and peace that lasts.

PURPLE HEART ANNIVERSARY

The 207th anniversary of the Purple Heart, a medal that recognizes Americans wounded or killed in action in war, will be observed August 7.

At Newburgh, N.Y., on August 7, 1782, General George Washington ordered the creation of a Badge of Military Merit. The badge was a purple cloth heart with a silver-

braided edge. In the Revolutionary War, only three are known to have been awarded.

It wasn't until the bicentennial of Washington's birth, Feb. 22, 1932, that the medal was reinstated as the Purple Heart and awarded retroactively to deserving American World War I soldiers. Today, it continues to be one of the highest honors received for combat duty.


According to records of the Military Order of the Purple Heart, an association for recipients of the award, approximately 1,744,804 Purple Heart medals have been awarded since its reinstatement.


SAILPLANE SOARING CONTEST

All of the sailplanes in the contest will be constructed of fiberglass and a majority of them produced in Europe. The sailplanes typically cost \$30,000 to \$40,000 dollars with some of the ships costing as much as \$60,000 dollars.

There is a large difference between a glider and a sailplane in that a sailplane is capable of gaining altitude through the use of energy contained in the atmosphere (thermals) whereas a glider merely floats to the ground. If all the engines on a jet airliner were to fail then the airplane by definition would become a glider. On the other hand, a sailplane is towed by a power plane generally to an altitude of 2,000 feet, where it is released. From that point, depending upon the conditions of the day, a pilot can easily stay aloft hours on end and cover hundreds of miles. It may be interesting to note that sailplanes have reached altitudes of over 50,000 feet and have flown distances of over that 52 hours at a time.

A typical contest day begins with a mandatory pilots meeting which includes a very detailed weather briefing, a description of the task to be flown that day, the launch order, and any special instructions. Afterwards, the pilots return to their ships where they prepare for the days task. If it is a good day with strong thermals, the pilot will load water into the wings of the sailplane to give it more inertia and therefore fly faster. A good analogy would be, "Which can you throw farther - a ping






TEMPLETON SISTERS

And you, I remember you. Standing there straight as a soldier. You didn't have a hat, but you were giving the right salute. Remember little sister? Not to be outdone, she was saluting the same as you with her right hand over her heart ... remember?

What happened? I'm still the same old flag. Oh, I have a few more Stars since you were a boy. A lot more blood has been shed since those parades of long ago.

But now I don't feel as proud as I used to. When I come down your street you just stand there with your hands in your pockets and I may get a small glance and then you look away. I saw one man take his hat off then look around, he didn't see anybody else with theirs off so he quickly put his back on.

REMEMBERING FRANCIS SCOTT KEY


August 1 marks the birth date of the father of our national anthem, Francis Scott Key, who was born in 1779. Detained aboard a British ship during the bombardment of Baltimore's Fort McHenry on the night of

September 13-14, 1814, Key was inspired by the sight of the American flag still flying above the fort at dawn. It was then that Key wrote the poem "The Star-Spangled Banner."

The poem first was printed anonymously under the title "Defence of Fort M'Henry." On Sept. 20, 1814, however, it was published by the Baltimore Patriot and attributed to Key. The poem became popular throughout the nation when it was later sung to the music of an old English drinking tune. "To Anacreon in Heaven."

It was not until 117 years later that the "The Star-Spangled Banner" was made the official national anthem, when President Herbert Hoover signed it into law on March 3, 1931.

Key died in Baltimore on January 11, 1843.

The principal determinants in the selection process shall be qualification and experience in administering complete, meaning all administrative activities, of projects of like nature and the responsiveness of the proposal related thereto and as coorelated and compaired with the proposed fee.

Proposals are to be received in the office of the county Judge, either delivered personally or transmitted by public or private carrier and addressed to the County Judge, Mr. Tommy Seargeant, Box 348, Brackettville, Tx. 78832. 



If you travel around New Mexico, expecially on Pueblo Indian land you are bound to see Harnos. However the Pueblo people did not invent harnos. These beehive type outdoor ovens were brought to America by the Spanish who had adopted them from the Moors.

In Pueblo land almost every back yard has a harno. They are made of adobe bricks and mud, sometimes the dome top is made of lava rock.

Cooking in a harno involves knowing your own harno and using your own special skills. First you light a blazing fire inside, wait until it burns down. Then you must sweep out the coals and ashes, you swab it out with water to get it down to the right temperature, then swab out the excess water.

The temperature is then tested by putting a piece of paper inside. If the paper burns instantly it is too hot. When the temperature is properly fixed the breads or pastries are put inside. Indian bread is made this way at most Pueblos and takes about forty-five minutes to bake.

There are many types of harnos and the cooks adapt their baking to their own harnos and the materials they have to work with.

Harnos doors are covered in many ways. I have seen them covered with wood, garbage can lids, tops of oil drums, tin or tin covered wood, or the drip can of a modern stove.

If you walk through Taos Pueblo when bread is baking you can't help trailing the aroma and buying some. You can watch it being taken out of the Harno with a big wooden spatula and put on a nearby rickety table. There is honey on the table, you can drizzle some on your own bread and eat it hot and sweet. Believe you me, that hot bread and honey is "larrripin".

pong ball or a golf ball? " The sailplane pilots are very meticulous about the condition of their ship, even down to wiping the dust and bugs off that would cause a minute amount of drag.

At the designated time, the pilots roll their ships to the runway for takeoff.

Takeoffs are the most tense time for the pilots. If the rope breaks at low altitude while he is heavy with water, things happen fast. Upon reaching 2,000 feet above the ground, the pilot will pull the rope release, disconnecting the tow plane from the sailplane, and start rearching for lift.

Lift is found in the form of thermals. Thermals are parcels of heated air rising from the ground. As the air rises, the surrounding air cools until the thermal reaches the dewpoint temperature and forms a cloud. Clouds are the visible portion of a thermal. Therefore a sailplane pilot looks for rising air (lift) directly below a cloud. Thermals run from 200 feet per minute in strength to over 2,000 feet perminute. That would be the equivalent of climbing a mile high in just over 2 minutes.

The object of the competition is to see who can complete the prescribed task in the least amount of time. This equates to speed and like any other form of racing, the fastest speed wins.

The contestant will fly around the local area gaining altitude, testing the thermals, and waiting for the strongest part of the day. When he feels that the conditions are just right, he flys through an imaginary gate 5,000 feet high and 3/4 of a mile wide. The pilot will fly from thermal to thermal until he gets to the first turnpoint where he takes a photograph of the turnpoint from a special angle. These photographs are taken by two cameras in the sailplane and are used to determine if the pilot made it arouand the course in the specified order. He will conti nue around the course, taking pictures of the turnpoints until he is on the final leg home. At this point the pilot calculates the final glide speed which gives him the best performance. The object is to cross the finish line just above the ground and at top speed. Anything less would be a waste of energy and performance.

The finish is the most spectacular part of the competition for the viewers because the sailplanes are crossing just in front of them, sometimes less than 10 feet off the ground and at speeds of over 150 m.p.h. They are also dunping the water that they carried for the race at the finish line, because it would be dangerous to land with all the weight, and it appears they are trailing smoke. They streak across the finish line, pull up, and start a steep turn in for landing. It is a breath taking sight to see these sleek and beautiful powerless flying machines in action.

To give a good performance at competition, a pilot has to use a terrific amount of skill and finesse. In a race, a second here or a foot there may be the difference in winning or not.

The sailplane will average 90 m.p.h. for a task of sometimes 400 miles or more. This is faster than a lot of general aviation aircraft can do with an engine.

After the days soaring is over, the pilots group around the computer monitor where the results of each days competition will be scored and displayed, talking about the thrills and excitement they experienced during the days competition.

Sailplane pilots come in all ages from the teenager who just got his license at age 16 to the veterans that have been flying since Wilbur and Orville were learning how to ride bicycles. There is a special connection between sailplane pilots and enthusists which bind them together and give them a common interest to share.

I would like to invite you to attend our contest and share with your patrons the experience of competition soaring.

Next to a bird, piloting a sailplane is the purest form of flying and perhaps the most enjoyable to experience.



TEXAS AIR CONTROL

The Texas Air Control Board has adopted new rules, effective July 18, 1989 that will revise the state's plan for controlling inhalable particulate matter, including out door burning. The rules, while permitting several common practices by farmers and ranchers, do not relieve landowners from the consequences, damages or injuries resulting from burning. Also, certain requirements spell out specific procedures for out-door burning.


"Outdoor burning may by authorized by written permission from the executive director of the Texas Air Contol Board if there is no practical alternative and if the burning will not cause or contribute to a violation of any federal primary or secondary ambient air standard," TACB said.

Outdoor burning will be authorized for campfires, dead animal burning to control the spread of disease, rural area on-site burning of trees, brush, grass, and other dry plant gowth for right-of-way maintenance, landclearing operations, and for certain forest, crop, and range management purposes.

Also, salt marsh grass management burning may take place only in Aransas, Brazoria, Calhoun, Chambers, Galveston, Jackson, Jefferson, Kleberg,1 Matagorda, Nueces, Orange, Fefugio, and San Patricio counties and only under certain conditions.

In many cases, such as salt marsh burning, information must be provided to TACB at least 15 days in advance for the agency's review.
