## SOUTHWESTERN BELL TO CHANGE DIALING PROCEDURE

Beginning in late 1990, all telephone customers in the "512" area code will have to begin dialing "1-plus 512" or "0-plus 512" on all long distance calls within the "512" area.

Karen O'Neill, area manager for Southwestern Bell Telephone, explained that traditionally customers do not have to dial the area code for long distance within the same area code.

"That is changing. We are having to develop a new dialing plan as we near the point where we will be running out of new phone numbers in the '512' area," O'Neill said.

The area manager emphasized that the new dialing procedure will not be necessary until next year, starting in September.

"However", she said, "on a strictly optional basis, customers may start dialing the 512 area code beginning earlier in 1990. We'll announce publicly when the optional dialing arrangement will go into effect."

"We'll be putting out additional information through the news media, and with bill inserts, direct mail and even personal visits with business customers, long distance companies, terminal equipment companies and cellular telephone vendors," O'Neill said. "In many

cases their equipment will have to be reprogrammed to enable the new dialing arrangement."

O'Neill explained that the dialing of the "512" area code will become necessary in 1990 because new local dialing prefixes that resemble area codes will be created to make new phone numbers available to meet growth in South Texas.

"The new prefixes will have an '10' or a '11' as a middle digit, as do area codes. Local number prefixes in this area do not have such a configuration at this time," O'Neill said. "As we create such local dialing prefixes, it will be necessary to dial the '512' code on all long distance calls in the same area to avoid confusing the telephone switching equipment."

O'Neill said that beginning in 1995, it will be necessary to create a new area code in South Texas, in addition to the "512" code.

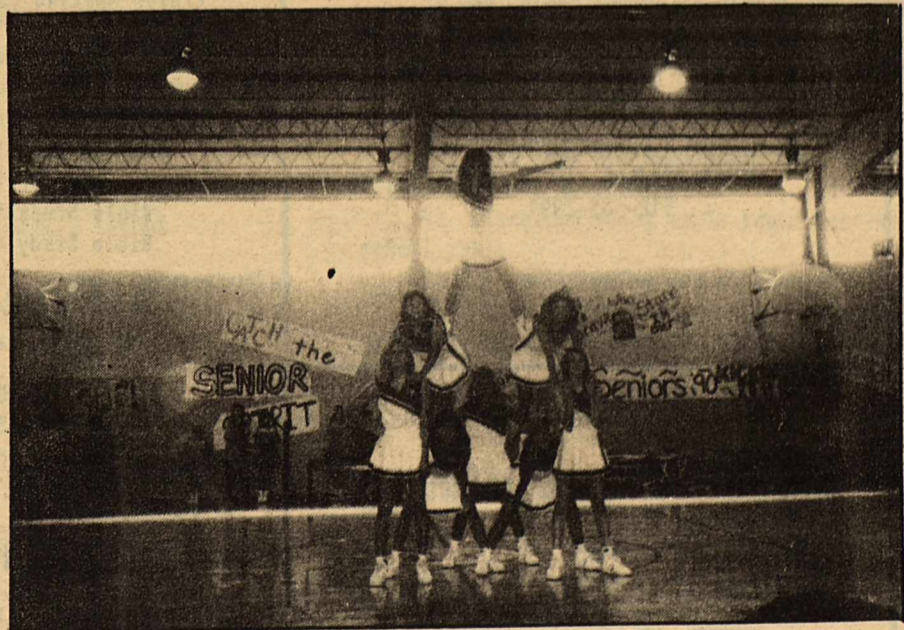
"The step we are taking next year is a temporary measure to keep up with growth without creating a new area code." O'Neill said the Houston area recently had to create the "409" area code out of what had been part of the "713" area code. The Dallas area, too, will be creating a new area code to enable provision of new phone numbers, O'Neill said.

## COMMISSIONERS COURT MEETING

The regular monthly meeting of the Commissioners Court was held on September 11, 1989, with all members present.

Minutes of past meeting were read and approved. Bills and Officers reports were approved.

Irma Perez, the County Librarian, informed the Court that she was hiring Maria Sanchez as assistant Librarian. She will begin her 6 month probation period immediately.

Notice was given of salary increase for all employees and officials with the exception of the County Commissioners.

The 1989 - 1990 tax rate was set.

Mary Luna was hired by Commissioners Court as Custodian of All County Buildings. It was also approved by Commissioners Court that Commissioner Bill Bizzell would be in charge of outside maintenance and Commissioner Rose Mary Slubar would be in charge of inside maintenance and cleaning.

Hiring a DPS Secretary was discussed. Justice of the Peace Alvin Hall offered one of his secretaries to work for DPS Officers, two half days a week. Since the Commissioners Court felt that they could not afford another full time employee with all the benefits, accepted Judge Hall's offer with gratitude. The DPS Troopers really need help and the County is very appreciative of their contribution to this County.

The Commissioners Court went into executive session to discuss personnel, pending litigation, salaries, and land acquisitions. When in open session, no decisions were made.

Discussion on resolution regarding the 911 Emergency number system was had. This subject was tabled.

Authorization was given by the Court for an outside audit of County funds and offices by Bill Schuler.

Authorization was given to Judge Seargeant to request a study on County employees and Officials from the Texas County and District Retirement System.

A discussion was held concerning the possibility of forming a Community Council of SWT (a new agency) by Real, Uvalde, and Edwards, and Kinney Counties.

Payment for new Cancer insurance that some 20 County employees have chosen to take, was approved.

County Auditor, Betty Deason was asked to audit and pay checks for the "Heat Stress" program.

Again Commissioner Slubar asked that an engineer be hired or acquired to check out the low water crossings on the Tularosa Road and the Pinto Bridge on Standart Lane. Judge Seargeant said that an engineer was coming from the Texas Highway Dept. in the very near future. The Court needs an estimate of how much it would cost to construct these two water crossing and bridge.

Authorizations to advertise for storm sirens for the Fort area was given.

It was approved to paint the inside of

the courthouse. Bids for paint contract will be accepted.

It was decided to buy road signs for all county roads.

It was approved to begin immediately on some repairs of the old jail building in preparation of the New Senior Citizens Center. The amount of repairs that will be done will depend on money availability.

The budget was amended for \$1,110.00 for Justice of the Peace supplies.

A resolution was passed to work with the City on replacing the swimming pool. It was also agreed to share in maintenance so the pool will be available to the people of this community.

Commissioner Bizzell requested an accounting of money spent on cleaning the cemetery. Also the Court wanted to know who authorized the work to be done. It was established that in the future, authorization would be given by the Commissioners Court on any work done. All the County cemeteries need to be cleaned. The Cemetery in Spofford was cleaned about three weeks ago. The County Cemetery in town is now clean and the old County Cemetery located on El Paso St. will be cleaned in the very near future.

A deputy sheriff slot was approved for an employee of the Drug Task Force. The salary for this employee will not be paid by the County.

It was approved to sell the old deputy sheriff's white ford to the City of Brackettville for \$250.00 under the interlocal Governmental agreement.

The meeting was adjourned.

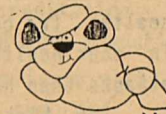

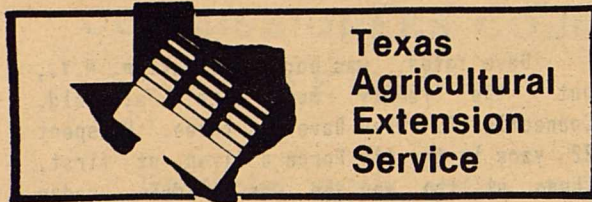

This will be the final call for fertilizer for your home turfgrass, ornamentals, and fruit trees. Fertilizer will help put your landscape fruit trees in good shape for winter. Caution and common sense are good words to keep in mind, but many trees will benefit from a boost before we have any cold weather.

Keep in mind that the tree should not be actively growing too close to a freeze as fertilizer will promote more growth resulting in severe freeze damage.

Trees under three years need more attention and in some cases, should not be fertilized as they may initiate new growth.

On mature trees that are not actively growing, apply one cup of ammonia sulfate (21-0-0) around the dripline. Remember that the dripline is the edge of the tree's canopy and is usually the edge of the tree's root area. For trees that look to be in poor health, two cups should be added. Also trees in poor health are more susceptible to borer attacks than healthy ones.

Too high rates than those suggested could cause freeze damage, but the correct amount at the right time will make the trees look healthier and bloom better next spring.

It is also time to treat for borers in your fruit trees. Peach tree borers are active in August and September during which time they will lay eggs around the base of trees. The eggs hatch in about 10 days. Newly emerged young bore into barks near the hatch site and begin feeding.

The life cycle is complete in one year. Eggs laid in August and September produce young which mature and become adults next August and September.

Borers, if in heavy enough numbers, can severely damage trees. If they cause enough damage to the layer just under the bark, the tree will most certainly die.

There are several good pesticides which are labeled for control of the peach tree borer. They should be sprayed or poured directly on a tree's base. Apply enough formulated insecticide to thoroughly wet the target area. Always read and follow all label directions.

**CITY NEWS**

The regular council meeting began at 4:30 p.m., the public hearing followed at 5:30 p.m., September 11, in the meeting room at City Hall, with Mayor Vito La Gioia presiding. The minutes for the previous meeting were approved, and the city financial reports were accepted.

The animal control officer, Joe Bravo, who is licensed and certified for the job, was given a fifty cents per hour pay increase.

The 9-1-1 resolution, regarding the emergency phone system, was discussed. This system is the same as other areas have in use. If you have an emergency and need immediate help or attention, simply dial the central number. If this resolution were to be passed and put into use, it could possibly be one and one half years prior to its activation. The city would need to spend \$44,000 to upgrade the phone system prior to its operation. There are approximately 3600 phone lines, and each phone line would be charged fifty cents, plus 1/2 % per month in order to pay for the upgrade. The main station would be located at the Sheriff's office, and would require three or four employees to operate it around the clock. This resolution has been tabled until the next meeting, when a decision will be made.

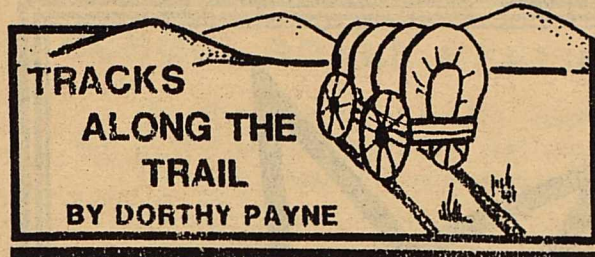
The council passed a formal resolution against the underground blast area in Val Verde County, a new chlorinator for the city water well, as well as self contained breathing apparatus for the employees that work on the chlorinator. This action was approved.

Near Santa Rosa, New Mexico there is a dark blue circular lake about 150 feet across, surrounded by sheer sand stone cliffs. Inside this bowl-shaped hole are large square blocks of stone stacked along the edge.

Naturally this bowl of a lake is called 'Hidden Lake'. People will tell you of other small sink holes near here like Blue Hole, but few know about Hidden Lake.

Years and years ago the Indians who lived here used the caves and crevices as protection against the cold winter winds. The steep sand stone walls are covered with pictographs.

**CITY NEWS**

The Fire Department requested funds to buy Scott Breathing Apparatus, which allows firemen to go through heavy smoke. They are also in need of mandatory equipment items, such as uniforms, and other items of equipment. This was totaled, but it appears that any money which will be used will go for the equipment and not the air packs. Four hundred and fifty dollars was added to the

Fire Department budget for the purpose of sending one fireman per year to school for certification.

In the annual budget, taxes were increased to the rate of .6227 per one hundred dollars. The tax ordinance passed, 13,000 have been funded for road repairs, and \$3,500.00 for parks and recreation.

When the time comes that a city manager will be hired, \$2,000.00 has been funded for that position. Due to the city not having replaced the previous city manager at this time, the salary savings has been great. Ten thousand of this has been saved toward matching grant programs.

The city is in good financial shape, and the County and City are going to assist each other in the swimming pool project.

During the public hearing, a presentation was given by the city about proposed projects, amount of funds being requested, amount of local funds to be used, and the estimated amount of funds and project activities that will benefit low/moderate income persons.

Time was allowed for discussion and comments from citizens,, and then the hearing was adjourned.

**SCHOOL BOARD MEETING**

Mr. Bobby McCall, Superintendent, called the meeting to order at six thirty, Monday night. The minutes of the regular meeting of Aug. 16th and the special meeting of Aug. 21, were approved.

There was no old business and the first four items on the agenda were appointments of Committees, which were approved. These were attendance rules and a committee formed to review excess absences, parent advisory committee for migrants, parent advisory committee for ESL, and a vocational education advisory committee.

The appointment of appraisers for the Texas teacher Appraisal system was approved with Mr. McCall, Mr. Sims, Mr. Mills, Mr. Burks, Mrs. Harrison and Dr. Tindel as the appraisers.

The Texas teacher appraisal system calendar was adopted.

There was a discussion on the career

ladder criteria with it being noted that they will use the current years appraisals for '89 - '90 career ladder.

There was a discussion on consideration of financing for air conditioning and additional classrooms and other campus improvements. There are 38 classrooms plus the auditorium to be air-conditioned at a cost of approximately \$1900-\$3800 per classroom. The electricity would have to be increased to handle the air conditioning. The only improvement is the Jones Elementary roof. The discussion continued as to whether classrooms should be added and where would they be placed or to get portable buildings. Funding for these improvements was discussed with it being decided to have a representative from TASB to explain the Captial Aquisition Bond to the board members at the next meeting. A survey will be conducted to see how the community feels about the coming projects and whether or not another bond issue would be excepted.

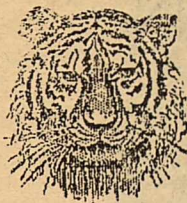
A request for a bus route extension was approved with the exception of traveling in inclement weather.

A compliance visit is scheduled for February, 1990. A compliance visit is different than an accreditation visit. Accreditation is concerned with education and instruction while a compliance visit is a checkup on finance records, teacher assignment files, migrant and Chapter 1 and vocational programs. The visit is to make sure that everything is where the school says it is and that teachers are teaching what they are qualified to teach.

There was a bid to buy a Risograph machine of two payments of \$5841 and \$100 installation fee. The two payments would be made one this year and one next year. There was no action taken as a demonstration was asked for first. A decision would be made at the next board meeting.

Mr. McCall recommended that the board not tie themselves down to the State Purchasing Contracts. It was feasible that they could purchase the same items from the companies that deal with the State Contracts for the same price plus a small addition.

## UNEMPLOYMENT

"What appears to be happening", Nabers said, "is that in spite of the fact that we are gaining jobs in the state, we are not gaining fast enough to keep us with the demand. People are entering the labor force faster than jobs are being created".

Of interest is the recent national report showing Texas as a state where a large number of the unemployed do not seek unemployment benefits. Payouts from the insurance program are currently averaging approximately \$2,700,000 a day Nabers says. "However, the trust fund from which benefit

payments are drawn is very healthy - better than it has been in the past ten years", she added.

Unemployment rates rose in almost every area of the state. Corpus Christi, however, posted a decline for the month and Bryan-College Station again received the state's lowest rate - 5.1 percent. Amarillo, at 5.8 percent, and Fort Worth - Arlington and San Angelo, each with 6.0 percent, also came in with very low rates.

## Quickly Cook Beef Strips In Microwave

Do you feel like your days are spent playing "beat the clock?" Then you're probably in need of some time-saving tips that will help you win the game, particularly in the afterwork hours.

Preparation time: 15 minutes  
 Cooking time: 15 minutes

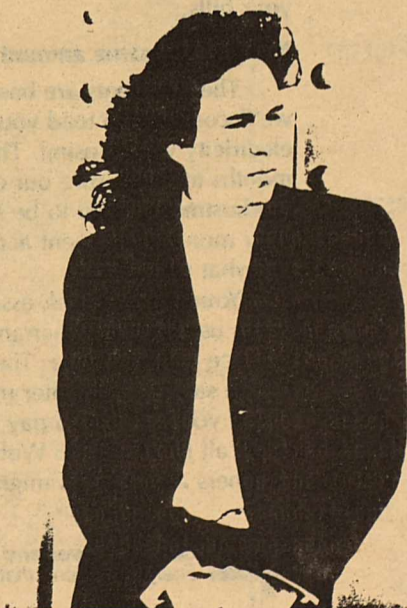
- 1-pound beef top round steak, cut 3/4-inch thick
- 1 medium onion, thinly sliced and separated into rings
- 1/3 cup catsup
- 2 tablespoons brown sugar
- 1 tablespoon cider vinegar
- 1 teaspoon each cornstarch, dry mustard and hot pepper sauce
- 1/2 teaspoon salt
- 4 corn muffins, quartered

Cut beef top round steak into 1/8-inch thick strips; reserve. Place onions in single layer over bottom of 11 3/4 x 7 1/2-inch microwave-safe baking dish. Cover with waxed paper and microwave at HIGH 2 minutes. Arrange reserved beef strips over onions. Microwave covered at MEDIUM or 50 percent power (300 to 325 watts) 5 minutes. Pour off drippings. Meanwhile combine catsup, brown sugar, vinegar, cornstarch, dry mustard, hot pepper sauce and salt, mixing thoroughly. Stir into beef mixture and continue cooking, covered, at MEDIUM 8 minutes\*, stirring after 4 minutes. Arrange muffins on individual plates. Stir beef mixture and spoon an equal portion over each muffin. 4 servings. 406 calories per serving.

\*Full-sized ovens, microwave at MEDIUM 6 to 7 minutes; stirring after 3-1/2 minutes.

Note: Three-fourths cup original flavor barbecue sauce, 2 teaspoons chili powder and 1/2 teaspoon dried oregano leaves may be substituted for catsup, brown sugar, cider vinegar, cornstarch, dry mustard, hot pepper sauce and salt.

Note: Recipes were tested in a 650-watt oven. If your oven has a different wattage adjust times accordingly.
