





Buffalo hunting has always been an important part of New Mexico economy. After the harvest was over in the fall the people who lived up and down the Rio Grande and the Pecos began to plan for the annual buffalo hunt on the plains.

In the last part of September, Las Ciboleros met at Lucera in the Mara region. They were armed with lances, skinning knives and carts. The night before the hunt they celebrated with a farewell dance.

The hunting caravans rumbled over the Llano Estacado. A camp site was selected and a camp set up near a waterhole.

When dawn came the hunt was on, as soon as one buffalo was downed, the helpers and butchers began to cut up the carcasses and haulad them back to the camp. There the meat was cut up and hung up to dry. Then packed up to take back to the settlements.

Of course travelers on the plains could expect trouble from the Indians. Sometimes the dangers were many. The situation became so acute that in 1830 the Governor sent soldiers and cannons to escort the hunters home.

Most of the time the hunters had to rely on their own efforts. If the Indians appeared they would circle their carts and defend themselves.

The Ciboleros returned to the plains for buffalo year after year. Soon trails were formed over the Mescaleros Ridge, and from the upper Rio Grande valley as far as Tucumcari mountain and the Rabbit Ear near Clayton, New Mexico. Same of todays highways follow along the trails, especially through the passes in the mountains.

In the days of the Ciboleros men lived fast and hard. Their way of life has vanished from the plains and well never be seen again. Only the folk tales and ballads written about them remains.

REP. HARRISON REPORTS MEETING WITH THE TEXAS PLANT FOOD INSTITUTE


State Representative Dudley Harrison, (D-Sanderson), District 68, reports that the Texas Plant Food Institute held its 1990 Annual Convention in Fort Worth on January 17th-19th. The convention focused on the issues and problems of the fertilizer industry today.

Rep. Harrison, as chairman of the Texas House Agriculture Committee, was a keynote speaker at the convention. He informed the group that the goal of the committee was to improve communication between commodity groups and the eleven state agencies that the committee oversees. "We want to make the state agencies better aware of the agricultural associations' concerns so that they may deal with them more effectively." Rep. Harrison said.

Rep. Harrison also spoke to the members on issues that are at the forefront of agriculture today. "As demanded by the public, today's farmer and rancher must also be an environmentalist, an ecologist, and a conservationist. The agriculture sector must address such issues as food safety, water quality and organic farming." Harrison said.

During the week of Janauary 22nd-26th, Rep. Harrison will speak to the Texas State Teachers' Association in Del Rio and he will attend meetings in Houston on Normal Occurring Radioactive Waste. He will finish the week in Corpus Christi by giving a speech to the Texas Agriculture Aviation Association on the new pesticide regulations.

SPECIAL CITY MEETING

The City of Brackettville held a special meeting Monday, January 22, 1990. Mayor and all Council members were present. Mayor La Gioia opened the meeting by welcoming all the visitors. Mayor La Gioia informed the Council the Fire Department would like to bring a circus to Brackettville, and he thought it would be good for the community and would be a good fund raiser for the Fire Department. The Council approved the Fire Department request. Mayor La Gioia read resolution 1990-1 taxation of property exempt. This resolution would allowed the City to tax certain goods, wares, ores, and other tangible personal property that is forwarded out of this state within 175 days of its aquisition or importation into this

Mayor La Gioia stated he had received quite a few complaints on the service and reception of the TV cable. Mr. Melvin Zamzow, General Manager, from Falcon Cable TV in Pleasanton was present to hear complaints and

answer questions from the visitors and the Council.

Questions such as how many TV cable connections were there in Fort Clark and Brackettville? Answer: Approximately 850. How much revamping had been done on system since Falcon took over? Answer: Have replaced line from Las Moras mountain to dish and buried some cable that was on top of the ground at the Fort. When the TV goes off after 5:00 p.m. or on the weekend, customer calling, has to leave his message on

the answering machine.

Mr. Zamzow replied yes the customer did have to leave a message on the answering machine and these messages were checked frequently. One visitor said he was told no service is provided on the weekend and he would have to wait till Monday. The response time to fix the TV cable was discussed. The visitors stated sometimes the cable was off for hours and sometime it was off for days and shouldn't the customer get credit on their billing for the time it was off. Mr. Zamzow told the people if they would leave their name and such he would look into it. Mr. Zamzow stated the repairman was only in Brackettville several days a week because he was servicing other towns owned by Falcon, and within the area Falcon owned they have 8,000 connection to service with only five men, but are looking to get a serviceman to live in Brackettville. One Lady stated she had called 6 days in a row and complained about her Disney channel being off and she never had anyone come and repair it and the personnel from Falcon was very rude. Another visitor stated he had paid his bill and he still got cut off and when he told the serviceman he had paid the bill the serviceman just replied, "Sorry I've got a cut off notice on you" Mr. Zamzow stated the serviceman is suppose to check with the local collection agency before he did any disconnects. Channel , 5, & 6 are the channels that the people are having the most trouble with. Mayor La Gioia asked Mr. Zamzow when could the people expect some result? Mr. Zamzow stated he needed to bring his boss down here to look over the system. Mr. Zamzow stated it would cost about \$400,000 to revamp the whole system and it would cost about \$90,000 to microwave from the mountain and because of the expense to upgrade it would be a long time span. Mayor La Gioia stated looking over the system wouldn't suffice and when would'Mr. Zamzow get back with him with the results and what Falcon plans to do to the system. Mayor La Gioia after great effort finally got Mr. Zamzow to committ himself to get back with him at the end of February. The main office of Falcon is in California and the working office is located in Pleasanton, Texas.

Mayor La Gioia informed the Council no decision could be made on the employees' insurance at this time because more information was needed.

The Planning and CDBG Grants will go before the review committee in Austin on the first week of February. The City will be notified after they have met and made their decision.

The City landfill has many violations but the City is in the process of correcting them. The landfill will be closed Monday, Tuesday, and Thursday starting February 12. Winter hours are from 8:00 a.m. to 5:00 p.m. and the summer hours will be from 9:00 a.m. to 6:00 p.m


