

**ONE DEAD AND THREE INJURED IN ACCIDENT ON HWY. 674**

On February 24, 1990, at approximately 2:00 a.m., an automobile accident occurred on State Highway 674, three miles North of Brackettville. The vehicle was a 1988 Chevrolet pick-up truck. The truck turned over approximately two times and also tore down 200 feet of fence.

The driver was Jesus Rodriguez. The passengers were fifteen year old Basilio Pacheco, seventeen year old Gerardo Pacheco, and twenty year old Salvador Pacheco, Jr.

Gerardo Pacheco was pronounced dead at the scene of the accident by Justice of the Peace, Alvin Hall at 3:27 a.m. Gerardo Pacheco was buried in Ciudad Acuna, Mexico, by Cemeterio Dolores.

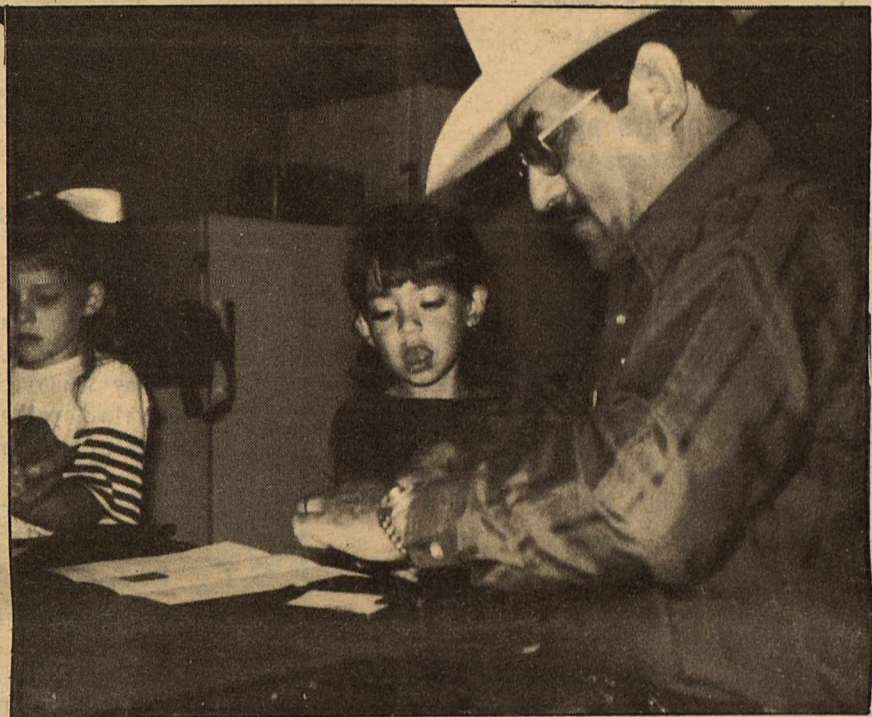
Salvador Pacheco, Jr. sustained multiple injuries and was transported to Val Verde Hospital by ambulance. The other two boys had only minor injuries and were not transported by ambulance.

**TWO BODIES FOUND**

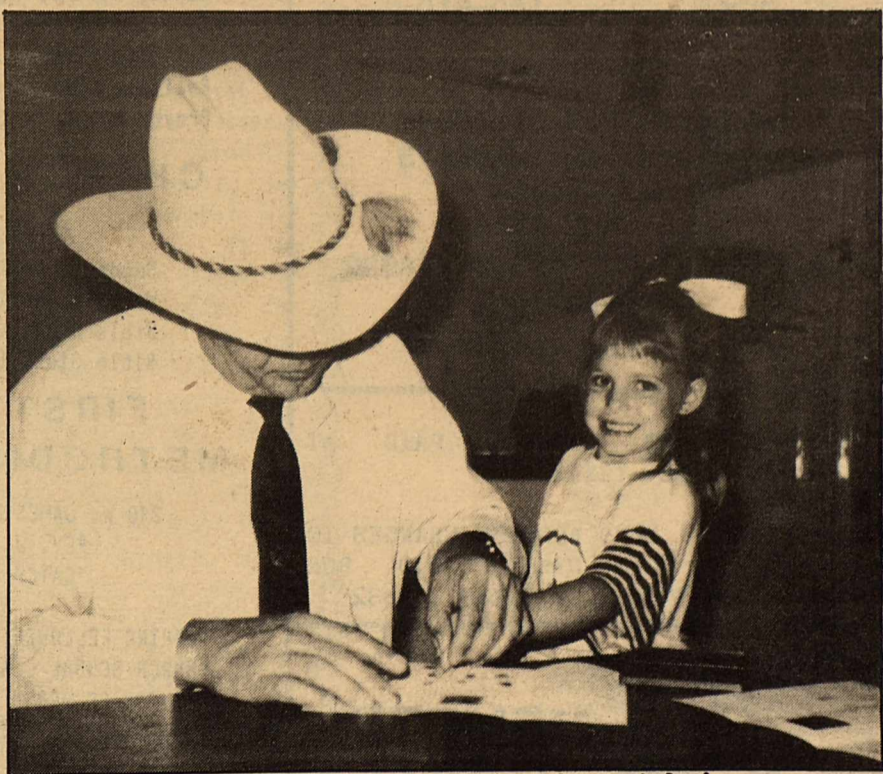
Early Friday morning, February 23, 1990, officials were called to the scene at the headgates of the Rio Grande on the Moody Ranch approximately twenty-five miles south of Brackettville. Local workmen had discovered the body of a young hispanic male.

Early Sunday morning, February 25, 1990, officials were again called to the scene at the headgates of the Rio Grande on the Moody Ranch. Another young hispanic male had been discovered.

In both cases, Sheriff Norman Hooten contacted the Mexican Consulate in hopes of obtaining an identification. As of this writing, no identification has been made. Both bodies were held for seventy-two hours and then buried in the Kinney County Cemetery on Wednesday, February 28th at 10:00 a.m.

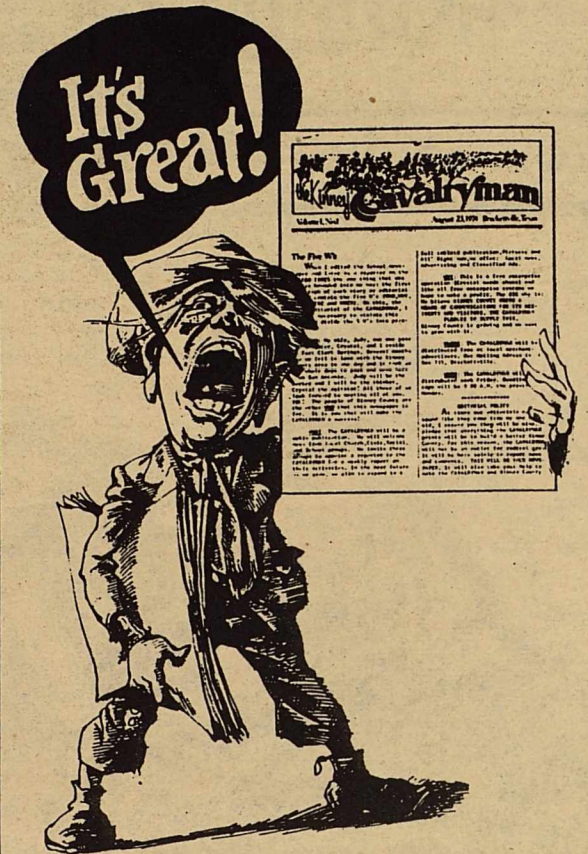

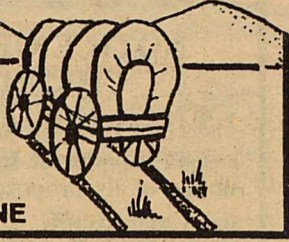

ALONG THE  
TRAIL

Almost every word used in cow country came from the Spanish. We say "lingo" for language which is from the Spanish word "lengua." "Vaquero" becomes "buckaroo," "jacima" becomes "hackamare." "La Reata" becomes "lariat," other words are "bronco," "adios," "latigo," "angora," "hurro," "ante" and "remuda." A favorite is "cimarron," which means a roon cow critter that is wild and hard to handle.

There are two major uses for cattle, one is for milk and these are cows raised on a dairy. But most of the cattle of the southwest are headed for the slaughter house.

In Mexico there is a third use for cattle, these are raised for fighting. There are twenty to thirty ranches in Tlaxcala that raise los toros bravos. There has been fighting bulls for more than a hundred generations. There is not even a Spanish word for bullfight. In Mexico it is "la fiesta brava," or a corrida de taras meaning a running of the bulls.

If you would trade places with a fighting bull and had a choice would you rather be branded, crop you ears, made a steer and in your prime be sent to a slaughter house? Or would you rather take your chances in the bull ring?

You may be sorry for the fighting bulls but they always end up in the same way other cattle do, in the slaughter house.

In the United States more young men are injured or killed in various sports than in all of Latin American's "bullfights." All ranchers who raise cattle for any purpose can identify with each other.

## NOTICE OF TARIFF CHANGE TO CENTRANET® SERVICE

GTE Southwest Incorporated gives notice of its proposed tariff changes to CentraNet® service, which is a Central Office-based service that provides PBX-type features to multi-line business customers and is currently being offered in all company wire centers where such facilities exist to provide the service.

The Public Utility Commission of Texas approved a generic tariff for CentraNet® service up to 100 lines in Docket No. 7652. The proposed tariff revision would establish specific rates for CentraNet® service involving 101 to 400 lines. Other proposed revisions involve the rate applicable to changes, additions, or deletions to the data bases and a new rate is proposed for ad\*ditional trunks.

The names of the three CentraNet® packages have changed from Standard, Premium, and Deluxe to CentraNet® 1000, CentraNet® 2000, and CentraNet® 3000, respectively. Direct Call Pickup has been added to the three CentraNet® packages while Multiple Call Park and Shared Speed Call 30 have been added to CentraNet® 2000, and Speed Call 30 and Call Forward Busy/No Answer Split have been added to CentraNet® 3000. Flexible Night Answer and Automatic Route Selection also have been added as new optional features.

The proposed changes and new service offerings have been assigned Docket No. 9251, and pursuant to Section 43(d) of the Public Utility Regulatory Act will become effective June 23, 1990. Rates for service will be applicable to customers who subscribe to the service as well as existing customers. Therefore, there will be no effect on any other rates of the company. The company's gross annual revenues will increase by approximately \$399,600, or less than one percent annually.

The proposed rates are on file with the Public Utility Commission of Texas, and are available for public inspection at the offices of GTE Southwest Incorporated. Persons who wish to intervene or otherwise participate in these proceedings should notify the Commission. The deadline to intervene in this docket is 3:00 p.m., March 19, 1990.

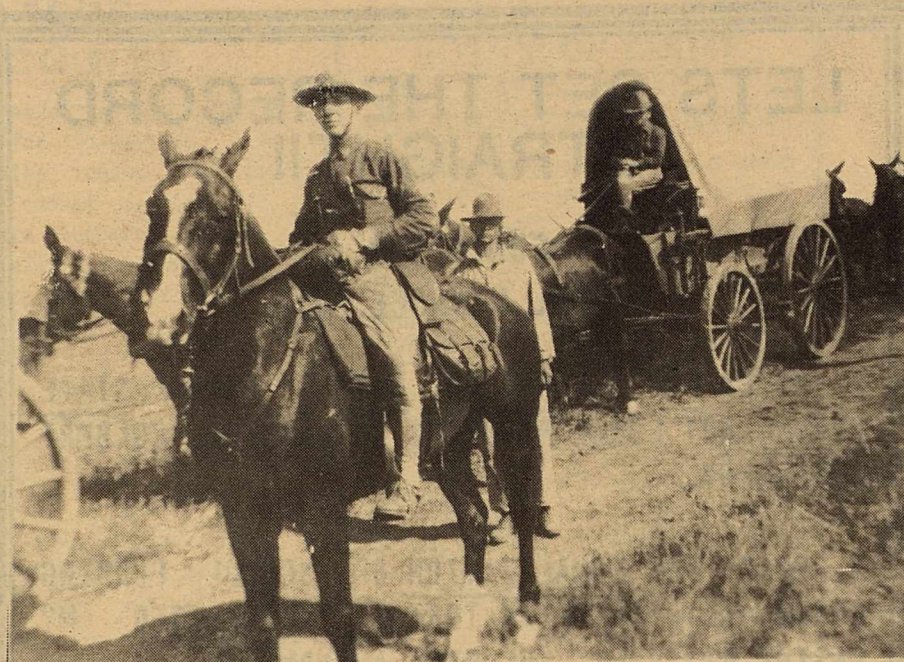

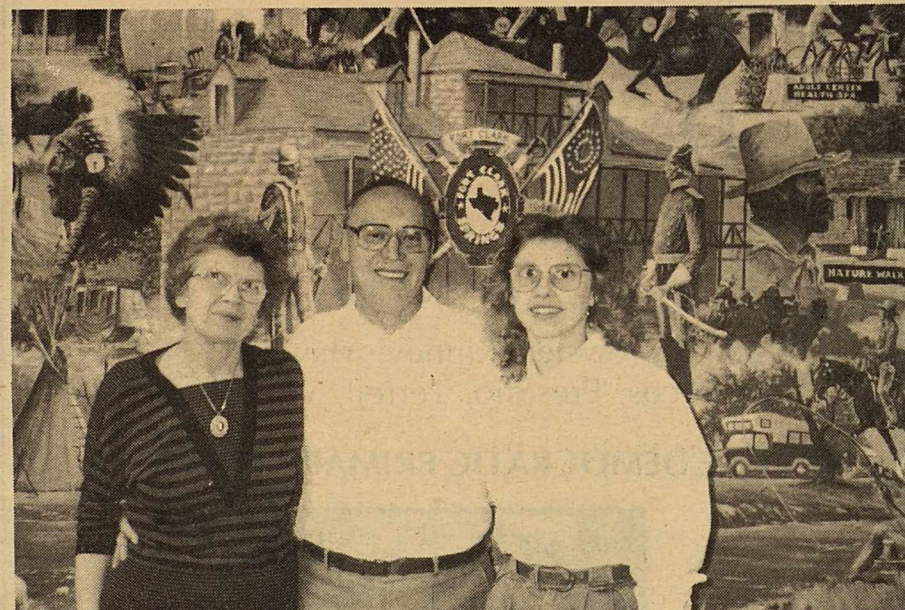


### OLD ARMY DAYS

Allen agreed that Fort Clark has changed tremendously and it brought back many memories. "You know, 49 years really goes by fast," said Allen.

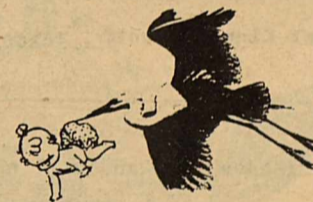

TO THE VOTERS OF KINNEY COUNTY

I had hoped that this campaign would be clean and free of any personal attacks. Unfortunately, I have been made the scape goat for something I had no part in. I trust that in view of the facts presented here, the majority of the voters will be able to see slanderous rumors for what they are. It appears that someone is making a desperate attempt to shift the blame.

As County Commissioner, I abstained from voting on a resolution opposing the proposed norm waste facility during a Commissioner's Court Meeting on October 10, 1988. At the request of the C.A.R.E. group, I signed an affidavit stating that I would remain silent on the issue because my cousin Fourth Coates had signed an option to sell his land to this industry. Since a relative was involved, I wanted to avoid any possible conflict. In accordance with State Law, I readily agreed to sign an affidavit which stated that "I have not, and will not, participate, influence, discuss or enter into any vote with the Commissioner's Court of Kinney County, Texas for the norm waste dump site." This affidavit is a matter of public record and is filed with

the County and District Clerk. I have tried to abide by this affidavit and remain silent as long as I was in public office. Since my resignation as a County Official in December 1989, my legal council has determined that I may now make this public statement. I signed this affidavit in good faith, believing that my silence would meet the approval of all concerned. However, some have deliberately chosen to take advantage of my silence and twist the facts, in an effort to discredit me personally, in order to gain some type of political advantage.

Contrary to some rumors, I was not the County Judge who invited this industry to Kinney County, nor did I try to locate property for them to purchase. I was not the County Judge who set up meetings with the Commissioner's Court, Mayor and City Council of Brackettville, Chamber of Commerce, civic groups, local businessmen and other community leaders soliciting their support. I learned about this project months later, after the wheels had already been put into motion.

In recent months, and contrary to my wishes, my sister signed an option to sell her

land to this industry. Her decision to sell was her own, and was a result of her own concern about possible property devaluations.

I own the land that joins the proposed site on the south side. I inherited this land from my grandparents and someday would like to gift it to my children. I have no interest in selling my land to this industry, nor have they approached me to buy my land in any form or fashion, past, present, or future. If anyone stands to lose from property devaluation, I do. Therefore, the accusation that I have supported this industry just does not make sense. I would never support or sell my land to an industry that would present a health problem to the people of Kinney County. My years of volunteer service with the E.M.S., Brackettville Volunteer Fire Dept., and Kinney County Memorial Clinic demonstrates my concern for the health and well-being for the people of Kinney County.

Do not be misled by those who make accusations, without the facts and proof to back them up. Let's center our efforts on correcting the problem rather than making it a personal political vendetta, which only serves to further divide the community. I hope this letter will put an end to the slanderous accusations that are being made against me.

Please look at my entire record, investigate the facts and arrive at a fair and truthful conclusion. I am proud of my public service and have always tried to support those issues that will improve our County. Thanks for your time, your support and your vote.





I hope you will give serious consideration to my request and let me know when the public hearing can be scheduled so I can inform my constituents.

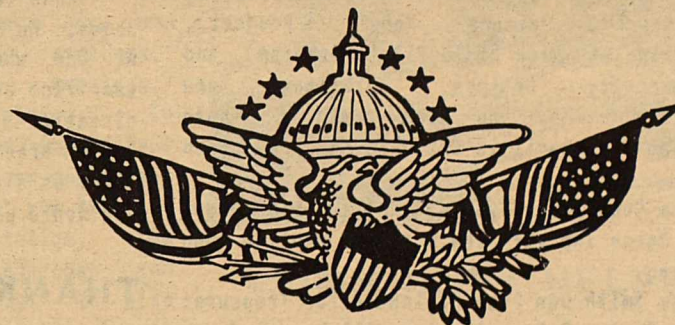

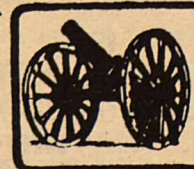

**REFLECTIONS**

E. Stanley Jones, a world-renowned missionary and author, suffered a crippling stroke after he reached his eighty-seventh year. What would he do with "the rest of life?" That notable man forced himself by the greatest pain and effort to dictate the material for his last work, his twenty-eighth-

book. His earthly work came to a close--but not his influence.

To pour out one's life in service for others is the challenge of the Christian gospel. Let me suggest two reasons for this kind of living.

In the first place, Jesus Christ has poured out his life for us. The central message of the Bible is that God gave. He has given His Son for man's redemption. In service and in sacrifice Jesus empties Himself for us. He died for our sins. He shed His blood so that man might have the forgiveness of sins and the peace of God in his soul. A right relationship with God is man's basic need--more basic than the air he breathes or the water he drinks, or the food he eats.

Christ triumphed over the grave. He conquered death. The Son of God lives now. But never let us forget that He still offers Himself to us by the genius and power of the Holy Spirit. That "self-giving" by the Lord and Master is a fresh reminder every day that we are to give life in His service for God's glory and man's good.

In the second place, we ought to share life because that's the only way to keep on living. A greedy, covetous person in an unhealthy, un-Godlike, repulsive individual. The Bible says a stinging word at this point: "covetousness, which is idolatry." If we hold on to, cling after, or grasp life and the "things" of life, then we are disobedient to the God who made us.

In His famous Sermon on the Mount, Jesus tells us to lay up treasure in heaven, not on earth. Moth, rust, inflation, death and a thousand other intruding enemies will take away from us what we desperately try to store up for ourselves.

None of us will ever be an E. Stanley Jones. We can be, however, the Covenant People of God whose tracks go in the direction of sacrifice and service for others. This is the direction in which God continually moves. Fresh breezes from His Presence will buoy and carry us along if we are headed in the way that God wants us to go.

## NEWS FROM FIRST UNITED METHODIST CHURCH

Persons who have helped prepare for the sale so far include Cindy Braesicke, Helen Peck, and Leola Finger (committee members), and Jill Duncan, Francis Larson, Darryl Earwood, Flo Stafford, and Ira Finger.

The last study session of WHAT UNITED METHODISTS BELIEVE taught by Pastor Cole was held Sunday evening, February 25. The class reviewed for "our theological task"—Scripture, Tradition, Experience, and Reason—and the United Methodist approach to utilizing these that makes for greater tolerance, puts more responsibility upon each individual member for "hammering out" a belief system that "fits" and "works for him or her," and that allows for

pluralism or many different theologies.

After reflecting upon the "Catholic (Universal) Spirit" taught, preached and lived by the founder, John Wesley, class members then learned about the documents, Holy Living and Holy Dying, a joint Roman Catholic-United Methodist consensus worked out over three years of inter-disciplinary study, and EPISCOPACY: A LUTHERAN/UNITED METHODIST COMMON STATEMENT TO THE CHURCH. The latter document discusses the similarities between the two denominations, in terms of history, structure, and standing in relation to other denominations and ecumenical discussions.

The class reflected upon the three aspects of God's grace lifted up by Wesley in his sermon, "The Scripture Way of Salvation." The activity of God leading, supporting, and helping us even before we know Him or his love (grace prevenient—going before) Wesley called the "porch of faith." The "door of faith" is when a believer is "put right" with God, when he or she experiences grace ("justification"), is assured of God's presence or love, receives pardon or forgiveness for sins, etc. With that "conversion" (whether understood as a point or a process) God's grace continues to work through, in, and for the believer. And this is called "sanctification," the continuing work of God in Christ through the Holy Spirit, in "perfecting him in love," in giving him the "mind of Christ" and teaching/ helping her to "walk as Christ walked." This process Wesley called the "room of faith." All Methodists expected each other to "go on to Christian Perfection," to "put away outward sin" and follow the guidance of God's Word and Spirit until they truly "loved God and all men," toward their full maturity and humanness in Christ.

The class learned that as "the West was won" to the name of Christ there were new inventions: "revivals," "camp meetings," "brush arbors," "protracted meetings," "Chatauquas," and "collection plates." It reflected upon the newness and imperatives placed upon Christianity by that new experiment enacted in the First Amendment of the Bill of Rights to the U.S. Constitution, the "disestablishment" of state churches and (radically new) "Religious Liberty!" It also discovered that as Christianity and the circuit riders pushed further West, there was a general lowering of educational levels and concern for formal liturgy, the sacraments, etc. For some Methodists and many others "saving souls" became all-important and too often that was reduced down to meaning (only) the process of "justification." Except to fight with the Baptists over baptism (Methodists honored the three historic modes of Christianity, sprinkling, immersion, and pouring), the Presbyterians over "free will," and the Episcopalians over liturgy or formal worship, a great deal of concern and awareness regarding both doctrine and discipline was lost. It is ironic that some Methodists joined other revivalist Christians in forgetting all about "sanctification" and the continuing work and leading of the Holy Spirit in perfecting the believer which frees her or him not only to their full potential and personhood, but at the same time frees them to participate in the continuing work of God as the Body of Christ in behalf of the world. The purpose of the

Methodist Episcopal Church (1784), "to reform the continent and spread scriptural holiness across the land," thus got lost at times. At this time, the primary vehicle for keeping Methodists sound in doctrine were the hymns they sang joyfully, especially the many hymns of John Wesley's brother, Charles. Pastor Cole read, for amusement and edification, Wesley's seven "rules for singing" among the Methodists.

The class also listened to a sermon by the Rev. Mr. David Stewart, pastor of First UMC, Del Rio, which pulled together so much of the material covered in the four sessions regarding UMC beliefs and approach to belief, theology (thinking in faith) and ethical and other decision-making. The class responded positively as he made the point that United Methodism offered a belief system that allowed for "balance," gave one "a good foundation," kept one from "getting locked in," and freed/allowed a person to wrestle until he had a theology that would work for and fit him/or her. After reminding persons of our heritage and the horrible conditions in England that Methodism addressed and reformed, he made the point that "to ask a United Methodist to not be concerned about social issues, is to ask him to not be a (United) Methodist."



## "COMMUNITY HELPERS"

Brackettville's Head Start children have been studying "Community Helpers" this past week. In an effort to emphasize how important "Community Helpers" are, the children were shown a tour of the Brackettville Fire Station by Gilbert Sanchez and David Martinez. Mr. Sanchez and Mr. Martinez showed the children fire proof suits, fire equipment, safety precautions, and how to use a fire extinguisher.

The Head Start children also learned about the parts of a fire truck. Mr. Martinez and Mr. Sanchez explained the purpose of the different machinery on the truck and showed the children the siren, the hoses, the extinguishers and many other important parts. The tour and demonstrations proved to be a good lesson in "Community Helpers."

It's easy to tell the alligator from the crocodile—the alligator has a much broader snout and is less aggressive and active than crocodiles.

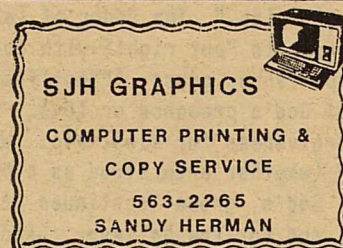

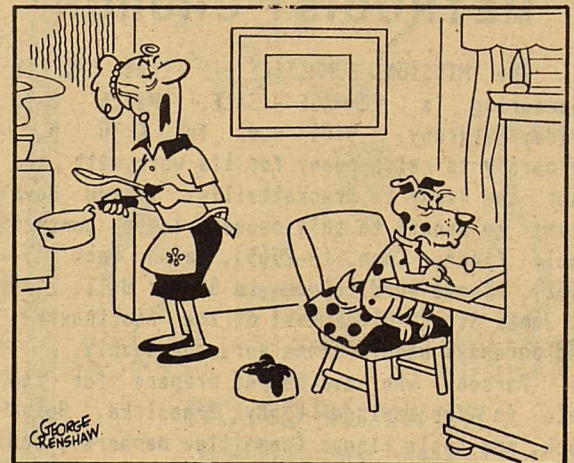
