



In far west Texas and north into Eastern New Mexico stretches an extensive plateau about one hundred eight square miles in area. It is called by the Spanish "Llaão Estacado" which means "palisaded" or "staked plains."

There are several theories as to how this area got its name. One is that the early Spanish explorers in that region called it the "staked plains," because they set stakes in the ground to mark their routes over the treeless plains where watering places were few and far between

Another theory said the Spanish named the plateau because there were so many "yucca plants" known as "Spanish bayonets" or "daggers."

Yet a third theory was it was named "staked plains" because the plants at the foot of the mountains looked like stakes or palisades from a distance.

According to the diary of Thomas Falconer, who went on the Santa Fe expedition of 1841 said the plains were without timber, water and would kill the horses. The land itself looked

In San Antonio the opinions was that it was too vast to attempt to travel over.

The "Llano Estacado" is bounded on the north by the Canadian river, on the west, southwest and south by the valley of the Pecos, and on the east by the head-waters of the Red, Brazos, and Colorado rivers. It is a high isolated plateau. It is composed of limestone which is somewhat more resistant to erosion than the encarpment is called the "caprock."

When I lived on the edge of the caprock it was infested with diamond-back rattlers. There is little rainfall, sparse grass, no trees, and in spite of a popular view point is not level by undalating.





HOUSTON LIVESTOCK SHOW RESULTS

Kinney County 4-H members had another successful show in Houston last week. There were approximately 1500 lambs entered in the junior market lamb show in Houston. The quality was extremely good and the Houston Livestock Show has been known as one of the toughest lamb shows going. Stephanie Ahrens took honors having the reserve champion crossbred lamb of the show. Kimberley Ahrens had the 1st place medium wool lamb in the lightweight division. Justin Coates had a 9th place lamb in this same class which had over 200 other lambs in it and took judge Larry Shell, from Oklahoma, about 3 hours to judge. Wil Shahan had a 2nd place lamb in the mediumweight crossbreds and Lacey Esser had a 23rd place in the same weight class. Richard and Walt Esser had 15th and 16th place lambs respectively in the heavyweight crossbred division. Jared Shahan had a 13th place lightweight finewool. The Grand Champion lamb sold for \$40,000. Stephanie Ahrens' reserve champion crossbred lamb sold for \$8,500. H members from Brackettville will be competing in San Angelo this week to wind up the spring junior Stock Shows. Congratulations are in order to all 4-H'ers from Kinney County for a strong showing at the 1990 Houston Livestock Show.

TIME FOR PRUNING!

Homeowners are reminded that March is the best time to prune roses. Hybrid Teas, Floribundas, and Grandifloras are usually pruned heavily at this time (down to 18 to 24 inches form the ground). Weak or dead canes should be removed or shortened to healthy tissue any time during the year. If you prefer a less drastic approach to annual pruning, you can cut back the vigorous canes one-fourth to one-third their length for a more attractive plant, especially for old shrub-type roses. A light application of fertilizer with some pruning in mid-August can lead to some fall flowering.

ANNUAL RAM TEST & FIELD DAY

The Annual Ram Performance Test Field Day and Sale is set for March 15 at the Sonora Experiment Station. The formal program will begin about 1:00 p.m. followed by the sale of performance tested animals at around 2:30 p.m. There are 400 rams on the test. new for this years tests are two groups of Australian Merino-Rambouillet rams that are being evaluated. There will be 75 rams available for public auction. These 75 rams must perform above average on the test and pass visual inspection and meet certain minimal production.

The program will feature a discussion of the new initiatives in wool and mohair marketing, comments on the lamb markets, an Australian Merino evaluation program will conclude with the sale of the eligible performance tested rams. 

FRONTIER GUNS & FRONTIER GALLEY

The name is unusual and the husband/wife business is equally unusual. Warren and Francis Outlaw demonstrate their marvelous creative talent and appreciation for the artistic and rare treasures that grace their side by side shops, on North Street. It is worth your time to pay them a visit, and while there, select a bargain or two to take home.

They bought the store building in 1979 in ghost town condition and have photos to prove it. With much imagination and improvisation, they put together a quaint and picturesque structure which is compatible with the unusual history of Brackettville.

The building is divided into separate shops. At 202 North Street, you will find the Frontier Gallery, which is filled with many beautiful and delightful works of art—paintings by Frances—and many antique items. It is a treasure house of interesting and fascinating creations. In addition custom built frames from old lumber are created on the premises to enhance western subject paintings. Many of these frames are on display at the Breen Gallery, on Ann Street.

Warren is top gun at the Frontier Gun Shop at 204 North Street. He can fill orders for new guns for sportsmen, and collectors, for just 10 percent over wholesale cost plus freight charges. He has accumulated a stunning variety of old firearms, including many small caliber weapons. Filling out his shop is one of the largest collections of Pancho Villa and Mexican Revolution (of 1910) photos that can be found in the southwest.

Both Warren and Frances are Texas born folks, he in College Station, and she in Houston. Warren gave 35 years in Store Supervision positions as Kroger Company spread throughout the south. Frances was also employed with the company for many years. She is now active with local art groups and specializes in smaller paintings for residential decoration. They both enjoy the good life as residents of Fort Clark Springs.

OLDARMY DAYS

Fort Bowie, Arizona Territory in the 1880's.

This photo, appears to me, that is was taken during this time frame, due to no visible piping on the five button blouse coats of the enlisted troopers. The scene is of a platoon of troopers riding out of old Fort Bowie. This was the entrance and the visible wall was part of the sutler's store and faces west. This Fort was part of the chain of Forts along the Butterworth Stage Line. I haven't viewed this location in approximately fifteen years, but this wall was still remaining, and the only standing structure, and the entire fort was being prepared to be rebuilt. It is approximately 18 miles south of the interstate highway from El Paso to Tucson.

TO THE VOTERS OF KINNEY COUNTY

As we approach election day, March 13, I believe it is important that each voter know as much as possible about each candidate and his or her background. I would like to point out some of the accomplishments made during my 11 years in public service.

As City Manager: the following improvements were made to the overall operations of the City of Brackettville during my 2 year period:

1) The Utility Department-

- a) An improved cost-saving method of record keeping and billing was developed.
- b) Gas leaks were reduced from a 40% to under 5%, unaccountable. All gas meters were re-calibrated.
 - c) Water leaks were reduced from 30% to 10% unaccountable.
- d) A new water main was installed on Sweeney St. with funds received from a C.D.B.G. Block Grant.

2) Fire Department-

a) For little cost, a 6X6 Rural fire truck was obtained from the Texas Forest Service. This enabled the Fire Dept. to cover rural, rough-terrain fires.

- b) A new Fire Truck Chassis was purchased in 1979. I arranged and took the existing pumping unit to Texas A&M University to be reworked and placed on the new truck chassis. This method saved the City approximately \$30,000.00. Insurance premium cost in Brackettville and Fort Clark were reduced, when this unit was placed into service.
- c) Approximately 15 new fire hydrants were installed, for broader fire protection coverage; Hence, Insurance Premiums were reduced with-in these areas.
- 3) Concrete drainage ditches-were completed through the downtown sections of the City, under a C.D.B.G. Block Grant.
- 4) Low water crossings with walk-bridges-were installed on Las Moras Creek under another C.D.B.G. Block Grant.
- 5) A new back-hoe-was purchased under a lease purchase plan with yet, another C.D.B.G. water improvement grant, which paid for this new unit at no cost to the local taxpayers.
- As County Commissioner, the following improvements were made to the overall operations of the County during my 8 years of service:

When I was elected Commissioner in 1980, the County was in

serious financial condition. The previous administration had paid no attention to a balanced budget. Chronic budget amendments were being made, resulting in a large debt to our local bank. The following measures were implemented to pay off the debt and get the County back on a solid financial standing.

1) Across the board reductions in budgeted expenditures. Though unpopular at the time, this was the only way to bring expenditures in

line with receipts.

2) With a referendum passed by the voters we were able to consolidate the following offices and departments.

a) Four J.P. precincts were consolidated into one County-Wide J.P. precinct.

b) Four constable precincts were consolidated into one County-Wide constable.

c) Four County Road Departments were consolidated into one County-Wide road department. The first year under this plan the road dept. expenses were cut in half.

All of these changes reduced expenditures by eliminating a duplication of services, cutting over-head, better management of personnel, less capital outlay, better equipment maintenance and the reduction in the amount of equipment needed.

3) The Commissioner's Court and the County Sheriff negotiated a contract with the U.S. Marshal's Service to begin handling Federal prisoners. The basic operational cost of the jail would be necessary, with or without, the prisoner care program: therefore, the revenues that are generated more that off-set the expenses necessary for the basic operation of the jail. These funds have helped the County's cash flow problems and have created employment opportunities.

4) As a result of these procedures being implemented, the following changes were made in the County's Finances, beginning with

my first year as a Commissioner through my 8 year tenure:

5) During my 8 years as County Commissioner, the taxpayers, not only benefited by a complete change in the handling of County Finances; but also, major capital improvements were made to two public facilities:

a) Kinney County Library- A grant had been obtained to build a new library. The administration, prior to 1979, had advanced a disproportionate amount of money to the architect and the contractor, with the building only being 30% to 40% complete. The performance bond was handled by an Insurance Agent from Uvalde and was proven to be invalid. As a result, the taxpayers were cheated out of many thousand of dollars. The Friends of The Library, and many others contributed time, effort and money to see this project completed. We can all take great pride in this fine facility.

b)Kinney County Memorial Clinic Expansion-The City of Brackettville and Kinney County worked together to obtain a grant to enlarge our Clinic in 1986. I was proud to serve as the volunteer contractor for this project. The addition to this facility has greatly improved the health care for the citizens of Kinney County.

I am proud of these accomplishments, however, there are still many ways our County Govt. can be improved; some of which, I presented in my previous mail-out and newspaper article. If elected, I believe that I can restore credibility, responsibility and strong leadership to our County.

In closing, regardless of who wins this election, the most important thing is that the people of this County come together and put aside personal differences. If we will forgive one another and pray for one another great things are possible. Thank you for your encouragement, support and your vote.

REFLECTIONS BY PRESTON TAYLOR FIRST BAPTIST CHURCH

Our family sat around the dining table eating black-eyed peas, turnip greens, corn bread, and milk. We had been in the hot cotton field all morning.

During the rushed meal time, an older brother said to me, "Preston, don't bother my T-Model car. It won't start because it's out of gas."

Within two minutes I slipped away from the table. A few moments later, I climbed up on the hood of the "I-Model." Then I unscrewed the gas cap and looked inside the tank. The tank looked empty.

As quick as a seven year old boy could do it, I dashed back into the house, slipped a couple of matches out of the box, and perched myself back on the hood of the car again.

I struck a match and moved it under my nose as I tried to look for a few drops of gas.

"Whoom!" The small explosion threw me off the car, and I threw two handfuls of sand into the car tank before the family got out to see what was happening.

All of us need to know we can be in explosions that are more danger-filled than an empty gas tank with a seven year old boy hovering over it with a match.

A person's love life out of control can explode in his or her face and cripple that one for life and bring heartache to a lot of other people. Does a boy or girl have enough money and a big-paying job to take care of a family

and assume total responsibility for that family? Then why "play around" with temptations which one can't control?

To The Editor, Kinney County Cavalryman:
