#### Freedom of Information Act

Freedom of Information Act Does Not Apply to Private **Employer Personnel Files** 

Dear Commissioner Nabers, I recently read in your column that an employee doesn't have the right to see his/her personnel file. I thought this right existed under the Freedom of Information Act of 1974. Could you please clarify?

Dayton, TX

Dear J.K., I am glad you wrote because your question misunderstanding about the Freedom of Information Act. Under the Freedom of Information Act, citizens have the right to access non-classified information COMPILED BY THE FEDER-AL GOVERNMENT. The Act restricts the ability of the federal government to withhold information from the public. It does not apply to individuals or entities outside the federal government and has nothing to do with the rights and responsibilities of private sector employers and employees. It would, however, be available for use by employees of the federal government who wanted to access their personnel files if access were being denied.

I would suggest contacting your U.S. Congressman for further information about the scope of the Freedom of Information


Dear Commissioner Nabers, The new Worker's Compensation law which goes into effect in January of 1991 requires employers to have a drug prevention program in place. Since the Worker's Compensation Commission has not yet finalized rules which tell employers what to do, will employers be subject to any kind of penalty for NOT having a program in place on January 1, 1990?

Dear B.F., According to officials at the WCC, employers have until the middle of June 1991 to get their drug prevention program in place without penalty. Even though the rules have not yet been finalized, the WCC is NOT mandating or advocating drug testing as a part of any drug prevention program. Whether to drug test will remain up to the discretion of the individual em-




#### Lions Club Spreads Christmas Cheer



#### Accent on Health

Use Seat belts, Avoid Alcohol for Holiday Traffic Safety!

Sobriety and seat belt use are the simplest, but perhaps the most effective, precautions for saving lives on Texas highways every holiday season.

"Many people who died last year might be alive to enjoy this year's holidays, had they buckled up and driven sober," Dr. Robert Bernstein, Texas Commissioner of Health, said. "It is senseless to fail to use your seat belt and to drive while intoxicated," he added.

Statistics from the Texas Department of Public Safety show that motorists who do not use safety belts are 15 times more likely to be killed in accidents than those who do. In 1989 about 75 percent of the 3,361 persons killed in traffic mishaps in Texas were not wearing safety belts.

Bad weather and drunk or fatigued drivers make Texas roadways especially risky during this time of year. Last year, DPS counted 36 persons killed in traffic accidents during the 78-hour Christmas period and some 32 more during the 78-hour New Year's period.

Seat belts hold passengers in place during a wreck, preventing a second "human collision," against the windshield, dash or door. They also prevent people from being thrown out of their vehicles. Since children are especially vulnerable to being injured or killed in a traffic accident, they should ride protected in child passenger safety seats.

Texas law requires that those younger than 2 must ride in safety seats. From age 2 to 4 they must ride either in safety seats or be secured by safety belts. All front-seat passengers, regardless of age, must ride buckled up.

"Some people brag that they can drive just fine when they drink," Dr. Bernstein said. "If this is true, why do so many deaths on Texas roads involve alcohol?"

Last year in Texas, some 40 percent of all fatal auto accidents statewide involved driving while intoxicated as a contributing factor.

Dr. Bernstein endorses a "designated driver" plan, in which one person in a group volunteers not to drink and assumes the responsibility of driving others home. Some restaurants and bars now provide free non-alcoholic beverages to a designated driver. In addition, many communities are arranging free or low-cost taxi service for persons unable to drive safely.

Dr. Bernstein said each ounce-and-a-half of liquor or 12-ounce beer requires about an hour to be metabolized in the bloodstream. Food helps slow the absorption of alcohol, but eating while drinking will not keep anyone from getting drunk. Also, coffee and cold showers cannot help a person become sober.





There is a marker down the valley of the Brazos and just east of Waco, or at least there was. It may be gone now. Once at this point over a hundred years ago, there was 6 or so log buildings. They were Republic of Texas - approved John F. Torrey's Trading Post. The marker said in part - "Here the Indians signed treaties and received present until 1854. If you look around you can see the last Great Council grounds in this once Empire of the Tejas. Near the river are as much as a thousand teepees. There are Chiefs and braves of twenty nations and tribes from the ancient Caddo to the Shawnee. Three thousand of them, the mightiest peace talk, ever in Texas.

These nations were on the

Great Council Grounds for the last time in the Republic. There were Caddo, Hainai, Anadarko, Kichai, and their western allies, Waco and Towakoni. There were Delaware from far away in the Alleghenies, Shawnee from Ohio, Chickasaw and Biloxi from Mississippi, Cherokee from the Carolinas, Pawnee & Wichitas from the Plains and angry Comanches from the west

Finally it could only end in the ultimation - reservation and the Indians last desperate reply -"The Great Spirit did not make me a reservation Indian."

And the Indians ("the really first Texans) slowly rode away from their last Captial of the land of the Tejas, in 1854.





#### Old Army Days

Somewhere in Mexico, circa 1913. A U.S. Army First Sergeant, assigned to the 5th Cavalry, is shown in his office (tent) in the field. The "Field", was some area in Northern Mexico. The reason for the 5th U.S. Cavalry Regiment to be in this location, was due to the agreement between the United States of America and the Mexican government which allowed U.S. troops to cross into Mexico in pursuit of the alleged "Bandit", Pancho Villa, who had raided the U.S. border town of Columbus, New Mexico. Villa, was also responsible for

other border raids, into Texas and Arizona. Of course there are always two sides to every story. To Villa, these raids were justified, due to the fact that as a revolutionary, he and his army, or bandits, needed supplies in order to oust the dictatorship which was in control of Mexico.

The U.S. Government, had a much different attitude about the border raids than did General Pancho Villa. This government considered that these raids were absolute banditry! Therefore, the agreement between the two governments regarding the

entering of Mexico by U.S. troops in pursuit of the "Bandits", entered into effect.

The First Sergeant in this photo is wearing the uniform of the era, turn of the century khaki, copied from the British army. Of course this particular khaki color is not the same as the khaki shade that troops of World War II, and Korea remember. He is wearing rank chevrons the same as a Buck Sergeant, with a Diamond centered and just below the lower stripe. Note the old typewriter just to the left of him. He is not my image of an old army First Sergeant, he appears too mild mannered looking.

First Sergeants, came into being about the end or right after the Civil War. Since Revolutionary War days, officers realized needed they noncommissioned officer to be in charge of the enlisted troops. So, what they came up with was a sergeant that was the roughest enlisted person in the outfit, that at least had enough sense to guide all of the enlisted, to do what the officers wanted. In other words, if you were a private during those times, and someone with authority gave you an order which you did not like, and you decided that you were not going to do it, the "Tom Sergeant" could possibly take you behind the "barn" to put some knowledge into your body!

## TDHS Announces New Centralized Referral System

The Texas Department of Human Services announced today a new centralized referral system will be effective January 11, 1991. This system will help assure a more timely and consistent response to community referrals within region 09. Region 09 is comprised of 21 South Texas Counties. This system will also allow for a more accurate identification of referral patterns within each county and help improve delivery service.

The new centralized referral system will be administered out of San Antonio and will utilize a toll free number, 1-800-292-5032. Two rural staff members, Megan Gardner and Leticia Hernandez will be assigned to handle rural referrals.

In conjunction with the centralized referral system, a regional Night Duty unit will also be implemented. The Night Duty unit will provide coverage after hours, weekends and on holidays. All after hours calls will be handled by this unit accessed through the rural toll free number. After midnight all calls will be referred to the Abuse Hotline in Austin (1-800-252-5400).

""Implementing both the centralized referral system and the Night Duty unit will help us provide a better more consistent response to the community," said Michele Huels, Rural Child Placement Director. "Once the new systems are in place they will free up local staff to provide more services to their clients."

After examining the bullet, it was determined that it was from a 30-06 (soft point core lokt) a high powered deer rifle.

Can We Afford Pollution?

Can you put a price tag on pollution? Two Americans who have researched the high cost of air and water pollution, and how it affects our economy, were recently honored for their efforts.

John V. Krutilla's and Allen V. Kneese's work began in the 1950's when there was little concern for the environment. Prior to their groundbreaking work, economists regarded air and water as free commodities, since they lacked market-pricing mechanisms. Their research led to the cost-benefit analysis contained in environmental impact studies.


The Volvo Environment Prize this year carries with it a \$260,000 cash award, to be shared by the winners. The Prize goes annually to those who have made an outstanding contribution to the environmental field. The recipients are chosen by a committee of internationally prominent environmentalists.

The committee said the professors' work laid the foundation for a growing body of research and knowledge about the complex relationships between the environment and the economy. As a result, environmental economics has become an important area of environmental and economic research, combining theories of production and economic growth.




Make this holiday season special with Mince Cheesecake Pie.

#### MINCE CHEESECAKE PIE (Makes one 9-inch pie)

- (9-inch) unbaked pastry
- jar ready-to-use mincemeat
- (regular or brandy & rum) 11/2 teaspoons grated orange
- 2 (3-ounce) packages cream cheese, softened
- ½ cup sugar
- eggs teaspoon vanilla extract

Place rack in lowest position in oven; preheat oven to 425°. Combine mincemeat and 1 teaspoon rind; turn into pastry shell. Bake 15 minutes. Meanwhile, in small mixer bowl, beat cheese and sugar until fluffy. Add eggs, vanilla and remaining ½ teaspoon rind; mix well. Pour over mincemeat. Reduce oven temperature to 350°. Bake 25 minutes or until set. Cool. Serve warm or chilled. Garnish as desired. Refrigerate leftovers.
