Look For The Good

Do you have a tendency to see more negatives than positives in situations you face? Do you pick out shortcomings in people rather than identifying the good? Is it easier for you to find what's wrong instead of uncovering what's right?

Our world is far from a perfect place. There are very few absolutes. People are less than perfect. Situations are less than ideal. Most circumstances will have both good and bad aspects. You are free to choose what you concentrate on.

Some people, we'll call them bad finders, choose to focus on the bad. Regardless of what is happening, they look for the fly in the ointment. On a beautiful sunny, spring day, a bad finder will worry about sunstroke and dehydration.

The bad finder always has something negative to say about people he or she knows. Regardless of an individual's positive attributes, a bad finder zeros in on any perceived flaws. The bad finder constantly complains about other people and what's wrong with them.

Bad finders claim they are just being realistic. Bad finders are rarely happy. They grumble constantly. They are

usually mired in some crisis. When they get past one emergency, they find another one to take its place. They are abrasive and hard to get along with.

People looking for the good, good detectors, have a different outlook. Regardless of the situation, a good detector has a knack to find the good, no matter how hidden it may be. This type of person considers a rainy weekend an opportunity to relax and catch up on some reading rather than something to be depressed about.

Host-Team Coyotes Run Off With District, Area

One should not be too surprised if Borden County tried moving the Region 1-1A Track Meet in a couple of weekends from Levelland to Gail.

The Coyote tracksters definitely found the home cooking to their liking this week again at Gail.

Not even a week after they swept both the boys and girls divisions in their annual Coyotes Relays they pulled off that same feat again this week, first sweeping the District 6A Meet on Wednesday and then the 5A/6A Track Meet on Thursday, all at Gail.

"We definitely had more highs than lows," Borden County Coach Trey Richey said. "This speaks volumes for our kids. They just really performed well."

"This was the first time ever for our girls to win an area meet and the third time for them to win district. It's like the seventh or eighth time our boys have won district now and their second time to win

area. We were the runners-up at area last year, but it's the first time we've won this meet (area) since back in 200 or 2001.

This area should be well represented at the Region 1-1A Track Meet on April 26 and 27 at Levelland. The top four finishers in each race at area qualified for regionals where to top two finishers in each race will run again next month in the big state track meet in Austin.

"Right now, a lot of it depends on our health issues. We've got some people banged up on both sides," Richey said.

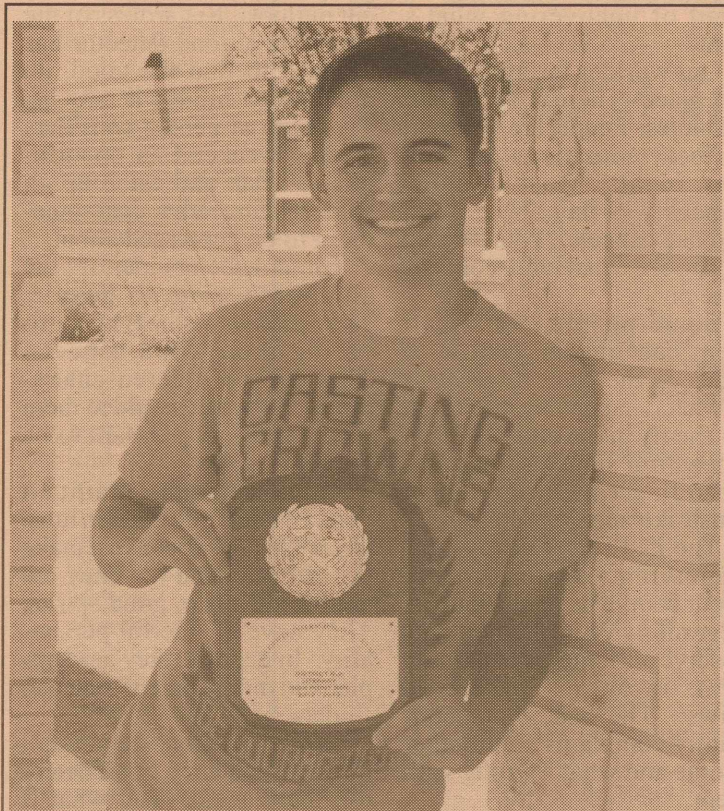

Don't Be A Target

Credit Card fraud can easily hit a little too close to home - take time to manage your credit cards and accounts.

As unemployment has increased, it has become more difficult to obtain credit. With that in mind, some people may choose to hang on to old cards "just in case" they lose their job and are unable to obtain a new card to use as a safety net. There are pros and cons to this idea.

Some credit card companies charge fees for dormant accounts. No one wants to pay fees on an account they are not even using, so that might lead you to close the account.

Unused cards can also put you at risk for fraud. Fraud tends to increase in times of recession. This fraud can go undetected if you do check your statements regularly... especially if you move and forget to notify the company of your new address.

On the flip side, cancelling long-standing credit accounts may reduce the length of your credit history, which damages your credit score. (Having accounts with a long history increases a credit score, since it indicates stability and reliability). In addition, cancelling a card could increase your debt to credit ratio, hurting your credit score even more.


Decisions about old, unused credit card accounts require careful thought. If you are unsure if you have unused accounts, check your credit report. It will also help you spot unfamiliar credit applications and unexplained balances that would indicate that you are a victim of fraud.


Consider closing down unused accounts, especially if you are applying for a loan. If later you decide you need a credit card, you may find a better deal on the market that are available only to new card holders.

Remember that cutting up a credit card is not the same as

cancelling it. Cutting it up will stop you from using it but you still need to contact the company and ask them to cancel it. Ask for a confirmation letter as well. Sometimes the account will be left open for a while in case any payments you've made haven't come through yet. Double check a month or two later.

We plan to hold a couple of arts and crafts day camps this Summer for youth to participate in - watch for details!

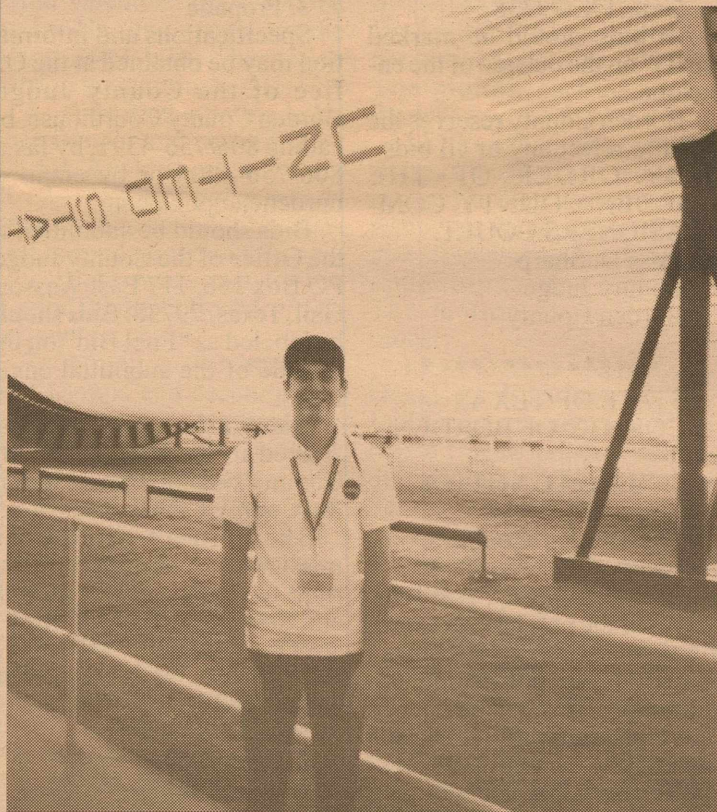

BHS Students Qualify for State Rodeo Finals

The Texas High School Rodeo Association is made up of ten regions. Region II includes students from Borden County, Ft. Stockton, Sonora, Eldorado, Van Horn, Menard, Midland, Odessa, and Andrews—just to name a few. One hundred students competed in the High School division of Region II this year.

The first rodeo of the year was held in Alpine, with rodeos following in Andrews and Ft. Stockton during the Fall and Spring semesters. After tabulating the point totals for sixteen rodeos, the top ten in each division qualified for state. Senior, Riley Smith missed first place in the Team Roping by one point.

He and his partner, Sam Powers, of Sonora were second for the year. They received Reserve Champion buckles. Riley also qualified for state in Tie-down calf roping.

Sophomore, Sean Tucker, and his partner, Ty Baker, of Van Horn, qualified in Team Roping. Sean will also compete in Tie-down calf roping at State. Sean placed third in the average at the Regional Finals to move him up in the rankings to fourth for the year. His fourth place finish was behind three seniors.

The THSRA State Finals will be held in Abilene, TX, June 9-15, 2013.

The Junior High division of the Texas High School Rodeo Association will have their State Finals Rodeo in Gonzales, TX May 26 – June 1, 2013. Several Borden County Junior High students qualified for state. Dylan Murphy won the Breakaway roping for the third year in a row. He qualified for the National Finals as a sixth grader.

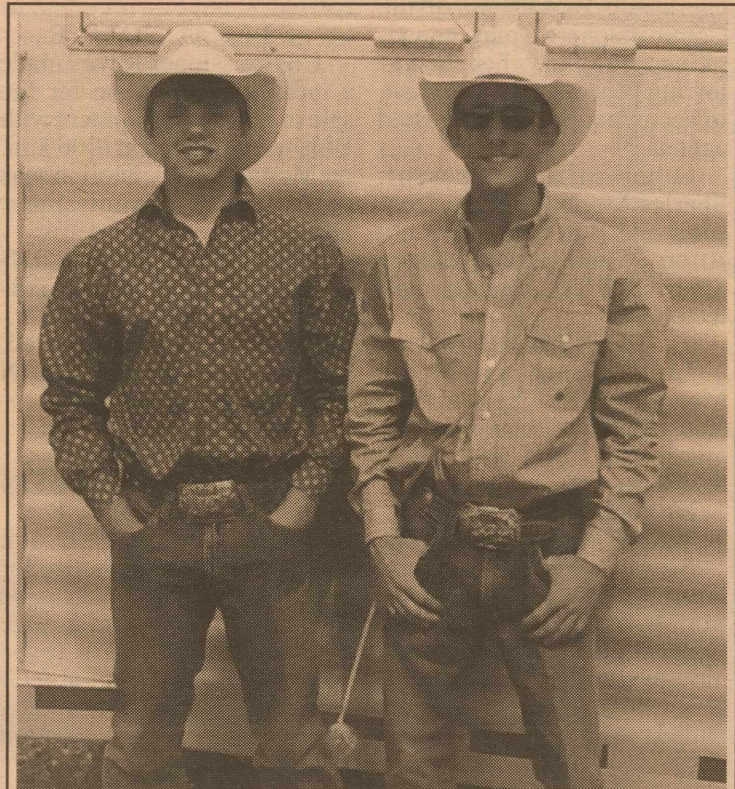
He will also compete at state this year in Ribbon Rop-

ing, Goat Tying, Team Roping and Chute Dogging. Hunter Jones will Team Rope with his partner, Corbin Sumners.

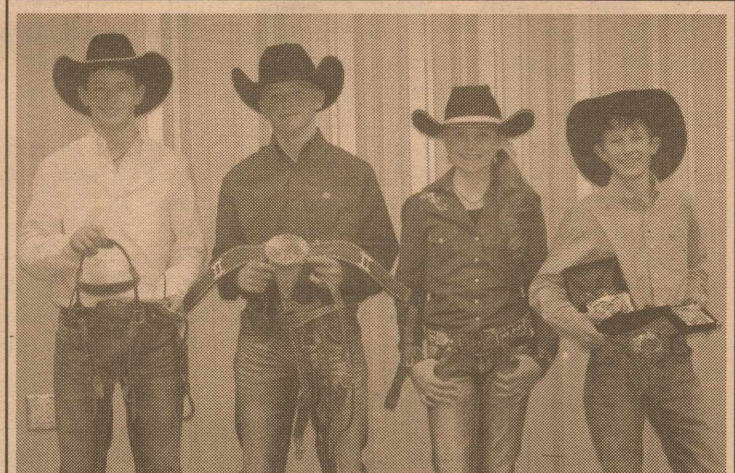

THSRA is not sanctioned by the UIL. However, students must have passing grades to

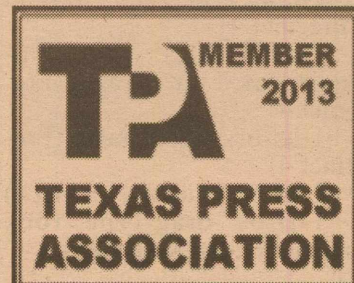

Notice of Drinking Water FLUORIDE Violation

March 2013

The Texas Commission On Environmental Quality (TCEQ) has notified the Borden County Water System that the drinking water being supplied to customers had exceeded the Maximum Contaminant Level (MCL) for FLUORIDE. The U.S. Environmental Protection Agency (U.S. EPA) has established the MCL FLUORIDE at 4 mg/L, and has determined that it is a health concern at levels above the MCL. Analysis of drinking water in your community for FLUORIDE indicates a compliance value in quarter four 2012 of 5.4 mg/L for EP001.

This is not an emergency. However, some people who drink water containing FLUORIDE in excess of the MCL over many years could get bone disease, including pain and tenderness of the bones. Fluoride in drinking water at half the MCL or more may cause mottling of children's teeth, usually in children less than nine years old. Mottling, also known as dental fluorosis, may include brown stain-

ing and/or pitting of the teeth, and occurs only in developing teeth before they erupt from the gums.

An alternate source of water should be provided to the affected population, which consists of children less than nine years old. The alternate water should be used for drinking and cooking only. However, if you have health concerns, you may want to talk to your doctor to get more information about how this may affect you.

We are taking the following actions to address this issue: water vouchers are available to families with children 14 years of age or younger, also we are working to correct the problem by investigating the possibility of connecting to another system.
