

## **Deadline to Enroll in Key Farm Bill Safety Net Programs Approaches Producers Have Until Sept. 30 to Sign Up for ARC/PLC and MPP-Dairy**

Farm Service Agency (FSA) roll in ARC or PLC. Covered reminds farmers and ranchers that they have until Sept. 30 to enroll in several key Farm Bill safety net programs – Agriculture Risk Coverage (ARC), Price Loss Coverage (PLC) and the Margin Protection Pro-gram for Dairy (MPP-Dairy).

Although producers already have elected ARC or PLC, now is the time to sign the contract and complete the enrollment process for the 2014 and 2015 crop years.

Dairy operations are also reminded to enroll for coverage in 2016 before the Sept. 30 deadline. Just \$100 covers 90 percent of milk production at a \$4 margin, and with incre-mental premiums, up to an \$8 margin can be covered.

ARC and PLC programs trigger financial protections for agricultural producers when market forces cause substantial drops in crop prices or revenues. More than 1.76 million farmers and ranchers are expected to sign contracts to en-

commodities under the programs include barley, canola, large and small chickpeas, corn, crambe, flaxseed, grain sorghum, lentils, mustard seed, oats, peanuts, dry peas, rape-seed, long grain rice, medium grain rice (which includes short grain and sweet rice), safflower seed, sesame, soybeans, sunflower seed and wheat. Upland cotton is no longer a covered commodity. The elections for each farm stay in place through 2018, but ownership and shares can be adjusted through the annual en-rollment. MPP-Dairy offers protection to producers when the difference between the milk price and the average feed cost (the margin) falls below a certain dollar amount selected by the producer. Participating dairy farmers will remain in the program through 2018 and pay a \$100 administrative fee each

year. Producers also have the option of selecting a different coverage level during open enrollment each year. MPP-Dairy payments are based on an operation's historical production, which will increase by 2.61 percent in 2016, if the operation participated in 2015, providing a stronger safety net. More than half of the nation's dairy producers are enrolled in the program. For more information, visit www.fsa.usda.gov/dairy.

The Borden County Varsity and Junior Varsity teams traveled to Lueders Friday to take on the Lueders-Avoca Raiders. Both groups made very short work of the home team as the Junior Varsity allowed just one first down during the contest while scoring 45 points and ending the game one minute into the second half. This JV team consists of

sophomores Braxton Barnes and Nick Proulx, freshman, JW Nix, Payton Merket, Trent Collins, Lukas Grantham, Jeremy Souder and Ben Justice. Also joining the Coyotes this Also Johning the Coyotes this past week was junior Dylan Murphy. This group got off to a quick start as Nick Proulx while miniting the Raiders to no first downs, the Offense got quick scores from the ofscored from 13 yards out. Proulx added another short run to push the lead to 12-0. Payton Merket added a long run to extend the lead to 18-0. Proulx added another score and a point after run to push the lead to 25 to 0.

On the next possession, Payton Merket hit JW Nix for a nice 38 yard touchdown pass play. This made the score 31 to 0 late in the second quarter. On the defensive side, Proulx intercepted an errant Raider pass and moments later Merket hit Ben Justice with a pass to extend the lead to 37 to 0. Merket finally got a kick to split the uprights making the halftime score 39 to 0. On the first series of the second half, Proulx brought a close to the first game of the evening racing 51 yards to pay dirt and a 45 to 0 final for the JV.

The Coyote varsity would take the field next, but the results would be much the same. The Coyote offense used only 17 offensive plays on the evening to put up 62 points in one half of action, while the defense, playing the first team defense consisting of Korbin Martinez, Hunter Jones, Trace Richey, Ryan Willborn, Corbin Sumners, Jayton Lewis and Diego Bernal played most of the first quarter before turning things over to the second group for the rest of the first and second quarters to end the contest.




as he scampered 19 yards un-touched for the final points of the contest, making the final tally on the game at 62 to 0. Statistically for the Coyotes

### Would You Child Be Safe in a Car Crash? Sept. 13-19 is National Child Passenger **Safety Week**

Every parent wants the best for their child, but when it comes to keeping their child safe in the car, there is often confusion surrounding which car seat is safest and how to use it correctly. Even though the majority of parents buckle up their children in car seats, booster seats, or seat belts, most do not use them correctly. According to the National Highway Traffic Safety Ad-ministration (NHTSA), nearly 3 out of 4 child safety seats are not used properly, which is a grave risk when traveling. Correctly securing your children its job correctly, it has to be: properly in age- and size-ap-propriate child safety seats in the back seat of a vehicle is the most effective way to your vehicle, and protect them in the event of a crash. In vehicle crashes, car seats reduce the risk of fatal injury by 71 percent for infants and by 54 percent for toddlers. This year National Child Passenger Safety Week will be celebrated from September 13-19th and provides an opportunity for parents to make sure they are transporting their children safely.

Children are at greater risk than adults in a vehicle crash. In fact, motor vehicle crashes are the number one cause of death for children. Crash data from the National Highway Transportation Safety Administration shows that on average, nearly 2 children under age 13 were killed, and 345 children were injured every day in 2013 while riding in cars, SUVs, pickups, and vans. Unfortunately in 2013, nearly 40% of children killed in car crashes were unrestrained they were not in car seats, booster seats, or seat belts.

That's why Texas A&M AgriLife Extension Service agent and Certified Car Seat

Technician, Julie Smith, is urging all parents and caregivers to attend one of the many car seat checkup events or inspections by appointment (call (806)756-4336 for an apt in Gail) that will be offered all over the country during National Child Passenger Safety Week. To find a checkup event or inspection by appointment location near you, go to http:// www.safercar.gov/cpsApp/ cps/index.htm and then check the box for Child Passenger Safety Week 2015.

Parents are reminded to keep children rear-facing until at least age two or until the weight and height limit of their rear-facing convertible seat, usually 40 pounds or more. Also, children should stay in a age four, weigh 40 pounds or more, and are mature enough to sit still in a booster. Finally, use a booster seat until a seat belt fits your child correctly. This is usually at 4'9" tall and sometime between ages 8 and 12 years old. The average child

safety seat inspection by a certified child passenger safety technician. Technicians provide hands-on advice and instruction. Make sure your chil- back seat! dren are safe and you are in compliance with the current child safety seat law in Texas.

The law requires all children under 8, unless taller than 4'9", to be in a child safety seat system, which includes traditional child safety seats with har-nesses and booster seats.

Remember: All child passengers under age 13 should ride securely restrained in the back seat, where they are safest — every trip, every time! If you are unable to attend an event during National Child Passenger Safety Week, you don't have to wait until next year to check if your car seat is properly installed. To locate a certified Child Passenger Safety Technician in Texas, go to http://buckleup.tamu.edu.

Follow these guidelines from NHTSA to keep your children riding safely

· Birth – 12 months: For the best possible protection, your child under age 1 should always ride in a rear-facing car seat. There are different types of rear-facing car seats; infantonly seats can only be used rear-facing. Convertible and 3in-1 car seats typically have higher height and weight limits for the rear-facing position, allowing you to keep your child rear-facing for a longer period of time.

· 1 - 3 years: Your child should remain in a rear-facing car seat until he or she reaches the top height or weight limit allowed by your car seat's manufacturer. This may result in many children riding rearfacing to age 2 or older. Once your child outgrows the rearfacing car seat, your child is ready to travel in a forward-facing car seat with a harness.

 $\cdot$  4 – 7 years: Keep your child in a forward-facing car seat with a harness until he or 5-point harness system until she reaches the top height or they are ready to ride in a weight limit allowed by your booster seat. Booster seats are car seat's manufacturer. Once for children who are at least your child outgrows the forward-facing car seat with a harness, it's time to travel in a booster seat, but still in the back seat.

8 – 12 years: Keep your child in a booster seat until he or she is big enough to fit in a seat belt properly. For a seat belt to fit properly, the lap belt reaches 4'9" at age 11! If you're a parent or caregiver, don't miss this op-per thighs, not the stomach. per thighs, not the stomach. 
# **Borden County Students Encourage Community** to Support Lubbock **Meals-on-Wheels**

#### **Proposition Number 1** (SJR 1)

SJR 1 - Current law provides an exemption of \$15,000 from the ad valorem taxation for public school purposes of a residence homestead. The proposed amendment would increase this exemption to \$25,000, starting in the tax year beginning January 1, 2015. In order to reflect the increased exemption on the homestead of a person 65 years of age or older or a disabled person, the proposed amendment would provide a reduction to the current limitation on the total amount of ad valorem taxes. The proposed amendment would protect school districts from all or part of the revenue loss by authorizing an appropriation of funds according to formulas set by the legislature. In addition, the proposed amendment would authorize the legislature to prohibit a political subdivision from reducing or repealing a homestead exemption adopted by the political subdivision. Finally, the proposed amendment would prohibit the imposition of a tax on the conveyance of real property, but would not prohibit the imposition of a business tax measured by business activity, a tax on the production of minerals, a tax on the issuance of title insurance, or a change in the rate of a tax in existence on January

The proposed amendment will appear on the ballot as follows: "The constitutional amendment increasing the amount of the residence homestead exemption from ad valorem taxation for public school purposes from \$15,000 to \$25,000, providing for a reduction of the limitation on the total amount of ad valorem taxes that may be imposed for those purposes on the homestead of an elderly or disabled person to reflect the increased exemption authorizing amount. the legislature to prohibit a political subdivision that has adopted an optional residence homestead exemption from ad valorem taxation from reducing the amount of or repealing the

exemption, and prohibiting the enactment of a law that imposes a transfer tax on a transaction that conveys fee simple title to real property."

### **Proposition Number 2**


(HJR 75) HJR 75 - In 2011, voters approved a constitutional amendment to allow a surviving spouse of a 100 percent or totally disabled veteran an exemption from ad valorem taxation from all or part of the market value on the disabled veteran's residence homestead, as long as the surviving spouse had not remarried. The amendment did not apply to surviving spouses of veterans who died before 2011. This amendment would extend the exemption in such cases. The proposed amendment would apply only to ad valorem taxes imposed for a tax year beginning on or after January 1, 2016.

The proposed amendment would appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of all or part of the market value of the residence homestead of the surviving spouse of a 100 percent or totally disabled veteran who died before the law authorizing a residence homestead exemption for such a veteran took effect."

#### **Proposition Number 3** (SJR 52)

SJR 52 proposes a constitutional amendment to repeal the requirement for the Comptroller of Public Accounts, the Commissioner of the General Land Office, the Attorney General, and any other officers elected statewide to reside in Austin, Texas, the state capital. Under current law, these statewide elected officers are required to reside in the capital of the State of Texas while in office. This amendment would not apply to the residency requirement for the Governor.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment repealing the requirement that state officers elected by voters statewide reside in the state capital."



#### **Proposition Number 4** (HJR 73)

HJR 73 proposes a constitutional amendment that would grant the legislature the authority to pass statutes to allow a professional sports team charitable foundation to conduct charitable raffles under the terms and conditions imposed by general law. The laws passed under this authority may provide that the professional sports team charitable foundation may use proceeds from such charitable raffles to pay reasonable advertising, promotional, and administrative expenses. Any law enacted by this provision only applies to entities defined as professional sports team charitable foundations on January 1, 2016. Additionally, any law enacted by this provision may only allow charitable raffles to be conducted at games hosted at the home venue of the professional sports team associated with a professional sports team charitable foundation.

The proposed amendment would appear on the ballot as follows: "The constitutional amendment authorizing the legislature to permit professional sports team charitable foundations to conduct charitable raffles."

#### **Proposition Number 5** (SJR 17)

SJR 17 proposes a constitutional amendment which would increase from 5,000 to 7,500 the maximum total population threshold of a county that is allowed to construct and maintain private roads as long as the county imposes a reasonable charge for the work

The proposed amendment will appear on the ballot as follows: 'The constitutional amendment to authorize counties with a population of 7,500 or less to perform private road construction and maintenance."

#### **Proposition Number 6** (SJR 22)

SJR 22 proposes a constitutional amendment that would add the right to hunt, fish and harvest wildlife, including by use of traditional methods, in the Bill of Rights of the Texas Constitution. This right would be subject to laws and regulations intended to conserve

and manage wildlife and to preserve the future of hunting and fishing. The proposed amendment would establish hunting and fishing as the preferred method of managing and controlling wildlife in Texas. The proposed amendment is not intended to affect any law or provision related to trespass, property rights or eminent domain, and would not prevent the legislature from authorizing a municipality to regulate the discharge of a firearm in a populated area in the interest of safety.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment recognizing the right of the people to hunt, fish, and harvest wildlife subject to laws that promote wildlife conservation."

#### **Proposition Number 7** (SJR 5)

SJR 5 proposes a constitutional amendment to dedicate a portion of revenues from (1) the state sales and use tax, and (2) the tax imposed on the sale, use, or rental of a motor vehicle, to the State Highway Fund (SHF). Under current law, these funds would be deposited to the General Revenue Fund. Money deposited to the SHF is intended to be used only to construct, maintain, or acquire rights-of-way for public roadways other than toll roads; or to repay certain transportation-related debt

The proposed amendment would appear on the ballot as follows: "The constitutional amendment dedicating certain sales and use tax revenue and motor vehicle sales, use, and rental tax revenue to the state highway fund to provide funding for nontolled roads and the reduction of certain transportation-related debt."


