## USDA Food Donations Make Local School Meals Tasty

Food donations of the U. S. Department of Agriculture have helped make low-cost meals for schools possible for the last 18 years. This year, 31 different foods are being distributed to schools in Ar-

kansas, Colorado, Kansas, Louisiana, New Mexico, Oklahoma and Texas.

Under this program, schools receive such items as turkey, ground meat, roast, chicken, flour, butter, shortening, meal, green beans, corn, fruits and cracked wheat, which is used in preparing cakes and rolls.

School lunches today are better than ever. Such favorites as fried chicken and roast turkey are seen often on school lunch menus. Mr. John Slaughter, southwest area food distribution director, said.

Fresh Bartlett pears now are being purchased for school lunch use, although canned fruits make up the biggest portion of fruit allotments. Canned fruits which have been donated for use during this school year are apples and applesauce, apricots, cherries, peaches, pineapple and plums.

### Deer Permits Issuance Dates Are Announced

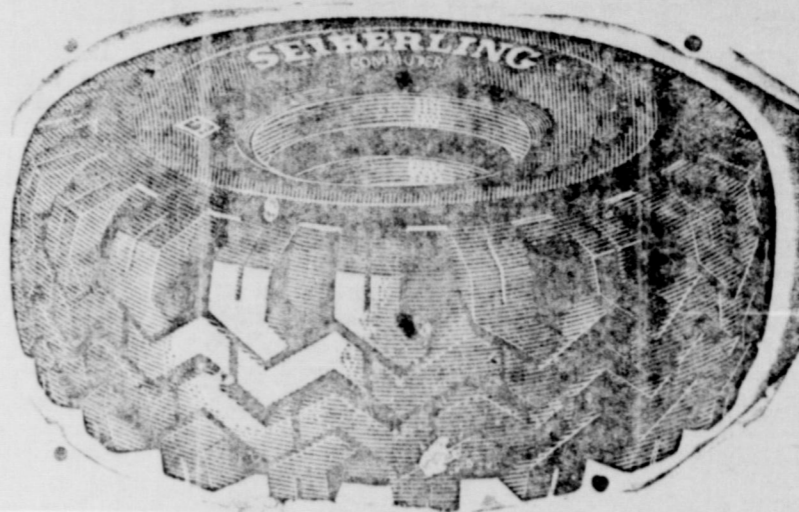

## Social Security Benefits Offered To Three Groups

"Many people who call at our offices throughout the nation continue to surprise our interviewers by thinking of social security as only a one-way form of income insurance," reports R. R. Tuley, Jr., district manager of social security in Abilene.

"One caller will know only of the retirement benefits; another the disability program; the next the survivorship payments," Tuley went on.

He added that with the retirement part now being over 27 years old, the survivors portion over 24 years old, and the newest, disability, now in its tenth year, such single-shot ideas are much more fre-

quent than should be true. Tuley furnished the following to summarize the three-way family income protection in the Social Security Act.

1. RETIREMENT. At age 62: early retirement amounts range from 80 to 99 per cent of the basic amount calculated as of age 65. At age 65: no reduction in benefit amount if no payments were made before age 65. At age 72: payment of benefits no matter how high current earnings may be.

2. SURVIVORS. Lump sum death benefit. Monthly payments to children under 18 or continuously disabled since age 18, to widows aged 62 or more or with children in their care, to dependent parents aged 62 or more, to dependent widowers at age 62.

3. DISABILITY: Monthly payments to disabled person and certain dependents.

**30 Peanut Tourers Find Crops Almost Up To Par**

An interesting and educational tour of six peanut farms in the Gorman area of Eastland County was attended by 30 people last Thursday.

The tour was planned and led by County Agricultural Agent J. M. Cooper with the assistance of two members of his crop improvement committee, D. B. Warren of Gorman and Oscar Schaefer of Rising Star. Although only 21,000 acres

or 57 per cent of Eastland County's allotted acreage was planted this year, due to an extremely dry spring, it is felt that the big rains of August and September may bring the overall county production close to that of recent years.

The tour began at Vernon Files' farm, 2.5 miles south of Gorman.

The visitors, representing all parts of Eastland County, as well as Callahan and Comanche counties, observed a crop which was planted the last few days of July. It was determined that this crop was 79 days old and seemed to be in excellent condition from the standpoint of growth of vines and progress of fruiting.

B. C. Langley of the West Cross Timbers Experiment Station, Stephenville, predicted that this extremely late crop could, in another five or six weeks, develop an average or better yield of peanuts, providing a killing frost is delayed this long. Mr. Files' peanuts are of the Argentine variety.

The next stop was the farm of Bill Andry, approximately one mile west of Gorman. His crop was predominately of Argentine Spanish variety, planted June 10, and partially developed with assistance of an irrigation system installed by Andry in the late summer.

The group was particularly interested in the installation and operation of the irrigation system.

Many similar systems for uses in production of peanuts and Coastal Bermuda are expected to be installed on area farms next year.

The last morning stop was at the farm of Mitchell Campbell, four miles west of Gorman. Campbell displayed his crop of certified Spanish Starr peanuts, being grown under the registered seed program of Texas A&M University.

He explained the regulations and requirements pertaining to farmers who produce seed under contract with the university.

Those on the tour lunched at the Brown Jug Cafe compliments of Southwestern Peanut Growers' Association.

After lunch, Ross Wilson, manager of the association, discussed the quality control program being carried on this year by the association, in cooperation with the USDA, the peanut shellers, growers and inspection service.

Following lunch, those on the tour visited the farms of D. B. Warren, Claude Fuller, and Wayne Eaves, north of Gorman.

The group observed the test plots for nematode control at the Warren farm and observed peanut production under irrigation sprinkler systems at the farms of Wayne Eaves and Claude Fuller.
