gave a resume of the work done in 1963 by the committee. Fifty four members have been enrolled during the year. Four applications for Civil War Veterans grave markers have been filed, and a monument commemorating Camp Solomon, later called Camp McCord, erected on the courthouse lawn. The superintendents of the high schools are being contacted and the contest information distributed. 4 Men Inducted In January; 8 Are Due To Go In February

Eight young men have been ordered for induction into the Army in February, and four were inducted in January, the Selective Service Board office in Eastland reported this week.

Ordered for February induction are Ralph W. Clary, Richard L. Rogers, Joe D. Walton and Frank W. Weiss, all of Cisco; Kenneth R. Welch and Wallace R. Preston, both of Gorman; Jackie R. Nelson of Okra; and Clarence H. Williams of Breckenridge.

Sent in January were Jimmy F. Flemmings of Rising Star, Jerry A. Clower of Eastland, William M. Patton of Ranger and Roger G. Broyles of Cisco.

A total of 75 percent of the number sent for pre-induction physicals in January were rejected for physical, mental or moral reasons, the board reported.

The average county rejection percentage if 50 per cent, and last October, there was

100 per cent rejection, it is reported.

In line with the new national policy, the local board will begin classifying 18-year-olds in February.

The state draft quota for February calls for 517 men, compared to 812 for January.

The state quota of 517 for February is the Texas share of a national call for 12,000 men, all for the Army.

More than 6,000 men over the state will be called up for pre-induction physical and mental examinations in February, also, the state director of Selective Service said.

The February quota will be filled mostly with men who are volunteers under 26 years old and nonvolunteers ages 19 through 25. Most of them will be 22 years old.

No man whose draft board file reflects that he is maintaining a bona fide family relationship with a wife or a child or children will be selected in response to this call.

County's Arid Rangeland Needed Snow's Moisture

By Soil Conservation Service

Rangeland conditions in Eastland County are not the best, for this time of year. The rainfall pattern of 1963, a dry summer, shortened the forage reserve going into the winter. Brush-infested pastures also contributed to low forage production. Approximately two-thirds of the rangeland in Eastland County is considered to have a medium to high priority brush problem. Mesquite, oak, juniper, and mixed low brush and cactus are steadily spreading over the Rangeland.

To make the problem more understandable, brush takes from 120 to 240 gallons of water to produce one pound of dry forage. Grass requires from 80 to 90 gallons of water to produce one pound of dry forage. Expressed another way, an inch of rain over an area of grass will produce 340 pounds of dry forage. An inch of rain over an acre of brush will produce 160 pounds of dry forage. This shows the importance of wa-

ter conservation and utilization on the rangeland.

Brush eradication is almost impossible, but it is possible to control brush. The density of the brush determines the intensity of treatment. Tree dozing, rootplowing, and basal treatment with herbicides are the primary controls practiced on mesquite. Chopping, dozing, and chaining, along with sprout control by goat-ing, are the primary controls practiced on oak.

In most cases, where brush is a problem, a seed source of the better grasses is needed. Seeding of native and introduced grasses is done following brush control.

Management, deferment of treated pastures, will determine the success of the treatment, as well as, frequency of control measures. There is some forage reserve on treated pastures currently; however, stock are grazing only current growth on winter grasses in brushy pastures, with little or no reserve feed.

The control of brush is an

expensive operation; however, a brushy range becomes a liability rather than an asset. Future generations will benefit from the efforts toward conservation of the grazing resources now. The American people are providing, through the United States Department of Agriculture, share the cost programs for farmers and ranchers, which enable them to carry out these needed treatments. In many cases with out such costs share assistance, the job could not be done.
