# Museum opens Sunday All prospective candidates file

The Memorial Museum, located directly north of the Tsa Mo Ga Club House, will have its. formal opening Sunday afternoon from 2 to 6 p.m.

This unique and interesting building, carrying the look of the typical "Bonus Shack", which indeed it is, was donated to the club by members of the Mrs. Annie Miller family. The Miller family moved to Yoakum County in 1915 and. for many years lived in this little house, then located in the southwest part of the county. At one time this same house was the home of the family of Mr. and Mrs. T. E. Payne Sr., when they were running cattle on the Miller range in the early '30's.

Sue Stevens, a long-time member of the Tsa-Mo-Ga Club, Ben Miller and other members of the Miller family, possessing a keen interest in American Heritage and recognizing the importance of the preservation of objects and treasures relating to early life in the west, gave this little house in order that the people of this area and posterity could enjoy and keep alive the memories of those early days.

Club members moved the house into town and made plans to restore the building in the front, with antique posts and 'ginger-bread'' trim added. Battle lines have been drawn, with 15 candidates officially in the running for five elective county offices in the May 7 Primary Election.

R. B. Woodward, democratic chairman of Yoakum County, announced on Tuesday that all of those who had previously announced intentions of seeking the five posts have notified him that they desire to have their names placed on the primary ballot. In addition to the 15 who will be seeking county-wide nominations, Woodward has also been notified that nine other men will be seeking seven state or national offices with names to be placed on the Yoakum County ballot for the May 7 election.

Contests are shaping up in the races for five county offices, in the race for State Representative of the 98th District and for the office of Chief Justice of the Court of Civil Appeals, Seventh Judicial District, Amarillo.

Woodward said that following the expiration of the filing period on Monday it appears evident there will be no contests for Judge of the 121st Judicial District, District Attorney of 121st Judicial District, U. S. Congressman, State Senator, and Yoakum County Democratic Chairman. The official filing roster, as

# Tax collections 97.7 per cent in

An amazing 97.7 per cent of Yoakum County's taxpayers had paid their taxes by February 1, the date unpaid assessments became delinquent. That left the county with only about \$20,000 due in unpaid taxes, according to E. W. Craig, chief deputy in the county tax office.

Taxpayers have already paid the county \$858,682.16 of the total tax bill of \$878,876.81, Craig said. He described this fact as an outstanding record, although fairly typical for Yoakum County.

Taxes became delinquent February 1 and those who have not paid their obligations will be required to pay penalties of one and one-half per cent per month.







# The GLAD Way

Loo long have we thought of The Way of the Cross as the "sad way." There may be sad moments along every noble path, but not all great ways are sad ways. The path of motherhood may have sad turns but it is a satisfying path. The path of education climbs some difficult and steep places but it is a thrilling way. Isaiah talked about the highway of God, where faithful servants passed on good errands. The way of the Cross is the way one takes when he serves God. the eighth annual Yoakum County Livestock Show and Sale which will get underway in Plains Friday morning, February 12. Dean Emeritus W. L. Stangel will begin his judging chores at 10 a.m. when the first of the beef breeding cattle are led into the arena. Four beef cattle breeders are expected to bring in 10 head of registered animals. Forty fat steers, 10 commercial steers, 31 lambs and about

Plans have been completed for as many as five animals on a commercial basis. Roger Campbell and Chip Bennett will each have entries in this new class. Those animals will be located in pens on the north side of the Arena Building. They will not be groomed and fitted for show because they are to be handled in the same manner as commercial feeders would handle livestock. They will be judged as pens and the boys will receive ribbons and premium money. The premiums for this class are donated by the Yoakum Soil Conservation District, sponsor of this new class.




