

Stanley Duvall Is Candidate For County Judge

Stanley Duvall, of Denver City, who has filed as a candidate for the office of county judge of Yoakum County, this week issued the following statement:

"After much careful deliberation and thought of the responsibilities involved, I have decided to seek the position of judge of Yoakum County, and earnestly ask for your consideration and support.

"I have thoroughly checked the duties involved as county

judge, and believe with my past experience as businessman, civic worker, city council mem-

ber and mayor, I can fulfill these duties to the benefit of Yoakum County.

"I have resided in Denver City since 1939, owning and operating Stanley's Hardware until its sale in the fall of 1960. I attended the first meeting to organize and incorporate the City of Denver City and served as a member of the city council as well as two terms as Mayor. During my first term as mayor, the original water company was purchased, and in the second term, the present city water system was completed, with filtering plant, new wells and needed sewage extensions, the trash pick-up system was inaugurated and land secured from Shell Oil Company for the original Shell Addition.

"I was instrumental in securing the land for the Denver City park, in working for the installation of the swimming pool and facilities, and in securing the first paving for the city. During my tenure as councilman and mayor, I was fortunate to have the cooperation of my fellow councilmen and our commissioners, and feel certain I can work with and enjoy the cooperation of all officials in the county should I be elected as county judge.

"I have always been interested in our youth, serving for 12 years as Scoutmaster, and upon coming here, organized the Cub Scouts and served as its first Cubmaster. Having reared one son, I believe I know and understand youth and its problems.

"I helped organize the American Legion, was a charter member and served two terms as post commander. During World War II, I was appointed by the President as a member of the county's advisory board for the draft board, and later served as a member of the draft board. I helped organize the Lions Club and am a charter member, served on the committee for the Co-op Dairy. I also helped organize the Chamber of Commerce, am currently a director, and a member of the committee working on securing of a railroad into Denver City. In addition, I am a member of the Community Building Board, I have devoted many hours and effort to the securing of new businesses for our area.

"I am a member of First Methodist Church, and have served as a trustee and member of the official board for 22 years, having also served as president and chairman of the official board.

"I bring these things to your attention only as a means to show my continued interest and efforts extended towards community betterment in all phases. As your county judge, I pledge continued effort for the improvement of the county as a

whole. "I am much interested in our agricultural outlook and promise my influence and efforts in

finding better use for our land and to encourage industry into our area, such as packing and canning plants.

"I believe in getting a dollar value for a dollar spent; also in promoting agriculture and industry in our county, in added

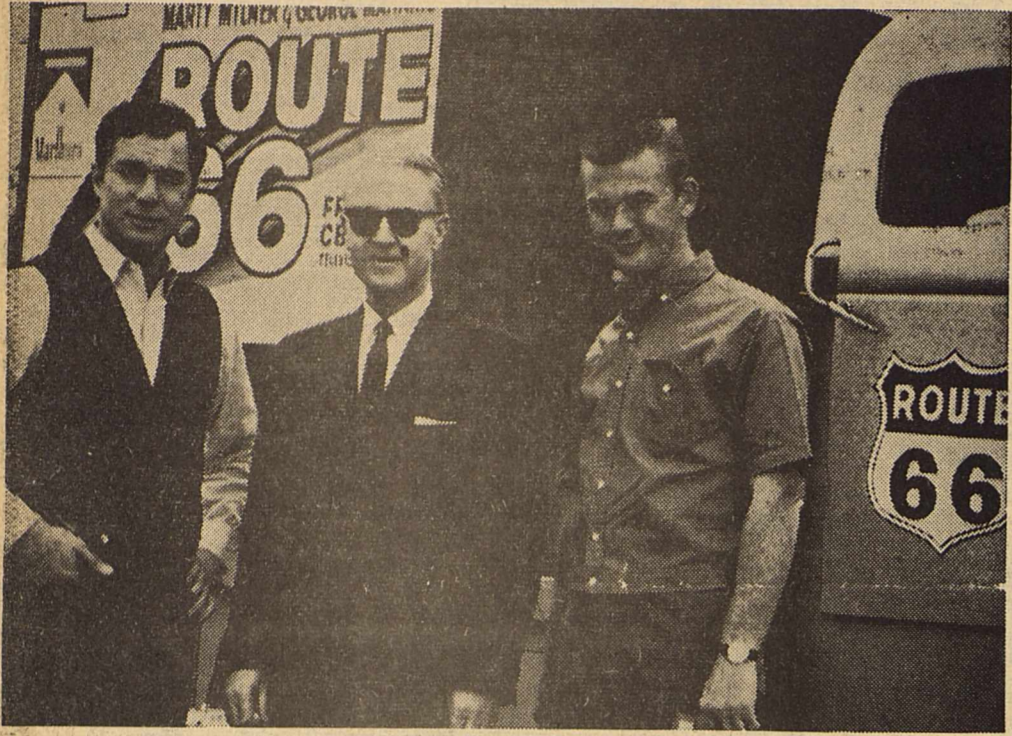

Seals are not sold; no specific donation is expected from those who receive them. present, afford to lower their own rates.

Several months ago this case, along with a cross-suit on the part of the City of Plains against Lea County Co-op was heard before Judge Ledbetter of 121st district court. In that hearing, without a jury, Judge Ledbetter, in effect, actually made no ruling, in that he denied Lea County Co-op their injunction and denied the City of Plains their request of a summary judgement forcing Lea County Co-op to suspend operations within the municipal limits of Plains.

Council for the City then requested that the case be tried further in the local district court with the presence of a jury. This is the case that is to be heard in the pending court session slated to begin March 19.

Loe pointed out that at the time the franchise was purchased, by Lea County Co-op, as they were high bidder over Southwestern Public Service Company, it was not a question of whether or not the City desired to purchase the facilities of the old Plains Light and Power Plant, but that the City, at that time, simply couldn't afford it.

Further, Loe pointed out that previous to the construction of the local power facilities and many times subsequent to that time, offers have been made to buy back the franchise, but that Lea County Co-op has not been willing to sell.

At the present, the City, according to Loe, is making a substantial profit from its power plant. Explaining why a rate reduction at this time was felt to not be in the best interests of Plains, several things were

pointed out. In the first place, Loe said, many civic improvements such as the addition of street lights, additional city paving and a very rapid expansion of the City's sewer system is being accomplished with these profits, taking away the necessity of having to vote.

It was also pointed out by Rod Duff, who was City Secretary at the time Plains began its municipal power in September 1957, that in planning for the repayment of the bonded indebtedness incurred to construct the power plant, Lea County officials were contacted and asked if their rate at that time was considered by them to be fair and equitable. Duff stated that their answer was in the affirmative and that the Plains rate was set at the same figure and so was the repayments schedule on the bonded indebtedness.

Also pointed out by Duff, is the fact that the bonding company itself suggested that the City look into the matter of furnishing the municipal power, as a means to securing jointly a bonding agreement for the needed construction of sewer facilities, as the bonding company further pointed out that these facilities would hardly bring in enough revenue to pay off the created indebtedness.

Most observers are quite sure that however the outcome of the trial locally, the losing interest will appeal the case until, in all probability, it reaches the state supreme court.

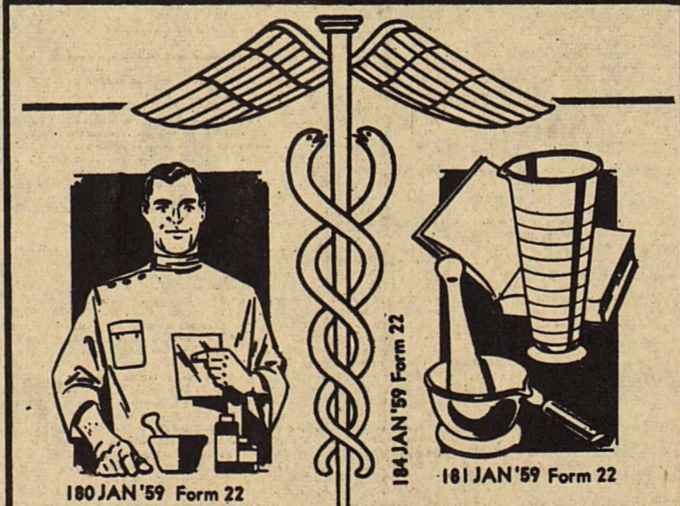
