Age 65 Could Be "Graduation" To Many Dollars

Retirement a graduation or a commencement? It may be both - yes, for many people. It might be said those who retire - for whatever reason at age 65, graduate from active work to retirement, commencing a completely new life, according to R. R. Tuley, Jr., district manager for the Social Security Administration in Abilene.

"For many, of course, this will not be considered a graduation. For many who have worked hard all the time since their early years, it may seem more like an expulsion. For some - even some who have talked about all the good things they would do when they reached retirement age - it will mean that all those days of leisure ahead are dreaded, even as they first commence.

"So, the question may be, then, how does a person graduate from making a living -

to living a life?." he went on. If you are 65 and going to apply for your social security retirement beliefits (and meacare benefits), you will find that you will be allowed to work part time and draw your social security retirement. You will find that you will be allowed to earn up to \$1680 a year in wages and self-empoyment and still get all of your retirement checks. You will also find that even if you earn more wages than \$1680 you will often be due some retirement checks. And this combination of some work and some social security, checks frequently may work better for you than either complete retirement or full-time work.

It may be that you will be one of the many persons who look forward to full retirement to travel - to give some of their retirement time to service organizations - to use some of their talents which they have not found time to use while working full-time.

Whatever your choice, to retire or not to retire, Tuley urges that you contact the local office for social security and discuss your situation 3 months before that 65th birthday. "Inaction is one way of saying 'No' to Medicare coverage, and may cost you some income dollars," he added.

AN ORDINANCE

AN ORDINANCE FIXING AND DETERMINING THE GENERAL SERVICE RATE TO BE CHARGED FOR SALES OF NATURAL GAS TO RESIDENTIAL AND COMMERCIAL CONSUMERS WITHIN THE CITY LIMITS OF CARBON, EASTLAND COUNTY TEXAS, AND PROVIDING FOR THE MANNER IN WHICH SUCH RATE MAY BE CHANGED, ADJUSTED AND AMENDED AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF CARBON, TEXAS:

SECTION 1. Effective with the first gas bills rendered after the final aprpoval of this ordinance, the maximum general service rate for sales of natural gas rendered to residential and commercial consumers within the city limits of Carbon by Lone Star Gas Company, a Texas corporation, its successors and assigns, is hereby fixed and determined as follows:

First 2,000 cu. ft. or less \$1.344 per Mcf Gross; \$1.21 per Mcf Net. Next 10,000 cu. ft. @ \$1.011 per Mcf Gross; \$.91 per Mcf Net. Next 10,000 cu. ft. @ .900 per

All Over 22,000 cu. ft. @ .789 per Mcf Gross; .71 per Mcf Net. MINIMUM BILL — \$2.633 Gross; \$2.42 Net per meter per month.

Mcf Gross; .81 per Mcf Net.

ADJUSTMENT

The amount of each net monthly bill computed at the above stated rates shall be subject to the following adjustment: Plus an amount equivalent to the proportionate part of any new tax, or increased tax, or any other governmental imposition, rental, fee or charge (except state, county, city and special district ad valorem taxes and taxes on net income) levied, assessed or imposed subsequent to July 1, 1969, upon or allocable to the Company's distribution operations, by any new or amended law, ordinance or contract. Each gross monthly bill shall be adjusted proportionately. Company, at its option, may forego the application of this adjustment; however, failure of Company to apply such adjustment shall not constitute a waiver of Company's right from time to time, or at any time, to make such adjustment, in whole or in part, in any subsequent current monthly bill that may be applicable to such bill.

Net rate shall apply to all bills paid within ten days from monthly billing date; gross rate shall be applicable thereafter.

The above rate is applicable to each residential and commercial consumer per month or for any part of a month for which gas it used at the same location.

In addition to the aforesaid rates, Company shall have the right to collect such reasonable charges as are necessary to conduct its business and to carry out its reasonable rules and regulations in effect.

SECTION 2. The rate set forth in Section I may be changed and amended by either the City or Company furnishing gas in the manner provided by law. Service hereunder is subject to the orders of regulatory bodies having jurisdiction, and to the Company's Rules and Regulations currently on file in the Company's office.

SECTION 3. The fact that there is an imperative public need for anordinance fixing and determining the rate for gas and gas service furnished to residential and commercial consumers creates an emergency, and the reading and passage of this ordinance at three separate meetings is hereby suspended and this ordinance shall take effect and be in full force from and after the date of its passage at a single meeting and the approval thereof by the Mayor.
