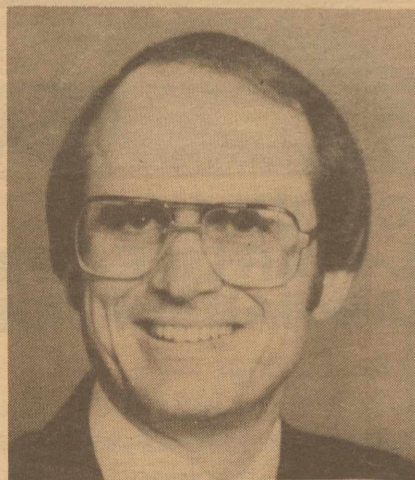
Pastor L.D. Hinson extends a cordial invitation to the public.

\$4 entry fee for non-members. Student entries will not be assessed an entry fee.

All paintings must be framed and securely wired for hanging. Any work not in good taste may be rejected. Each entry must have a card attached to the back giving required information. Canvas size must not exceed 900 square inches. No wet paint accepted.

Judging will be from 9 a.m. to 11 a.m. July 31. Entrants may attend the critique immediately following the judging. Purchase awards will be selected from 2 to 4 p.m.

Grand Entry for the annual rodeo is set for 8:30 p.m. A saddle will be given away during the rodeo. Queen candidates are accepting contribu-

tions toward that valuable prize.

A barbecue dinner will be served at noon Saturday. Persons are requested to bring potato salad and cobbler for that event.

Candidates seeking to be crowned Rodeo Queen are Dana Altman, sponsored by Plains Lions Club; Kristi Harris, Roping Club candidate; and Krissy Bowen, sponsored by Plains Chamber of Commerce.

The big day will be concluded with a dance.

Plains Fire Department Purchases New Foam Unit

Residents of the area can rest a little easier now that Plains Volunteer Fire Department has additional fire-fighting equipment. The new equipment was demonstrated by the Department during Open House July 8.

The new equipment, a 500-gallon Water Expansion Pump System (WEPS), was obtained through the help of Texas Forest Service's Rural Community Fire Protection (RCFP) program. Through the program, TFS provided the WEPS unit and shared half the cost with a check for \$2,500. Plains Volunteer Fire Department paid the remaining cost and furnishes the truck upon which the foam unit is mounted.

The WEPS unit was installed Tuesday with representatives of TFS assisting.

State Representative Jim Rudd of Brownfield attended the demonstration.

The WEPS unit will allow local firemen extended operations time on the scene of a fire. A major asset of the equipment is that it expands the "wetting ability" of plain water by ten times. In other words, with the 500-gallon unit, Plains firemen will be able to generate some 5,000 gallons of firefighting foam.

The system mixes water and compressed air with a sudsing agent to generate foam. The system is becoming increasingly popular with firefighters all over the state because it can be used on either ground cover or structure fires. It can be "the difference" on remote rural area fires, which have no large sources of water available.

Another major asset of the WEPS, invented by a TFS researcher several years ago, is that it does not need an expensive chemical as a sudsing agent.

Preferred foaming agent, a low-cost by-product of the Kraft paper-

making process called "soap skim", is also available from Texas Forest Service. Cost is \$36 for a 55-gallon drum; \$6 for a 5-gallon container

and containers are included in these special prices.

Soap skim is non-corrosive, biodegradable and safe as dish washing liquid. Used in structure firefighting, WEPS foam causes less "water damage" than does plain water. Although "soap skim" is used most often as a foaming agent in WEPS units, it is frequently used as a wetting agent in regular pumping units.

The only "string attached" to the RCFP cost-sharing assistance to Plains VFD, is a signed agreement between the Department and TFS. In exchange for the financial assistance, the VFD agrees to assist Texas Forest Service in the event help is needed on a large ground cover fire in the area.

Equipment cost-sharing is just one of the ways the state forestry agency is aiding Texas communities and fire departments. Free training in ground cover firefighting is another. TFS trainers offer courses in ground cover tactics, ground fire organization and WEPS operation, to fire departments across the state. These courses are accredited by Texas Firemen's and Fire Marshals' Association.

More than 900 Texas communities and fire departments have received TFS equipment or training during the past several years.

Plains residents should take this opportunity to extend thanks to Plains Volunteer Fire Department for their efforts at assuring persons in the community of responsible, caring fellow townsmen ready to respond to every call.

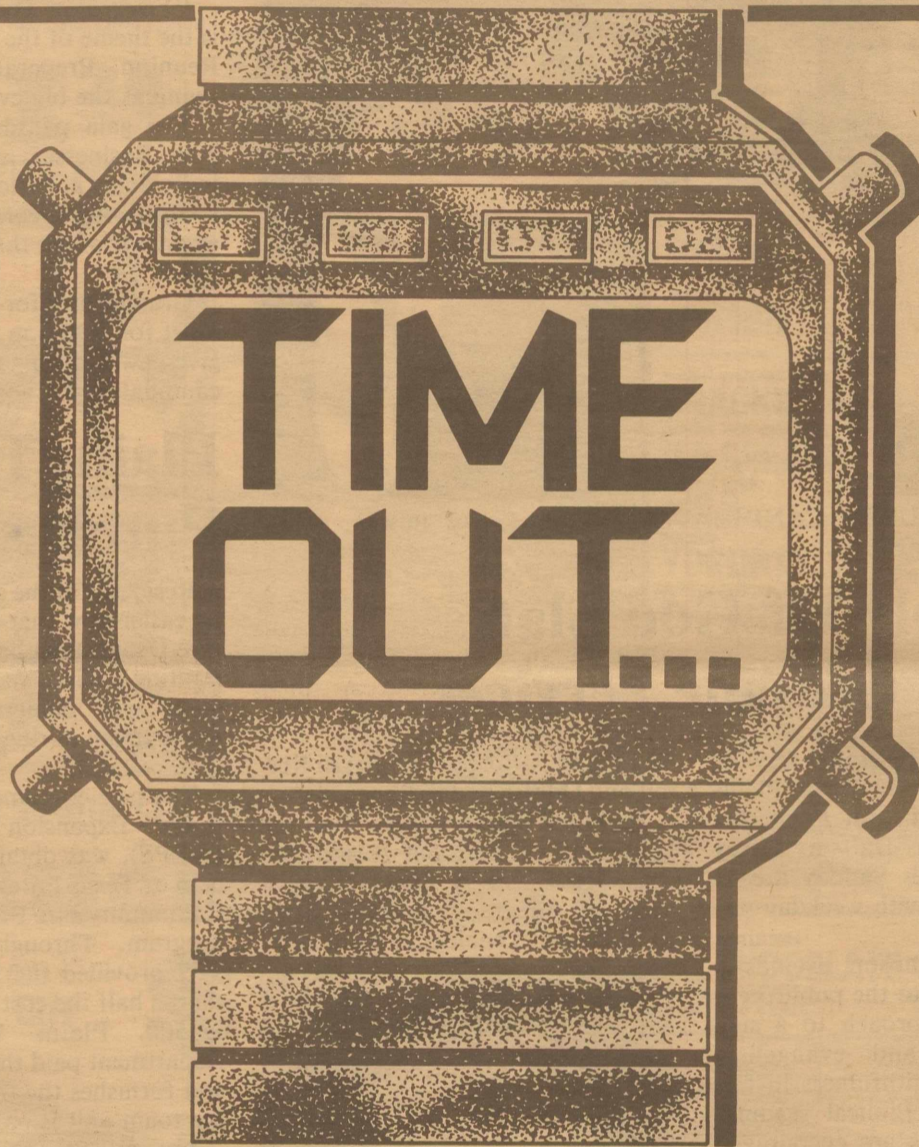

"Two With Song", a sacred musical duo, will present a concert for the Sunday morning worship service in Plains United Methodist Church. The program will begin at 11 a.m.

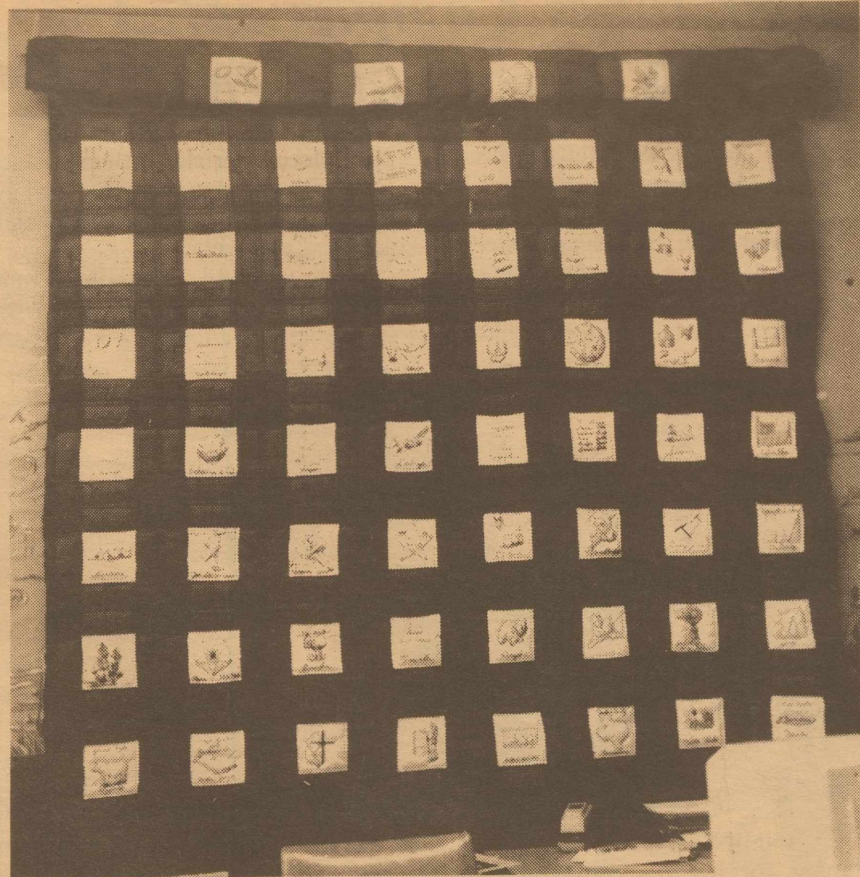

Ham, vegetable casserole, layered salad, Jell-O salad, hot rolls, vegetable tray, iced tea and pastry tarts were served.



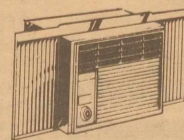

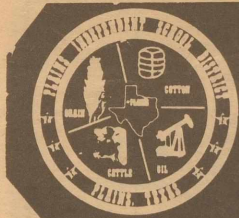

From The Superintendent's Desk

DEAN ANDREWS



1904 — Mary McLeod Bethune used \$5 she had saved from selling potato pies to construction workers as a downpayment on a cabin and some land near Daytona, Florida. Five students enrolled in her school, which eventually became Bethune-Cookman College.

1917 — Congress passed the Smith-Hughes Act, which provided federal funds to improve vocational education in elementary and secondary schools.

1930 — Approximately 67 percent of the population between the ages of 5 and 17 was enrolled in school. The typical school year was 172 days. About 29 percent of all 17-year-olds graduated from high school.

1944 — The Serviceman's Readjustment Act, commonly known as the G.I. Bill, provided college, technical, and on-the-job training for veterans of World War II. Similar laws were enacted for veterans of Korea and Vietnam; in all, they provided education for more than 27 million ex-servicemen.

1950 — The National Science Foundation Act provided funds to improve teaching in science and mathematics.

1953 — The Office of Education was moved from the Interior Department to the new Department of Health, Education and Welfare.

1954 — In *Brown v. Board of Education*, the U.S. Supreme Court ruled that "in the field of public education the doctrine of 'separate but equal' has no place". The Court ordered school systems to desegregate "with deliberate speed".

1958 — The National Defense Education Act, a response to the Soviet launching of Sputnik, provided funds to improve teaching in physical sciences and foreign languages, to promote guidance and counseling in schools, and to upgrade the use of television and other media for instruction.

1960 — Approximately 79 percent of the population between the ages of 5 and 17 were enrolled in school; 65 percent of the seven-year olds were high school graduates.

1965 — President Lyndon Johnson signed the Elementary and Secondary Education Act, designed to address the educational needs of culturally disadvantaged children. This law was the first large-scale federal program to support elementary and secondary education. By 1980, schools in low-income neighborhoods had received more than \$3 billion in aid under the bill.

1972 — Title IX of the Education Amendments Act prohibited discrimination on the basis of sex in any education activity receiving federal aid. The law was most frequently associated with increased opportunities for women and girls in athletics.

1973 — The Rehabilitation Acts (Section 504) prohibited discrimination against persons with physical, mental, or emotional handicaps in any federally funded institution.

1975 — The Education for All Handicapped Children Act (Public Law 94-142) required schools to provide "a free appropriate education" for disabled young people aged 3-21 in "the least restrictive environment". Under the law, schools began to "mainstream" disabled students into regular classes.

1979 — The U.S. Department of Education became the 13th Cabinet-level federal agency.

The mandates of House Bill 72 and House Bill 246 have gone a long way to improve and reform education in our great state. We have said before and will say many times again, that educators and lawmakers continue in their efforts to provide the best possible education to the children of our state. Schools have come a long way since the time when students wrote on slates, shared books, and studied by firelight. Thomas Jefferson wrote "Above all things, I hope the education of the common people will be attended to; convinced that on their good sense we may rely with the most security for the preservation of a due degree of liberty". Today, improved technology makes possible a quality of education that Thomas Jefferson could only have dreamed about.

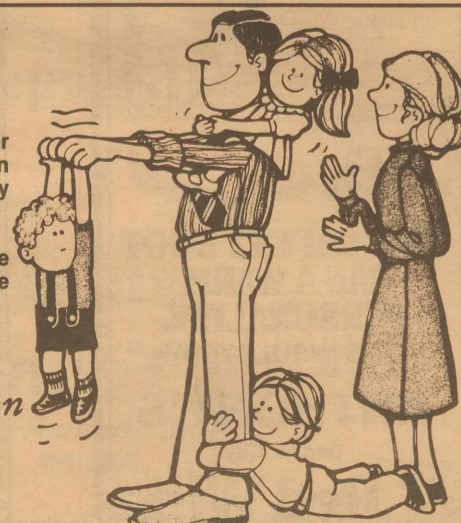




