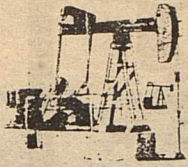

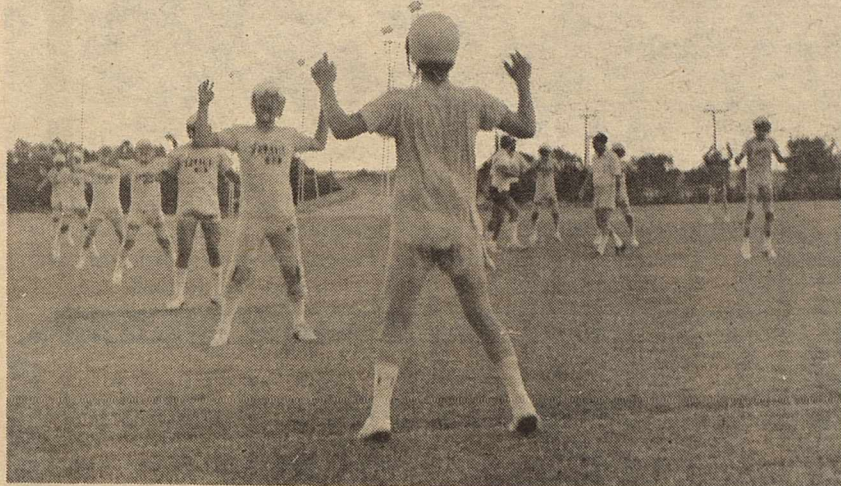

## School Board Okays Purchase Of John Deere Tractor/Loader

Plains Independent School District's board of trustees met Monday evening for the annual budget hearing. All members were present.

The 1985-86 budget was approved as amended and the 1986-87 budget adopted.

Following the budget hearing, the board convened for a tax rate hearing. The 1986 tax roll was accepted as certified. A tax rate of thirty-four cents per one hundred dollars valuation was adopted for the 1986-87 school year.

At 8 p.m., the regularly scheduled board meeting was called to order by Jack Palmer, president.

Board members approved an additional five hundred dollars to be added to the contracts of those teachers placed on career ladder level two for 1986-87.

Six days of the 1986-87 school year were approved for early dismissal. School will dismiss at 2:30 p.m. Sept. 5, Sept. 26, Nov. 26, Feb. 19, March 13 and May 28.

Bids were opened and considered

for the purchase of a John Deere tractor and loader. Accepted was a bid from Plains Farm Supply, Inc. for a 1450 John Deere tractor as specified with front end loader for a total of \$12,975, purchase price less trade-in.

Trustees also opened and considered bids for the purchase of a 35-passenger school bus. A bid of \$28,417 submitted by Bridges-Hemphill Enterprises was accepted.

Substitute teachers approved for employment for the 1986-87 school year are Cynthia Blair, Margaret Box, Kenneth McGinty, Diane Bennett, Shirley Bunch, Cindy Davis, Kathy Jones, Sydney Murphy, Paula McMinn and Pam Redman.

Guidelines for implementing the Texas Teacher Appraisal System for 1986-87 were adopted and the Plains ISD discipline management plan amended. July bids were approved for payment.

Resignation of Jamie Shipp was accepted and Renee Norman employed for the upcoming school year.

**Commissioners Court**

Yoakum County Commissioners Court met in regular session Aug. 11 in the County Courthouse. All members were present.

The court approved a motion to hire Attorney Buddy Manor to represent Sheriff Jimmie Rice and Yoakum County in a suit pending in Ector County.

Petitions presented earlier requesting the establishing, enlarging and equipping of the county hospital were certified by the voter registrar with the necessary number of qualified voters required in calling a special election. A written order calling an election was introduced for consideration and duly approved.

The election is set for Tuesday, Nov. 4 from 7 a.m. to 7 p.m. in the county's regular voting precincts, at the polling places with election officers named by the court.

A bid in the amount of \$22,811.40 for an anesthetic machine for the hospital was accepted by unanimous vote.

Budget amendments were approved for the 1986 annual audit. Bills for July were read and approved for payment including payment of registration fees of Jim Barron to attend the NACo Conference.

Commissioners also voted to advertise for bids for a self-propelled pneumatic roller with and without trade-in of a Hyster roller with purchase price to be paid by the issuance of warrants, rate not to exceed eight percent and maximum maturity two years. Bids are to be received Sept. 8.

Also approved was motion to advertise for bids Sept. 8 for a 6,000 gallon booster trailer, insulated, with heating coils, used and in good condition.

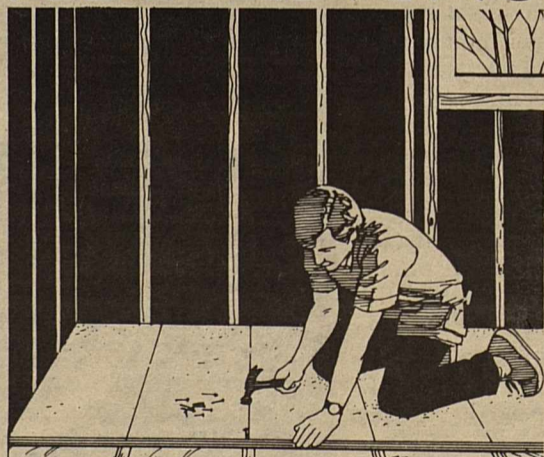

## From The Superintendent's Desk

According to informed sources in Austin, education lobbyists seemed to share the consensus that the mood of both Democrats and Republicans right now is to leave education alone during the Special Session. With Lt. Governor saying, "We can't afford not to fund the education reforms," to cut Texas Education Agency's funding now could set off a tremendous backlash.

Commissioner Bill Kirby made an effective plea for no cuts before the Senate Education Committee, and most knowledgeable veterans on the Hill say the sentiment is with education for the moment. At a state meeting of the PTA the day before the House Appropriations Committee met, a resolution was passed unanimously calling for an increase in education funding.

Meanwhile, the State Board of Education covered all the bases by approving four proposals including one for increased funding, one for current level funding, and one for ten and twenty percent cuts.

If budget cuts are necessary, the SBOE position is that local districts should pick up a larger share. The board's rationale on this according to TEA Communications Director, Terri Anderson, is that the local districts would have more control deciding which program would need to be either cut or strengthened.

If education is fortunate enough to escape cuts this summer, no one should be deluded into thinking that every program will be scrutinized come January. According to Raymon Bynum, some vocational programs are at the top of the list.

A plan generally supported by State Representative Jim Rudd, chairman of the House Appropriations Committee, does include the possibilities of reducing funds for the half-day kindergarten and the career ladder.

Virginia shares easy to prepare recipes that are sure to please the heartiest of appetites.

- MEXICAN CASSEROLE**  
 2 lbs ground lean hamburger  
 1/2 soup can of water  
 1 4 oz can chopped green chilies  
 1 chopped green pepper  
 1/2 lb grated Velveeta cheese  
 2 cans cream of mushroom soup  
 1 8 oz can enchilada sauce  
 1 pkg Doritos  
 2 T chili powder

Mix ground meat, pepper, onion and chili powder together and cook slowly until meat is lightly browned, drain off excess fat. Remove from heat and add remaining ingredients reserving cheese and Doritos in a

greased 9x12x2" pan, place a layer of Doritos, then one of meat, then one of cheese. Make second layer of each ending with cheese, grated on the top. Refrigerate 24 hours to season. Bake at 350° for 45 mins.

**BARBEQUED PORK CHOPS**

- 1/2 c water  
 2 T sugar  
 1 1/2 t salt  
 1/4 t cayenne pepper  
 1 lemon  
 2 T Worcestershire sauce  
 8 pork chops  
 1/4 c vinegar

- 1 T mustard  
 1/2 t pepper  
 1 med sz onion, sliced  
 1/2 c catsup  
 2 t liquid smoke

In sauce pan add: water, vinegar, sugar, mustard, salt, pepper, onion, lemon sliced with peel, catsup, worcestershire sauce, liquid smoke. Bring to boil, stirring. Pour over pork chops. Bake at 300° for 1 1/2 hrs.

**CHICKEN CASSEROLE**

- 6 chicken breasts  
 1 pkg dry onion soup mix  
 1 can Cream of Celery Soup  
 1 small carton of sour cream
- Mix together and pour over chicken. Bake approximately 45 minutes.

**SOUR DOUGH OLD TIME STARTER**

- 2 cups unsifted flour  
 1 T salt  
 1 T vinegar  
 2 T sugar  
 1 1/2 c water
- Combine flour, sugar and salt in a stone crock. Mix well, add water and beat to a smooth batter. Add vinegar. Cover with cheese cloth and set in a warm place until thoroughly sour. You determine this by the yeasty smell. Usually takes approximately 12 hours.

**SOUR DOUGH BISCUITS**

- 1 1/2 c sifted flour

- 1/4 t baking soda  
 1/4 t butter  
 2 T baking powder  
 1/2 t salt  
 1 c sour dough starter
- Mix as regular biscuits and roll out and let rise about an hour. Bake in 425° oven for about 20 mins. Makes about a dozen large rolls.

## JoAnn Barron Participates In International Crusade

"Americans are treated as honored guests," reflects JoAnn Barron who participated in an evangelistic crusade July 3-17 in Brazil. "And the Lord uses this, to open doors for the gospel to be shared."

Crusade arrangements for the 19 Americans were made by International Crusades of Dallas, a non-profit organization that assists and equips Baptist congregations in sharing the gospel all over the world, JoAnn explains.

A former resident of Plains, Calvin Beach, is executive vice-president of International Crusades. He is the son-in-law of Mr. and Mrs. L.E. Lemley. Ben Meith, a former resident of Seminole, is president.

Witness materials, explains Mrs. Barron, are so effective an interpreter is not needed to lead someone to be saved. A small manually operated "disc" and the Crusade volunteer's own personal testimony that has been translated into the language of the country, give a person a step by step instruction in how to receive Jesus Christ as a personal savior.

"Many people from Argentina traveled 72 hours on a bus to share the gospel," says Mrs. Barron. "They got off the bus singing and praising the Lord for the opportunity He had given them to share with the Brazilian people what Jesus had done for them. I wondered if I'd be praising the Lord after 72 hours on a bus!"

"We flew to Rio where several of our interpreters joined us for an eight hour bus trip through the most beautiful mountains to Varginha. We saw palm, banana, orange, apple, pomegranet, lemon, lime, papaya and even pine trees and huge coffee and sugar cane fields, terraced mountains with cattle grazing, resort areas featuring 'hot springs' that resembled an American Dude Ranch."

Mrs. Barron worked in Varginha, a city of 100,000 with just one Baptist Church. Its membership was 90.

"On two previous crusades to Brazil, I worked with very poor churches. But Varginha has many doctors, lawyers and teachers with the same concerns the poor people had — they wanted their friends and relatives to know Jesus," says Mrs. Barron.

"Each morning we visited homes, had lunch in the home of a different church member each day, visited all afternoon and had church services in the evening."

Mrs. Barron was able to present a Bible, a record and copies of personal testimonies to the mayor along with a letter of greetings from Mayor T.J. Miller, on behalf of the City of Plains.

"The mayor locked his office door and listened carefully as we played the record. He read the testimony and told us he felt he

would go to heaven because he tried to be a good person and attended church. We read from the Bible that if a person could be good enough to go to heaven, Jesus would have not had to die. He realized that salvation is not by works but the price Jesus Christ paid on Calvary. He thanked us for coming and said he knew God was our only hope. We found that regardless of a person's social standing or position, everyone needs the Lord."

Mrs. Barron reports there are just two classes in Brazil although middle class is becoming more prevalent. She also states that coins minted in Brazil prior to 1986 are imprinted with a symbol of spiritism (Jasan) but new money without the sign is now being minted and its value increased.

"In Brazil," she adds, "the automobile always has the right of way. If you are struck by a car, it is your own fault. And you can't be a church member if you drink or smoke."
