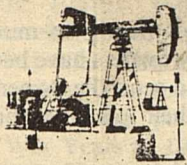

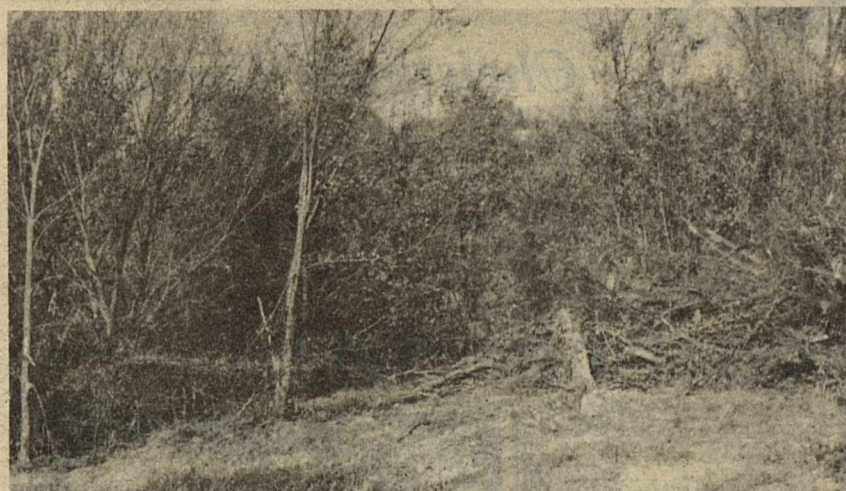

Plains Citizens Praised For Clean-Up Efforts

Residents of Plains are commended this week for efforts in the clean up campaign which has been a joint endeavor of the City and South Plains Health District.

Open Letters to the citizens of Plains from Mayor T.J. Miller and Don Weems of South Plains Health District are printed in this issue.

Letters of complaint were mailed to a number of property owners in reference to the clean up campaign. Those persons who have not responded by cleaning up their property are hereby notified that the deadline for doing so is Monday, Dec. 15.

"I feel we have been more than fair with all property owners who have had a complaint filed against them by the health officer," says A.G. Brantley, Justice of the Peace. "The time has come to set an absolute deadline for all that have not taken care of these complaints."

"The deadline is Monday, Dec. 15. At that time, a warrant can be issued by this court for those who have not complied with the law. Following arrest, a fine up to \$200 will be set."

"I encourage each of you to cooperate fully in the efforts to clean up our city," Brantley adds.

Johnnie Fitzgerald, Commis-

sioner Precinct 4, has announced his workers will help with clean up efforts when there is available time. The crew will also have precinct equipment available, including dump trucks, front end loaders and grader.

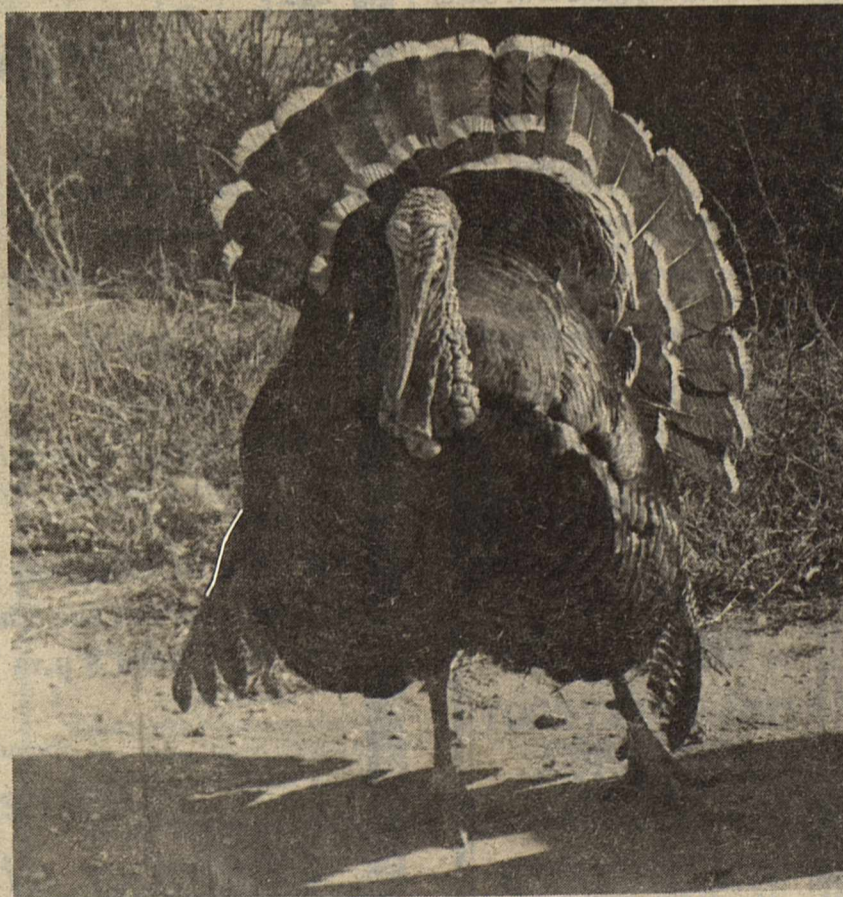



American Heart Awards Research

The American Heart Association, Texas Affiliate will spend more than \$2 million for grants to support heart research projects in Texas during their 1986-87 fiscal year, according to Addison A. Taylor, M.D., president of the Association. A total of 113 grants will be funded, averaging \$24,000 for each project.

This basic biomedical research is conducted at 16 institutions throughout Texas. The national arm of the Heart Association allocated an additional \$1.9 million for research in Texas. This combined funding of \$4.6 million represents approximately 37 percent of total dollars raised by Heart Association volunteers in Texas last year. Since 1949, the American Heart Association has committed over \$633 million for cardiovascular research.

Sudden Deaths Linked To Cocaine

The American Heart Association warns that cocaine use, in any form or amount, can seriously damage the heart and cause severe disability or death.

Cocaine recently has been the recognized cause of many deaths in the U.S. and in Texas, and has probably contributed to many more. According to the Heart Association, many of these deaths can be traced to the effect of cocaine on the heart. "Cocaine use can cause irregular heart beats," says Addison A. Taylor, M.D., president of the American Heart Association in Texas. He adds, "These irregularities can lead to cardiac arrest and sudden death."

Many sudden death cases are linked to cocaine use. Death can occur from even a single dose of cocaine. "The risk of death increases as the dosage increases," says Taylor. Smoking or intravenous use also increases the risk. Several deaths have occurred while "snorting" cocaine.

The Heart Association says cocaine is dangerous because its use causes heart attacks in apparently healthy people. The arteries that feed the heart squeeze shut and interrupt the blood supply, so a portion of the heart muscle dies. Death or long-term disability can result. People who have some degree of heart disease, including those who may not know it, increase their risk of heart attack by using cocaine.

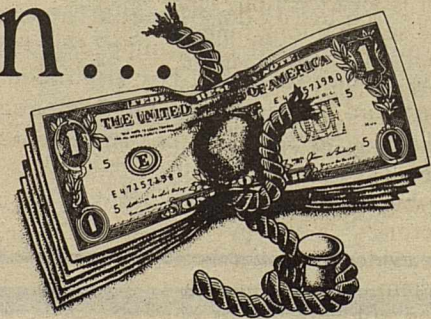



From The Superintendent's Desk

Two of the questions frequently asked at school are "Why do I have homework?" and "Why don't my children have more homework?" Both are valid and pertinent questions. We all have questions concerning homework at one time or another, and perhaps the following paragraphs will answer some of those questions.

There are at least two views on the subject of homework. Parents are never sure that there is enough of it and students feel that even a little is too much. Schools generally attempt a compromise of these two stands. In many schools, the amount and type of homework is left to the discretion of the individual teacher.

Homework helps parents to keep in touch with what their children are learning at school. Yet, due to the diversity or complexity of the subjects their children may be studying, parents may sometimes feel intimidated by homework when it does arrive at home. Should this happen a discussion with the teacher and principal in many instances can clarify the situation.

The purpose of homework should be to practice previously taught material, not to introduce new material. Teachers' use of classroom time can eliminate much homework by providing time for students to practice at school. However some students need more practice in particular skills and homework provides the opportunity for this practice. However, if a student seems exceedingly burdened -- or never have any kind of homework -- parents have reason to be skeptical. If homework is used as a punishment or appears consistently to be the same for every student (two things educators frown upon), then parents ought to find out why.

It should be remembered that school is hard work. A student who tackles two or three hours of homework every night is putting in nine-hour days. This can quickly become tedious and demoralizing.

The following are ways in which you can help your children:

- *Provide a place for children to read and study.
- *Limit the TV, or its sound level at least.
- *Be a facilitator in their learning to schedule time. Say, for instance, "Do you want to study before dinner and then play basketball at 7:30?"
- *Encourage them to work for an interval, take a break, and then go back to it.
- *Schedule trips to the library.
- *Ask about their assignments. Discussion reinforces learning.
- *Encourage their independent reading.
- *Set an example by continuing to learn and study yourself.
