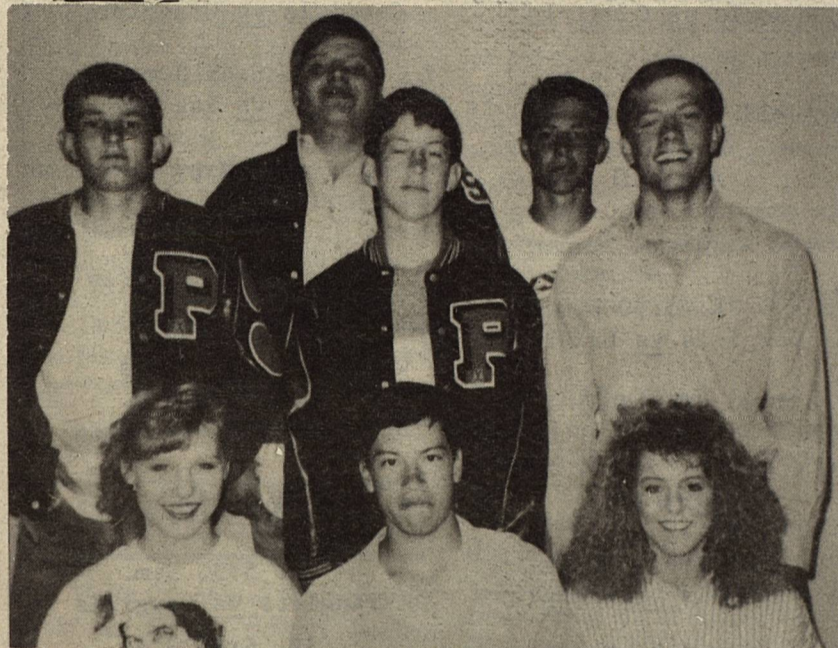

Literary Meeting Held At Library

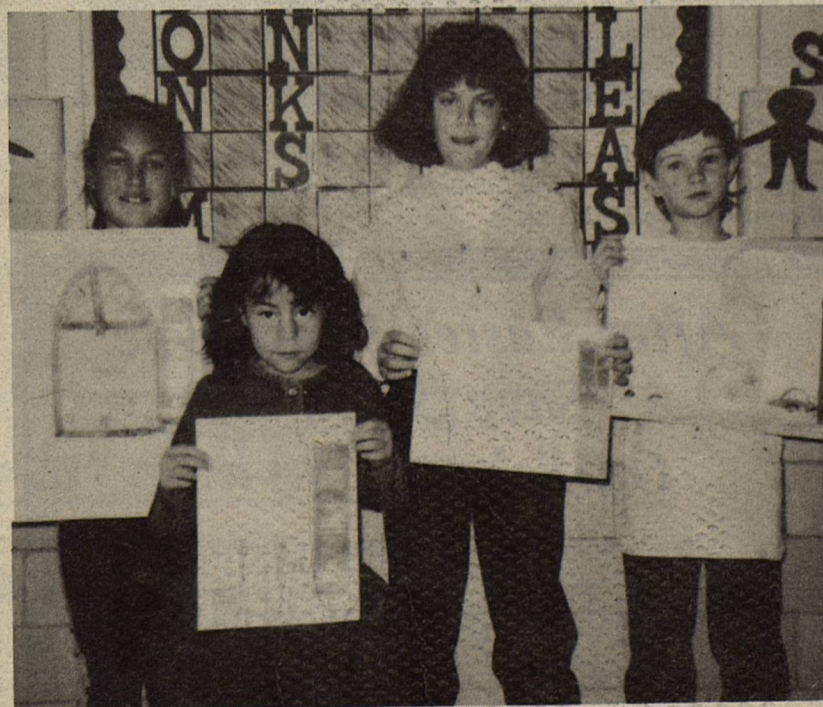
A called meeting of the Laubach Literary program was held Friday night, March 21 in the Heritage Room at Yoakum County Library.

STUDENT INSURANCE COVERAGE

Plains Independent School District carries insurance to cover all students with blanket insurance for any school-time or extracurricular activity, including interscholastic sports, for Grades K-12. Parents are given an opportunity to purchase 24 hour student accident coverage.

Our insurance program this year does not have the usual exclusions, limitations, or controls found in most policies. The payment of medical EXCESS over any other family or employer group insurance or plan. Any other plan must contribute its maximum payment before this insurance has any liability. Plains I.S.D.'s program is one of supplemental coverage designed to pick up balances left by the family or employer group insurance or plan, and, if no other coverage is available, to honor the medical expenses to the limit stated in the policy provisions.

The blanket accident coverage is divided into separate layers of coverage as follows:

The first layer covers medical bills incurred from the first dollar to a medical maximum of \$250.00 per accident. Bills incurred under this layer of coverage are paid with drafts issued at the school.

The second layer covers medical bills exceeding \$250.00 to a medical maximum of \$9,750.00 per accident for student injuries, and a medical maximum of \$9,750.00 per accident for injuries occurring in the interscholastic sports program. This layer also includes a \$1000.00 Accidental Death Benefit and a \$5,000.00 Dismemberment Schedule.

If an accident occurs, an insurance form should be obtained from the Business Office. The form contains sections to be completed by the family, the doctor, and the supervisor/teacher at the time of the accident. Each section must be complete before a claim can be filed. The form should then be returned to the Business Office along with invoices or bills from doctors and hospitals.

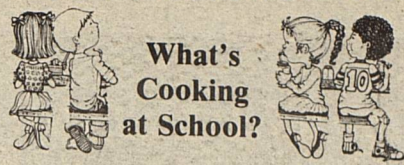

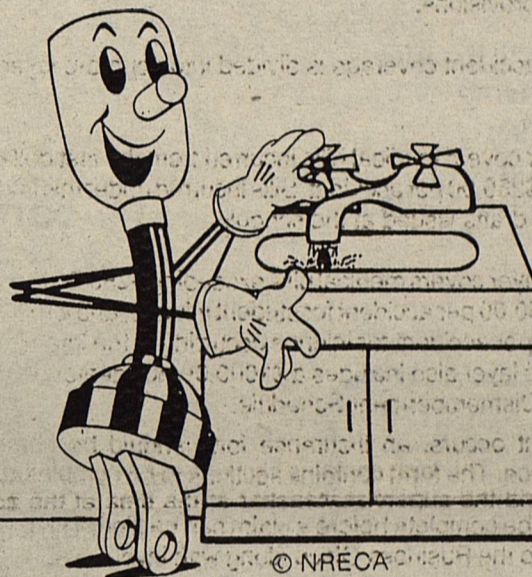

To All Poka-Lambro Telephone Cooperative, Inc. Subscribers:

The Federal Communications Commission requires Poka-Lambro Telephone Cooperative, Inc. to increase subscriber line charges, effective April 1, 1989. The charges to residential and single line business customers will increase by \$.03 per month and for certain Centrex and Centrex-type customers by \$1.00 per month. This increase applies to single-party and multi-party line customers.

These subscribers line charges are designed to recover a portion of the costs of connecting telephone customer to the nationwide telephone network that in the past were recovered through interstate long distance charges. We anticipate that the increased subscriber line charges authorized may be offset by reductions in charges by long distance service providers.

The new charges, effective April 1, 1989 are:




