Cowboy Cross-Country Team Sets School Record

The Cowboy Cross Country team members, Armando Ramirez, Michael Sainz, William Matta, Junior Lira, Lacy McAdams, Jimmy Robertson and Earnest Chavez have captured the third straight District Championship title for Plains High School. This year's performance was the best in the school's short history of the sport.

Armando Ramirez placed a record breaking first place finish for Plains. Ramirez' time beat Henry Gonzales' three mile record with 17:05. Michael Sainz came in second with 17:26 and Junior Lira placed third; Lacy McAdams, sixth and William Matta, ninth. Other runners were Earnest Chavez and Jimmy Robertson. The Plains team came in first with a total of 26 points.

At the Regional Cross Country Meet held in Lubbock, the Cowboys managed a fourth place finish with 121 points tallied. Michael Sainz, who narrowly missed qualifying for State by two places, captured a 12th place finish; Ramirez, 14th place; Lira, 22nd; Matta, 43rd; and McAdams, 51st.

The Cowgirl Cross Country Team competing at the District level found Sarah Chavira placing 11th; Kemi Cobb, 12th; and Annette Martinez, 16th.

Best Selling Christian Author To Speak At Levelland Seminar

The title of Mrs. Christenson's seminar is "Lord Change Me" and is based on one of her books, which have sold over two million copies.

The non-denominational seminar, scheduled Feb. 10, 1990, at the First Baptist Church in Levelland, is open to all women throughout West Texas and is sponsored by 12 area churches.

"We are tremendously excited that Mrs. Christenson is planning to conduct a seminar in Levelland. Her books and seminars have changed many lives; and we extend an invitation to all women throughout West Texas to participate in this very special event," said Debbie Davis of Levelland, seminar coordinator. "We encourage interested persons to register as soon as possible."

Mrs. Christenson conducts prayer seminars throughout the world and is a

board member of Chuck Colson's Prison Fellowship. She also is the organizer and chairman of the board of United Prayer Ministries, a non-profit organization which operates a non-denominational prayer chain for the twin cities area in Minnesota. Mrs. Christenson, the wife of a former minister, is a homemaker and grandmother.

"I struggled alone with God for 14 months, allowing Him to change me," she explained in her book, "Lord Change Me". "All during this time, He was clearly putting the emphasis on me, not anybody else. God used seven methods to teach me how He wanted me to change and how He would provide the direction and the means for my changing. This is an on-going process of becoming more like Christ until we see him face-to-face."

The seminar begins with registration from 8:15-8:45 a.m. Feb. 10 at the First Baptist Church. Mrs. Christenson's seminar will begin at 9 a.m. and will include six sessions, whose titles are "Why Me, Lord?", "Changing Through Reading God's Word Devotionally", "Changing Through Study-

ing the Bible", "Changing Through the Holy Spirit Recalling Scripture", "Changing Through Three Methods of Prayer" and "Four Sources of Wisdom Changing Us".

Deadline to register is Jan. 20. Registration fee is \$7.50. A late registration fee of \$9.50 will be charged those registering after the deadline.

Letter To The Editor

Dear Editor:

In response to the article in last week's Plains Pride written by Texas Tech Journalism Student Laquintta Wilson, I'm sorry to say that the information was incorrect.

Plains and Denver City have not joined together to build a new garbage dump site. A few months back, Plains was approached by Denver City about forming an interlocal board made up of two people from each City Council and three from Commissioners' Court for a landfill project. Plains City Council had several special meetings along with the regular meetings, trying to make decisions on this, as well as meeting with engineers from Texas Department of Health for advise and explanations of the new EPA laws. They did vote to join Denver City and the County in this effort.

Plains elected two board members being Jim Warren and Kevin Guetersloh; the County also elected their board members. It was our understanding that when Denver City elected their board members that future meetings would be set up for this project. The next that Plains heard from Denver City, was an article in the Denver City Press saying that Plains would not work with Denver City and they in no way wanted Plains to be the operator of the landfill and several other things!!!!. They also sent an agreement to Plains saying they wanted a yes or no answer 24 hours after Plains meeting. Plains City Council did not like the agreement presented and hired an attorney to draw up an agreement. Denver City had advised they would pay engineering fees for closing Plains present landfill and charge \$12.50 per ton for Plains to dump in exchange for Plains giving Denver City a dozer. The engineering for closing the landfill would be

\$18,000 and the dozer is worth \$40,000.

Then Denver City decided they would not pay engineering cost for Plains, but they still wanted Plains' dozer because of the special cost of \$12.50 per ton (at this point in time, no one knows if this is a special price or not).

Plains sent another agreement, taking out the offer of the dozer and with the understanding that if this was not acceptable that an agreement could not be reached. Denver City did not accept this agreement, so negotiations ceased at this time.

Plains will have to close their present landfill by May, 1991, and we are in the process of seeking other towns and joining in a regional landfill. We have been advised by the Texas Health Department that a landfill cannot operate under the new strict EPA laws unless they have from 30,000 to 50,000 customers. Therefore, regional landfills will probably be the answer for small towns.



TRANSPORTATION

The transporting of students is a very important and demanding job that requires much care and hard work. With our most valuable asset, your kids, at stake, safety is our major concern. We strive to ensure that each vehicle and driver is the very best that we have to offer.

It is our responsibility at school to see that the transportation program is run in the most efficient and best manner possible. Assignment of buses, drivers, and seeing that all of our vehicles are kept in top running shape and maintained on a very rigid schedule is a matter that we deem very important. Our drivers are required to be certified every three years and are subject to a driver's license check and physical every year.

Robert Rios is our transportation supervisor and maintenance mechanic. His job is to keep each vehicle in tip-top shape. With 28 vehicles, this is a full time job. Robert strives to ensure that each trip made with a school vehicle will be a safe and uneventful trip. As with any vehicle, breakdowns do occur but with careful maintenance of each vehicle, this is kept to a minimum.

Our route buses leave each morning at 6 a.m. and return at 7:40 a.m. In the afternoon, they leave at 3:45 p.m. and return at 5 p.m. These buses average 56,000 miles per year.

Our activity trips vary according to the time of the year. During the Fall, football, basketball, and volleyball are the major sports that require transportation. During the Spring, tennis, track, UIL events, and golf make up the major areas that require transportation. Other trips might include field trips and various other contests, such as the one act play. These activities added 51,758 miles to our vehicles in the past school year.

The average cost of our vehicles are as follows:

- Bus - \$20,228.88
- Van - 14,820.67
- Pickup - 8,782.20
- Car - 14,054.19

Our transportation budget for this year is \$168,920. which accounts for 4.223% of our entire budget. As one can see, transportation is a very important part of our school system and requires constant work to ensure that ours in the best and safest that we can have.




"While a complaint ratio may not tell you whether an insurer is good or bad, it does offer some notion of a company's level of policyholder satisfaction."




