#### Sanity Trial Will Be Next Step in **Davenport** Case

Application will be filed in Tom Green County court probably Friday to try Gratton Davenport for insanity, is was announced Thursday morning by W. A. Wright, Davenport's atsulting from the pardon granted the occasion. Davenport, convicted here of the murder of Sam Rodgers at Mertzon on Feburary 3, 1925, and sentenced to life imprisonment. The pardon mitment to a hospital for the insane the lunchers. for the remainder of his life, and provides that in the event he is not admitted to some state institution he shall be confined in a private sanitarium.

The application for Davenport's arraignment before Judge J. T. Mathison for insanity will be filed by his father, J. I. Davenport of Katemcy, Mason county, Judge Wright said. Two experts who testified at the murder trial that Davenport was hopelessly insane, will come to San Angelo, this time to testify for the state. They are Dr. J. J. Judge Wright said he would endeavor to have the case set at a time when both alienists can be present. If Davenport's relatives request it, the trial will be before a jury of six. Otherwise the evidence will be heard and Davenport's mental condition will be passed on solely by Judge Mathison.

Hens should receive a grain ration of crushed corn, milo, or kafir, together with wheat or oats. For each quart of grain mixture, feed 1 quart of the following laying mash:

Pe	ounds
Wheat bran	28
Ground milo or ground corn	20
Wheat gray shorts	20
43% protein cottonseed meal, prime	
Finely ground oyster shells	1%
Fine salt	

The above is a standard ration recommended by A. L. Ward, who for seven years was with the Extension Service of A. & M. College.

ORDINANCE APPROVING STATEMENT OF CITY ENGINEER CONCERNING PROPERTY OWNERS AND THEIR PROPERTY ABUTTING ON DALE STREET FROM ITS INTERSECTION WITH THE WEST LINE OF MAGNOLIA STREET TO ITS INTERSECTION WITH THE EAST LINE OF THE ABILENE & SOUTHERN RAILWAY RIGHT OF WAY DESCRIBED AS DISTRICT NUMBER ONE AND MAGNOLIA STREET FROM ITS INTERSECTION WITH THE NORTH LINE OF ALBERT STREET TO ITS INTER-SECTION WITH THE SOUTH LINE OF DALE STREET AND DECLARING AN EMERGENCY BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WINTERS: That,

WHEREAS, Heretofore the City Council of the said City, by ordinance, directed the improvements of the above named streets, by raising, grading, and paving the same; and WHEREAS in accordance with said ordinance, plans and specifications for the said work were duly prepared

by the City Engineer and adopted by the City Council; and

WHEREAS, Thereafter in accordance with the law and the provisions of said City, bids were received, opened and considered by the City Council and the bid of the Thurber Construction Company, Contractor for the improvements of the said streets, was accepted by the the said City Council; and

WHEREAS, the said improvements consist of improving the said streets within said limits by raising, grading, and filling the same, and by paving the same as follows:

Dale Street as above described, 2½ inch brick on 5 inch concrete base; Magnolia Street as above described, 2½ inch brick on a 4 inch concrete base;

pavement; and

WHEREAS, the said contractor has entered into contract with the City of Winters for the construction of said improvements, which contract has been duly approved by the City Council and executed as required by the law, and said Contractor executed with approved security, and filed with the City Council, bond for the construction of said work in accordance with said ordinance, specifications and contract, which bond has been duly approved by the said City Council; now

THEREFORE, Be if further ordained by the said City Council of the City of Winters as follows, to-wit:

(1) That a necessity exists that a portion of the cost of said improvements shall be assessed against ownproperty abutting on said streets named to be improved, and against their property and against owners of street and steam railways occupying said streets and their property in accordance with the law, and the said City Council does hereby declare such necessity. (2) That the total estimated amount of the cost of improving said section of Dale Street and Magnolia

Street, as reported by the City Engineer, is the sum of \$23,500.31, that the names of the property owners against whom and whose property such assessment is proposed to be made as shown on the City Engineer's statement and the total amount and amount per front foot, which is proposed to assess against such property owners and other matters and things are as follows, to-wit;

(3) That the portion of the cost of such improvements which may be assessed against such property owners and their property and owners of street and steam railways and their property respectively shall be assess by ordinance of the said City Council, passed after notice to such owners, and other interested parties, and a hearing to them, and the said amounts, when so assessed, shall constitute a lien against the property of the said owners in accordance with the terms of the law, and shall be declared to be a personal liability of said owners. That the said assessment against owners of property abutting said streets and their property shall be made ac-cording to the front foot rule in proportion as the frontage of each owner on the said streets is to the whole front-age to be improved, provided that if in the opinion of the City Council this rule of apportionment shall be found to be unjust or unequal in any respect, then the said CityCouncil shall adopt such rule of apportionment as shall be found to be instant owners and the said city are owners and the benefits to the said rule of apportionment as shall be found to be just and equal considering the equities of the various property owners and the benefits to their property and the burdens imposed by the assessment, and provided that no assessment against any owner or his property shall be made in excess of special benefits in the enhanced value of said property by means of said improvements.

(4) That a hearing shall be given to said owners of abutting property and street and steam railways, and to all others having any interest in or claim or lein againstt such property, their agents or attorneys, which shall be held at the City Hall in the City of Winters, being the regular place of meeting of the City Council, on the 28th day of January, 1927, at 7:30 o'clock p. m., at which time and place owners of property abutting said streets and owners of railways and street railways and other interested parties, their agents, or attorneys, are hereby notified to be and appear, and a hearing will be given to them concerning said proposed assessment and con-cerning the benefits of the said improvements to their property and concerning all the said proceedings with ref-erence to the said improvements, or any invalidity therein, concerning any matter or things whateover in conerence to the said improvements, or any invalidity therein, concerning any matter or things whatsoever in con-nection with the said improvements or assessments, at which hearing the owners of such property and railways and street railways and others interested, may appear in person or by their agents or attorneys and present their objections, if any, to any matter or thing concerning the said assessments or proceedings and may present any evidence which they may desire concerning same; that said hearing shall be continued and adjourned from day

to day and from time to time until all owners, and persons interested, and all matters in connection with any protest or objections of said property owners shall be fully heard and disposed of. (5) That the City Secretary of the City of Winters is hereby directed to give notice of said hearing by publication in The Winters Enterprise, a newspaper, being a weekly paper of general circulation in the City of Winters, by publishing this ordinance for three (3) consecutive weeks, the first publication of which must be at least ten (10) days prior to the said hearing.

least ten (10) days prior to the said hearing. WHEREAS, the fact that the improvements herein referred to, are being delayed pending the taking effect of this ordinance and the condition of said streets and public places, endanger public health and safety, and the necessity of proceeding with said improvements constitutes and creates an urgent necessity and requires that the rule providing that ordinances shall be read at more than one time or at more than one meeting be suspended and requires that this ordinance be passed and take effect as an emergency measure and such rules are accordingly suspended and this ordinance shall take effect and be in force immediately from and after its passage. On motion of Alderman G. E. Seagler seconded by Alderman H. K. Reid, the above ordinance was passed

with the following vote:
