The Union men did not even come back to bury their dead, we buried them for them. We captured the Washinton Artillery which was the best the Union army had. though the war was over and wrote and told my people that would be at home again in thirty days.'



bility to stick to the dry dirt, but the man who sticks comes in on the wave crest.

My experience is that we have been hurt worse by wet weather since I came here than by dry weather. We are always worse scared than hurt by dry weather and one thing is especially noticeable and that is that we give up too quick. We should .continue to plant turnips and beans and blackeyed peas for fall eating and live more at home.
