CECIL A. LYON DEAD AT SHERMAN


SHERMAN, Tex., April 5.— Brig. Gen. Cecil A. Lyon, Texas national guard, died at his home here last night.

WINTERS SCHOOL RUNNING SHORT

Public attention is directed to the statement elsewhere in this issue from the school board regard ing our school. The sum and that the district does not provide enough money to finance the school longer than about seven months and, until some other way is provided, the patrons must pay direct for the schooling of their children if they would keep them in school longer.

Last year we provided a fund for this extra time by a public donation each one paying into the fund as it pleased him.

This proved unsatisfactory for the simple reason that many children remained in the school at the expense of their neighbors, hence the present plan provides


