## AMENDMENTS REJECTED BY THE SENATE

WASHINGTON, Oct. 29.—The Senate this afternoon rejected the last of the amendments to the league of nations treaty, submitted by the foreign relations committee when it defeated the Shields amendment and the Moses amendment.

The Shields amendment was beaten by a thirty-one to forty-nine vote, and the Moses amendment was dropped by a vote of thirty-six to forty-seven.

The Shields amendment would have given "empires" and "federations" only one vote, but a maximum of three delegates without further voting strength.

Moses' amendment would have barred colonies voting in disputes affecting the mother country.

Brownwood, Oct. 24.—Director of organization Robert L. Arthur, of the Lone Star Trail Association announced this afternoon that the quota of fifty members in the Brown county division of the Association had been subscribed in Brownwood. This completes the work of the association in this city and the officials will leave to continue the work eastward.

Success was reported from every town which the party had visited except Ballinger. Mr. Jno. W. Dunn, secretary of the chamber of commerce, has been appointed as director for the association for Brown county.

## SCHOOLS PLANNING FOR VICTORY WEEK

A minimum of 30 Victory Savings Cards will be sent from District Headquarters to every teacher in this District, for use by the school pupils. These Victory Savings Pledge Cards will be distributed by each teacher to the pupils, who will take the Victory Savings Pledge Cards and get the Savings Pledge of their parents or friends. The signed Victory Savings Pledge Cards will be collected by the teachers and delivered to the Principal or Superintendent of the school who will classify the cards according to the banks or post office through which purchase will be made and deliver them direct to these banks and postoffices. Fracked labels will be furnished by District Headquarters, to the Principals and Superintendents of the schools for this purpose. Teachers will also organize Thrift Clubs in every school room and make direct sales and take Thrift Club Pledges from the pupils for War Savings Stamps and Thrift Stamps to be purchased by them during the remainder of the year. The school in each County or Parish securing the greatest amount in pledges and sales, per capita will be awarded the School Victory Honor Flag. Victory Week in the schools will be from Nov. 9th to 16th. As every school has an equal chance to win this handsome flag there is likely to be some competition in the selling of Thrift and War Savings Stamps from Nov. 9th to Nov. 16th.

## MAY TURN TEXAS RAIL ROADS BACK

AUSTIN, Oct. 28.—Apparently reliable reports received here today said that Texas railways will be turned back to corporate management on December 1st. The reports say that the Federal government will retain general control of the roads but will allow the executive heads of each railway to determine the general matters of business, improvements, upkeep etc.

It is understood from the report that the duties of regional directors will be done away with.

## Miners Refuse to Call Strike Off

### WITNESSES TESTIFY IN PLUMMER CASE

The state began introducing testimony in the Ernest Plummer trial at San Antonio, Monday afternoon, where a number of Ballinger men went to attend the trial.

The San Antonio Express gives the following report of the case, which will probably consume most of this week. The Ledger will report the trial just as published by The Express:

G. A. Marshall was on his knees pleading for mercy when he was alleged to have been shot by his stepdaughter's husband, T. E. Plummer, on Theo Avenue, May 1, 1919, according to the first four witnesses placed on the stand in the 37th District Court, where the trial of Plummer, charged with murder, opened Monday morning.

A bloody shirt, said to have been worn by Marshall at the time of his death, and a pistol, said to have been the one used by Plummer, were introduced as evidence by District Attorney D. A. McAskill, representing the State. The shirt has a hole burned in it, and has been perforated in two places.

F. D. Glidden's testimony in effect was that he heard voices, and upon investigation saw Plummer approach Marshall and order him to come across a fence surrounding a garden in which he was working. Marshall, he said, was then ordered to kneel, whereupon Plummer shot him, kicked him, shot him again, and then kicked him. Plummer then threw his pistol into some weeds, testified Mr. Glidden, and picking up his coat walked away.

Lieut. Green, when placed on the witness stand, told about the same story as that related by Glidden, adding that Marshall was holding up his hands when shot and was pleading with Plummer for mercy.

Marshall exclaimed: "O Lordy! O Mama!" according to several witnesses. It was brought out in the testimony that in calling "Mama," he was addressing his wife, who was running toward him.

Mrs. C. E. Smith told of seeing the two men, Marshall kneeling with one hand held up and the other down by his side; Plummer standing in front of him with a pistol pointed at his breast. Two shots were fired, she said, one before Plummer kicked at Marshall, and the other one afterwards. When asked by the attorneys for the defendant if Marshall's hand was placed in such a position as to be near his hip pocket, she said: "He was holding it down."

Mary Marshall, stepdaughter of the dead man, and sister-in-law of Plummer, testified along lines of witnesses preceding her on the stand. Other witnesses questioned

were Mrs. Blankenship and Deputy Sheriff Lewis.

Monday morning and a major portion of the afternoon were consumed in selecting a jury. Following are names of jurors empaneled: O. F. Helms, Preston Brook, R. A. Ferguson, J. W. Fitch, Adam May, F. W. Bast, D. R. McCormick, Steven Margowitz, Charles Zizzleman, Will Groos, Claud B. Harken and W. M. T. Crow.

District Attorney D. A. McAskill is assisted in the prosecution by W. S. Anthony, Edward Dwyer Jr., and Bryan Mauermann. Attorneys for the defense are Chambers & Watson, H. E. Wilson and Victor Keller.

Marshall was killed following the filing of charges of assault against him by Mrs. Plummer in Justice Court. Jurors were questioned closely by attorneys for the defendant as to whether or not they believed that taking human life was justifiable when it was shown that insult had been given a relative of the defendant and that he (the defendant) might have become temporarily impassioned because of such insult.

The meeting will be held at 1:30 p. m., and an effort is being made to have a large number present from every church in the Association. Preceding the addresses, there will be an instruction school for all the church organizers and team workers, from all the churches, conducted by the county leaders, and occupying some thirty minutes.

There should be hundreds of people from the county and Ballinger also, whether Baptist, or not, as it will be well worth the time. Ballinger is rarely favored with leaders of such prominence and ability as Dr. Gray and Miss Mallory.

**AMENDMENT VOTE IS NEXT TUESDAY**

Sheriff Perkins is busy distributing the election supplies for the amendment election to be held in Texas next Tuesday, Nov. 4th. The tickets, were received by County Judge Parish several days ago. Six amendments are submitted to the voters of Texas, some of them good ones, which should be adopted, some not so good, which should be considered well before the voter scratches his ballot, and some which should be swatted good and hard, and forever put to death.

The first amendment on the ticket is the one authorizing the legislature to enact a law allowing the issuance of bonds not to exceed \$75,000,000 for the construction of hard surfaced roads on public highways. This amendment provides for the levy of a tax not to exceed 25 cents on the

\$100. The adoption of this amendment does not mean that seventy-five million dollars worth of bonds will be issued at one time. It only gives the legislature authority to issue the bonds just as needed, and a tax levy made to take care of what is issued.

This amendment is being supported by the good road advocates, and will no doubt receive a big vote in some counties. Rannels county can get as much of this money as it will match dollar for dollar.

For amendment to Section 51, of article 3, of the constitution authorizing the legislature to grant aid to Confederate soldiers, sailors and their widows, who have been residents of this state since January 1, 1912.

For amendment to article 16 of the constitution authorizing a division of the net proceeds of the prison system of this state between the state and prisoners confined in the penitentiary or their dependents.

For amendment to article 16 of the constitution of the State of Texas, authorizing the issuance of bonds by the city and county of Galveston.

For the amendment to article 8, section 9, of the constitution of the State of Texas, providing for the levy of taxes, not to exceed 20 cents for roads, streets and bridges and not to exceed 50 cents for the erection of public buildings, streets, sewers, waterworks and other permanent improvements, and not to exceed 60 cents for the maintenance of public roads in one year.

For the amendment to sections 10, 11, 12, 13, 14 and 15 of article 7, of the constitution of the State of Texas, fixing the constitutional status of the University of Texas, the Agricultural and Mechanical College of Texas, the College of Industrial Arts, at Denton, Texas, the Sam Houston Normal Institute at Huntsville, Texas, the North Texas State Normal at Denton, Texas, the Southwest Texas State Normal at San Marcos, Texas, the West Texas State Normal at Canyon, Texas, and the East Texas Normal at Commerce, Texas, and other state educational institutions and determining the interest, respectively of the University of Texas, the Agricultural and Mechanical College of Texas, and the Prairie View State Normal and Industrial College in the university permanent fund; and providing for the support, direction and development of state educational institutions.

**PRESERVE PAINTINGS OF PAINTED ROCKS**

AUSTIN, Oct. 27.—On the banks of the Concho river, near the town of Paint Rock, are the most remarkable Indian paintings or pictographs in the entire southwest, in the opinion of J. E. Pearce, assistant professor of anthropology in the University of Texas. Mr. Pearce is the first scientist to visit that region. These unique pictographs may be seen upon the Concho for a distance of half a mile. They are found wherever there is a suitable surface for the paintings. E. D. Sims, of Paint Rock, who owns the property, has expressed his willingness, to give it to the state or national authorities provided it is made into a park and adequately guarded.

Showing as they do the earliest forms of communication between the tribes of primitive men these inscriptions and paintings have a profound significance, Mr. Pearce said. He urged that they be protected and preserved as they are rapidly disappearing before the advances of civilization. Several lines of development, such as cartooning, sculpture and even writing itself, may be traced from this early work of the primitive man.

Most of the paintings in the region visited by Mr. Pearce are made in deep, dark red with an occasional black figure. Many objects, horses, men, turkeys, the sun, moon and stars, appear in the pictures and represent all phases of the life of these early tribes. Largely the pictures show scenes of fighting, and some figures are shown with arrows or tomahawks over their heads to represent a method of killing. So much valuable historical material is included in these paintings that they will be copied in scale soon for a report that Mr. Pearce will make to the Smithsonian Institute, and it will be published by the Bureau of Ethnology. Mr. Pearce is doing this research work for the Smithsonian Institute and the University of Texas.

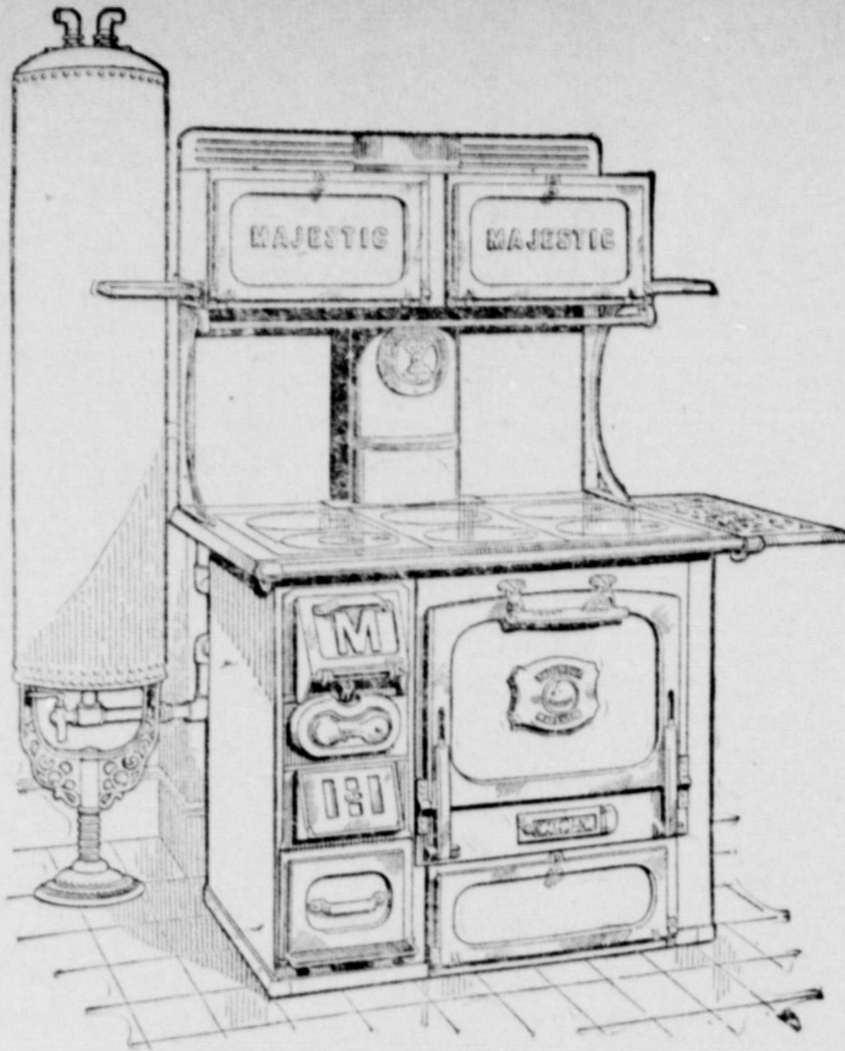

## ATKINS CASE AT ANGELO CONTINUED

The trial of David Atkins, charged with killing Tom Hardin at Knickerbocker twenty-two years ago, was billed to come up at San Angelo this week, but was continued and set for January 29, next year.

This case will be watched with interest in view of the fact that it occurred so many years ago. Atkins was arrested for the killing and released under bond. He jumped his bond and was at liberty up until a short time ago when the officers located him and arrested him and brought him back to San Angelo to face trial. The man was allowed bond again and is remaining at San Angelo to be tried. He says that he wants the case settled and is ready to face trial.

Atkins went to South Africa and spent twenty years in that country. He came back to America and was soon identified as the man wanted for murder twenty-two years ago in Tom Green county.

In reviewing the case the San Angelo Standard published the original account of the killing, a clipping of which was preserved by the sister of Tom Hardin for twenty-two years.

Mrs. Philip Hodges of Liberty Hill, a sister of Tom Hardin, the man who was killed at Knickerbocker, spent the past week in San Angelo as the guest of Mr. and Mrs. D. R. Hodges. Philip Hodges and D. R. Hodges, former deputy sheriff and deputy United States marshal here, are brothers Mrs. Hodges lived in San Angelo twenty-seven years ago. Her visit here last week was the first since 1902, and naturally the changes she noted were many.

Mrs. Hodges was residing in Limestone county when her brother, Tom B. Hardin, was shot to death at Knickerbocker in 1897. A widow survived the tragedy and, according to Mrs. Hodges is now making her home at San Marcos.

Just before boarding the east-bound Santa Fe train Saturday afternoon to return to her home, Mrs. Hodges drew from her hand bag a clipping, yellow with age, which was taken from The Standard of the issue of the week after the shooting. The old newspaper account sheds new light on the killing, which now has come to have wide interest because of Dave Atkins' arrest after so many years of wandering to escape the hands of the law. The Standard's story of the shooting is in part as follows:

At seven o'clock Saturday night at Brown's beer saloon at Knickerbocker, Tom Hardin was killed. The way the difficulty came up is about as follows: Sam Moore and Dave Atkins were drinking, preparatory to going to a Mexican dance in the neighborhood. Moore had his six-shooter behind the bar and asked the bartender, W. K. Brown to give it to him, that a friend of his wanted to borrow it. He took the pistol and left the saloon and in a few minutes after two shots were fired two or three hundred yards from the saloon. Shortly after Moore and Atkins entered the saloon and the bartender upbraided them for shooting, as it would bring his place into disrepute. Moore denied that he had shot and Atkins said "You did shoot, Sam," and just then Tom Hardin entered the saloon and called for a bottle of beer. While the bartender, Moore and Atkins were arguing about who fired the two shots, Hardin said it was a shame for people to hurrah the place by shooting and that one of the bullets had just missed his head. Moore said that whoever said he did the shooting was a liar (or words to that effect) Atkins had taken five or six drinks of beer during the previous two hours and his blood was hot. Hardin was still cursing Moore for the disturbance when Atkins took the matter up and said: "Damn you, you struck me over the head with an ax handle once." Hardin denied ever striking him with an ax handle and Atkins called Hardin a liar, etc. Hardin then put his right hand on Atkins' shoulder and told him not to abuse him that way, then Atkins, quick as lightning, fired two shots and Hardin fell to the floor and expired in about twenty minutes. Both shots struck him in the head, one in the forehead and the other just below the eye. The pistol used was a double-acting 32 or 38 caliber. Hardin was unarmed. Both Atkins and Moore skipped out immediately after the killing. Mr.

Brown came to San Angelo and reported the tragedy to Sheriff G. W. Shield at 10:30, and the sheriff immediately left for Knickerbocker with Mr. Brown and Deputy Dick and Charlie Runyon.

Mr. Hardin was a first class citizen a gentleman in every sense and a prosperous merchant of the place, and was well thought of by nearly everybody. He came to Tom Green county from near Marlin, Falls county, several years ago and has relatives in Stephenville, Erath county. He leaves a wife and a child.

After a diligent search the officers returned to town Tuesday evening without capturing the alleged murderer. Sam Moore was arrested for carrying a pistol and as an accessory to the murder.

### FREE FOR ALL IN NEGRO CHURCH

A split on the question of calling a pastor for the Second Colored Baptist Church, caused a free for all and general knock down and drag out Sunday night.

The congregation had been called together for the purpose of getting rid of the old pastor, who lives at Calvert, Texas, and makes the trip here occasionally to preach, and to employ in his place a preacher who lives at Stamford.

Certain of the members, including Sister Tennessee Thompson, opposed the firing of the old pastor, and her persistence in that direction caused the moderator to say to Mrs. Thompson that she was a "particular" friend of the old pastor.

The insinuating remark of the moderator was resented by Tennessee, and she accused the moderator of stepping on her morals, and proceeded to protect her character by hanging a chair over the moderator's head.

This started a free for all, and chairs, window sticks, rocks mirrors, etc., were brought into play. Dave Jones, Ella Roberts, and Tennessee Thompson were the names more prominently mentioned in court Monday morning.

Sheriff Perkins appeared on the scene Sunday night, after the fracas had been reported to him, and after getting the particulars of the trouble, complaints were filed by the officers against Tennessee Thompson, Dave Jones and Ella Roberts. Tennessee and Jones plead guilty to an affray and paid their fines Monday morning. Ella Roberts employed her lawyer, and will contest her case, claiming that she did not fight and only acted as a peace maker for the church.

The second chapter in the free for all was written Monday morning about ten o'clock, when Rufus Thompson met Rev. E. E. Moore

on the streets near the Ballinger Loan Co. office.

Rufus Thompson, the husband of Tennessee Thompson, the star combatant at the meeting house Sunday night, attacked Rev. Moore with a LaPerla bottle filled with water, and Rev. Moore looked a dead negro for a time.

Rufus had just paid the fine for his wife, and meeting the negro preacher on the streets he landed a blow on the side of the head which made blood flow freely and brought to the pavement an unconscious colored preacher.

Rufus charged that the preacher had made insulting remarks about his wife and had charged that she was not a lady, and he used the LaPerla bottle as a weapon for settling the trouble.

Deputy Sheriff Armstrong appeared on the scene and placed Thompson in jail and later he plead guilty to aggravated assault and paid a fine amounting to \$46.

Rev. Moore says that he came here to look after the work of the church, and did not anticipate any trouble. He claims to be in good standing with the people of Stamford, where he lives. No charges were filed against him, the facts in the case showing that he was not to blame for the trouble.

## SCHOOL TEACHERS MUST HAVE HOMES

"I can't believe that the people of Ballinger are going to go back on me," said County Superintendent Bugg, "but I am having poor success getting homes for the school teachers who will be here to attend the institute next week."

Mr. Bugg says there will be more than two hundred teachers here, and so far he has listed homes for only about forty. Mrs. A. S. Love phoned Mr. Bugg she could room four teachers, and if necessary would try to make room for a half dozen.

"I am receiving letters from teachers asking me to get rooms for them," said Mr. Bugg, "and we must have the rooms, or Ballinger will receive a black eye."

The teachers from four counties are coming here to attend the institute. There will be at least one hundred teachers from this county alone, and Tom Green, Sterling, and Coke counties will join in the institute, and there will be about one hundred and fifty teachers from the three counties, making two hundred and fifty in all.

The school law requires the teachers to attend the institute, and they will be here in full force for one week.

Mr. Bugg says that everyone who has a spare room should notify him. A reasonable rate for lodging will be paid by the teachers, and as the same roomer will occupy the bed every night it will not be necessary to change the bed linen daily, and the teachers can be accommodated at a small cost.

It is expected that some will give both board and lodging, but lodging is the question Mr. Bugg wants help on now, and the teachers can take their meals at the cafes.

This is a matter which the Chamber of Commerce should handle, but as that organization does not seem to be working overtime, every one who can furnish room for one or more teachers should phone Mr. Bugg at once.

The institute convenes here next Monday, and many teachers will arrive Sunday.

Young Noyes, son of a wealthy West Texas family, met his death while riding on his father's ranch near Ballinger. Coppini was sent for and told to fashion the young ranchman's figure and stand in life size and to place it out on the plains as an everlasting memorial. —Fort Worth Star-Telegram.

Mr. Noyes first planned to erect the monument on his ranch, where his son was buried, but decided later to erect it in Ballinger, where his son spent part of his boyhood days, and where the monument could be protected from destruction and defacement.

Coppini reached here in time to superintend the work of erecting the monument and seeing that the staturary was put up according to design.

Coppini says the Noyes monument is his masterpiece, and he had different views of the monument photographed after the work was completed.

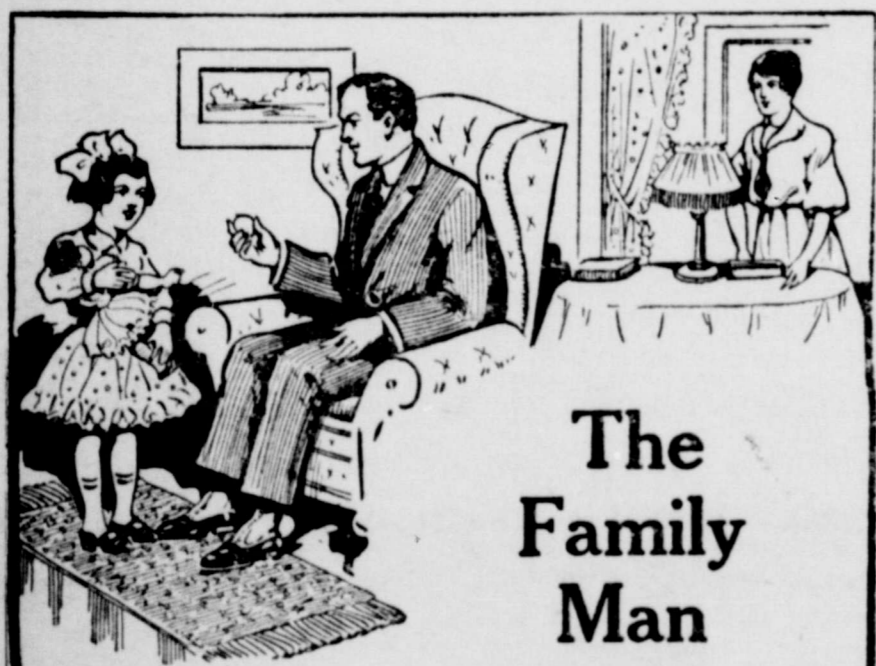

## PROPOSE CHANGE FOR SANTA FE

The people of this city and the traveling public from Brownwood West, could get a better train service if they would ask for it. The Santa Fe officials would no doubt make a through train out of the east bound train which arrives here at 9:28 a. m. and arrange a schedule for that train which would give connections with the main line and other roads between San Angelo and Temple, and at the same time give the people west of Coleman another through mail train east.

The following schedule has been suggested, and the people should get busy and ask that it be adopted by the Santa Fe, not to the minute suggested, but on a basis which would serve the purpose.

Train leave San Angelo 3:30 a. m., Ballinger 4:40 a. m., Coleman 6:00 a. m., Brownwood 7:30 a. m., Lometa 9:00 a. m., Temple 12:30 p. m.

This schedule would make direct connection with the Frisco North and South at Brownwood, with the San Saba branch at Lometa, and both Santa Fe and Katy North and South at Temple. It would also connect with the H. & T. C. at Lamapapas, leaving that place at 12:30 and arriving at Austin at 4:30 p. m. and such a schedule would give an all day light ride to most any point in the state.

Making this stub train a thru train would do away with two stub trains on the Temple-San Angelo branch and would relieve the congestion now existing on No. 92, the evening train East of Brownwood as it now has to take care of all business originating in West of Brownwood on both the cut off line and the Angelo line, and it is usually late on account of connections to made at the various junctions between Brownwood and San Francisco.

The early morning train out of Brownwood could be operated on time as there are no connections West of Brownwood for it to be held for. It would give this country a thru train instead of two stubs as is now the case, both ending out at Brownwood.

Parties going east on the morning train as it is now operated, have to relay at Brownwood, and wait for the California train, which is usually from two to four hours late, and thus causing passengers to miss their connection at Temple, and forced into another lay over.

Under the present schedule only one outgoing mail train is operated each day. The morning train only carries pouch mail and that stops at Brownwood.

This is a change which we believe would meet with the general approval of the public of this part of the state, and we are going to take the matter up with Mr. Keenan and Mr. Maxson, and get their views on the question. Unfortunately the city has no chamber of commerce secretary at this time to handle such matters and what is everybody's business seems to be nobody's business.

D. G. Lacy, who returned here last week and announced that he would resume drilling on the Russell ranch, left the city first of the week, and stated that he would organize a new drilling crew and return here soon.

The derrick for Russell No. 3 is ready for rigging and it is expected that the new well will be spudded in soon.

When Judge Doss completed his address, his little daughter, who was standing in front of the monument, assisted by other children, pulled the string which released the American flag that was covering the bronze group.

School children, escorted by their teacher, gathered around the base of the monument and deposited beautiful flowers, as a sentimental contribution and then sang "America."

The grounds had been prepared by the artist and at his suggestion, and this part of the program was carried out in a most impressive way.

Judge M. C. Smith, represented the city in accepting the monument and made an impressive address. Judge Parish represented the county in receiving the monument, and also made an address. Judge Guion made an address and introduced the sculptor, who designed the monument and made what he said was his masterpiece.

Coppini spoke briefly, explaining why it was the proudest day of his life, and how he came to make the monument his masterpiece. His address was emotional and full of love extended to the state of Texas, which he claims as his home state.

The sculptor left Sunday afternoon for Austin, where he has a contract to do some work for the State University in erecting a memorial to Major Littlefield.

# TO FINISH LACY WELL; OIL FOUND

D. G. Lacy is in Ballinger this week arranging to resume drilling on his well about seventeen miles southeast of Ballinger. It was at first reported that he had sold out but Mr. Lacy says that he has bought out all his associates in the holdings, and will complete the well himself.

Mr. Lacy will bring an entirely new crew of drillers here from Ranger, and expects to start drilling in a short while, although nothing can be done until some casing arrives. The hole was closed down at the report that Mr. Lacy had sold out at a depth of 1005 feet.

A good showing of oil has been struck, just a little less than a thousand feet deep, according to Mr. Lacy, and indications are especially good. He says that he confidently believes that he will get a good well in this location, and says that the fact that salt water was found in Russell No. 2 does not bother him at all in his well. He says that such a thing is apt to happen in almost any hole, and even then does not affect other holes drilled nearby.

A greater play on the land in the vicinity of this well is expected, and is even now being evidenced. The Gulf Production Co. will soon spud in their third well, and it is understood that they will drill it on a 4,000-foot contract. Nothing further is known as to the first two holes drilled by this company.

The Nelson Brothers' Mustang well has been shut down for about thirty days, and no cause has been assigned, but it is understood that they will resume drilling within the near future.

## SAFETY FIRST IS 1130 FEET DEEP

A late report Saturday afternoon received by The Ledger from Mr. Hunter says that more gas has been struck in his well at 1130 feet. Mr. Hunter says that he believes that within the next few hundred feet the drill is likely to find gas enough to supply the town of Ballinger.

The well of the Safety First Oil and company on the W. E. Allen place, west of Ballinger, is down 1130 feet according to the latest reports received here from F. W. Hunter, the president of the company, and drilling is progressing in black time. The gas pocket that was struck a few days ago has been cased off, and the drill is going on down. The gas was struck at 700 feet, but it was not in paying quantity, and was cased off. Even now, however, some of the gas leaks under the end of the casing four hundred and thirty feet deeper, and comes to the surface.

Drilling is progressing day and night at present. Operations will be going on during Sunday, said Mr. Hunter, although it was at first intended to shut down for boiler repairs.

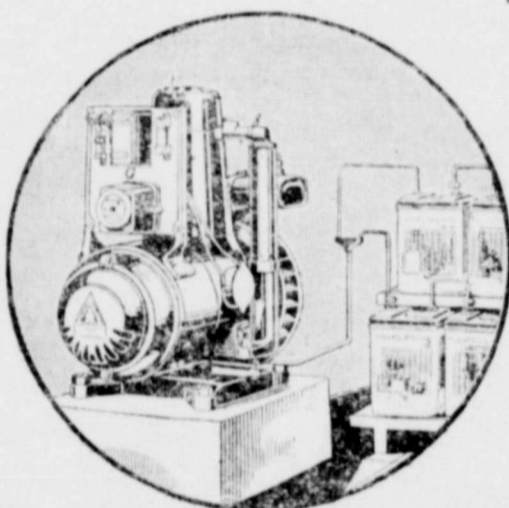

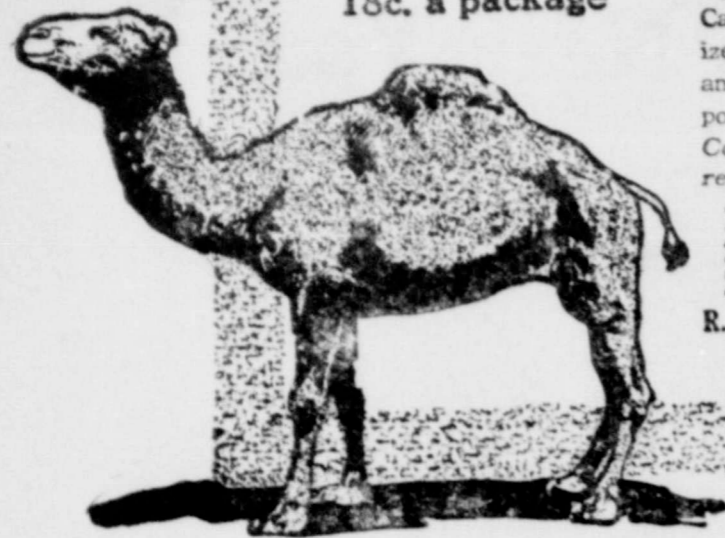
