WATSON GIVEN 99 YEARS FOR KILLING PATTERSON

WACO, Tex., Dec. 1.—A verdict of guilty was returned in the T. R. Watson murder case this morning. The jury rendered the verdict at ten-thirty and fixed Watson's punishment at ninety-nine years in the pen. Watson was convicted on a charge of murdering Bank Commissioner Patterson at Teague, Texas, last August. Attorneys for defense will make motion for new trial and if overruled will appeal to the higher courts.

FARMER FINDS EASY FIGURING AT 20.20

George Englert was in the city last Tuesday, and while here he reported the sale of his cotton, and judging from the figures he had dotted down he has made good farming in this county and pockets a big profit by holding his cotton for 20 cents.

Mr. Englert sold twenty bales and he received 20.20 for it, making his cotton figures all twenty it was easy to figure. Mr. Englert came to this county eleven years ago, when he was still in his teens, being eighteen years old. He started to farming for himself on halves eight years ago, and as a result of his work in this county he now owns a 160 acre farm, free from debt and well stocked with good cows, chickens, horses, and hereafter he will come to town a little faster than usual, and will do some joy riding, as there is a little space left for another Ford.

Mr. Englert reports sings of prosperity throughout his section of the county, saying that new houses are being painted and much other farm improvement is underway.

WOUNDED HUNTER RETURNS HOME

Ed O'Kelley arrived home on Thanksgiving afternoon from San Angelo, where he had been since receiving serious injury in an auto accident earlier in the week. Mr. O'Kelley is getting along as well as could be expected, and is regaining strength from the weakness caused by the great loss of blood, and the physician announces that he will not be a cripple as was at first reported.

W. A. Tally, a member of the hunting party who was with Mr. O'Kelley when the accident occurred, returned home Wednesday, after giving all the assistance he could, and after seeing that Mr. O'Kelley was in good hands at San Angelo. The accident occurred 160 miles from San Angelo, in the breaks of Devil River, and was caused by the car skidding. The car skidded on the rough road and struck an embankment in such way as to throw Mr. O'Kelley's lower limb against a broken windshield, and a gash to the bone was inflicted just above the shoe, the leaders and arteries being severed.

It was due to the clever work of Mr. Tally that the flow of blood was checked and the man's life saved. The limb was corded in such way as to stop the flow of blood and the journey back to San Angelo hurriedly made. Mr. O'Kelley was in a serious condition when the party reached San Angelo.

Will Stuart and a man by the name of Lee Milligan continued the trip after accompanying the wounded man back to San Angelo and after being informed that he was getting along alright.

GREEK RIOTING IS FINALLY SUPPRESSED

LONDON, Dec. 1.—Greece issued an ultimatum this morning in which that nation formally refuses to accede to the demands made for disarmament by the allies. Official reports received here says that rioting in the streets of Athens has been suppressed.

GIVING OF THANKS IN SUCCESSFUL MEET

There was perhaps never a more successful Thanksgiving held in Ballinger than that held at ten o'clock on Thanksgiving morning of this year at the First Presbyterian church. The attendance of both men and women was such as to bring words of commendation from Rev. Atwood, pastor in charge of the service.

The program as published in this paper was carried out, and the audience listened attentively at the appropriate sermon delivered by Rev. Bost, pastor of the Navarene church, who had been selected to preach the sermon. Rev. Bost spoke in the most practical way, his message coming from a heart that was overflowing with the true thanksgiving spirit. The preacher emphasized how the Israelites were drawn closer to God by holding their annual feast and likened Thanksgiving to the early day feast. He enumerated that many things the American nation has to feel thankful for, and appealed to his hearers to show their appreciation of the great blessing with which we are blessed.

At the close of the service a collection was taken for the charity work and steps taken to carry on the charity work of the city. The committee which recently resigned it was claimed resigned because they had no funds to work with, and it was the unanimous wish of the people assembled that this committee be retained and it was so voted, and plans made for supplying them with the necessary cash.

The committee announced that they would come together Friday afternoon to take up the work and appoint a committee to solicit funds. This soliciting committee will call upon you, and it is to be hoped that you will realize the importance of the work, and out of your abundance and to spare you will contribute to the fund to help keep the wolf away from the door of the unfortunate within our midst.

A member of the committee stated Friday that he was in touch with poor families where there were a number of children who would be glad to get warm clothes, and food. Perhaps there are some who are not able to give cash, but who have a surplus of clothes who will gladly contribute. PAY LOSS, APOLOGIZE AND PUNISH

WASHINGTON, Dec. 1.—The state department is in receipt of a notice from Germany in which the German government signifies its willingness and readiness to pay all indemnity for the loss of American lives lost when the British steamer Marina was destroyed, and also offers an apology and offers to punish the submarine officials responsible for the destruction of the ship and loss of lives, if it develops that the vessel was sunk unjustly.

She was carried to her room in a helpless condition and medical aid hastily summoned, and the latest report received from her Friday afternoon stated that she was not getting along well. We understand that the injuries and that the unfortunate lady will be crippled for a year or more.

COLLEGE STATION, Tex., Dec. 1.—The fifth annual older boys' conference of the Texas Y. M. C. A. began here this morning with about 500 delegates in attendance.

The conference is held annually under the direction of the state Y. M. C. A. organization, for the purpose of improving the moral condition of boys of Texas. Delegates are all over 15 years of age, and represent schools, Y. M. C. A.'s, boy scouts, Sunday school classes, churches, boys' clubs and other organizations.

The conference will last three days. All sessions are being held in the main auditorium of the A. & M. college and the boys are housed in the dormitories.

Several speakers of state-wide and national reputation will address the delegates. Among these are Leonard Paulson, of the International Y. M. C. A. Committee, New York; Dr. W. B. Bizzell, president of A. & M.; L. A. Coulter, state Y. M. C. A. secretary; Dr. J. C. Hardy, president of Baylor university and Jesse R. Wilson, state college Y. M. C. A. secretary.

The organization meeting was held this morning and officers were elected. A banquet for the delegates at the college dining hall is the feature for tomorrow night, and special religious services Sunday will close the conference.

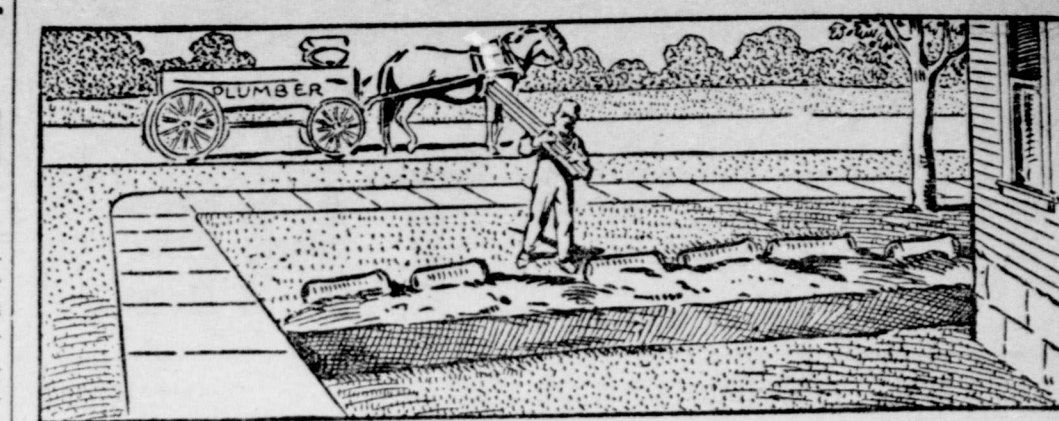

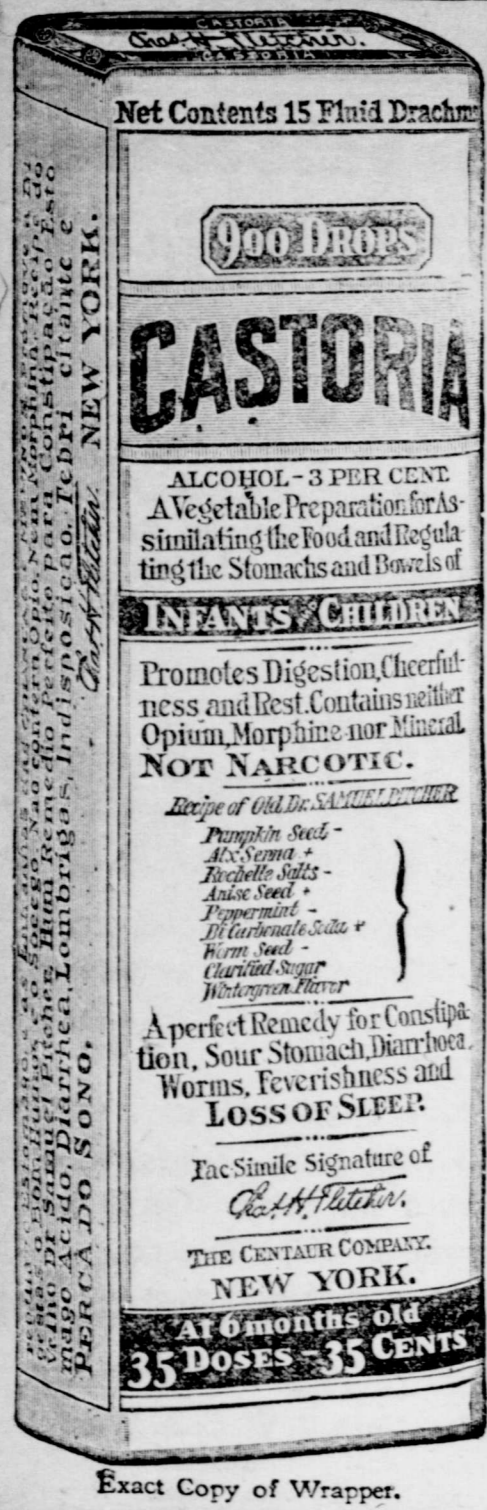

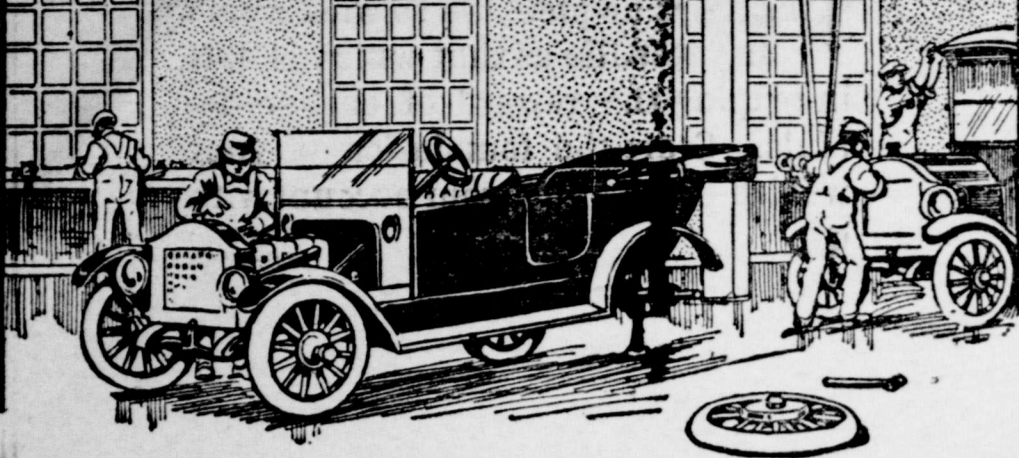

Thanksgiving turkey doesn't worry him. He bought some hounds to protect his turkeys from coyotes and got some traps and a small pump to pump smoke into skunk dens. So in addition to the neat little sum of turkey money he has some wolf hides, scalps and skunk hides to lessen the cost of high living.

Now then not all the coons are up one tree in Rannels county, but there are some coons, some cats and some turkeys.

I heard of an automatic rat and cat ranch some fellow was going to start. His plan is to skin his cats and feed the catresses to the rats and sell the rat cats. On the other hand he is to skin the rats and feed the cats on rats. But this man out here with his coon dogs and wolf dogs and traps and bellows and grasshoppers and boll weevils and turkeys is a close competitor with the rat-cat man.

It is certain and sure that Rannels county has as many by-products and sidelines as any county anywhere. A farmer here who owns 246 acres of fine level prairie land used to haul stove wood a distance of 25 miles to Ballinger and swap it for flour.
