HECKLERS GREET TWO TEXAS U. GIRL STUDENTS DIE IN WRECK

JIM IN ABILENE

(By Associated Press)
UNDATED—The campaign addresses of the principal candidates for governor were carried out Friday, despite the heavy rains in West Texas in an attempt to prevent the speakers from going to the battle grounds.
James E. Ferguson, speaking for his wife, Governor M. A. Ferguson, encountered heckling as he divided his address at Abilene between an attack on Dan Moody and defending the present administration. He will speak tonight in Cisco.

While making an address in Wichita Falls Friday night, Lynch Davidson received a telegram from A. M. Ferguson, of Sherman, a brother of James E. Ferguson, announcing his support to Davidson. Davidson will close his West Texas campaign with addresses today in Bowie and Decatur.

Dan Moody continued his campaign against Fergusonism at Canyon. He will speak at Post, Snyder and Lubbock today.

WICHITA FALLS, June 19.—Lynch Davidson, before departing today for Electra, indicated his belief that A. M. Ferguson's telegram, which he received last night, in which the Sherman man announced his support of Davidson in politics, said, "I must warn my friends that this may be another effort to drive the anti-Ferguson vote away from me."

The negro chauffeur was seriously injured.
Mrs. Walter Dealey and several other Dallas women in the car were slightly hurt and gave up the trip to Austin, going back to Waco.
Crozier continued to Austin by bus.

AUSTIN, June 19.—The Travis county grand jury was ordered by Judge Hamilton today to investigate the death of Isabelle Crozier and Louise Speer, who were killed in an automobile accident here last night.

Kansas Golf Head Says Game Too Slow for Him (By Associated Press)

FORT LEAVENWORTH, June 19.—Although he is president of the Kansas State Golf Association, Brig. Gen. Edward L. King, commandant of the general service schools here, spurns the ancient game.
"It's too slow," General King said. "Golf is fine for women, children and old men, but until I become superannuated, I shall continue to play tennis and handball. I have tried a game or two of golf, but I prefer vigorous sports."

Schools and Colleges Using Most Limestone BEDFORD, Ind., June 19.—More limestone was used in the construction of schools and colleges in 1925 than for any other purpose, announced the Indiana Limestone Quarriers' Association. The amount used was 21.5 per cent.

Office buildings consumed another twenty-one per cent of the stone, while churches, hospitals, court houses, city halls, bank buildings, hotels and clubs were large users, aggregating about forty-seven per cent.

Production in the Bedford-Bloomington district last year was 11,803,890 cubic feet, having a valuation of approximately \$14,500,000.

UNEMPLOYMENT IS LOW IN FRANCE (By Associated Press)
PARIS, June 19.—A statement by Daniel Vincent, minister of commerce, that "we are working in our country" seems borne out by the latest public statistics. These show there are only 409 persons—22 of them women—drawing unemployment doles in France. Of these 95 are in Paris. These are the lowest figures registered since the war. The highest mark was reached in 1921 when there were 91,225 unemployed. This number sank to 10,071 the following year and then to 2,674 in 1923, 1,227 in 1924 and to 705 last year.

FILES FELONY SWINDLE CHARGE

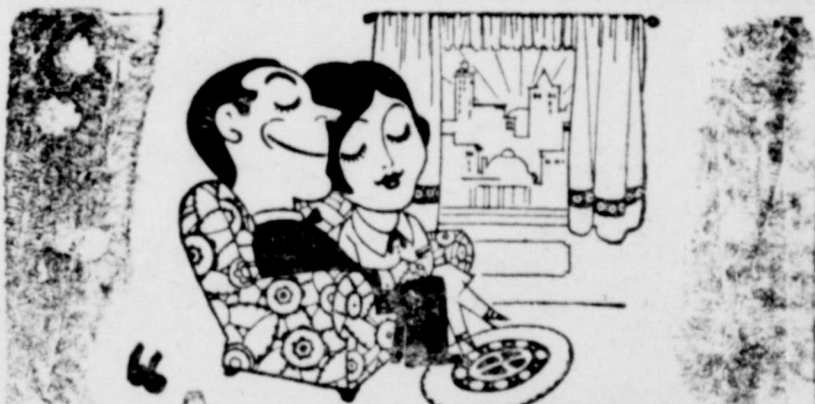

Not much has been said in this county about the county primary to be held next month, and if a few more candidates do not make application for some office before midnight tonight not much will ever be said about it.

Jim Ferguson says that Texas is getting the services of two governors for the price of one. During the present administration it looks like the voters got two governors, a senate and a house of representatives, all for the price of one governor.

Ablene citizens are being hard hit this year by storms and destructive rains. Almost every storm of any kind striking in West Texas this season has either hit Abilene or the Abilene trade territory and in each instance growing crops have been destroyed.

The Runnels County Democratic Executive Committee will meet Monday to give the candidates a place on the ticket for this county. This will not be a

hard task as the committees of other counties are to have when they meet, as there will be only a few candidates in the Runnels county "derby", while Coleman, Brown, Taylor, Nolan, Tom Green and other nearby counties have some three, four or five entries for every office.

Coleman citizens are planning to take a step that other progressive West Texas towns have taken in the past few years. A couple of representatives of the West Texas Utilities Company have made several trips to Coleman in the past few weeks to ask the citizens of that place to sell their light plant. Monday night of this week a petition signed by several voters of Coleman was presented to the city council asking them to call an election to sell the light and power plant. Coleman will eventually become a good town.

Says 'Dan's the Man to Get Out'

HOUSTON, June 19.—Lynch Davidson replied to the request that he withdraw from the race for governor, by stating that "if there is any withdrawing to be done, 'Dan's the man.' Dan's candidacy gives Ferguson the only strength he has in this race. If Texas has another reign of Fergusonism, the fault will fall on Dan Moody for having entered the governor's race. The Lampasas Moody supporters say I can elect Dan. I can also defeat Dan.

"When Jim Ferguson challenged Moody to bet his office on the outcome of the primary and Moody accepted, Moody lost the first opportunity to rid the state of Fergusonism," Mr. Davidson said. "Moody could then have and still can lay down the challenge that both of them withdraw their candidacy for the gubernatorial race. This would accomplish what Moody says is his only purpose—to rid the state of Fergusonism. If he had done this, instead of accepting the bet, it would have cleared Moody of any odor of attempting to further his personal ambitions, and would have placed Ferguson in such a position, in case he did not accept, that his defeat would have been assured. Instead Moody made an election bet, which he hoped would strengthen his own campaign, and let slip the real opportunity to save Texas.

"I am not fearful of Ferguson receiving a majority as long as I am in the race. The fact that I have received letters from Mike and Will Hogg, Houston oil capitalists, who are financing the Moody campaign at Houston, and from Dudley Woodward, Moody's manager for Travis county, asking me to withdraw, evidences nothing but the fact that the Moody bubble is about to burst.

"This same Dudley Woodward was one of the hundreds of Moody's friends who advised him not to enter the campaign in the first place. Another was B. K. Gore, of Fort Worth, Moody's assistant campaign manager for Tarrant county. Therefore, I do not attach any weight to estimates of my strength with the voters of Texas when they come from Moody managers.

"The Lampasas petition signed by members of the Moody Club in that city, asking me to withdraw, was obviously inspired by a 'confidential' letter broadcast to Moody's supporters by Mrs. Jane Y. McCallum, of Austin, manager of Moody's campaign among the women voters. Referring to me, Mrs. McCallum said in this letter: 'Send him letters and petitions urging his withdrawal and wire him. If he is to be in your town, circulate a petition beforehand and present it to him, and furnish copies to the press if you deem this advisable.'

"Every day's developments give me more reason to believe that the question of Fergusonism and Moodyism also, will be settled in the first primary, by my winning a clean majority over both of them. It is absurd for Moody supporters to ask me to withdraw, when Moody is the one man who gives Ferguson his strength.

"The opportunity to rid Texas of Fergusonism before the primary is still open. The offices which Ferguson and Moody bet belong to the people, but the candidacies are their own. 'Dan's the man' to challenge Ferguson that they both withdraw."

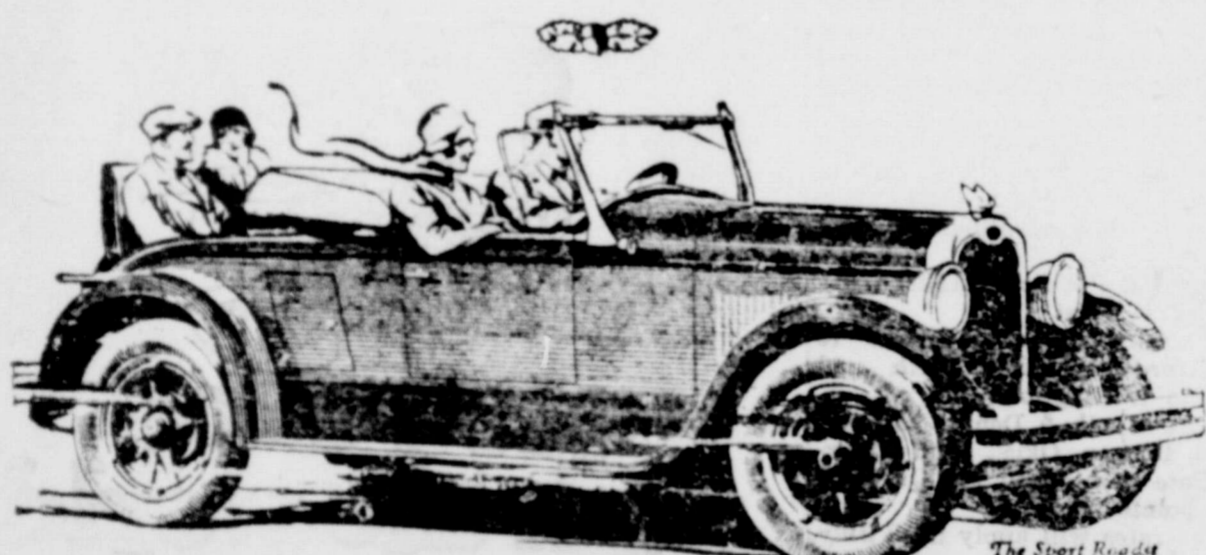

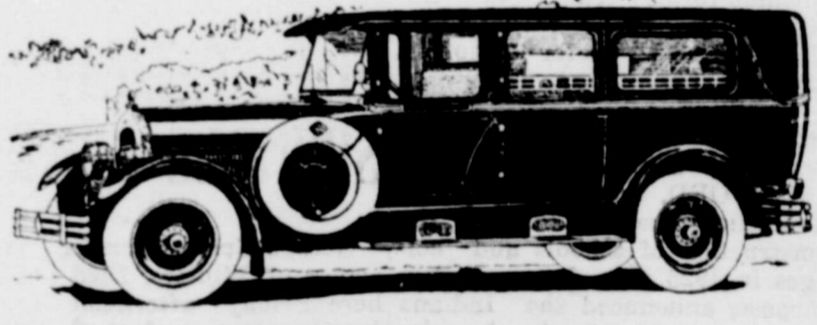

IN HOSPITAL AFTER FAILING TO SAVE FRIEND'S LIFE

Her futile attempts to save from drowning Miss Coy Aycock, near Ballinger six weeks ago has sent Miss Gyrene Freeman to the San Angelo hospital, doctors assigning as her trouble that heroic attempt to save her chum from a watery grave. She is a daughter of J. A. Freeman, local auto salesman, and former assistant chief of police of Ballinger—San Angelo Standard.

Miss Freeman was at the time of Miss Aycock's death, staying in Ballinger with the young lady, attending school here. Her parents had moved to San Angelo and she was staying here until the local schools had closed.

Miss Aycock was drowned in the Colorado River, five miles West of here. Miss Freeman, after attempting to rescue her playmate, ran several hundred yards barefooted over rocks and briars to summon aid. Her feet received severe cuts and bruises.

Mr. Freeman formerly lived here, for several years being in the barber business, later going into the automobile business.

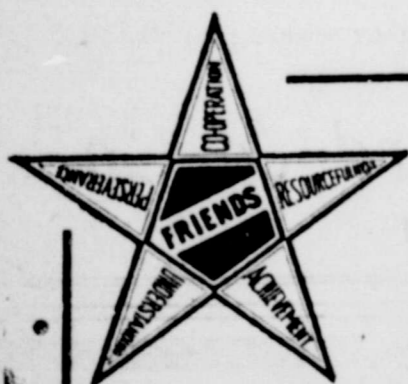
