PARTY OF 100 FIRES ON KLAN IN MEETING

(By Associated Press)
GROTON, Mass., Oct. 2.—A pitched battle, in which between seventy-five and a hundred shots from rifles and pistols are believed to have been fired, broke up a meeting early today of several hundred members of the Ku Klux Klan.

The Klansmen, who were assembled in a field, were driven to the cover of their automobiles when a party, estimated at nearly 100, drove up and opened fire from behind several trees which they had felled across the highway.

The felled trees compelled the Klansmen to drive through fields in order to gain the roadway.

Local police summoned state police but no casualties were reported.

The ground was littered with glass from the broken windshields.

FILES CHARGES AGAINST CHUDEJ

AUSTIN, Oct. 2.—F. W. Chudej, member of the State Textbook Commission, against whom Attorney General Dan Moody filed quo warranto proceedings Friday, for his removal from the commission, today was served by citation.

The petition filed asked for an injunction restraining Chudej from purchasing in the textbook commission meeting scheduled for October 13, when more book contracts are to be let.

It also charges that Chudej is ineligible to be a member of the commission.

Methodists Move into New Church for Services Sun.

Members of the Methodist church of this city will meet for the first time in the first unit of their new building on the corner of Murrell Avenue and Tenth Street, Sunday morning at 9:45 o'clock when the Sunday school services will be held. W. A. Francis, chairman of the building committee announced today.

"The first unit of the new church is paid for and has been accepted by the building committee," Mr. Francis declared. "We accepted the structure and paid for the work on September 30."

Since June 1st, the Methodist congregation has been meeting in the old skating rink and the contractor, C. D. Mills, has been busy tearing down and re-building the church house. It was erected at a cost of \$15,600.

The general contract was for \$11,000; the old lumber and stone used in the building from the old structure was estimated to be worth about \$4,000, and the plumbing and lighting fixtures amounted to \$600.

The new building contains eight Sunday school rooms, two dressing rooms, and a main auditorium. The Sunday school rooms are very large and they will be partitioned to accommodate several classes.

The main entrances to the building of which there are three, are on Tenth Street. Two entrances will be constructed when the upper portion of the building is completed. The main entrance now, however, is in the center of the front. Two Sunday school rooms are in the front of

RETURNS PRISONER TO COLEMAN JAIL

C. W. Watson, an oil driller, of Cisco, who is charged with slaying Jack McMath, an automobile dealer, on the streets of Coleman Thursday at noon, was removed from the Ballinger jail and carried back to Coleman late Friday. Deputy Sheriff Reese, of Coleman, came after Watson, and it was expected that the grand jury which was in session at the time of the killing, would return a bill Saturday.

Watson was removed from the Coleman jail and brought to Ballinger Thursday night on account of the intense feeling which developed in that city following the killing. The officers reported that the excitement had subsided somewhat and it was believed no further threats of violence would be made.

Watson shot McMath twice as McMath was walking across the streets and after slaying the auto man Watson drove to a cafe where he was arrested. It was said that McMath was unarmed and in his shirt sleeves. He was recently divorced from his wife. Watson is a single man.

FORMER MAYOR OF BROWNWOOD DIES

BROWNWOOD, Oct. 2.—Uncle Joe C. Weakley, former mayor of Brownwood, and widely known, died at his home here today.

Mr. Weakley was prominent in the early development of Brownwood and was active for many years in the affairs of the State Firemen's Association.

College amended yesterday by the House to include Texas Tech, the College of Industrial Arts, the eight teachers colleges and all other institutions of higher learning in the state.

POSTAL RECEIPTS SHOW INCREASE

The third quarter of the 1926 year of the postal department has just closed and for the three months of that quarter, the total receipts here show a gain of about 5 per cent over the same period of 1925, J. A. Reese, postmaster, announced Friday.

The total for the third quarter of 1926 is \$4,440.41, and for the same period in 1925 was \$4,229.24.

The second quarter of this year, however, was larger than the third quarter by about \$100, the second quarter's receipts being \$4,523.44.

The fourth quarter, composed of the months of October, November and December, is expected to show an increase over all quarters of the past two years.

Business is continuing to show progress in this section, despite the low price of cotton, and the local postoffice is accurately reflecting business conditions in other lines.

13,500 KILLED BY AUTOMOBILES

WASHINGTON, October 2.—Approximately 13,250 persons were killed, and 350,000 were injured by automobiles in the United States during the first eight months of the year, the American Road Builders Association reported today.

YANKS BEAT CARDS 2 TO 1 IN OPENER

(By Associated Press)
YANKEE STADIUM, New York, Oct. 2.—Herb Pennock, New York Yankee pitching ace, held the St. Louis Cardinals to three hits today while his teammates, led by Babe Ruth, battled their way to a 2 to 1 victory over the National League champions in the opening game of the world series.

YANKEE STADIUM, New York, Oct. 2.—Before a colorful throng estimated at 65,000, a figure shattering all world series attendance records, the New York Yankees and the St. Louis Cardinals took the field today for the opening game of the world's baseball championship.

Two southpaw stars, and rival contenders, were picked for the pitching duel, with Herb Pennock on the mound for the Yanks and Willie Sherdel carrying the hopes of the first St. Louis team that ever entered the fight for baseball's premier title.

Light sprinkles of rain punctuated the half hour before the start.

St. Louis started the series off right by scoring one run in the initial inning when Douthitt doubled and scored on Bottomley's single.

The Cards also gave the Yanks a score in the same frame when Sherdel walked Combs in after the bases had been filled.

Pennock outpitched his two St. Louis rivals, Billie Sherdel and Jess Haines. Haines, right-hander, took up the mound burden for the Red-Birds after the American Leaguers had tallied the winning run in the sixth inning.

The score: Yankees—2 runs, 6 hits, no errors; Cardinals—1 run, 3 hits, 1 error.

ST. LOUIS, Oct. 2.—The Cardinals, whose roster of 31 players, cost only \$39,000, are a young

crew. The average age of Manager Rogers Hornsby's sluggers is 27 years.

The average age of the outfielders and infielders is a few months less than 26; that of the catchers 28, and the pitchers less than 28.

Eleven of the squad are playing their first full season in a major league, and only seven of the crew have been with the Cardinals over a span of years. The latter are Hornsby, Sherdel, Haines, Blades, Bottomley, Sothoron and Toporec, while the eleven who are playing their initial full-year swing in the big time circuit are Pitchers Reinhardt, Herman Bell, Hallahan and Clough; Catchers Vick and Warwick; and Fielders Douthitt, Holm, Hafey, Thevenow and Flowers.

Clough tips the age beam the lightest with 20 years, while Grover Cleveland Alexander, 39-year-old campaigner of many major league seasons and a Cardinal acquisition from the Chicago Cubs, is the oldest. Clough has not pitched a full inning this season on account of his inexperience.

**RESERVES DEFEAT
BEARCATS 12-6**

The fighting Bearcat football squad of the Ballinger high school lost their second game of the season here Friday afternoon when the Howard Payne Reserves of Brownwood scored two touchdowns for 12 points while the Bearcats, unable to get the ball over the goal line, scored a couple of field goals for a total of 6 points.

The Bearcats were outweighed some 15 or 20 pounds to the man but despite this they put up a much harder battle than was seen in their first game this year which was with the San Angelo Bobcats.

The crowd that witnessed the game was of fair proportion but it was not as large as expected to see the regular football games that the Bearcats will take part in during the remainder of the season. It was a real peppy crowd and showed the team was getting much more backing this year than for several seasons.

The Bearcats and Coach Wright worked hard during the past week after their loss to San Angelo but yesterday's game was not expected to come out in Ballinger's favor. However, the score was different from what was expected by the local grid fans.

The Reserves were booked to win this contest but they could not get going properly except on one or two occasions when they made several nice gains. Their touchdowns came after short end runs and were nothing short of breaks in the Bearcat defense. Ballinger boys were the stars on the Reserve squad.

Three Ballinger boys were with the Reserve team: 'Nig' McCarver, C. A. Doose Jr., and Tom Penn. McCarver played a greater part of the game. He was at first started at right end and in the second quarter was removed for a substitute, but in the second half was brought back into the line-up and put the backfield. McCarver's breaks thru the line featured the Reserve offense. He made some three or four material gains thru the line with his body twist working and shaking the

would-be tacklers as he went. He came near getting loose two or three times for touchdowns but he was always stopped.

Young Doose also played in the backfield and worked hard to get his team going against his former team mates. Doose was in almost every play and working hard.

Tom Penn played a part of the last quarter in the line for the Reserves. He was in many of the plays and assisted his side of the line in making a hole for his backfield men to make their attempts.

The entire Ballinger team started, but it was J. B. Arthur's field goals that kept Ballinger from having a goose-egg at the end of the game.

Arthur was good on two of his three attempts at field goals. He kicked the first goal from about the 25-yard line, in the first quarter, and was from an angle on the field. The oval passed between the uprights by just a few inches and Referee Mack held up his hands signifying the kick had been successful.

The second field goal came in the fourth quarter from about the 28-yard line. The Bearcats had been endeavoring to get the ball over the goal line but they could not get closer than the one-foot mark and this was in the last quarter following a drop-kick by Arthur which was knocked out of bounds by 'Red' Rayburn on the Reserves 1-foot line. Arthur had attempted a field goal but the kick was a bad one and Rayburn followed it up to push it out of bounds near the goal line.

In the backfield for the Bearcats, Alagood, Parrish, McKenzie and Arthur all starred. They played good defensive and offensive but their charge was not equal to that of the Reserve backs. Alagood played a defensive game that was not equaled by any player on the Reserve squad. He stopped many plays after they had gone thru the local line and looked as tho they were gone for the goal.

These backs attempted only two or three passes, all unsuccessful, one being intercepted by 'Red' Reynolds, Reserve center and captain, who came very near getting away for a touchdown but McKenzie's speed overtook him and caught him at the Bear-

cat's 10-yard line. McKenzie was knocked out in this play and was taken from the game.

In the line, Pug Powell, Mason, Rayburn, Doy Smith, Frank Reese, Tuckey, Foreman and Marecek played good defensive ball. Many times during the afternoon, one could see Powell and Reese getting their men out of the way and then getting the man with the ball. Mason and Rayburn were equally as good, getting in every play and always up with plenty of talk and ready to go. Marecek was going good in his side of the line also.

The subs Coach Wright played in the game were equally as good and played hard to stop the advances of the opposing team.

The Bearcats go to Eden next week where they play the Eden high eleven in starting the Bearcats' regular schedule.

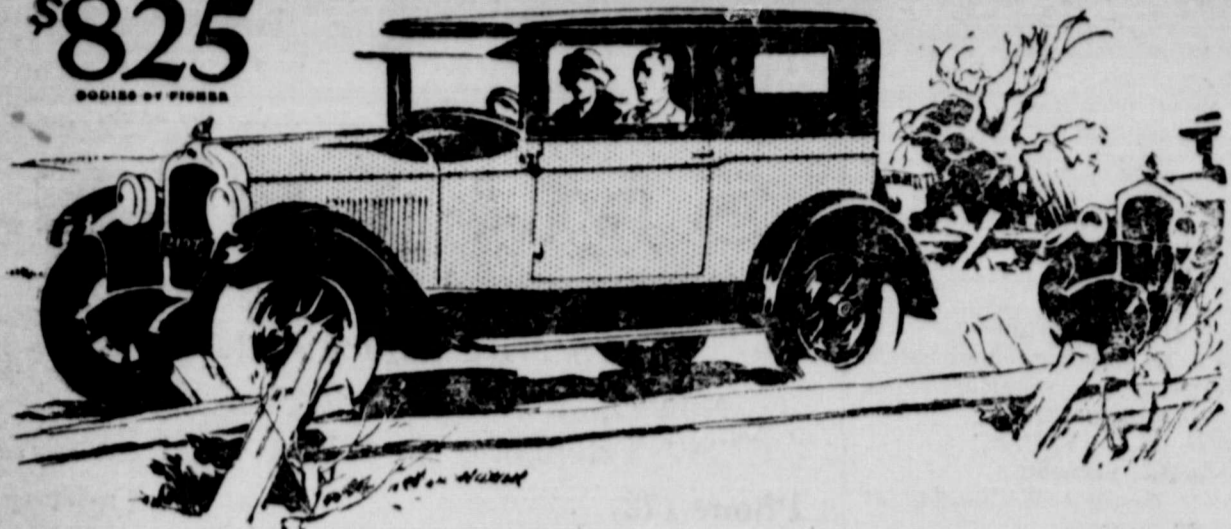

RUNNELS BEFORE PUBLIC'S NOTICE

Runnels county came in for good play at the San Angelo All-West Texas Exposition, and was given first place, not only in the county agricultural exhibit, but in first winnings by individual entrants in poultry and other departments.

Runnels county was also given first place with some good publicity and advertising. The San Angelo Standard made prominent mention of the visit of the large delegation of Ballingerites to the fair, and had the following to say in an interview with County Agent Lehmborg:

"Runnels county, first among the exhibitors at the All-West Texas Exposition here, is first in the mind of C. W. Lehmborg, farm agent, as the banner agricultural county in West Texas. He cites as reasons the development of farming there in the last few years, yields per acre, a fifty thousand bale cotton crop this year, and yields per acre in various lines as well as quality produce as demonstrated here and at Abilene.

"While the exhibit here is a different one from that which carried off fourth honors at Abilene, the pears and the maize that were in the Abilene exhibit were also made a part of the exhibit here. Another feature of the exhibit was a showing of pecans grown by Lou Munsey, residing five miles South of Ballinger, on the Colorado River. Mr. Munsey has four hundred trees, which he has been budding for the last twelve years. He has them now to a high state of perfection and is producing a number of varieties. He showed five of them here.

"As to yields per acre, Mr. Lehmborg cites that Frank Kemp this year produced at the rate of 95 bushels to the acre of red rust proof oats, the field comprising forty acres. He is selling them as seed now at the rate of \$1 per bushel.

"Bruce Dobbins, of Drisco this year grew a few acres of pure line milo maize, that made at the rate of two tons to the acre. Of this amount 75 per cent is seed, which he is selling at 10 cents a pound for planting purposes. That makes him at the rate of \$300 to the acre, which isn't bad on anybody's land.

"Again Bert Fletcher is making a bale of cotton to the acre, which isn't so bad when many fields are doing less and in some it takes many acres to make that much.

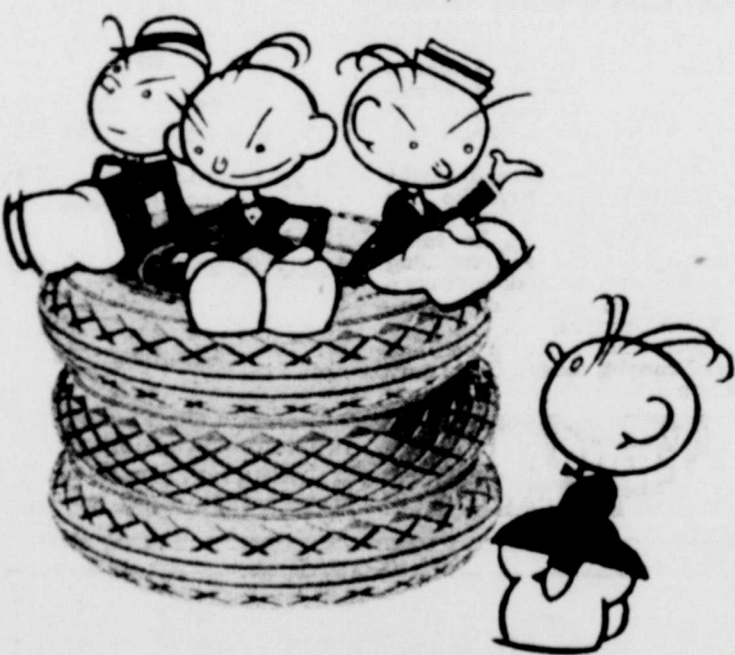

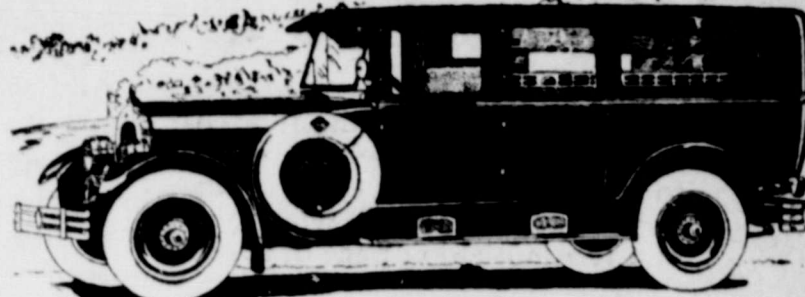
