#### TAXATION-GUBMITTING AMENS MENT TO CONSTITUTION.

Joint Resolution amending Section 3, Arfiele 7, of the Constitution of the State of Texas, increasing the amountof tax that may be voted on school districts and providing for a majority vote of the property tax paying voters of such district to vote such tax. Section 1. Be it Resolved by the Legislature of the State of Texas: That Section 3 of Article 7 of the Constitution of the State of Texas be so amended as to hereafter read as follows:

Section 3. One-fourth of the revenue derived from the State occupation taxes and a poll tax of \$1 on every male inhabitant of this State between the ages of twenty-one and sixty years shall be set apart annually for the benefit of the public free schools, and in addition thereto there shall be levied and col-lected an annual ad valorem State tax of such an amount, not to exceed of such an amount, not to exceed twenty cents on the \$100 valuation, as with the available school fund arising from all other sources, will be sufficient to maintain and support the pub-lic free schools of this State for a period lic free schools of this State for a period of not less than six months in each year, and the Legislature may also pro-yide for the formation of school dis-tricts within all or any of the counties of this State by general or special law, without the local notice required in other cases of special legislation, and may authorize an additional ad valorem tax to be levied and collected within such school districts for the further maintenance of public free schools, and the erection and equipment of school buildings therein, provided that a majority of the qualified property tax paying voters of the district, voing at an election to be held for that purpose, shall vote such tax, not to exceed in any one year 50 cents on the \$100 val-uation of the property subject to taxation in such district, but the limitation upon the amount of district tax herein authorized shall not apply to incorporated cities or towns constituting separate and independent school districts. Sec. 2. The Governor of the State of Texas shall and he is hereby directed to issue the necessary proclamation for the submission of this amendment to the qualified voters of the State of Texand the sum of four thousand (\$4,000) dollars, or as much thereof as may be necessary, is hereby appropriated out of any money not otherwise appropriated to defray the expenses of publication of such proclamation. At such election the qualified electors voting and favoring said amendment shall have the price of property out of reason whenever there is a prospect of a railroad comming through the country. W. P. 

PROPOSED AMENDMENT TO THE STATE CONSTITUTION FIXING THE COMPENSATION OF THE GOVERNOR AND LIEUTENANT GOVERNOR.

Joint Resolution proposing an amendment to Article 4 of the Constitution of the State of Texas by amending Sections 5 and 17 of said Article 4 so as to fix the compensation of the Governor at eight thousand (\$\$000) dollars per annum in addition to the use of the Governor's mansion, fixtures and furniture, and the compensation of the Lieutenant Governot at twenty-five hundred (\$2500) dolla.s per annum. Be it Resolved by the Legislature of

the State of Texas:

Section 1. That Section 5 of Article 4 of the Constitution of the State of Texas be amended so as to provide that the Governor of the State shall receive as compensation for his services, an annual salary of eight thousand (\$8000) dollars and with the use and occupation of the Governor's mansion, fixtures and furniture, said Section 5


as amended, to read as follows: Section 5. He shall, at stated times, receive as compensation for his services an annual salary of eight thousand (\$3,000) dollars, and no more, and Special attention paid to shall have the use and occupation of the Governor's mansion, fixtures and furniture.

That Section 17 be so amended as to read as follows:

Section 17. If, during the vacancy in the office of the Governor, the Lieutenant Governor should die, resign, refusa to serve or be removed from office or be unable to serve or if he shall be impeached or absent from the State, the President of the Senate, for the time being, shall in like manner administer the government until he shall be su :ceeded by a Governor or Lieutenant Governor. The Lieutenant Governor shall receive an annual salary of twen-ty-five hundred (\$2,500) dollars per year, and no more. During the time ha administers the government as Governor, he shall receive in like manner the same compensation which the Governor would have received had he been employed in the dutics of his office. The President of the and no more. Senate, for the time being, shall, during the time he administers the gov-ernment, receive in like manner the same compensation which the Governor would have received, had he been employed in the duties of his office.

Sec. 2. The Governor of this State is hereby directed to issue and have published the necessary proclamation for the submission of this resolution to the qualified voters for members of the Legislature of the State of Texas, as an amendment to the Constitution of the State of Texas, to be voted upon on the day of the next general election of the State of Texas, which will be held on the day fixed by law therefor. AU persons favoring said amendment shall have written or printed on their bal-lots as follows: "For the amendment to the Constitution fixing the salary of the Governor at eight thousand (\$8,000) dollars per annum, and the Lieutenant Governor at twenty-five hundred (\$2,-500) dollars per annum." The county commis-sioners so chosen, with the county judge as presiding officer, shall compose the county commissioners' court. which shall exercise such powers and jurisdiction over all county business as s conferred by this Constitution and the laws of the State, or as may be

hereafter prescribed. Sec. 2. That the sum of one thousand (\$1,000) dollars is hereby appro-priated out of the State Treasury not otherwise appropriated for the purpose of defraying the necessary expense of submitting the above proposed amend-ment to the people of the State, at the next general or special election in the manner required by law, by the Gover nor of the State W. R. DAVIE, (A true copy.)


