Brownfield Had Her First Fire Monday

Just about dark Monday night or just as people were either finishing their chores of eating supper, an alarm of fire was turned in by several pistol shots being fired in rapid succession, but too late as the earliest arrivals found the interior in a mass of flames. Mrs. Moore's small boy was the only person present, Mrs. Moore being away on a visit, and he was engaged in cooking his supper, but when he suddenly found that his home was burning, he was so frightened that he managed to save only a few things.

The men made a brave effort and succeeded in saving the windmill by keeping it literally saturated with water from a tank near by, being also aided by good fortune of the wind being from the north, as the mill stood a few feet from the house on the northeast.

Happily, Mrs. Moore had just taken \$850.00 insurance on her residence and contents, and this sum will greatly aid her in replacing her property, though as it always happens, she no doubt lost family relics that were priceless.

Our Mineral Wealth.

The recent announcements in the press that New York capital had invested heavily in the sulphur beds near the mouth of the Brazos river, which also carries with it the construction of a new city, and a new seaport, brings glad tidings for the new year and forcibly directs attention to the possibilities of our mineral resources.

It also carries with it a lesson in finances that we must all learn, to-wit: OUTSIDE CAPITAL MUST DEVELOP TEXAS. Many of our local capitalists have been stumbling over our mineral deposits chasing vendor-lien notes ever since we wrested title from the Indians, and while our mineralogists have been crying aloud in praise of our natural deposits the mineral kingdom has found few willing subjects in Texas.

Texas has many world projects and it takes international minds to grasp many of them.

Iron Ore Deposits.

Attention has been called to the fact that a press notice concerning the United States Geological Survey's Bulletin 450—"Mineral Resources of the Llano-Burnet Region, Texas," by Sidney Paige—does injustice to the character of the iron ores which occur in Llano and Mason counties. The statement which is made in the bulletin and which in the case of three iron-ore deposits is favorable to the extent that they should be further exploited by means of diamond drills or additional prospecting shafts is as follows:

"Though a few localities are in eastern Mason County, most of the iron showing are in that portion of Llano County which lies north of Llano River. All of the known occurrences of magnetite are described, but it is believed that not more than perhaps three of the deposits promise to become of industrial value. No assurance can be given that the three most likely deposits can be developed into profitable mines in advance of adequate explorations by means of diamond drills or by prospecting shafts in addition to those already opened, and it is considered that the less promising deposits will not warrant any large expenditure for prospecting unless the market value of iron ores increases.

"The permissible scope of the geologic work did not admit of magnetic surveys, but it is suggested that such surveys should be carried on in connection with any future explorations of the more promising magnetic deposits of this district. Surveys with compass and dip needle would perhaps serve as adequate guides in the preliminary magnetic exploration of these iron-ore deposits, after which, if the results obtained warranted such a course, more refined methods and studies might be applied."

If the value of any the iron-ore deposits should be certainly proved the question of transportation would be a matter for further consideration.

MILL STARTED.

A Fine Grade of Meal Being Made.

After noon yesterday, the managers of the Terry County Mill and Feed Co., got their mill and engine in working order and most of the evening was spent in making a splendid sample of meal. Of course several stops were made to tighten belts, as they were all loose and had to be adjusted, while part of the machinery was new and had to be frequently oiled and the belts adjusted. The managers believe that when everything has been accurately adjusted, and the operators are a little more familiar with their machinery and location everything will move along at a rapid rate.

The crusher has not been installed, but we presume it will be put down immediately, or as soon as workmen can get to it. In the meantime, you can get fresh, home made—better than any brought on meal—right now, any day in Brownfield.

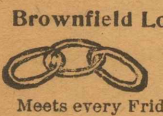

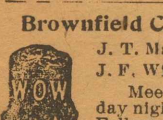

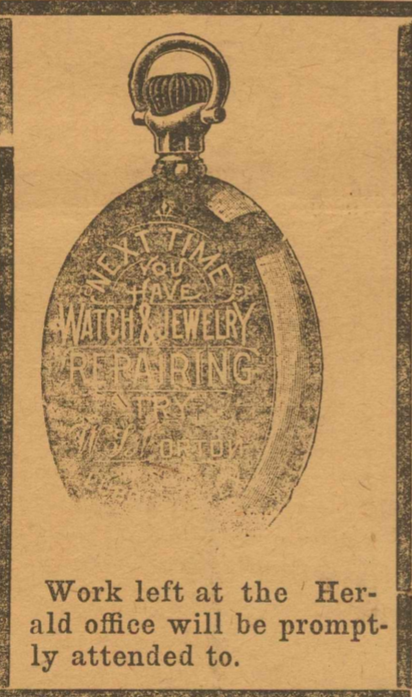

Should parties practice for pay, as physicians do, perhaps they should be prosecuted; but prosecution or no prosecution, it is the duty of everyone to do all that can be done to allay suffering and prevent death. There's a number of simple remedies that at times past have proven effective in the treatment of this dread disease, and at the risk of incurring the displeasure of the Board of Health, The Herald is going to give them. Dissolve two ounces of saltpeter in one quart of water, rub vigorously on the spine from the neck down until there is relief, the patient standing to the knees in hot water in which a quantity of mustard has been placed. Give medicine to insure activity of the bowels and liver. Mustard or onion plasters applied hot to the spine and kept as hot as the patient can bear them, changing to fresh ones as they cool, have also proven effective. Where the disease is suspected, try one of these remedies at once and hurry for a physician. 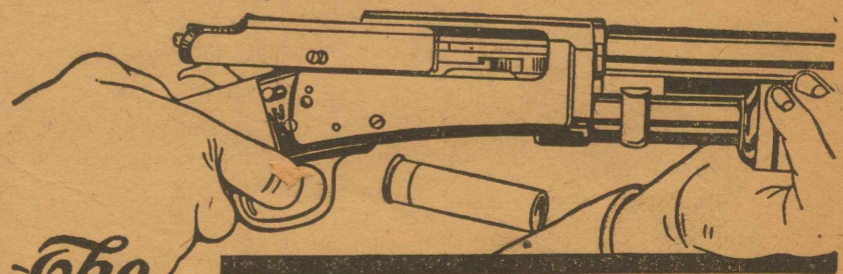
