



Lloyd Watson Killed.

News reached here last Sunday that Lloyd Watson had been killed by falling from a high cliff on an island off the coast of California. He was stenographer at a summer resort on the island and was out for a walk and fell a distance of 1200 feet or more and remained several days before he was found. The following letter from his brother Hugh to their parents gives a complete account. Hugh's home is at Clifton, Arizons, and he was notified of the accident and immediately went to that place and arranged for the burisl. Lloyd left here about seven years ago and is well and kindly remembered tera.

THE LETTER.

Los Angeles, Cali., March 8, 1908. H. A. Watson, Goldthwaite, Texas. DEAR FATHER:-You have gotten my wires before this, I suppose, although you don't seem to have replied


On the 3rd of this month I received a wire from Catalina Island, saying Lloyd had been missing since ist, but could learn none of the partiulars so came out on 5th, reaching here next day. Had to lay over here until Saturday, when went out to island by steamer.

Of course it is hard to tell you what I am going to, but it has to be done if you want the truth. When I reached Avalon they had recovered his body from a ledge, he having fallen a great distance. You see he had gone out for a walk and had strolled into what they call the "Devil's Pocket" and instead of waiting until someone found him, he had attempted to climb out. They tell me it is impossible to get out of that place without help from the outside, but it is supposed he did not know that, with the result that he fell, and in falling lost his life. It was necessary to use a launch and 1800 feet of rope to recover his body, and three men risked their lives in the work

I brought him over here and will bury him in Rosedale cemetery tomorrow at 10:30. I was going to bring him home, but you see cremation would be imperative and I think you had rather he was buried here, for I have bought a piot in a beatiful place, and it is what they call a perpetual grave, the city guaranteeing to tend it always. I want you and mama to know that he is in one of the prettiest places in the world, and that the place will always be taken care of. If you should desire to move the body that is your privilege at any time.

You must know that I have done everything in the power of anyone to do under the circumstances, and while I wish he could have been buried by the side of Charlie, still you must realize that it was impossible to do so.

He called again to the man to disclose his identity or he would shoot to kill. Still he got no reply. McEuen walked up to the hogpen, looked into the enclosure and saw a man crouched in the corner. He stepped back six or eight feet and fired directly at the crouching figure

Hinton partially regained his feet and crying out, "Virgi, you have killed me," he feil dead, The inquest was held today and

McEuen was exonerated, the verdica being justifiable homicide. The only solution to Hinton's strange behavior was that he was trying to play a joke on McEuen.






