COMANCHE

The nine year old son of Davee Carney died of pneumonia at Ft. Worth Tuesday and was buried here Wednesday. Ewing, another child, is also sick with pneumonia and is not expected to live.—Exponent.

The baby girl of Mr. and Mrs. Frank Maloy measured out a dose of carbolic acid and attempted to swallow it Wednesday morning. Dr. Townsend was at once summoned and it was found that the child had not swallowed much of the acid and will recover.—Reporter.

Ollive Rabi, from Ballinger, was here this week visiting home folks.

J. M. Baxley left Monday on a business visit to Waco.

Last Saturday from 1 to 3 p. m. every business establishment in Hamilton closed its doors at

the request of our railroad committee, to attend a mass meeting at the court house to discuss the railroad situation.—Herald.

ANAS

A. K. Ellis, who moved to the Wichita Falls country last fall, is here on business this week. He reports crop conditions fine in his section.

Young Hartman, son of Nat Hartman, of Big Valley, died Tuesday night. He was making a crop with his brother-in-law, D. W. Webb, on China and was taken with pneumonia several days ago. He was buried in the Big Valley graveyard in Mills county.

The examining trial of L. W. Little was held before Justice of Peace, J. K. Rector, jr, Monday. The defendant is charged with assault and attempt to murder and was bound over to await the action of the grand jury and promptly gave bond in the sum of \$500. The case grew out of some trouble at a dance in the neighborhood west of Holt some time back.

Last Saturday evening Joe Yarborough stabbed a Mexican while standing on the streets of Richland Springs. Yarborough was arrested by deputy sheriff Nelson Smith and brought to town and lodged in jail. The Mexican died from the effects of the wound Sunday night. The affair is the more regrettable from the fact that Yarborough belongs to one of the highly respected families of the county. There is

no doubt that the act was committed in a fit of insanity and without the least bit of moral responsibility.—News.

BROWNWOOD

The home of Mr. and Mrs. J. F. Day on Fisk avenue was the scene of a pretty home wedding last night at 8:45 when Mr. E. S. J. Whitehead and Miss Annie E. Day were united in marriage.

Smallpox claimed its first victim in Brown county this morning at 4 o'clock when Eddie McAden, of the Indian Creek community, died after an illness of some twenty-seven days. The young man contracted the disease at Tyler, so the Bulletin is informed, and it was transmitted to his father, but the senior McAden's case was a milder form and he is recovering.

A wire from the chief detective of Oklahoma City, F. L. Staton, advised Sheriff Emison yesterday that Milt Dupree has been arrested and would be held until officers from Brownwood could arrive there. It will be remembered Dupree left Brownwood on the night following his acquittal of a murder charge in this county, while out on bond in the misdemeanor case, and has not been seen since. Some two or three of the whiskey case have been carried to the higher courts and have been affirmed. There are a number of jail sentences in addition to the fines and costs, which if he lays them out in jail will keep him in for several months.—Bulletin.

A total of 315 votes was polled at the city democratic primary election Tuesday.

Two men captured a six-foot eel at Galveston last Tuesday after a half-hour's struggle. It is said to be the largest eel ever caught off Galveston Island.

W. L. Bauman, an aged citizen of Devine, was found dead at his home Monday with the top of his head blown off and an old Confederate rifle lying on the floor at his forehead.

J. V. Wood & Bro. of Milford are preparing to open a lumber yard at Richland Springs. These gentlemen are friends of Mr. G. C. Parker, manager of the Goldthwaite Mercantile company's business.

Mrs. Michael J. Kearns returned to her home in Dallas last Friday night from Terrell, and found her husband's dead body lying across the bed in their room. The coroner held an inquest and his verdict was that death had resulted from natural causes.

An eleven-months-old mule colt sold at Denton, Wednesday for \$200. He weighed 800 pounds and measured fifteen and one-half hands high. The animal took the prize at the Dallas fair for the best mule colt.

Herschel Hanson, a 14 year old boy at Atlanta, Ga. was placed in the State Reformation school last week on account of being convicted of assault and battery. The boy is almost a giant in size being six feet tall, but still wears short trousers.

Plans for the most elaborate school building in the south and probably most remarkable institution of its kind in the United States were launched at Dallas Tuesday morning by the Alumni association and the board of trustees of Southwestern University at Georgetown, Texas. The structure will have three stories and a basement and is to be constructed of the white stone of Williamson county. It will cost at least \$250,000. The lobby of the first floor will be given over to memorial tablets more elaborate than those in New York's Hall of Fame.

GOOD ROADS.

An Election Ordered to Issue Bonds For Road Purposes.

The commissioners court in special session yesterday, in response to a petition of a large number of citizens, issued an order for an election to determine whether or not bonds for \$50,000 shall be issued by Mills county to build the public roads, the agreement being that the funds realized by the sale of the bonds shall be apportioned to the different precincts of the county in proportion to the taxable values. It is further agreed that the funds are to be used for road building alone and must not be appropriated for bridge building or repairing.

The Eagle has always advocated good roads and believes that to put the highways in first class condition and make repairs in a permanent way will be of more value to the county than the building of railroads or factories. The good roads movement is attracting the attention of the nation and the people everywhere are alive to the importance of building good country roads. Few counties can make first class roads at so small cost as can be done in Mills county and yet the repairs and improvements are badly needed. It is proposed to have the work done by the people of the county during the coming summer, after they have "laid-by" their crops and in that way the money expended will serve a two-fold purpose.

The Eagle heartily favors the proposition to issue the bonds, but has no quarrel with any citizen who opposes the plan, for we realize that every citizen has a right to his opinions on this or any other measure, and we will cheerfully give space to communications of reasonable length on the question of the issuance of the bonds, no matter whether the writers favor or oppose the issue, but we must require that the articles be presented by responsible citizens and tax payers and that there be nothing of a personal nature in any of them, for we are to discuss measures and not men.

The election takes place Saturday, April 9.

Commissioners Court.

Commissioners court has been in special session this week, for the purpose of appointing road overseers and transacting other important business. The list of overseers was not completed in time for the Eagle to publish it this week, but it will appear next week.

An order was entered correcting the field notes of Prairie school district No. 42, in order that bonds for \$1500 might be issued by the district to build a school house. This district is in the Democrat neighborhood.

Officers were appointed to hold elections for school trustees the first Saturday in April.

The county treasurer was instructed to pay off court house bond No. 11 for \$1000, which is held by the county school fund.

On petition of A. T. Sellers et al. an election was ordered in Big Valley school district No. 23 to determine whether or not the special school tax shall be reduced from 20 to 10 cents on the \$100 valuation, and March 26 was named as the time for the holding of the election.

Miss Jane Carson was allowed \$8 per month and Thos. Ragsdale was allowed an increase from \$10 to \$12.50 per month.

The allowance heretofore made to Robert Lee and Mrs. Ogles was discontinued.

The court purchased a telephone from the Rural company and had it installed in the sheriff's office.

Contracts have been signed for the building of a railroad from Temple to Hamilton and work is to begin by the middle of next month.

A cyclone near Center, Texas, last Monday destroyed the home of Jack Estee, killing him instantly and injuring his wife and daughter. No other damage was done other than the destruction of timber.

A traveling salesman, D. O. Robinson, fell out of a car window on the Brownsville road Friday night and he walked into Vanderbilt Saturday morning having suffered greatly from the cold.

Frank Craig was shot and instantly killed at Childress Monday morning by his 15-year-old son, who declares he was acting in defense of his sister, as the father was holding her by the hair and threatening to cut her throat.

A street car accident at El Paso caused by the blowing out of a fuse last Sunday night created a panic. Flames broke out and a number of persons jumped from the swiftly moving car. Two persons were killed outright and several were hurt.

A freight train was wrecked at Thompson, fifty-five miles from Galveston, Sunday, by striking a cow lying on the track. The fireman was killed and the engineer and head brakeman were so badly injured they are not expected to live.

One of the costliest and most complete hotels of the Harvey system on the Santa Fe railroad is to be erected in Temple as soon as work can be commenced. It is to cost \$140,000 and will occupy the site of the present frame building.

Four hundred persons who attended a spiritistic demonstration at the opera house in Patton, Pa. were precipitated together with a red hot stove into the basement, when the floor gave way. No one was killed and only about twenty-five were injured and burned.

Governor Campbell appointed Hon. C. H. Jenkins of Brownwood to a position on the court of civil appeals bench, the death of Judge Fisher having caused a vacancy. Mr. Jenkins is one of the best known lawyers in this part of the state and has been prominent in Texas politics for a number of years.

The woman called "Typhoid Mary" was released last Sunday after being consigned in Chicago hospitals, off and on, for three years, because physicians said that she was a living receptacle for typhoid germs and a menace to public health, as she is a cook and repeated cases were found in families where she has cooked. She was released with the understanding that she is to cook no more.

The state comptroller's department issued a warrant Monday for \$5000 in favor of Mrs. Nannie Huddle and her daughter of Austin, in payment for the famous oil painting of Davy Crockett, which has hung in the lobby of the state house for a number of years. The picture was painted by Mrs. Huddle's husband and placed in the capitol and the last legislature made an appropriation to purchase the painting,

COMMERCIAL CLUB.

Important Meeting and Matters of Interest Discussed.

The Goldthwaite Commercial club met in regular session Monday night.

The committee on securing an oil mill reported having heard nothing from Mr. Benoini and asking for further time, which was granted with instructions to report at the next meeting without fail.

Mr. W. E. Miller was requested to correspond with the gentleman at Palestine who desired to establish an oil mill here and ask that the club be given further time in which to consider his proposition.

The matter of issuing bonds for building good roads in the precinct was discussed and the club determined to circulate petitions at once asking the commissioners court to order and election to vote a bond issue of \$25,000 in precinct No. 1 for the purpose of building roads. Volunteers were called for to circulate the petitions and a number of the leading citizens took charge of the lists.

A COUNTY ISSUE.

The citizens having in charge the petitions asking for a bond issue in this precinct met with an enthusiastic reception Tuesday from town and country people alike, only a few refusing to sign, such refusal being based wholly upon the grounds that the issue should be county-wide, as all parts of the county needed the good roads and should be given an opportunity to vote on the subject. After the matter was thoroughly discussed it was decided to hold another meeting

of the club Tuesday night and change the plan and submit petitions to the people of the county for their signatures asking the court to order an election to authorize the issuance of \$50,000 in bonds by the county to be used on the roads, each precinct to be given its pro rata share of the funds, to be divided on the basis of taxable values.

The club meeting was largely attended and after discussing the proposition the plan of a county issue was adopted, it having been shown that to issue bonds for the entire county the present tax levy of 15 cents on the \$100 valuation could be used to pay the interest and create a sinking fund to redeem the bonds and about one-half of the funds now raised for road purposes would still remain to be used on the roads. A committee of five was appointed by the president to prepare a statement to the voters concerning the election and to look after the campaign in a general way, with authority to secure such assistance as necessary in properly bringing the matter before the citizens of the county.
