## A WEEK'S NEWS.

# Gleaned by Telegraph and Mail

PROM WASHINGTON. Forty-eight employes of the Census Bureau are recommended for promotion. Geo. W. Richards, of Cincinnati, is recommended for a Chief Clerkship.

The President has accepted another twentyfive miles of the Northern Pacific Railroad in Montana coming Eastward.

At the instance of the Department of Justice, warrants were issued for the arrest of Frederick H. Fall, late an employe of the Department, Arthur Payne and Thomas R. Foote, go-betweens in the attempt to bribe Juror Brown, and Frederick Shaw, one of the original panel in the Star Route case, charged with corruptly approaching Juror Doniphan.

The Committee of Ways and Means of the House of Representatives will meet in Washington November 20th, to assign to the subcommittees all subjects having reference to tariff. It is expected by that time the Tariff. Commission will have submitted a partial report.

Premotions in the army, consequent upon the retirement of Maj. Gen. Irwin McDowell, have been announced by the President, as follows: Brig. Gen. John A. Pope to be Major General, and Col. Reinold S. Mackenzie of the Fourth Cayalry, to be Brigadier General.

Both promotions take effect immediately.

The Presdent has appointed Wm. S. Smith, of New York, Edward Kinsley, of Massachusetts, and Dwight K. Tripp, of Rhode Island, a Commission to examine and report upon 250 miles of road constructed by the Atlantic and Pacific Railroad Company in the Indian Terri-

tory and Arizona. A. B. Mullett, at one time Supervising Architect of the Treasury, but whose connec tion with that department has not been recognized since 1877, formally tendered his resignation a few days ago as Superintendent of Construction for Public Buildings in St. Louis and other cities. His action is regarded as a preliminary step in asserting a claim compensation from 1877 to the date of his formal

An explosion of fireworks in the park at Philadelphia at the William Penn Anniversary celebration resulted in the death of eight persons, and a large number wounded, six of whom it was thought would die. The killed were Mrs. Mary Ann Coakley, aged thirty; John Conning, aged seventy-five; Isabella Scudder, (colored) aged twenty-nine: Howard Scudder, aged three; Ulysses Thompson, (colored) aged nineteen; Dorothia L. Modier, aged seven. William Summers, aged thirteen, died from heart disease.

Wm. V, Brown, assistant book-keeper of the Poughkeepsie (N. Y.) National Bank, who pleaded guilty to making false entries in the books and defrauding the institution of many thousands of dollars, has been sentenced to five years' imprisonment.

J.C. Tiffany, formerly Indian agent in Arizona, was arrested in New York, charged with conspiracy to defraud the Government of upwards of \$6,000, embezzlement and perjury. Tiffany says he resigned his position last July and has been engaged in the steel business in that city since April last. He said he had heard of five indictments, but did not think they would ever be presented, as it would not do for him to tell of some things that he knew. He was admitted to bail.

## KANSAS STATE NEWS.




