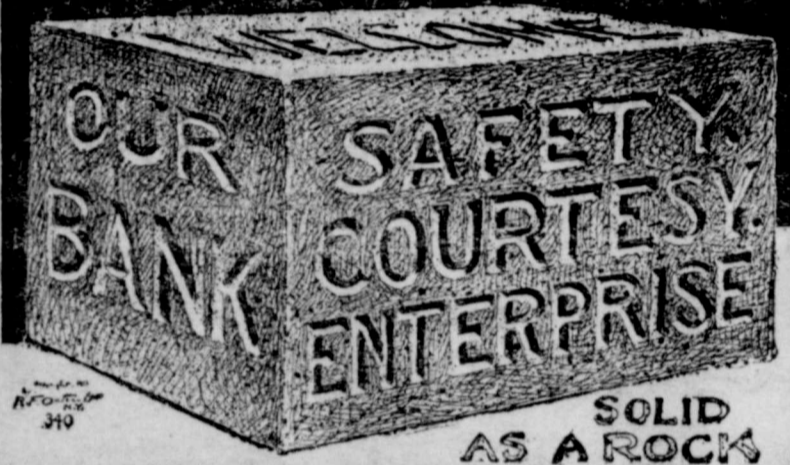

SECURE COTTON PICKERS

**Help Will Be Needed To Gather
The Bumper Crop**

If the present bright prospects for a bumper cotton crop continue, and no disaster befalls the crop, the yield is going to eclipse anything ever heard of in Mills county. And taking into consideration the splendid price the present outlook promises for both cotton and seed, it will be folly to let a pound go to waste. With the present scarcity of help to gather the crops of all kinds we have been so abundantly blessed with this year, and the great volume of work to be done, it will be well to look ahead to see if you are going to need pickers this season. If so, see that you and your neighbors get together at your local school houses or some other convenient place, decide how many pickers your community can use and if you are willing to co-operate with other communities in the county in sending someone to locate, and bring in this help, send a representative to Goldthwaite for a meeting that will be held in the court house on Thursday, September 4, at 3 p. m., to work out plans towards securing the help needed. It is very important that this matter have attention at once from the fact that this help will soon be needed. Do not overlook this matter and I would suggest you have a meeting not later than Wednesday, September 3.

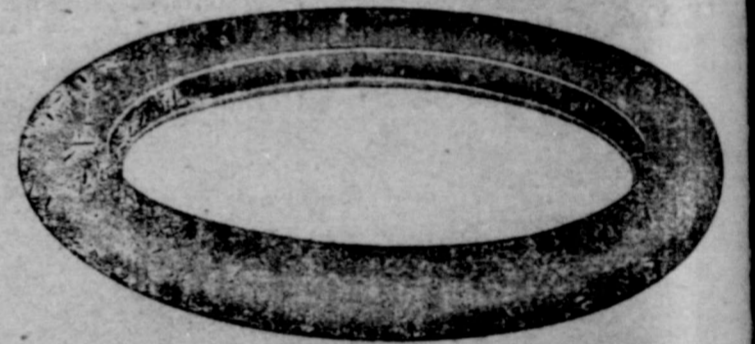
Riley Lee's little son, Doc, had the misfortune to break his arm. With usual proceedings will soon be all right.

Plaintiff alleges that on to-wit: the 1st day of July, A. D. 1919, he was and now is lawfully seized and possessed of the tract of land hereinafter described, holding the same in fee simple, and described as follows:

The south one-half (1-2) and the north west one-fourth (1-4) of the E. W. A BETTER DAY

A lot of this back-to-yesterday business is inspired by hatred of the new conditions which require study and work and adaptation. COUNTY SCHOOL BOARD

The county school board met with the district boards Monday and the meeting was continued over Tuesday. Rain and mud prevented a large attendance, but several matters of interest to schools came up for consideration.

There is a number of school districts desiring consolidation, but the new law makes it necessary for such consolidation to be submitted to the voters of the districts interested, whereas the county board formerly was charged with the responsible duty of making or rejecting such consolidations.

The state apportionment for schools will be \$7.50 per capita, but the county and special tax apportionment can not be made until the tax rolls are approved.

SOUTHERNERS PLAN RECONSTRUCTION

IN EUROPE—WORK IS TO BE OPENED IN BELGIUM AT ONCE.

Commission Abroad To Study the Situation.—Extensive Program is Planned—Church Busy in Other Lands.

Nashville, Tenn. (Special Correspondence.)—On August 29th a commission composed of Bishop James Atkins, of North Carolina, John R. Pepper, of Tennessee, Dr. Bella H. Bennett, of Kentucky, and Mrs. Luke G. Johnson, of Georgia, sails for Europe to arrange for the opening of extensive religious and philanthropic work in Belgium, France and other war-torn countries.

They represent the Centenary Commission and the Board of Missions of the Methodist Episcopal Church, South, which have set aside \$5,000,000 of Centenary funds for religious reconstruction in Europe.

They go with authority to purchase property and open work at once in Belgium and to make a careful survey of the needs in other countries and recommend an adequate program. Orphanages, schools, social centers, religious literature and direct evangelism will be the methods employed.

In some of the countries to be entered the work will be conducted in co-operation with the Methodist Episcopal Church, which is already operating in France, Italy and the Balkans, and is planning to expand its work greatly as a result of the Centenary, which in the two churches brought missionary pledges aggregating more than \$150,000,000.

JAPAN TO MODIFY KOREAN RULE.

So Predicts Dr. S. E. Hager, 25 Years a Southern Methodist Missionary in The Orient.

Nashville, Tenn.—That Japan will moderate her rule in Korea is the prediction of Dr. S. T. Hager, recently returned missionary of the Methodist Episcopal Church, South. Dr. Hager has spent more than a quarter of a century in Japan doing religious work.

"Japan is learning that her success in giving good government to Korea is fraught with difficulties, and that tolerance and good will must take the place of harsh and severe methods.

"The military leaders aim mainly at making their rule thorough and permanent, and naturally there is great temptation to the man of the sword to make his rule severe.

"But democratic ideas are growing in Japan, and more temperate treatment of the subject race will come about."

Dr. Hager says the Christian missionaries in the Orient are elated at the success of the Centenary movement, through which the church raised \$53,000,000.00 for missionary work in all lands.

Millions of this will be spent in the Orient. Hundreds of new missionaries will be sent and there will be a great advance movement in medical work, education and evangelism.

A SHOT AT LONG RANGE

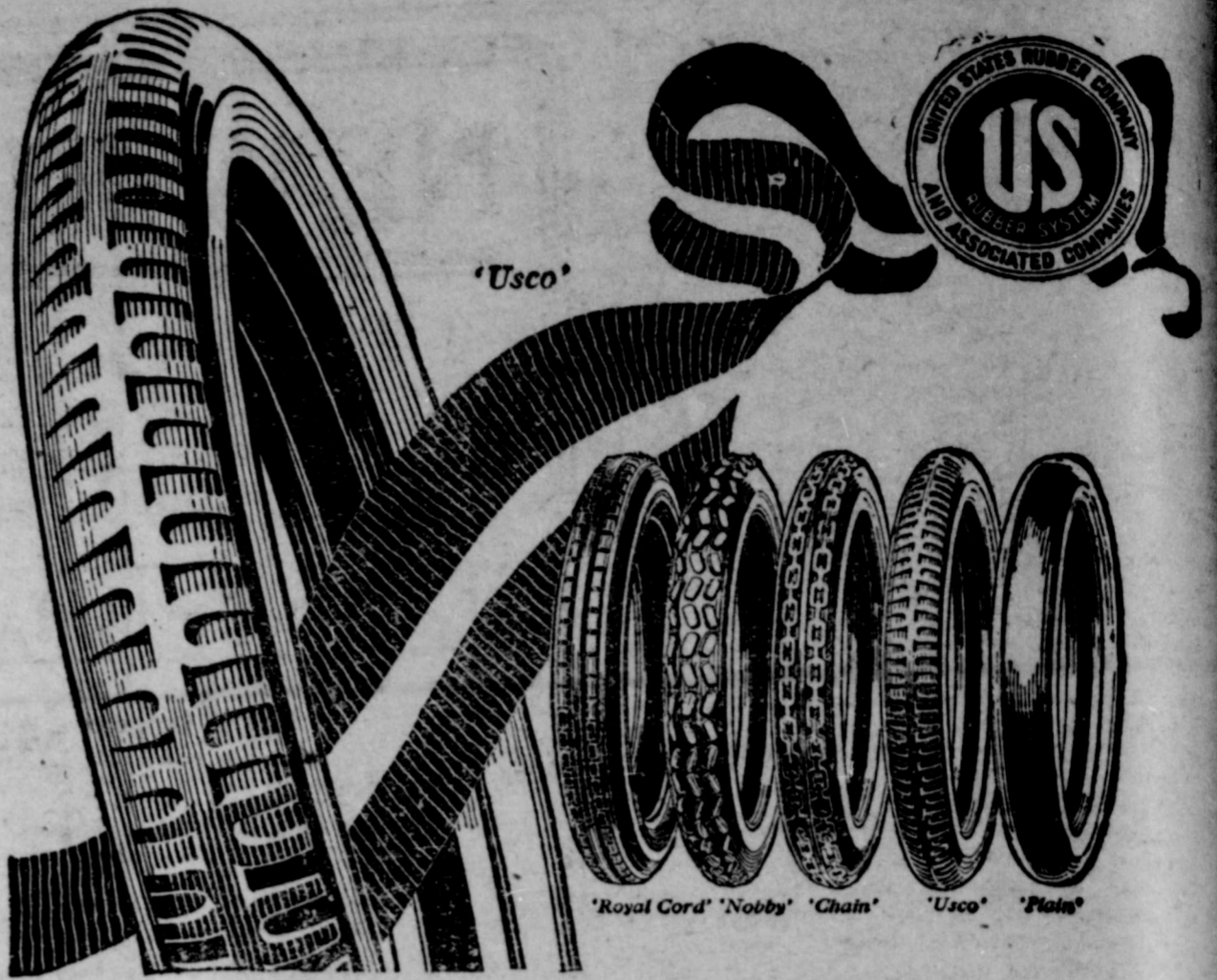
The young people and children may not comprehend the meaning of the heading of this article. Let me illustrate. Hunters frequently discover game so far away and for fear they can't get any closer they take a chance and shoot, both hoping and doubting as to results.

When we take into consideration the enormous cost to the human family of chewing tobacco, cigars, smoking tobacco, snuff and pipes and how men and women are wedded to these we are persuaded that a shot in that direction will be at long range, but as the hunter sometimes gets his game at long range, we will elevate our sights and take one shot at the filthy, unhealthy, expensive, profitless, often embarrassing, offensive and absolute uselessness of the tobacco habit. If we would excuse any it will be the old men and women who acquired the habit in the long ago, before the evils of same were agitated and when the great bulk of the tobacco used was the natural leaf as it came from the stalk. We have known some real old people who saw the evils of it and to set a good example before the rising generation they quit its use. If some quit, why not all?

Let that be as it may, we are convinced from actual experience, observation and testimony of many users of the weed that it is not only a filthy and useless habit, but wrong and if wrong, then without fear of successful contradiction, a sinful habit. If sinful and men persist in its use, why raise the question about drinking, dancing, 42, swimming and other questionable things members of the church indulge in?

What right has a minister of the gospel to go into the pulpit with the stench of an old pipe on his breath or the juice of tobacco in the corners of his mouth to tell others who are clean in that respect how to live, how to shun the pitfalls of the devil and set a commendable example before those with whom they mix and mingle? If this is consistency, then let us pull down the bars and all go out in the same big pasture of needless indulgences, pleasure seeking, etc. If it is wrong for a boy to smoke a cigarette, take a drink, dance and play cards because he loves these things and because he acquired the habit, how much less wrong is there in the older people and preachers chewing, smoking and dipping snuff? Recon- cile these and it will be thankfully received.

We were in a store only a few days since and a mother said she wanted some chewing tobacco for her boy and when asked how much, she said, "Oh, a dollar's worth. It will just last him a week." \$1.00 per week will amount to \$52.00 a year chewed up and spit out by one boy. What for? To gratify an appetite that does not add anything at all to the boy's growth, physical, moral, mental or religious condition. Can the preacher who uses tobacco consistently warn that boy against this extravagant, needless waste of money? If he can't, then are not his actions barriers in the way of his members in trying to warn boys of the evils of tobacco? Will the boys not meet their arguments with the fact that the preacher, the called of God, smokes and chews and never says anything about it being wrong? We have never heard a preacher who uses tobacco say one word against its use from the pulpit and yet approach them out of the pulpit and they will invariably admit that it is a filthy habit and a curse to the human family. Preachers as a rule put great stress on money raising for the church whether tobacco users or not (and this is not objectionable) but what about the preachers who use tobacco and all their crowd of chewers, smokers and dippers spending more money to gratify their appetites than all the world pays into the church to push forward the kingdom of our Christ in the salvation of a lost world? We are not fishing for a con-

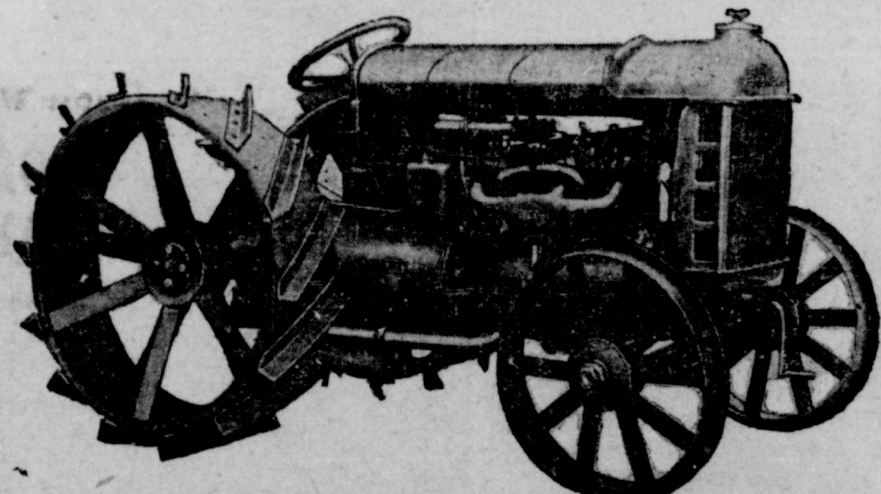

X brs S. 84 1-2 W. 18 1-2 vrs.; thence S. 88 1-2 W. 1306 vrs to a cottonwood mkd. X W. bank of river for corner a burr-oak mkd. X. brs. N. 71 E. 27 vrs. a pecan mkd. X brs. S. 18 E. 25 vrs.; thence down said river with its meanders, course S. 25 E. 1200 vrs. to beginning. That on the day and beginning last aforesaid defendants unlawfully entered upon said premises and ejected plaintiff therefrom and unlawfully withheld from him the possession thereof to his damage in the sum of \$5000.00.

BAPTISTS LAUNCH WORLD PROGRAM

PLAN TO RAISE \$75,000,000 FOR GENERAL PURPOSES WITHIN NEXT FIVE YEARS.

WHOLE SOUTH TO CO-OPERATE

Each State is Given Definite Task To Perform in Raising Huge Sum For Denomination's New Budget—Drive Is On.

Recognizing the need of the world for more religion and christian service along general lines, the Baptists of the South have resolved to contribute \$75,000,000 to a program of reconstruction following the war, and have laid plans to subscribe this sum during the week of November 30-December 7, a period of five years to be given in which to complete the payment of these subscriptions.

The decision to inaugurate this world program was reached at the meeting of the Southern Baptist Convention in Atlanta last May, when the more than 4,000 delegates present voted unanimously to undertake the

The campaign has now been organized with the general headquarters in Nashville, Tenn., where Dr. L. R. Scarborough, president of the Southwestern Baptist Theological Seminary at Fort Worth, is in charge as general director for the South. He is assisted by a number of men in charge of special divisions of the work, while each of the eighteen states in the territory of the Southern Baptist Convention has in turn perfected a state organization, including a State Director, a State Organizer and State Publicity Director. Each association, or district, within each of the states has likewise gotten busy by naming its associational or district directors, and the work of organization has been carried into the local churches to the extent that practically all of the more than 25,000 local Baptist congregations in the South have their workers named to help put over the biggest church drive that has ever been attempted in this section of the country. There are 3,000,000 white Baptists holding church membership in the South, and it is hoped to reach every man, woman and child among them with the message of this campaign and give each of them a part in the plan of saving the world by giving to the extent of their ability to this vast conservation fund.

Christian education, home and foreign missions, state missions, ministerial relief, orphanages and hospitals, are among the various general interests of the denomination that will be cared for in this campaign, the matter of local church expenses, and local church equipment not being included.

Between now and November 30th every effort will be put forth in organizing and mobilizing the Baptist forces in the South, preparatory to the launching of the big drive for the subscriptions and cash payments. July was known as preparation month, August was designated as information month, during which time every effort has been put forth in informing the people on every phase of the campaign, while September has been designated as intercession month, October as enlistment month, November as stewardship month, and the period from November 30 to December 7 as victory week.

"We have undertaken a big task," Dr. Scarborough, the General Director, says, "but we have undertaken it in God's name and for His glory, and by trusting in God and doing our whole duty, we will succeed. There is work here for all, and glory enough for all if we win, but we cannot succeed except we labor diligently and pray earnestly."

KINDERGARTEN DEPARTMENT

By the United States Bureau of Education, Washington, D. C., and the National Kindergarten Association.

We are all aware that for some years past there has been an ever-increasing demand among educators for a better understanding of things from the things themselves by actual experience, instead of merely through book knowledge.

Songs and stories about nature for instance, though they are very necessary and a very beautiful part of work with children, are not nature-study, but merely a means of emphasizing the things which have been observed by the child, and of aiding him to express his thoughts of these things in simple, beautiful language, motion and rhythm. Each new song or story about the object under observation is the opening of a new door into the world of nature and should lead to fresh observations.

There is nothing more dead to a child than a preserved specimen. Nature-study deals with life and life appeals to the vitality in the child. If a specimen is used, be sure it is a live one or a good picture (the preserved specimen should be the result of the lesson, not the basis of it).

We live in a world of living nature. What do we know of the grass under our feet, the trees of the forest and plain, the insects whose apartment houses fill the dead twigs, the birds which nest in the woods and fill the world with music, the stars overhead, clouds, rain, hail, wind, mist, dew or the sun which shines over all? The study of nature has to do with living things, or things that are doing something. The stars are twinkling and making light, the snow flakes are falling, making patterns and bringing us messages from fairyland. The birds are hopping, flying, singing, building nests, laying eggs and feeding their young. The worms are crawling and ploughing the ground and so helping to make things grow. Pussy is our pet; she is good company and will play with us and purr when happy. The dog is our friend; he guards the house at night and will run, jump and do tricks for us, bark, growl, howl and scratch. His body must be made strong so he can chase away his enemies or ours, jump for his food, bark for joy, growl when danger is near and scratch to dig holes in which to bury his bones. Why is his nose so pointed and why are his eyes so far back? Where does he live? How many legs, ears and eyes has he?

The fruit, vegetables and flowers are all growing and varicolored. The fruit and vegetables are good to eat and help us grow. The flowers are fragrant and beautiful. Nature-study will help the child to make simple, truthful observations upon the things about him to appreciate the beautiful in them and to express his thoughts in his various activities. NEW GAME LAW

The legislature passed a new game law at the regular session last winter. That law was made to conform to the federal law. Therefore, under both federal and state laws, the open season for doves commences Sept. 1 and continues to the 15th day of December. There are no zones in the state law hence this open season applies to the whole state. The bag limit for doves under both laws is 15 birds.

The open season for ducks, geese, brants and snipes commences October 16 and continues until January 31, and the bag limit for ducks is 25 and the bag limit for geese and brants is limited to 8.

The state and federal authorities are working together under an arrangement made by them and the state warden may report a lawbreaker to the federal authorities and the federal warden may turn the lawbreaker over to the state authorities.

Under the new state law, all persons hunting beyond the limits of the counties of their residence must pay a hunting tax of \$2. The licenses for hunting beyond one's county can be procured from the County Clerk.

People who expect to hunt beyond their county should get their licenses so they may avoid trouble, for the law requires hunters to carry such licenses and wardens to call on such hunters for them. A refusal or failure to show them is punishable.

FREE TEXT BOOKS

There will be no such thing as the children rushing to the stores to get textbooks when school opens next month as they have done so many years. This year no books will be sold, for the reason that the free text book law is now in operation and the state will furnish the books. The country has had free schools for little more than half a century and now we are going further toward education by furnishing free textbooks. To meet the expense of furnishing books the people of the state will pay a tax of 15c on each \$100 worth of property. Under this plan the bachelor and all who have property, but no children, will assist in the purchase of books, while the man with a dozen children and no taxable property will see books furnished his children without cost to him. Some communities are in danger of losing free books because of the trustees having failed to execute the bond required by the state. Where this bond has not been made it should be made at once or children will get no books. Public school pupils may purchase text books at regular prices if they prefer, or may exchange books on hand which they have used or turn them into the state at the regular exchange price.—Clarksville Times.
