CHURCH CAMPAIGN

Under the leadership of J. W. Gates of Coleman, as district chairman, plans and preparations for raising the San Angelo district's quota of the \$350,000 Christian Church Campaign, are going forward very rapidly. Following the conference in Brownwood last week, of members of the executive committee at large of the campaign and district leaders, Mr. Gates, who is a member of the executive committee at large of the campaign, assumed the responsibility for the success of the money raising movement in the nineteen counties of the San Angelo district, and is rapidly building up an organization that will reach every Christian Church in the counties assigned to him. Mr. Gates is not only one of the leading churchmen of the section but a progressive business man, and will apply the same business methods to this campaign that have made him one of the most successful and prominent business men of this section. Other members of the executive committee at large in the tenth district are: Millard Patterson, El Paso, L. C. Brite, Marfa; J. D. Jackson, Alpine, and Scott H. Maek, Ballinger.

Although the campaign will not be definitely launched until November 16, S. J. McFarland, chairman of the campaign, has announced that many churches in the state have already reported that they have raised their quotas. Sunday, November 16, has been set aside as "Campaign Day" and while ten days have been allotted this campaign, Chairman McFarland has expressed the belief that the entire fund will be in hand at the close of the opening day.

The county draft board met Monday to formulate plans for launching the campaign to raise funds to build a hospital at Carlsbad for the care of the soldiers who contracted tuberculosis during the war or as a result of the exposure and hardships. The campaign was ordered for the present month, but owing to the bad condition of the roads and the further fact that but few of the schools of the county have begun, it was thought best by the board to delay the opening of the campaign until Dec. 14 to Dec. 24.

WHY TAKE THE RISK?

Aside from any sentimental reasons, apart from any motives sociological or economic, removed from any sense of duty that we owe the world at large, there is the supreme consideration of giving our children both superior health and superior opportunity, that should keep us fortunate farmers anchored to the farm. We might be able to surrender our activities in the development of prize livestock or blue-ribbon white-dent corn and justify ourselves in entering upon a snug retirement; but it is obviously impossible that we could ever appease our consciences were we to take our human sweep-stakes winners to the foible show of the city and see lost any of that wonderful vitality bequeathed them by the great outdoors. Why take the risk? —Farm and Ranch.

A LONG LIFE

Professor Yves Delage read a paper in Paris this week before the Academy of Science in which he stated that certain microbes apparently live indefinitely. Regarding microbes centuries old he said: "Time no more than heat seem to have had effect on these little organisms. These microbes are still capable of cultivation and of movement. More than that Dr. Galipe has found in fragments of paper of Chinese manuscript dating before the age of printing, micro-organisms still living and able to move and that multiplied under suitable methods of culture."

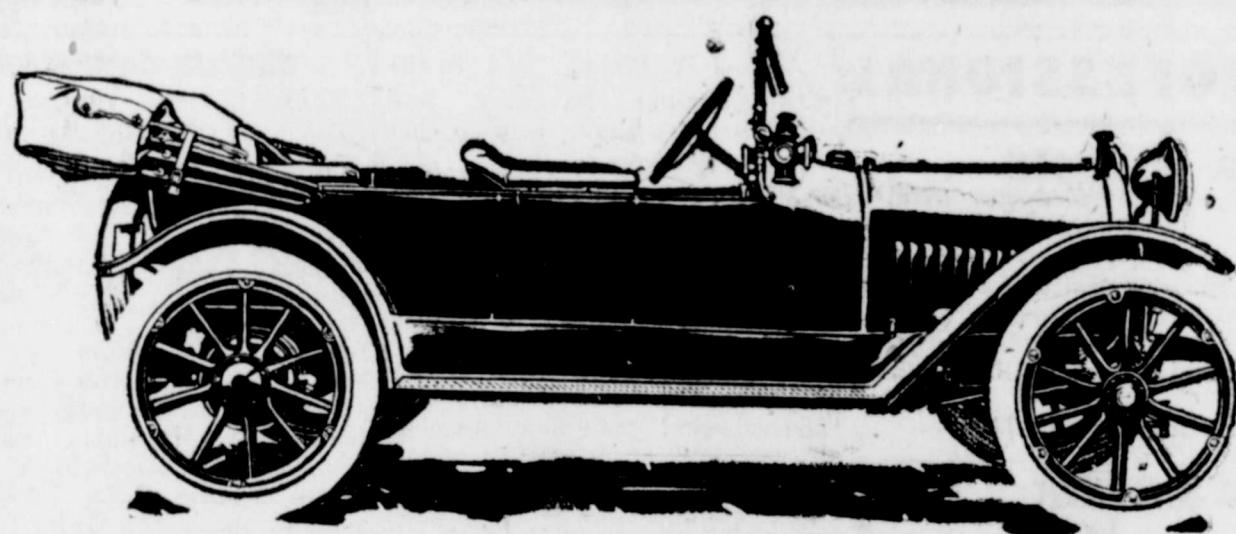

Roll Call Director Prather has been urged from many sections to allow an extension of time owing to the inability of teams in many places to get out into the country.

The order of the federal court at Indianapolis to the leaders of the coal miners to rescind the strike order before Tuesday night was obeyed in time to prevent an unpleasant situation. This action on the part of the union officials has a far-reaching effect and is of momentous consequence.

Revenues received by the state highway department from the auto tax in Texas—minus the proportion retained by the counties—will amount to \$1,350,000 for 1919, and it is estimated that the amount to be collected in 1920 will reach \$1,750,000. These estimates were made by the department for the federal bureau of roads in Washington. A considerable portion of these funds will be used for the operation of the department for the next two years.

The feeling has been welling up in the minds of the people of Texas for a number of years that the gubernatorial pardoning power has come to be exercised with a laxity which violates the spirit of the law conferring it. There have been numerous instances to suggest that those considerations which the law contemplates shall govern in the exercise of this power have been subordinated to others which it was never intended should be taken into account, with the result that an executive function that was designed to subserve the public welfare has been made into an instrument for the subversion of it.—Dallas News.

A booklet containing the numbers of motor seals allotted to each county and the schedule of 1920 vehicle fees is being mailed by the state highway department to every peace officer in Texas. The law requires that a numerical index of those obtaining motor seals be published annually, but it has been found impossible to publish this until too late in the year to be of service. The booklet now sent out tells the block of numbers allotted to each county and the county tax collector will be able from his records to tell who is the owner of any seal issued by him. The new seals are numbered in large figures and the record kept of these numbers and their owners is expected to net the state a large amount of money that has heretofore been lost.

The discovery of a shortage of 151,514,476 pesos in the accounts of the comptroller's office in Mexico for the year 1918 has created a sensation in the Mexican capital, said advices reaching Washington. The comptroller's report, which has just been made public in Mexico City, announces the shortage under the head of "funds unaccounted for," which covers sums owed by all those handling government funds, specifying embezzlements and failure to supply proper vouchers for expenditures. No trace can be found of this sum, which in American gold would be more than \$75,000,000, the report says, since no vouchers or documents of any kind showing authorization for the disbursements are in existence. The newspapers of the Mexican capital, the advices state, are attacking the government for the laxity which has made possible this shortage. The Universal is quoted as saying that there is no record of any defaulting paymaster having been arrested or made to turn back to the government any money. The Excelsior, under the heading, "The Death Dance of Millions," is quoted as saying that official silence and the lack of any satisfactory statistics "prevent us gauging at all accurately how deep the wounds are which the last ten years of revolutionary upheaval have caused on the public body."

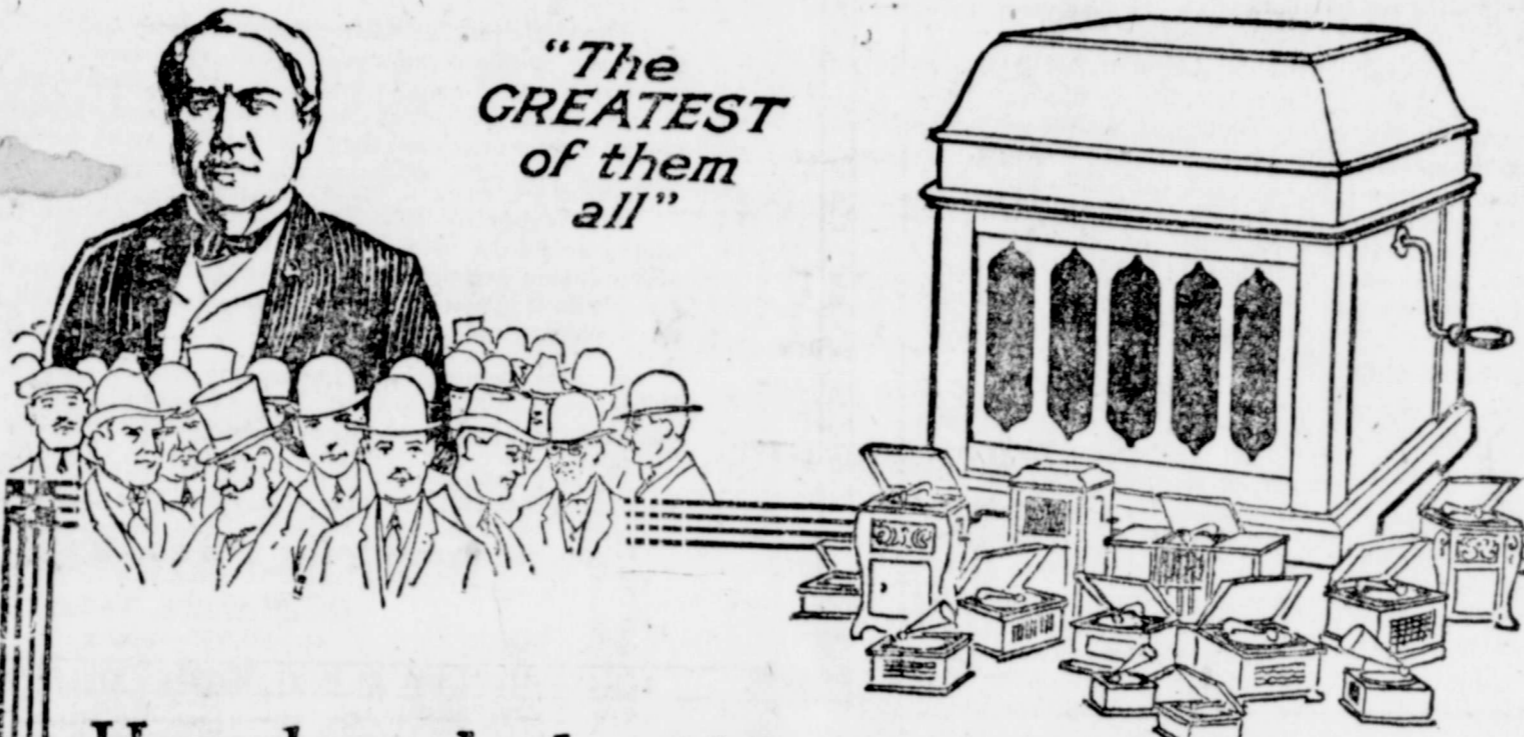

According to market quotations this week silver dollars are worth more as silver than they are as money, the price by weight being \$1.30 and more.

By a vote of 309 to 1 the house of representatives at Washington this week excluded Victor Burger, congressman from Milwaukee, because of his unpatriotic attitude and utterances during the war.

In his charge to the federal grand jury at Fort Worth Monday Judge Wilson laid special stress on investigating the misuse of mails and defrauding the government by affidavits claiming dependencies upon soldiers. If the grand jury makes a thorough investigation it is likely that something may be started.

In accordance with the custom President Wilson has issued a thanksgiving proclamation, calling on the people to observe the last Thursday in this month, which will be Nov. 27, as Thanksgiving day. Governor Hobby and the governors of the other states have issued proclamations in conformity with that of the president.

Announcement is made from Washington that arrangements are being made by the department of agriculture by which cotton growers and others interested in the price of cotton can be advised of the price paid at the various primary markets. Several important points are named from which these prices will be sent out and Dallas is named as the Texas city to furnish the quotations.

A company has been formed at Amarillo to publish a new daily paper, which will make its appearance the first of the new year. The capital is \$100,000, all paid in. Eugene Thompson, who was at one time an employe of the Eagle and has been a traveling salesman for the Southwestern Paper company for a number of years, has been made business manager for the new paper at a fine salary. Another Mills county boy has made good.

If advice to do your Christmas shopping early was ever timely and ever should have been heeded, surely the present year the warning comes with double force. In almost every line of trade help is hard to get and most mercantile establishments as well as other enterprises are running short handed. It is, therefore, necessary that the trade for the holidays be divided into as many days as possible. The dealers and their assistants will naturally give as prompt and rapid service as possible whenever a customer appears, but those who take advantage of the intervening time between this and the holidays will be surest of securing what they want, while the belated shoppers will take what they can get.

Labor unions are fast losing standing with the public, for the principle of anarchy which has actuated them in the past few years indicates their objects were strictly selfish all the while, without regard to the welfare of the nation, much less that of their fellow men. The railroad brotherhoods first "spilled the beans" when they threatened to tie up transportation facilities when the nation was in war with Germany unless they were paid unreasonable wages. On and on have these unions gone until it seems the limit was reached in the demand of the coal miners for 60 per cent increase in wages, a six hour day and a five day week. The federation of unions at once announced approval of the demands and threatened a sympathetic strike to tie up every industry in the country if the demands were not met.

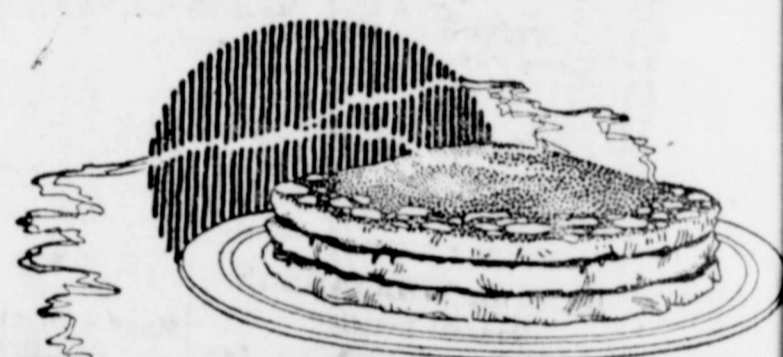

THE SOUTHERN STATES HAVE ADOPTED THE 56" AUTO TRACK WAGON

The price of cotton is sensationally high. This condition was not brought about by legislation, stabilization, organization, intimidation or insubordination. It was brought about by a short crop in succession to two preceding short crops. A further bullish influence is in the form of exhausted cotton stocks in the spinning centers and the raggedy condition of half the world. Until supply catches up with demand the price of cotton is bound to remain high. Perhaps it can't remain as high as at present through another crop year, for undoubtedly there is now a strong speculative influence at work. It is possible indeed that a slump is due before or soon after Christmas. We recall how ugly cotton acted last winter, when it declined ten cents a pound in the face of all the expectations growing out of the armistice and the subsequent good feeling. Labor difficulties probably will remain with us for quite a spell yet, as there are still some strikes in the making and the strike bacillus is still rampant. Continuation of industrial warfare will eventually be reflected in the price of such raw material as cotton. Cotton is of no great intrinsic value when it can't be shipped or spun into cloth. At any rate, this is not a time for a holding movement. Prices like the present afford the growers a lot of money for a little cotton. No bonanza lasts long, not even an oil gusher.—Dallas News.

We may not be able to compel other people to produce more, but we can make ourselves consume less. That is one way, and not an ineffectual way, of meeting a short market and boosted prices. A good deal of this profiteering is due to unnecessary extravagance. A good deal of it is attributable to unnecessary consumption. Production and consumption, even with regard to the essentials of life, are relative. There comes a time, of course, when no more can be produced, or no less be consumed, without suffering. We have not reached that time in this country. Much more could be produced, and much less could be consumed, without any impairment of health or happiness. Production is largely the other fellow's business, but consumption is largely our own.—Houston Chronicle.

ANIMALS AS HARVESTERS

Crops that may or must be
harvested by livestock save labor
at gathering time, and as a rule,
do not deteriorate so rapidly in
disagreeable weather as crops that
must be sold on the market. If
the rains come and the floods
descend, as they have in many
instances and most localities this
year, hogs, sheep and cattle may
defer harvesting or may con-
tinue harvesting, as the farmer's
judgment may decree.

It is manifestly more conven-
ient to shelter livestock in bad
weather than crops when the
crops are in the field. For a
similar reason marketing live-
stock is often more economical
than marketing crops.

The weather, as unfavorable as
it has been recently for gathering
crops, has not been disastrous or
even very detrimental, to the far-
mer who grazed a large portion
of his land in fields and pastures,
who has not depended upon fair
weather for picking cotton, pull-
ing corn or piling peanuts. Live-
stock are economical harvesters
on some farms and always relieve
labor for other purposes.—Farm
and Ranch.

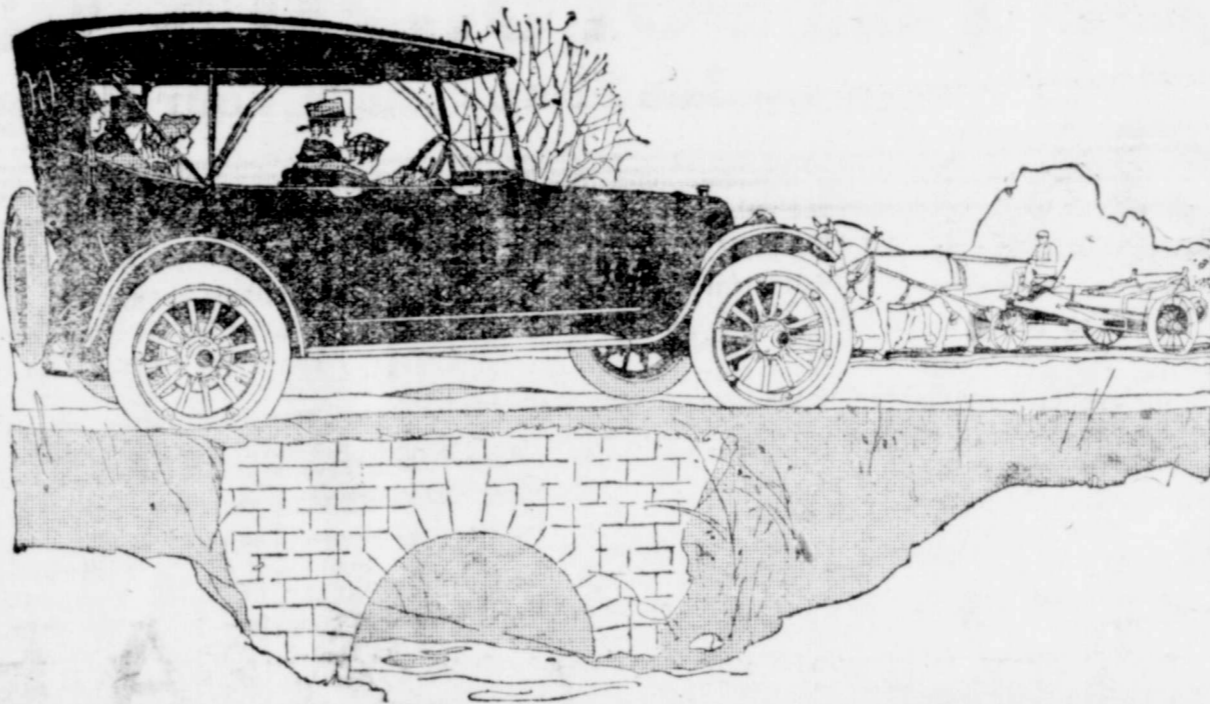

Referring to the fact that many people are taking advantage of the economic conditions growing out of the war to exact larger profits than heretofore and are attempting to justify such action by the statement that "everybody was doing it," Mr. Palmer, United States attorney general, said: "That kind of a man is one kind or another of a profiteer and he is, in my judgment, the most despicable scamp that can live in any community in this emergency. He ought to be rooted out and exposed to public scorn and if necessary confined in public prison. In the two months we have been engaged in the campaign to bring down the cost of living, prices have not gone up. If we can keep prices stationary for a time they will sag—they are bound to come down. If we can stop the movement of this vicious circle—increased wages, increased prices and increased cost of production chasing each other around like a dog chases his tail and hold the price steady—prices will drop."

Unless William C. Jenkins, American consular agent at Puebla, who was recently kidnapped by Mexican bandits and had to pay \$150,000 ransom for his liberty, can prove that there was negligence on the part of the Mexican authorities in the matter, he will have to pay his own ransom, an official announcement from the state department at Washington says. The fact that Jenkins was an official of the United States government has no bearing on the matter, the report stated. Americans in Mexico, it said, can expect no more and no different protection than is afforded to Mexicans under the Mexican law. The suggestion which has been made to the state department from certain sources to the effect that Americans in Mexico ought to be assured greater protection through diplomatic channels to offset the greater measure of protection granted to Mexicans by their courts will not be acted upon by the state department, a Washington official said Monday. The state department admitted, however, that the robbery of American and oil company paymasters "might be" different, as the paymasters are compelled to notify the authorities in advance of their route, time of departure and the amount of money carried.—News Letter.
