It is estimated that by placing the tax on the use of gasoline as well as the sale it will increase the revenue to the State from this source by at least 15 per cent, and collect the tax on as much as 850,000,000 gallons of gasoline in 1930, and this after allowing a deduction for ex- empting gasolize used in farm tractors and for other pur- pose.
