The debt statement shows the decrease of the public debt during July to be \$5,576,-053. Cash in the Treasury, \$198,890,405; gold certificates of deposit outstanding, \$15,535,000; legal tenders outstanding, \$346,-681,046; fractional currency outstanding, \$7,-205,710; refunding certificates outstanding, \$1,167,350. Debt less cash in treasury, \$1,-936,596,241 936,596,241.

The Comptroller of the Currency has declared a dividend of ten per cent in favor of the creditors of the First National Bank, Wichita, Kansas, making in all seventy per cent. The Comptroller of the Currency has just completed a table showing the losses charged off by National Banks for the six months ending March 1st, 1880. Total losses by all these hanks in that Banks for the six months ending March 1st, 1880. Total losses by all these banks in that period amounted to \$7,563,886. Losses for a corresponding period in 1879 were \$10,238,324. Of these losses during the last six months \$1,208,521 was on account of the depreciation in premium upon U. S. bonds held by banks, chiefly bonds which were shout to meture.

CANDIDATE IN OFFICE.

How the Republicans Have Changed their Minds Since Grant's Day.

Some of our esteemed Republican contemporaries are greatly shocked that a Major-General in the army should be the candidate of a political party for the Presidency of the United States. Paricularly, and still more, they are shocked that a Major-General should receive deputations in a house which he occupies only officially and which belongs to the people of the United States. LETTERS OF ACCEPTANCE.

Gen. Hancock and Mr. English Define Their Position,

New York, July 30.—The following is Gen. Hancock's letter of acceptance: GOVERNOR'S ISLAND, New York City, July

29, 1880, GENTLEMEN-I have the honor to acknowledge the receipt of your letter of July 13th, 1880, apprising me formally of my nomination to the office of President of the United States, by the National Democratic Convention, lately assembled in Cincinnati. I accept the nomination with grateful appreciation of the confidence reposed in me, The principles enunciated by the convention are those I have cherished in the past and shall endeavor to maintain in the future. The Thirteenth, Fourteenth and Fifteenth The Thirteenth, Fourteenth and Fifteenth Amendments to the Constitution of the United States, embodying the results of the war for 'the Union are inviolable. If called to the Presidency I should deem it my duty to resist with all my power any attempt to impair or evade the full force and effect of the Constitution, which in every article, section and amendment is the supreme law of the land. The Constitution forms the basis of the Government of the United States. of the land. The Constitution forms the basis of the Government of the United States. The power granted by it to legislative, executive and judicial departments define and limit the authority of the general Government. Powers not delegated to us by the Constitution, nor prohibited by it to the States belong to the States respectively or to the people. The general and State Governments, each acting as its own sphere without trenching upon the lawful jurisdiction of each other, constitute the Union. This union comprising a general Government with general powers, and State Government with State powers, for purposes local to States, is a polity, the foundations of which were laid in the profoundest wisdom. This is the Union our fathers made, and which has been so respected abroad and

and which has been so respected abroad and so benificent at home. Tried by blood and fire it stands to-day a model form of free, popular Government, a political system which, rightly administered, has been and will continue to be the admiration of the

every hazard to preserve.

But no form of government, however carefully devised, no principles, however sound, will protect the rights of the people unless the administration is faithful and efficient. It is a vital principle in our system that neither fraud nor force must be allowed to subvert the rights of the people When fraud, violence or incompetence control, the noblest constitution and wisest laws are useless. The bayonet is not a fit instrument for collecting the votes of freeinstrument for collecting the votes of free-men. It is only by a full vote, free ballot and fair count that people can rule in fact, as required by the theory of our Gov-ernment. Take this foundation away, the whole structure falls. Public office is a trust, not a bounty bestowed on the holder. No incompetent or dishonest persons should over he outwised with it or, if appointed

ever be entrusted with it, or. if appointed, they should promptly be ejected. Our material interests, varied and progressive, demand our constant and united efforts. A sedulous and scrupulous care of the public credit, together with the wise and economical management of our governmental expenditures, should be maintained in or-der that labor may be lightly burdened and The time has come to enjoy the substantial benefits of reconciliation. As one people we have common interests: let us courage harmouy and generous rivalry among our own industries, which will revive our languishing merchant marine, extend our commerce with foreign nations, assist our merchants, manufacturers and producers to develop our vast natural re-sources and increase the prosperity and happiness of our people. If elected I shall, with Divine favor, labor with what ability I possess to discharge my duties with fidelity, according to my convictions. I shall take care to protect and defend the Union and to see that the laws be faithfully and equally executed in all parts of the country alike. I will assume responsibility, fully sensible of the fact that to administer rightly the functions of the Government is to discharge the most sacred duty that can devolve upon an American citizen. I have worked like a Turk (presume that means hard work) in the country, in making fences, cutting down trees, repairing buildings, etc., and am at least able to say that St. Louis is the coldest place in the winter, and it is the hottest in the summer of any that I have encouns tered in a temperate zone. I have encounk tered in a temperate zone. I have known St. Louis, in December to have genial weather throughout the month. This December has been frigid and the river has been frozen more solid than I have ever known the

When I heard the rumor that I was ordered to the Pacific coast, I thought it probably true, considering the past discussion on that subject. The possibilities seemed to point that way. Had it been true I should of course, have presented no complaint, nor made resistance of any kind; I would have gone quickly if not prepared to go promptly. I certainly would have been relieved from the responsibilities and anxieties concerning Presidential matters, which may fall to those near the throne or in authority within the next four months, as well as from other incidents or matters which would not control action, concerning which would not control action, concerning which I might not approve: I was not exactly prepared to go to the Pacific, however, and I therefore, felt relieved when I recived your note informing me that there was no truth in the rumors. Then I did not wish to appear to be escaping from the responsibilities and possible dangers, which may cluster and possible dangers, which may cluster around military commanders in the East, especially in the critical period tast ap-proaching. All is well that ends well. The whole matter of the Presidency seems to me to be simple, and to admit of a peace-ful solution. The machinery of such a contingency as threatens to present itself has been all carefully prepared. It only requires lubrication owing to disuse. The army should have nothing to do with the election or inauguration of Presidents. The people elect the President, the Congress de-clares in a joint session who he is. We of the army have to only obey his mandates, and are protected in so doing only so far as they may be lawful. Our commissions exthey may be lawful. Our commissions express that. I like Jefferson's way of inauguration; it suits our system. He rode alone on horseback to the Capital, (I fear it was the "old Capital,") tied his horse to a rail fence, entered and was duly sworn; then rode to the Executive Mansion and took possession. He inaugurated himself simply by taking the oath of office. There is no other legal manner in our system. The people or politicians may institute parades in honor of the event, and public officials may add to the pageant by assembling troops and banners, but all that only comes properly after the inauguration not before, and it is not a part of it. Our system does not it is not a part of it. Our system does not provide that one President should inauguprovide that one President should inaugurate another. There might be danger in that, and it was studiously left out of the charter. But you are placed in an exceptionally important position in connection with coming events. The Capitol is my jurisdiction also, but I am a subordinate and not on the spot, and if I were so you also would be my enverging authority for there is be my superior in authority, for there is the station of the General-in-Chief. On the principle that a regularly elected President's term of office expires with the 3d of March (of which I have not the slightest doubt, and which the laws bearing on the subject informally recogni ing on the subject informally recognize), and in consideration of the possibility that the lawfully elected President may not appear until the 5th of March, a great deal of responsibility may necessarily fall upon you. You hold over; you will have power and prestige to support you. The Secretary of War, too, probably holds over; but if no President appears he may not be able to President appears, he may not be able to exercise his functions in the name of a President, for his proper acts are those of a known superior, a lawful President. You act on your own responsibility and by virtue of a commission, only restricted by the law of the land. The Secretary of War is the mouthpiece of a President; you are not. If neither candidate has a constitutional majority of the Electoral College, or if the Senate and House on the occasion of the count, do not unite in declaring some persons legally elected by the people, there is a lawful machine already provided to meet that contingency, and decide the question peacefully. It has not been recently used, no occasion presenting itself, but our forefathers provided it. It has been exercised and has been recognized and submitted to as lawful on every hand. That machinery would probably elect Mr. Tilden President and Mr. on every hand.

In probably elect Mr. Tilden President and Mr. Wheeler Vice President. That would be right enough, for the law provides that in a tailure to do so by the people the House shall immediately elect the President and the Senate the Vice President. Some tribunal must decide whether the people have duly elected a President. I presume, of course, that is in the joint affirmative action of the Senate and House, or why are they present to witness the count if not to see that it is fair and just? If a failure to agree arises between the two bodies there can be no lawful affirmative decision that the people have elected a President, and the House must then proceed to act, not the Senate. must then proceed to act, not the Senate The Senate elects Vice Presidents, not Presi dents. Doubtless in case of failure by the House to elect a President by the 4th of March the President of the Senate (if there be one) would be the legitimate person to exercise Presidential authority for the time being or until the apprepance of a lawful being, or until the appearance of a lawful President, or for the time laid down in the President, or for the time laid down in the Constitution. Such a course would be peaceful, and, I have a firm belief, lawful. I have no doubt Gov. Hayes would make an excellent President. I have met him and know of him for a brief period, He served under my command, but as the matter stands I can't see any likelihood of his being duly declared elected by the people, unless the Senate and House come to be in accord as to that fact, and the House would accord as to that fact, and the House would of course not otherwise elect him. What the people want is a peaceful determination of this matter, as fair a determination as possi-ble, and a lawful one. No other determina-tion could stand to them. The country, if not plunged into revolution, would become poorer day by day, business would languish and our bonds would come home to find a and our bonds would come home to find a dispirited market. I was not in favor of the military in South Carolina recently, and if Gen. Ruger had telegraphed io me, or asked for advice, I would have advised him not, under any circumstances, to allow himself or his troops to determine who were the lawful members of a State Legislature. I could not have given him better advice than to refer him to the special message of the

He desires, too, to be free to act, as he had the eventual greater responsibility, and so the matter was governed as between him and myself. As I have been writing thus freely to you, I may still further unbosom myself by stating that I have not thought it lawful or wise to use Federal troops in such matters as have transpired cost of the Missessipni within the last few troops in such matters as have transpired east of the Missssippi within the last few months, save so far as they may be brought into action under the article of the constitu-tion, which contemplates meeting armed resistance or invasion of a State, more pow-erful than the State authorities can subdue by the ordinary processes, and then only when requested by the Legislature, or if it could not be convened in session by the Governor, and when the President of the United States intervened in that manner it is a state of war, not peace. Yet the superior officers of the army are so year yedged in such a great crisis and are held. regarded in such a great crisis and are held to such responsibility, especially those at or near the head of it, that it is necessary on such momentous occasions to dare to determine for themselves what is lawful and what is not lawful under our system if the military authorities should be invoked, as might possibly be the case in such exceptional times upon a subject where such exceptional times upon a subject where existed such divergent views as to the correct result. The army will suffer from its past action if it has acted wrongfully. Our regular army has little hold upon the affections of the people of to-day, and its superior officers should certainly, as far as lies in their power, legally and with righteous intent aim to defend the right, which to us is the law and the institution, which they represent law and the institution which they represent. It is a well meaning institution, and


