

Our Postmaster Writes Message To All Patrons

Goldthwaite Postmaster Lucille Fairman broke out this week with a rash of exclamations as she announced new postal rates and took to writing headlines, which is one of the few things that Congress does not call upon Postmasters to do.

"Postal Cards!" was what Mrs. Fairman wrote first at the top of a sheet of imposing United States Post Office stationery. Then she wrote the following, which will not fit into any known Eagle headline:

"OLD PENNY postcard goes out with the Old Year 1951—NEW 2 cent postcard comes in with the New Year 1952."

After that fling, the Postmaster settled herself down and wrote the following for the information and edification of patrons of the Post Office. The next paragraphs are by Postmaster Fairman, including parenthetical remarks and what is known to the printing trade as 8 pt blk caps:

Effective January 1, 1952, the rate on postal cards was increased from 1c to 2c each with an additional charge of 10 percent of the value on purchases of 50 or more cards.

(This rate and the additional charge were fixed by an act of Congress and the Post Office Department has no authority to make any exception.)

Along with the increased rate on postal and postcards, is the increase from 1c to 2c an ounce on drop letters and other first-class matter mailed thru the post office boxes and general delivery window for local delivery where there is no city delivery service.

Special Service Fees affected are:

SPECIAL DELIVERY—which will jump from 15c to 20c on first-class letters and parcels under 2 pounds—and from 25c to 30c on second-, third-, and fourth-class matter.

RETURN RECEIPT CARDS
C. O. D. MAIL

Other effective dates for additional increases are:

APRIL 1, 1952—Second-class mail.

JULY 1, 1952—Third-class matter such as bulk-mailings by permit holders, and bulk-mailings of books and catalogs of 10 pages or more.

Mayor Long, Goldthwaite Lions Roll Out Red Carpet For Troops

During the past week and under the leadership of Mayor Loy Long and the Goldthwaite Lions Club, this city held out the hand of welcome to the Army and Air Force troops that during the next few weeks will be engaged in Exercise Longhorn—the most important and biggest-scale American military maneuvers to have been planned since the close of World War II.

Mayor Long gave assurance of "a hearty welcome" to Army and Air Force personnel and the Officers and Directors of the Goldthwaite Lions Club pledged "to do everything within our power to make every possible civil and civilian contribution toward the success of Exercise Longhorn."

President Ray Duren of the Goldthwaite Lions Club said that the officers and directors of the organization met on Friday afternoon of last week to unroll the red carpet of welcome to the Army and Air Force troops who will be engaged in Exercise Longhorn. Mr. Duren said that as a result of the meeting last Friday afternoon the following letter was sent to Lieutenant General Leroy Lutes, Commanding, at Fourth Army Headquarters at Fort Sam Houston:

"Dear General Lutes: We, the undersigned Officers and Directors of the Goldthwaite Lions Club, met today (December 28) and voted unanimously and enthusiastically to extend to you and through you a most cordial welcome to all of the Army and Air Force personnel that will be engaged in Exercise Longhorn. We are proud that Goldthwaite and Mills County will be a focal point of the important and impending maneuvers and we hope that you and all of those in your command will feel free to call upon all or any of us for any cooperation that we may be able to tender. We want you to know that a great big Welcome mat will be out to you and your troops.

"Please assure General Clarke of the First Armored Division,

Orders Given On Damage Control And Civil Rights

Details of the instructions that are being given to troops to safeguard civilian rights and property in areas in which the impending great military maneuvers, Exercise Longhorn, will be conducted, were published this week by Major General Bruce Clarke, Commander of the First Armored Division and Commanding Officer at Fort Hood.

The announcement regarding damage control and compensation and consideration for civilians during the maneuvers, which will have their focal point in Mills County, is as follows:

"The Maneuver Director of Exercise Long Horn has formulated a detailed plan for the prevention of damage to property during the joint Army-Air Force maneuvers here next March, Fourth Army Headquarters has announced.

"Included in the plans are the following points and provisions:

"The maneuver permits are trespass agreements. The government obtains permission only to use the land and cannot utilize buildings or other improvements on the property. Further, full settlement must be made for any damage.

"Commanders of units actively engaged in the maneuver are responsible that prior to arriving in the maneuver area, all personnel of their commands are given the following instructions:

Let's all of us leave the latch-string hanging out at our homes so that Goldthwaite and Mills County may be known far and wide for willingness to roll out the red carpet of welcome to strangers in our midst.

At this early stage of political activity in the still very young year of 1952 we have only one comment to make and it is to express regret that K. B. Henry, Mills County Commissioner for Precinct 4, has announced his decision not to seek re-election. GUEST EDITORIAL

(Editor's Note: Many astute observers have been suspecting that all of the talk about cleaning-up corruption in government has been just talk and no more than that. Raymond Moley, taking a look at the mess for which the "Queer Deal" is the Truman cannot carry the talked-about clean-up through. Here is Mr. Moley's article—written with restraint despite the scandals of which Americans are ashamed.)

Several things may happen in the promised Truman clean-up affair before this dispatch appears in print. Or, what is more likely, nothing will happen. But this is written in the confident feeling that, in any case, the President and his advisers can not find a legal way to do what has been promised.

After looking at this problem from all sides, I feel convinced that there is no effective legal way in which this administration can purge itself of corruption. The evil is spread too generally through the vast, shambling reaches of the government. And the legal means of self-correction are too meager.

At this writing it is apparent that Judge Thomas F. Murphy has reached the same conclusion. If he had done a bit more thinking before he enjoyed his latest bath of publicity, he should have realized that fact from the beginning. It is now reported that Judge Murphy has decided not to accept the task for three reasons: He could not get the men he wanted to serve with him; he would have no power of subpoena; he would injure his status as a judge and injure the prestige of the bench itself.

There are two additional reasons that might or should have deterred him. These are that no man could accomplish such a task and also, if there were such a man, his name would not be Murphy. Let us consider the second of these reasons first. Judge Murphy is a man of fine character; he is sincere and in what he has done so far, competent. His decision, however, has been decidedly limited. He came from the Bronx, which means that his probable sponsor was Edward J. Flynn, boss of that borough. His experience has been limited to the United States District Attorney's office in New York. It can be assumed that he is not familiar with the ramifications of the Washington bureaucracy. He was largely engaged in tax and insurance cases when he was plunged into the Hiss case. He did not prepare that case. It was really the product of fine work by the FBI. When Hiss was indicted by the grand jury, Murphy was in Europe on a tax case. He did his job well, however, in the two trials and well deserved promotion to the bench.

This is a rather scanty equipment for the biggest investigation of our time. Great political investigators of the past, such as Thomas Walsh of the Tea Pot Dome affair and Samuel Seabury in New York City, were men of seasoned experience.

But a combination of Walsh and Seabury would be inadequate for the task that needs to be done in Washington. Walsh was concerned with two or three actions that involved only three federal departments. Seabury dealt with only selected departments in one city. The trail of corruption and maladministration in Washington already runs through the Treasury and Justice Departments.

This newspaper, however, does not believe that it would be entitled to the confidence of its readers if it sold news or editorial space for any consideration of any sort. We do not expect and we would not want all of our readers to agree with us but we do hope for their respect. We do not see how any reader can have respect for or faith in the integrity of any newspaper that would sell its news or editorial space. The editor has written on this subject several times during the past 22 months but he feels it to be necessary to emphasize all over again the Eagle's policy now that the political year 1952 is upon us.

In our reporting of political news we shall make every effort to be fair, unbiased and objective. It may be that editorially, we shall have remarks and opinions to publish regarding both candidates and issues. In such case, the remarks and opinions will be based on conviction and an honest effort to place the public interest in the paramount position in which it belongs.

This year of 1952 will require the utmost sense of responsibility by those who rather and distribute the news of political campaigning. During this year, we are to elect a President of

Army Maneuvers

(Continued From First Page.)

"Off Limit" areas other than towns and villages within the tactical boundaries — that is, farms, ranches or other areas where maneuver rights were not secured—must be bypassed by all troops. Further, on land to which troops have maneuver rights, all homes, barns, other structures and adjacent house and barn lots will be considered "Off Limits".

"Every effort will be made to prevent damage to private property. Each unit of battalion or equivalent size will appoint a Damage Control Officer, who will be given necessary personnel, transportation, hand tools and supplies (barbed wire, staples, posts, etc.) to organize an effective unit repair party.

"The guiding principle for all damage control is that units will make prompt repairs of all minor damage they cause, and will report immediately to the Maneuver Rents and Claims Officer any damage which they cannot repair. Special engineer and repair teams will be available under Maneuver Headquarters for emergency repair and restoration."

Headquarters Fourth Army also announced that arrangements were being completed with the State Highway Department for maintenance and restoration for any damages which might happen to State roads in the area. Not only will prompt effort be made to effect repairs, they said, but in addition through coordination and liberal use of warning signs, every effort will be made to advance the traveling public of those areas in which active play of the maneuver is being accomplished and where special care is necessary in traveling on the roads.

Troops will be instructed, it was stated, to carefully open and close or continuously guard all gates.

They will be told to either cut or lay down fences, depending on which method will cause the least damage, and that repairs will be made promptly by unit repair parties.

They will be instructed to avoid cultivated areas to the maximum extent, use care to avoid injury to livestock, and to report all damage by the most expeditious means to the Maneuver Real Estate and Claims Office.

Additionally, Unit Control Officers will take aggressive action to limit and restore damage caused by their units by following the routes of advance of their units and making immediate repairs to fences and other minor damage and by checking defensive positions to insure filling of foxholes upon evacuation.

While Longhorn will last approximately seventeen days, lease agreements are for four months. This period of time is needed to prepare for the maneuver, due to the many problems and detailed work which goes with modern combat. A large segment of troops, which in actual combat would have been home troops occupying the area, must of necessity be thoroughly familiar with the terrain, calling for lengthy patrolling and familiarization.

Personnel charged with many of the duties required must also study the area yard by yard for movement of heavy equipment for ambulance routes, and for knowledge of general terrain features.

Observation of the maneuver play by umpires is all-important in lessons learned, and preliminary points for such observation must be chosen. Time is required also to establish elaborate communication facilities and lines. Such preliminaries will not interfere with normal use of land, officials said, and land owners can continue with planting of crops and grazing of cattle.
